




I was pleased to return to in-person quarterly Board meetings, and enjoyed both the strategic discussions and informal "water cooler" conversations with my fellow Board members and CKC staff alike. It was a welcome change after two years of Zoom meetings.

A true highlight of 2022 was the Annual General Meeting (AGM) in beautiful St. John's, NL in June. This was the first in-person AGM since 2019, and we successfully adopted a hybrid model that allowed members nationwide to join us. Special thanks to our Zone 1 Director, Frank MacArthur, and volunteers from the Newfoundland All Breed Kennel Club, who rolled out the red carpet for Board members and staff visiting from across Canada. We all left the AGM as honorary Newfoundlanders!

Throughout the year, our Board successfully moved several impactful initiatives forward, including the Integrated Breed Health Program, which will become an important program for all CKC member breeders. We also endorsed the move from our office at 200 Ronson Drive, Toronto to 5397 Eglinton Ave. W, which is just a short drive away. The new office space has a much smaller footprint to accommodate a hybrid workforce, is well situated beside a dog-friendly park, and will provide a substantial savings in our rent.

In November, we held a special referendum, and I thank the members who cast their ballot in support of six new breeds who were seeking full recognition, along with proposed bylaw changes and 38 Rules of Eligibility (ROEs). We were impressed by the voter turnout and we look forward to building on that success in the 2023 general election.

Thank you to my fellow Board members for their trust and support, our committee and council members who volunteer their time and expertise to our Club, to our dedicated staff, and finally our CKC Members. 2022 was a great year and I look forward to another as your Board Chair.



# **NEW BREEDS**

A special referendum was held in November 2022 allowing CKC members to vote on a number of bylaw amendments including rules of eligibility (ROE) for multiple breeds, and a vote to allow full CKC registration for six breeds (Russell Terrier, Russkiy Toy, Japanese Akita, Azawakh, Parson Russel, and the Miniature American Shepherd).

The CKC team worked with the board of directors, breed clubs, and breeders and owners of the six breeds to engage with members and encourage them to vote. All six breeds were voted in for full recognition! Three of these breeds (Russell Terrier, Russkiy Toy and Japanese Akita) had been included in a previous referendum without receiving enough votes to be fully recognized, highlighting the importance of membership engagement!

The success of this referendum was truly a grassroots effort. The CKC team kicked off the efforts with communications to the membership including social media images. The CKC Board of Directors shared these images on their social feeds, and they were consequently picked up by breed clubs, breeders/owners, and engaged CKC members.

The passionate breeders and owners of these six breeds jumped in on the efforts creating moving and meaningful videos introducing their dogs and encouraging members to vote. We began to see posts urging every member to ask their friends to vote to help these breeds. Voting results climbed from single digits to surpassing the minimum required to allow these breeds full recognition!

Thank you to everyone who worked with us to raise awareness and to all the members who took the time to vote and support these breeds.





# **NEW EVENTS**

2022 was the first year where event numbers surpassed pre-Covid levels! There were 3,339 events in 2019 representing 209,523 individual entries and 3,551 events with 221,337 entries in 2022. Seeing strong entries in an increased number of events after an abrupt lack of shows and trials throughout the previous two years of pandemic (716 events in 2020, 1765 in 2021), demonstrates the desire for owners, handlers, and breeders to get out with their dogs!





# **NEW MEMBERS**

Membership is also on the rise, growing from 16,667 members in 2020 to 19,023 in 2022.





# **NEW PROCESSES**

We have implemented new streamlined processes to speed up our response time! Registration applications where there is no co-ownership, no non-breeding and no additional consent required are now approved instantly.

Membership Plus applications submitted through the portal that require review by the CKC team will be actioned within two business days.

Basic Member applications submitted through the portal that require review by the CKC team will be actioned within seven business days.

When Members call the CKC, they now have the option to receive a callback, allowing them to keep their place in the queue.

 Over 225 call-backs were scheduled within the first two weeks of launching this option.

The chat feature has been expanded to allow Members to share their screen with a live agent for more efficient help and service.







# **NEW CKC TEAM EXPANSION AND** REPRESENTATION

The CKC team is evolving to be a better representation of the membership across the country. Nearly 50% of staff in 2022 were CKC members. The hybrid model of both working in the office and working from home has allowed the CKC team to better represent all of Canada. In 2022, almost 25% of the CKC staff were outside of Ontario.

Our CKC members had an exciting year with their own beautiful dogs! Some highlights from the CKC team:

- The first English Springer Spaniel to earn the title of Rally Grand Champion (which he did in August 2022) is owned/trained/handled by Mary in Shows & Trials. He was also the first ESS to earn a Rally Champion title!
- Jack the Bulldog was honoured with two Altered BIS earning him his Altered Championship, owned by Director of Operations, Sherry
- The #7 Terrier and #1 Staffordshire Bull Terrier in conformation is breeder/owner/handled by Terrina from Shows & Trials. She also bred and co-owns the puppy who is #1 Staffordshire Bull Terrier puppy/#3 Staffordshire Bull Terrier in conformation.
- #1 Gordon Setter Puppy and #3 Gordon Setter in conformation is owned/handled/trained by Savannah, the coordinator for the CGN program.
- #9 Great Dane in conformation is owned/bred/handled by Kristi in Regulatory.
- The top three Dalmatians in Rally Obedience are owned/trained/ handled by Heather in Marketing.



# **NEW ENGAGEMENT**

2022 marked greater engagement between the CKC and the membership, breed clubs, and with the dog owning public.



# ENGAGEMENT WITH THE PUBLIC

2022 brought new efforts to engage directly with the public and be the champion for purebred dogs in Canada. Ian Lynch provided commentary at several of Ontario's largest shows that were run in conjunction with events geared towards the general public including the Pet Expo and the Royal Winter Agricultural Fair.

lan's expert commentary made the dog show accessible to the general public. He explained how the judging worked, how dog shows are run, what the different classes mean, and included many facts and features about every single breed represented in the ring. Commentary can make the difference between a conformation show seeming complex and indecipherable to easily understandable and interesting.

### Introducing the Public to Purebred Dogs

In 2022, the CKC team worked to create new opportunities to introduce the public to purebred dogs.



# **NEW OPPORTUNITIES**

For the first time since 1998, there was a dog show at the Royal Winter Agricultural Fair! The CKC was thrilled to partner with the Royal to help celebrate their 100th anniversary. The Olde York and Credit Valley kennel clubs worked with the CKC and the Royal to be able to offer 6 days of conformation shows as a key feature in the Royal's Animal Theatre.

The show had the grand look one would expect of an event with the prestige of the Royal. You entered the Animal Theatre through heavy black curtains and walked into a bright area with four show rings on brilliant blue carpet with pristine white fencing.

The CKC's mission was to help facilitate a truly special show that allowed members of the public to see a wide range of beautiful purebred dogs.

- The public saw over 250 purebred dogs each day with six davs of shows.
- More than 80 different breeds were exhibited!

To engage directly with the public, we added a special feature to a dog show where we could welcome the public to meet and interact with these beautiful dogs. We created a space where people could ask questions about the breeds to the experts themselves, breeders and owners! We built the first CKC Meet the Breeds event where we showcased more than 40 different breeds (including some VERY rare breeds!)

We also presented multiple demonstrations highlighting the versatility of purebred dogs including agility, disc, movie tricks, and scent work.

Thank you to all the breeders and owners who shared their beautiful dogs, volunteered their time, and helped the general public have a face-to-face hands-on interaction with purebred dogs!

# **ENGAGEMENT** WITH BREED **CLUBS**

The CKC has been liaising with breed clubs across Canada to create ROE's, update breed pages in anticipation of a new website, and begin work on a new Integrated Breed Health Program. The new breed pages will be launched later this year and are geared towards intriguing and educating the general public about the wealth of breeds within the CKC.

# **ENGAGEMENT** WITH MEMBERS

For the first time since the start of the pandemic, the 2022 AGM was held in person in beautiful St John's, Newfoundland. The board of directors was able to meet in person with CKC staff and members, as well as with members joining virtually.

CKC members may have been seeing Reels from dog shows on our social feeds. CKC team members have been attending shows and capturing photos and videos to highlight the event. More to come in 2023!

# **NEW PARTNERSHIPS**

We took the opportunity in 2022 to review a few of our key strategic partners & affiliates.

### **NEW PROGRAMS**

At CKC's 2022 AGM, we announced the initiation of a new strategic program to better support CKC members and member breeders in the preservation and improvement of the health & wellbeing of purebred dogs: an Integrated Breed Health Program.

The Integrated Breed Health Program (IBHP) covers five key projects:

- Breeder Community Support: a review of CKC Codes of Ethics, Policies & Procedures, By-laws, and refining and adding value the Puppy list;
- · Creating Breeder Education courses and resources;
- · Compiling Breed Health Strategies for our recognized breeds;
- Developing a DNA Program that supports genotypic health testing and parentage verification; and
- Building a voluntary Breeder Program that highlights and showcases accountable CKC member breeders.

Supported by the Breeder Relations and Genetics & Medical Committee, 2022 work focused on finalizing the development and rollout plan for the IBHP projects, stakeholder engagement, discussions with key strategic partners, and other planning and initiation activities. With many interrelated elements members, breeders, National Breed Clubs, and other key stakeholders are being consulted every step of the way, and all project elements will be released to members in a phased and supportive method.

CKC members are encouraged to keep an eye on their inboxes throughout 2023 as more news of this program is shared and the first phases begin to roll out.

In 2023, the CKC office moved to a new space representing a savings of 2/3 in office expenses!

# CKC'S ADVOCACY UPDATE FOR 2022

The CKC's Advocacy efforts are guided by The Canadian Kennel Club's mission — the preservation of purebred dogs and the health, wellbeing, and enjoyment of all dogs. We remain committed to ensuring that the interests of CKC members, breeders, clubs, dog owners and their dogs are well-represented locally, nationally, and federally.

Key issues included dog importation, standards of care for outdoor dogs, breeder restrictions, and a ban on cropping, docking and dewclaw removal. We also monitored activity across the border and internationally, watching for trends and prohibitions (proposed and implemented).

Throughout 2022, there was a greater focus on growing stakeholder relations, to collaborate on important matters such as breed health and responsible pet acquisition.



# STAKEHOLDER RELATIONS

The CKC was pleased to work with many stakeholders, including those that represent the animal welfare, veterinary and pet perspective. Among them are The Canadian Veterinary Medical Association (CVMA), International Partnership for Dogs (IPFD), Pet Industry Joint Advisory Council (PIJAC), Royal Canin, BC SPCA, Humane Canada, and the New Brunswick SPCA, OFA, AKC, The Kennel Club and many others.

As part of CKC's greater focus on the health of all breeds, including brachycephalic breeds, CKC was pleased to host a Symposium in July, in collaboration with breed clubs of brachycephalic breeds, the Canadian Veterinary Medical Association, the International Partnership for Dogs and Royal Canin. We were also pleased to hold three webinars with breed clubs of brachycephalic breeds.

In addition, CKC held discussions with the Kennel Club, University of Cambridge, and the Orthopedic Foundation for Animals (OFA) regarding the University of Cambridge Respiratory Function Grading Scheme (RFG Scheme). CKC was excited to partner with OFA to bring the RFG Scheme to Canada. CKC sent a a Canadian lead assessor to Portland for training in January 2023, and Canadian events are in the works.

As part of a CFIA initiative encouraging the public to buy dogs from known sources, CKC developed a Google Ads campaign to promote accountable CKC member breeders and the importance of puppy buyers doing thorough research before buying a puppy.

We were also pleased to engage the New Brunswick SPCA, with plans to collaborate in a multi-stakeholder campaign pets in 2023 to promote the responsible acquisition of pets.




# **LEGISLATIVE HIGHLIGHTS**

The CKC and its members participated in public consultations regarding the proposed updates to the standards of care for dogs that live outdoors under Ontario's Provincial Animal Welfare Services Act (PAWS Act). The CKC and other stakeholders expressed concerns about the one-size-fits-all changes —particularly minimum space required in a housing pen, maximum time on a tether and water consumption — which became effective on July 1, 2022.

The CKC also consulted with the City of Toronto during its Animal Bylaw Review regarding pet licensing in addition to advocating for choice regarding procedures such as tail docking.

In addition, the CKC undertook a review of CFIA's new ban on dogs imported from rabies-positive countries to evaluate the risk to CKC members. We also continued to advocate for our member breeders who remain impacted by the commercial dog import requirements that were implemented in 2021 for dogs under eight months of age imported for breeding, resale, and show/exhibition (permanent stay).

The CKC and its members also participated in a public consultation to provide feedback on the Quebec Ministry of Agriculture, Fisheries and Food's (MAPAQ) proposed changes to the Animal Welfare and Safety of Act. They included restrictive requirements for breeders and a ban on cropping, docking and dewclaw removal. Although the rules were made official in August 2022, they will not be implemented until February 2024. We will continue to advocate for our members and seek provisions to mitigate the impact.



In the execution of its duties, the Audit Committee, comprised of three Chartered Professional Accountants, met five times throughout 2022, virtually via Microsoft Teams. The Chair attended the quarterly Board meetings, with the exception of the September Board meeting.

The Audit Committee supported the Canadian Kennel Club with the review of the audited financial statements, management letter, and documentation related to the audit processes. The Committee reviewed the strategic investments of the organization. The Committee monitored the financial health of the Canadian Kennel Club by reviewing the monthly financial statements and cash flow, monthly forecast, quarterly financial reports, and the annual operating and capital budgets. The Committee collaborated with the Executive Director on the recruitment of a Director of Finance. This new role will provide added senior leadership and expertise to the Canadian Kennel Club in areas beyond finance, such as I.T. and business operations. The Committee oversaw the development of the financial plans for the transition from the Canadian Kennel Club's current office to its new location.

Melanie Towell is the Audit Committee liaison to the IT Steering Committee, whose role is to provide input to the budget and internal controls related to IT Infrastructure.

The Audit Committee Chair is liaison to the Strategic Planning Committee.

The Discipline Committee met remotely via Zoom on February 16, August 13 & 14, and November 25, 26 & 27, 2022 to hear 64 cases in which appearances were made in 17 cases. Of the 64 cases heard, no files are being appealed as of December 20, 2022. The appeal deadline for the November meeting is January 6, 2023.

As of December 15, 2022, 50 of the 64 cases opened this year remain open. Thirty of the open cases are scheduled to be heard in 2023.

The Committee levied costs of the investigations and hearings in the amount of \$6,500 (plus applicable taxes) of which \$4,300 (plus applicable taxes) of these costs have been paid.

In 2022, 209 files concerning non-delivery of certificates were opened and 145 of those files were closed. Of the 145 files that were closed, five Discipline Committee files were opened. In accordance with Section 15.1 of the By-laws, non-delivery

complaints involving first alleged offences are within the iurisdiction of the Executive Director, so an additional eight files were opened for referral to the Executive Director.

The Breed Standards Committee meets electronically via Zoom to review new applications and discuss applications to revise breed standards on behalf of the breed clubs seeking changes to their existing standards. The Committee also reviews standards for breeds seeking CKC recognition and referred by the Event Officiating Committee and/or the Registration Committee. In 2022, it reviewed the breed standards for the Biewer Terrier, Grand Basset Griffon Vendéen, Pumi, and Viringo.

The Committee held four (4) meetings in 2022. Additional business is conducted by email as required. The Committee presented amendments to the breed standard for the following breed for approval of the CKC Board or Directors:

Breed standard amendments for the following breeds are in varying stages of processing with the Committee: Belgian Shepherd Dog, Bulldog, French Bulldog, Chow Chow, Lagotto Romagnolo, Siberian Husky, and Spaniel (French).

The Breed Standard Committee supported the recent decision of the CKC Board at the December 2022 meeting, concerning cropping and docking statements in breed standards, by offering to assist those breed clubs who have not already done so, to revise their standards.

The Committee also initiated a request to the CKC Board, that a statement concerning the health and welfare of breeds be added to all breed standards and the following was approved by the CKC Board at its December 2022 meeting.

To be included at the beginning of each breed standard:

The breed standard outlines the ideal characteristics, temperament, and appearance of a breed, and ensures that a dog can carry out its original purpose. Breeders and judges should be mindful to prioritize dogs that are healthy and sound in both mind and body.

To be included in Faults:

FAULTS: Any departure from the aforementioned ideals shall be considered faulty to the degree of which it interferes with health and well-being of the dog and the breed's [traditional] purpose.

I would I like to thank the members of the Committee, Nancy Downing and Linda St-Hilaire, CKC staff Sherry Wiess and Dee Jones and our CKC Board liaison, Tempest Deptuch, for their dedication and hard work this past year.

# **Breeder Relations** Committee (BRC)

The Breeder Relations Committee held seven (7) meetings remotely via Zoom during 2022, continuing their work to support staff in finalizing the development and rollout plan for the projects under the Integrated Breed Health Program (IBHP) - including Breeder Education, Breeder Community Support, a Breeder Program (Breeder Certification), and others.

Supporting staff as a steering committee for the above areas included in CKC's Integrated Breed Health Program (currently under development), the Committee kicked off 2022 with information gathering and vision mapping of the critical components for the program. This included a member consultation process in the spring of 2022. A survey was shared with over 13,000 individuals (any contacts associated with a litter registration submitted to CKC within the past ten years), and over 2,200 breeders participated in the survey.

We are extremely pleased and grateful for the amount of member breeder participation. The survey provided valuable insight into the priorities and concerns of our breeders and supported the overall direction the Committee has taken thus far. The Committee will continue to use survey insights to inform the development of the Breeder Program, and plans are underway for continued engagement opportunities and surveys.

The Committee also supported with environmental scans and market assessments, discussing learnings from other similar kennel clubs and international breeder programs, and investigating potential partnering opportunities to support content and program development.

We are excited to start sharing more of our progress with the membership in 2023, including upcoming announcements for how new relationships will support the development of the IBHP and our CKC member breeders, in specific, Breeder

Over the past year, the Communications Committee held six virtual meetings, in addition to sub-committee meetings and joint meetings with other CKC committees. The Committee's focus has continued to support CKC by providing counsel, recommendations and identifying areas of strategic communications priority.

Throughout 2022, the Committee placed a high priority on the need for an organizational-wide communications audit, that includes a proper stakeholder analysis and segmentation, and evaluation of all communication platforms. Some incremental changes have been implemented as a result of the work on the audit; however, the audit was on a hiatus with limited CKC staffing resources being available for a portion of the year. At the last meeting of the year, the Committee decided to proceed with the communications audit work on its own to allow CKC staff to focus on other areas of work. The outcome of a communications audit will help guide and develop a comprehensive communications strategy for the CKC.

The Committee provided feedback and input on the important role of the Executive Director as a spokesperson for the organization. The discussion resulted in an extensive list of future potential topics for development and inclusion in upcoming videos, including key areas such as Canada Food Inspection Agency (CFIA) updates, notice of upcoming changes that impact the membership, benefits of being a part of the CKC, and even opportunities for the Executive Director to engage in discussion with the membership of the CKC.

While the Committee was not involved in the website redevelopment project, it is now a standing agenda item for

committee meetings. The Committee will continue to provide input on important key areas such as a more intuitive user experience and assist in prioritizing member needs.

Over the year, the Committee actively sought out opportunities to be engaged in the development of communication strategies that impact membership and stakeholders. Early in the year, some Committee members assisted with a survey to judges regarding how best to receive breed standards. Towards the end of the year, the Committee was engaged in bringing together members of the Breeder Relations Committee, Genetics and Medical Committee, and the Communications Committee to discuss the key messaging and communications channels for the Integrated Breed Health Program (IBHP).

# Genetics and Medical Committee

The Committee shall be responsible for making recommendations to the Board in the development of policy, guidelines and/or programs as authorized by the Board of Directors related to canine genetics. This mandate will include but not be limited to the development of an advanced health registry. The Committee shall also be responsible for recommendations to the Board of Directors in the development of policy, standards and guidelines relating to trends, advances, and changes to canine medical procedures as they impact CKC breeders.

The Committee held eight meetings remotely via Zoom during

With the support of the Board of Directors, and a new dedicated staff position, the Committee's work in 2022 focused on three key areas (as part of CKC's Integrated Breed Health Program currently under development):

- 1. Advancement of a DNA Parentage Program incorporated into the Registration process of the CKC
- 2. Development of a Genotypic Health Registry
- 3. Development and Launch of Breed Health Strategies

Supporting staff as a steering committee for the above areas, the Committee met with potential DNA Program sponsors/ partners and resource gathering for the development of breed health strategies was performed. After careful review by the Committee, this research is now being presented to the National Breed Clubs for feedback, and in 2023 it will be used to build individual health strategies for each of our CKC recognized breeds, continuing information on recommended genotypic and phenotypic testing for breeding stock and any new breed specific health concerns breeders should be aware of.

Additionally, the Committee offered counsel and recommendations on several key topics, including:

### • The (Canine and Feline Sector Group) CFSG Conformation **Guidance Document**

This document was originally shared with the Committee in May 2021 to consider adding it to our educational resources for members. The document includes illustrations of the normal functions of a dog's various body parts in comparison to not normal functions. The thought was that this document could help move conversations away from the breed standards and direct them to what is a healthy dog. After further review, the Committee recommended not to adopt this document as an educational resource due to the complex nature of the subject matter and lack of Canadianspecific context.

### **Cloned Dogs**

The Committee provided feedback on an email inquiry received by staff about registering a cloned dog. Discussions centered on that CKC registers dogs based on pedigrees and parentage, not on duplicating DNA in labs and if this would allow for the registration of a cloned dog as it has the same pedigree as the dog from which it was cloned but was not born of a sire and dam. Discussion will continue if/when CKC receives feedback from Ag-Canada on this topic.

### **Titer Testing and CKC's Conformation Rules**

The Committee also provided feedback on a referral from the Shows & Trials Division staff on whether titer testing is sufficient for dogs to participate safely in events, in accordance with CKC Policies and Procedures. The Committee discussed up-to-date immunization or titer testing is sufficient to show protection; however, the current language in the rules and regulations and policies and procedures could be strengthened to clearly articulate this. The Committee will work in 2023 to adjust the language accordingly for better clarity for show-giving clubs and event participants.

The Committee thanks the Board for its continued support

of the strategic projects it brought forth this year and the membership and national breed clubs for participating in the initial consultation phases for building our breed health

We look forward to continuing our work in 2023 and beyond of supporting responsible purebred dog breeding, and the health and well-being of purebred dogs.

### **Obedience Council**

The basic objective of obedience trials is to produce dogs that have been trained to behave in the home, in public places and in the presence of other dogs, in a manner that reflects credit on the sport of obedience Obedience is a sport and all participants should be guided by the principles of good sportsmanship both inside and outside the ring. All contestants in a class are required to perform the same exercises in substantially the same way so that the relative quality of the various performances may be compared and scored.

Rally is a companion sport to CKC obedience. Both events require teamwork between dog and handler, along with similar performance skills. Rally provides an excellent introduction to all CKC companion performance events for dogs and handlers. The chief objective of rally is to provide a fast-moving and motivational activity that demonstrates the competency of handler and dog in performing basic obedience exercises without requiring exact precision for success. Rally can also provide the opportunity to refine training skills for competitors in other events The performance of dog and handler in the ring must meet the requirements of the rally regulations. Dogs in rally obedience events should demonstrate willingness. enjoyment and teamwork between the dog and handler. To that end, handlers are encouraged to use praise, encouragement and petting within the boundaries of these rules.

The purpose of field dog tests for pointing breeds is to encourage the development and use of those natural abilities for which pointing dogs were originally bred. Pointing dogs were selectively bred from dogs who exhibited pointing and retrieving from land and water instincts. These tests assist breeders who strive to enhance breed improvement by selecting breeding stock that have strongly demonstrated these fundamental breed traits.

The purpose of the water tests for pointing breeds is to provide an opportunity to demonstrate a dog's ability to retrieve from water. These tests gauge the natural hunting abilities for which they were originally bred, against standards of performance.

# Scent Detection Trial Council

The Scent Detection Trial Council shall be responsible for considering and subsequently making recommendations to the Board regarding all matters relating to Scent Detection Trials.

Scent Detection is a sport that is inspired by working detection dogs that locate a scent and communicate to the handler that the specific scent has been found. Detection is done in a variety of environments and often during changing conditions that task the skill and concentration of the detection dog. Scent detection is a positive, challenging activity that allows dogs to use their strongest natural sense in a way that builds and strengthens a foundation of trust between the handler and dog. A scent detection event is a performance event, which provides a safe and fun activity that is open to all eligible dogs and their owners. For a team to qualify, both the dog and handler must be working together as a team and must be able to read each other's reactions. Communication and praise of the dog during the search are encouraged in a CKC scent detection event.

# **Spaniel Council**

The Spaniel Council shall be responsible for considering and subsequently making recommendations to the Board regarding all matters relating to field trials and hunt tests for sporting Spaniels, or any other event related to sporting Spaniels in the field.

The purpose of a Spaniel field trial is to demonstrate the performance of a properly trained Spaniel in the field. The performance should not differ from that in any ordinary day's shooting, except that in the trial a dog should do its work closer to perfection.

The purpose of a hunt test is to assess and identify those dogs which possess the basic requirements of "flushing" Spaniels. It will test the merits and evaluate the abilities of Spaniels in the field in order to determine their suitability and ability as hunting companions.

Dogs are placed in four categories based on their ability, not age. Dogs do not compete against one another, but rather their performances are individually judged against the standard.

The Committee held eight formal meetings in 2022, including a presentation to the CKC Board of Directors during the September 2022 Board Meeting, and continued its work regarding the development of breeder, judge, and public education, to support the breed health of brachycephalic breeds, within the greater context of all breeds.

To further this work, the Committee held several webinars with the brachycephalic-related breed clubs in June, August, and November 2022. To support these efforts, the Committee also participated in a Symposium on Healthy Dog Breeding, in collaboration with the International Partnership for Dogs, Canadian Veterinary Medical Association and Royal Canin in July 2022.

The Committee has also been working to bring the Kennel Club and University of Cambridge Respiratory Function Grading Scheme to Canada and is pleased to support CKC's partnership with the Orthopedic Foundation for Animals, which will license the Respiratory Function Grading Scheme to both Canada and the USA. The Committee looks forward to working with the breed clubs and Canadian lead assessors on this important initiative, beginning with the launch of Canadian pilot events early in 2023.
