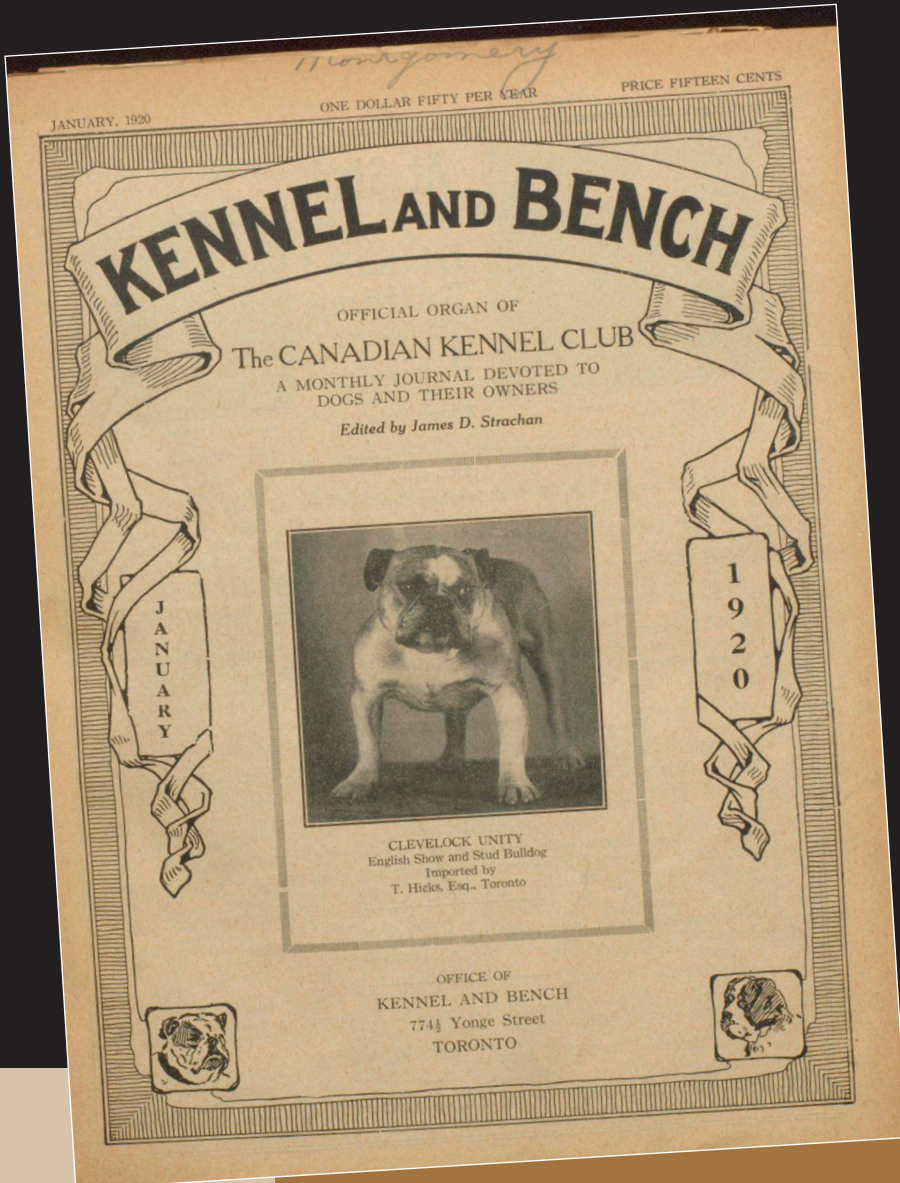

NOW AVAILABLE: ONLINE MEMBERSHIP RENEWALS!

For the first time in CKC's 130-year history, CKC members can renew their memberships online. As 2019 comes to a close, we encourage you to log into CKC's online portal to renew your membership today (Visa or MasterCard required).

The process is easy, simply log-in to the new Member Portal and click on the red RENEW button in the upper right-hand corner. If you haven't accessed CKC's new online portal yet, these [quick instructions on creating a portal account](#) will get you started.

Online renewals are NOT available for members with lapsed years. Members with lapsed years are encourage to contact Membership Services at 1-855-364-7252 (toll-free) to arrange for renewal.

Members can also renew by contacting Membership Services at (416) 675-5511 or Toll Free at 1-855-364-7252, by e-transfer at etransfers@ckc.ca (please send your security answer and membership number in a separate email to the same address), via telephone or online banking (EFT/Electronic Fund Transfer) using your 7-digit Membership number with a zero in front (0+Membership Number) as the account number, or in person at CKC's office.

NOW AVAILABLE: ONLINE DOG REGISTRATIONS

CKC has launched Online Dog Registrations on the Portal. Submit all types of dog registrations online, including:

- Individual Canadian Born Dogs (with litter registration numbers previously issued);
- Imported Dogs and Foreign-Born Dogs; and
- Miscellaneous Certification numbers, Event Registration Numbers, Performance Event Numbers, Canine Companion Numbers and **Temporary Competition Numbers**.

TEMPORARY COMPETITION NUMBERS: SELF-SERVE ONLINE REGISTRATION FOR LISTED DOGS

With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs", and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN.

While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number.

The process of obtaining a TCN will be self-serve; exhibitors will be directed to the CKC website to complete an online application and a TCN will be issued instantly upon completion.

Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC via mail, or by contacting the Shows and Trials Division by telephone.

Until March 2, 2020 dogs may still be entered into CKC events without a registration number or ERN by marking "TCN" on the entry form (or "Listed" if it is an old entry form). However, an e-mail address will be required. Before you apply for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if CKC has already created a TCN for them. There will be a tab for TCN Dogs on the Owner's Portal account.

Please note that if your dog does not have a registration number or ERN, and has already competed in a CKC event and earned points, scores, or awards, there is no need to apply for a TCN. CKC records will be updated accordingly.

CHANGES TO REGISTRATION NUMBERS AND EVENT SUBMISSION REQUIREMENTS

CKC has updated its dog registration numbering system as of November 1st, 2019.

With the exception of dogs registered as Canadian Born, all dogs registered after November 1st will receive a 12-character registration number. This number will include a prefix consisting of a two-letter abbreviation of the registration type, a hyphen, and the standard 9-character registration number (two letters followed by 7 digits).

Examples:

Event Registration Number:	EN-AB1234567
Miscellaneous Certification Number:	MN-AB1234567
Performance Event Number:	PN-AB1234567
Canine Companion Number:	CN-AB1234567
Temporary Competition Number:	TC-AB1234567

The entire number, including prefixes, must be used on all applications and when entering events. The entire number must also be submitted with all event results. Other prefixes not listed above include AK, AN, NR and FD for various CKC recognized breeds.

Dogs registered before November 1st, 2019 will maintain their current registration number, and will enter events using this number as written on their registration documents. *The new 12-character registration number only affects dogs registered after November 1st, 2019.*

Note: Dog's registered as Canadian Born Dogs WILL NOT have a two-letter abbreviation or hyphen in their registration number. Canadian Born Dog Registration numbers will remain as previously issued.

THE SECOND WEDGE STORY: SADIE THE BLACK LAB HELPS CHANGE ONTARIO LEGISLATION



A black Labrador Retriever named Sadie is responsible for a province wide relaxation of the rules that apply to patios and micro-breweries.

The Second Wedge Brewing Company opened in Uxbridge, Ontario in December 2015. It was actually a “tasting room”, rather than a pub, as they didn’t serve food, only a few packaged snacks. The owners, Rob Garrard and Joanne Richter, brought their black Lab Sadie to work (and to charm the clientele) and encouraged dog owners to bring their dogs, as they do in British pubs.

At first the brewery had package snacks available. However, Uxbridge has several excellent nearby restaurants, so eventually patrons preferred to get their food as “take out” and took it over to the Second Wedge where they and their canine friends could share a meal and a glass of the excellent beer, made on site.

Named for the “Uxbridge Wedge”, the second of the four wedges of the Oak Ridges Moraine, the tasting room attracted many visitors from out of town who enjoyed running, cycling or hiking the nearby rollercoaster trails (Uxbridge is the Trail Capital of Canada) and relished a cold one afterwards.

The dog friendly brewery had become a local success story until July 29 of this year when an anonymous complaint was filed with Durham Region’s Health. Nine days later, another complaint was filed. Although all previous inspections had permitted dogs on site, after the second complaint the health inspectors informed the Second Wedge owners that dogs (including their own Sadie) would no longer be permitted indoors.

An apologetic note, prominent on the front door, informed customers that their dogs could not enter the premises.

On August 30th the brewery launched a petition that would allow dogs in breweries. They received 7,000 signatures and the support of 40 other Ontario breweries. The owners also appealed to the provincial government.

Fortunately, the MPP for Uxbridge-Pickering is Treasury Board President Peter Bethlenfalvy. On Oct. 4 he made a formal request to MPP Prabmeet Sarkaria, Associate Minister of Small Business and Red Tape Reduction, asking the province to re-examine the health code regulations.

On Saturday, November 2nd, Bethlenfalvy, Sarkaria, and Christine Elliot, Deputy Premier and Minister of Health joined several local and regional politicians in the Second Wedge’s Brewery for an important announcement. Also in attendance were Richard Paquette, CKC Director for Zone 4, and life member Mike Macbeth, an Uxbridge resident representing the CKC and the Dandie Dinmont Terrier Club of Canada, with two of her dogs.

NOTICE BOARD

The Brewery was packed with supporters and their dogs. Despite the crush of the standing only crowd the dogs were all relaxed and friendly, including Peter Bethlenfalvy's Miniature Schnauzer. There wasn't even a single bark, proving that well behaved dogs deserved the opportunity to join their owners at The Second Wedge.

Mr Paquette and Ms Macbeth had the opportunity to speak at length with Mr. Bethlenfalvy prior to the government's announcement, assuring him of the CKC's support of any dog friendly legislation, and offering detailed information about the billions of dollars spent annually on the canine industry, proving the financial advantage and cultural importance of dog ownership.



The three Ontario MPP's announced that Ontario is proposing a bill to allow businesses the option to permit dogs within indoor spaces such as breweries (where food is not prepared) as well as restaurant outdoor patios. If passed, the proposed changes, giving business owners greater choice and flexibility, will come into effect January 1, 2020.

In the meantime, Sadie will resume greeting patrons of Uxbridge's Second Wedge Brewery, which she considers her full-time job.
