GENERAL INFORMATION

1. All communication regarding entries should be addressed to the Show Secretary
2. Entries without a fee will not be accepted
3. Acknowledgement of entries with a Judging schedule will be mailed as soon as possible after the closing date
4. Make all cheques payable to the show giving club
5. The Club and Canine Show Services 2000 Inc will not be responsible for cash sent through the mail
6. Returned cheques do not constitute a valid entry fee. A collection fee of \$15 will be added by Canine Show Services 2000 Inc in addition to any bank charges for each returned cheque.
7. There is no refund for duplicate entries. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made
8. Entry fees shall not be refunded in the event that the dog is absent, excused by a Veterinarian or Judge, disqualified or barred from competition by action of the bench Committee.
9. If because of riot, civil disturbance or acts of God, it is impossible to open or complete the show, no refund of entries shall be made
10. Exhibitors must abide by errors made in entering their dogs, regardless of how or by whom the entries were made. Change or cancellation of any entry after closing time is prohibited.
11. The Club reserves the right to refuse any entry subject to CKC rules
12. Dogs may arrive any time prior to their scheduled time of Judging. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Owners/Agents are responsible to have their dogs present when their classes are called to be judged
13. Exhibitors are requested to keep their grooming and crating areas clean and tidy. If space is at a premium, exhibitors must remove exercise pens if requested by the Show Superintendent

The Show Superintendent will be in complete charge of the show, which will be governed by CKC rules

IMPORTANT NOTICE TO OBEDIENCE EXHIBITORS

There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. Rules may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. If a foreign born and owned dog, to have an Events Registration Number or obtain this from the C.K.C. within 30 days of the trials.

A dog which has won a comparable degree in any foreign country is not eligible for entry in the Novice A class but may be entered in the Novice B class if it has not earned its C.D. degree in Canada. A dog that has won its C.D. degree in Bermuda or the U.S. or has won a comparable degree in a foreign country may be entered in the Novice B class if it has not earned its CD. Degree in Canada. A dog which has won its C.D.X. degree in Bermuda or the U.S. or has won a comparable degree in any foreign country is not eligible for entry in the Open A class but may be entered in the Open B class.

Chapter 6.5.2 of the C.K.C. Rules and Regulations for obedience trials, states in part: 'Where a bitch comes into season after the entry of the bitch has been submitted to the trial secretary and a veterinarian's certificate certifying that the bitch was in season within the ten day period preceding the trial, is delivered to or reaches the trial secretary ON OR BEFORE that date of the trials, the trial-giving club will refund entry, service charges and listing fees.'

Attention Foreign Exhibitors : Please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however they are to be payable in Canadian Funds. If you send a cheque in US funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheque "Payable in Canadian Funds" or "At Par" as they will not be cleared by banks. To simplify the process we urge you to purchase bank drafts or money orders payable in Canadian funds

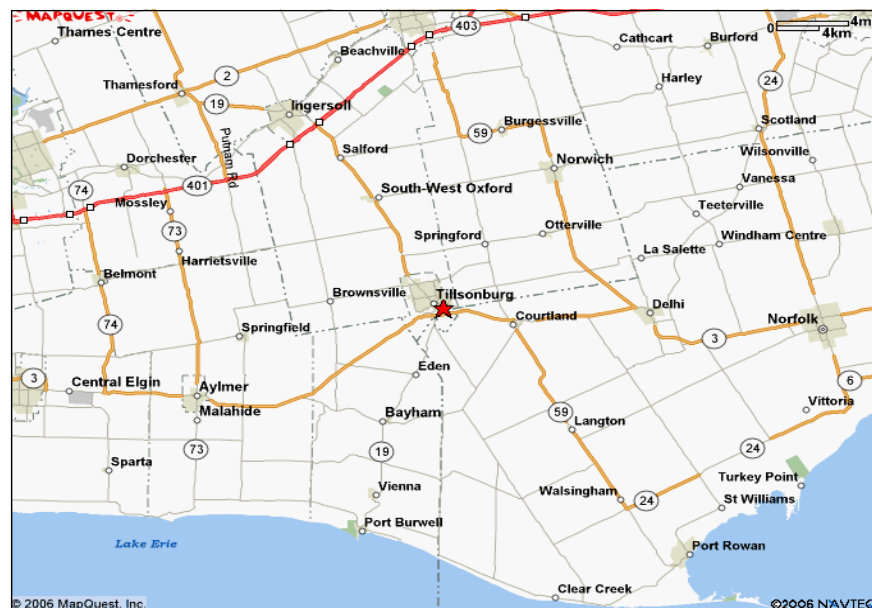

CHAMPIONS AND CHAMPIONSHIP POINTS

A dog awarded WINNERS at a championship show held under CKC Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of points to be credited to a dog awarded WINNERS shall be provided as follows;

Dogs competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points	0	1	2	3	4	5

- Includes dog awarded WINNERS
- In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall be included in the calculation for Championship points.
- To determine the number of Championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winner, Best of Winners, Best of Breed or Best of Opposite Sex, and the consult the schedule set forth above.
- In addition to the Championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following points provided that a dog was defeated at the group level
- No dog may be credited with more than 5 points in a single show

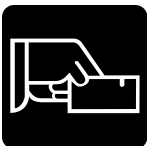
