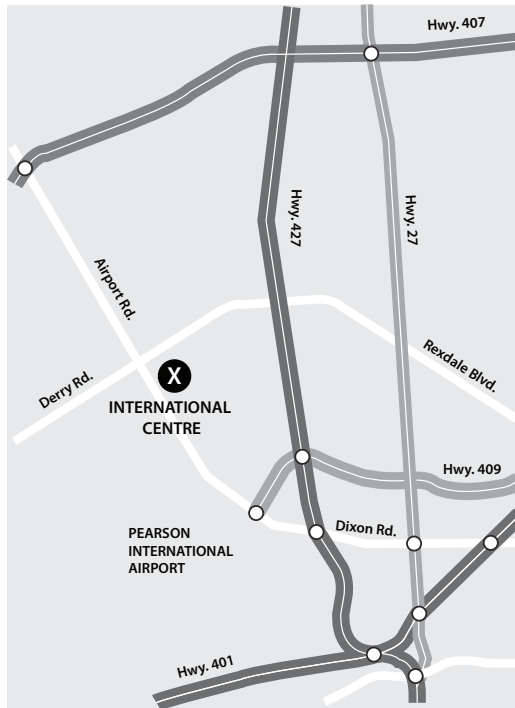

The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club.

Chapter 4 - Subsection 4.7.1 of the Conformation Show Rules and Regulations states: A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

IMPORTANT NOTICE TO OBEDIENCE EXHIBITORS

There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

A dog which has won a comparable degree in any foreign country is not eligible for entry in the Novice A class but may be entered in the Novice B class if it has not earned its C.D. degree in Canada. A dog which has won its C.D. degree in Bermuda or the U.S. or has won a comparable degree in a foreign country, may be entered in the Novice B class if it has not earned its C.D. degree in Canada.

A dog which has won its C.D.X. degree in Bermuda or the U.S. or has won a comparable degree in any foreign country, is not eligible for entry in the Open A class but may be entered in the Open B class.

NOVICE A CLASS:

One dog only may be entered in this class by any one exhibitor.

OPEN A CLASS:

One dog only may be entered in this class by any one exhibitor.

NOTE:

A dog entered in either of these classes must be handled in the ring by the owner or a member of his/her immediate family.

Dogs in obedience must wear a well-fitted plain buckle or slip collar. Slip collars of any appropriate single length of leather, fabric or chain with two rings, one at each end, are acceptable. There shall be nothing hanging from the collar.

BITCHES IN SEASON

BITCHES IN SEASON are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days preceding the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class; and the club will refund entry fees.

EVENT REGISTRATION NUMBER (ERN)

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Fee is \$58.50 per dog after January 1, 2012 plus applicable taxes.

- A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$58.50 plus applicable taxes.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

ENTRY INFORMATION

- No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- Substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
- Entries positively close 8:00 p.m. (EST) WEDNESDAY, FEBRUARY 22, 2012** and must be in the hands of the Show Secretary by that date.
- There is no refund for duplicate entries. Every effort will be made to find all duplicate entries, however if an entry has been processed and appears in the official catalogue, no refund will be made.
- Identification cards and judging schedules will be mailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the show.
- Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any N.S.F. cheques will be subject to a \$25.00 service charge.**

GENERAL INFORMATION

- The Show Superintendent will be in full charge of the show which will be governed by CKC Rules.
- The Purina National – ACKC Charity Event will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
- Judging will commence at 8 a.m. each day. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
- SHOW PRECINCTS: The Show precincts shall consist of all judging areas set aside for the show officials, judges, exhibitors and handlers and thirty (30) feet outside of the rings.
- NO Private exercise pens will be allowed. Exhibitors are requested to keep their grooming and crating areas clean and tidy.

Conformation Judges' Biographies

Mr. Edgar Bajona (Canada)

Edgar began exhibiting dogs in the Mediterranean (Malta). After moving to Canada he continued to breed and exhibit Afghan Hounds and standard Longhaired Dachshunds under the "Jagar" prefix. Served as President of the Afghan Hound Club of Canada and The Guelph and District Kennel Club, an all-breed club in Ontario, Canada. Received CKC approval to judge all breeds in 1995 and has judged throughout Canada, the United States, as well as The Royal Show in Queensland, Australia, Argentina, Brazil, Ireland and Mexico. He also judged at the World Show in Argentina in 2005. Edgar enjoys travelling and ballroom dancing and is fluent in Finnish and Thai languages.

Mr. Enrique Jorge Filippini (Argentina)

Born in Buenos Aires, Argentina in 1946. He started his canine activity in the Argentine dog clubs 30 years ago. His experience in purebred dogs began with the breeding and exhibition of Boxers, followed by Miniature Pinschers, Borzois and Italian Greyhounds. He achieved many high honors with his Miniature Pinschers in South America and Europe. His kennel produced Best in Show and numerous champions in different breeds. He later introduced more breeds into his kennel for breeding and exhibition - Afghan Hounds, English Cocker Spaniels, Dobermans, Chihuahuas (both varieties), Fox Terriers (Wire and Smooth), Salukis, Maltese, Chow Chows, Yorkshire Terriers, Chinese Shar-Pei's and Shih Tzu's, with which he obtained great success. Several of his "Alba's Imperial" Kennel Shih Tzu's won Best of Breed and Best Dog of the Year. Qualified "Best Breeder" and "Best Exhibitor" of all breeds in 1979, 1980, 1984 and 1989, becoming the first breeder to obtain such honors four times in his country. He is also breeding Miniature Schnauzers. Began his career as a judge with the Toy Group in 1984; an all-breed judge in 1988. He is also a Specialist Judge of the following breeds: Poodles (all varieties), Chihuahuas (both varieties), Dalmatians, Shih Tzu, Kuvasz and Afghan Hounds. Mr. Filippini is one of the most experienced judges in his country, and he has judged at International, National, Regional and Specialty shows. He is approved to judge all breeds, all Groups and Best in Show. Judged in Brazil, Paraguay, Portugal, Uruguay, Belgium. Chile, Bolivia, Costa Rica, Guatemala, Mexico, Italy, Australia, Canada, Israel, Russian, Japan, Peru, Netherlands, Finland, Spain, Switzerland, New Zealand, England and the United States. Highlights include the World Dog Show (Buenos Aires, Argentina in 1993); the Swiss World Dog Show (Berna, 1994) and the World Dog Show (Vienna, Budapest 1996), the American Championship Dog Show (Costa Rica, 1996) and the Toy Group at 2005 Eukanuba National.

Mr. Aldon W. Garland (Canada)

I am a CKC Member going on 52 years now. My very first purebred dog was a Cocker Spaniel in 1950. It was not until the late 1950's that I got into German Shepherds as a breeder and exhibitor. Since that time I have been involved with and owned Scottish Terriers, Basset Hounds and Newfoundland Dogs. My wife and I still have two Newfs.

In 1975 I become an all breed judge and have retired from judging in 2003. In the 50 plus years I have been involved in dogs and judging in many countries I have learned that a good dog may turn up in places you least expect.

Now I enjoy going to the Shows as a spectator and visit with exhibitors and judges that I know. Purebred dogs certainly remain a permanent interest in a person's life.

Sumiko Ikeda (Japan)

I was born in 1952 in Yokohama Japan. My family raised Shiba Inu, Japanese Spitz, and American Cocker Spaniels.

After I left home and married I started my own show breeding kennel "Sunshine Palace" with Miniature Schnauzers. I then began showing and breeding English Setters and Lakeland Terriers. In 1987, I was granted a license to judge Miniature Schnauzers and American Cocker Spaniels. Over the next 15 year I gained my license for all groups and Best in Show.

CHAMPIONS AND CHAMPIONSHIP POINTS

Chapter 15, Subsection 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Subsection 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

*includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge **SHALL NOT** be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Subsection 15.1.8 A Dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points, provided that a dog was defeated at the group level, save that no more than five (5) points will be credited to a dog for a single show.

Subsection 15.1.11 A class dog awarded Best in Show at an all-breed Championship show will be credited with five points inclusive of any points earned at the breed or group level.

Subsection 15.1.12. In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned at least one 2 point win either at the breed or group level.

MOVING CLASS DOGS TO SPECIALS

Chapter 8, Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the opening of the show, by the owner or handler. Every day of a 2 or 3 day show is a separate show. Please note that this rule is effective up to one hour prior to the opening of the show, NOT one hour prior to the judging of the breed.

**JUDGING OF BEST OVERALL TO TAKE PLACE IN THE MAIN RING
PRIOR TO THE BLACK TIE GROUP & BEST IN SHOW JUDGING**

Held under Canadian Kennel Club Rules. Judge: to be announced

Class Structure (Age Requirements)

1. **PEE WEE**
4 years of age up to 6 years of age as of December 31st of the year preceding the competition year. Optional and non-competitive. No placements are to be awarded, participant ribbons, rosettes and token trophies may be presented.
- 2A. **JUNIOR NOVICE**
For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.
- 2B. **JUNIOR OPEN**
For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have won six first places with competition in the Junior Novice Class, OR any handler wishing to enter this level. It is understood that once that handler has entered and competed in the Open Class, he/she may not compete in the Novice Class again.
- 3A. **INTERMEDIATE NOVICE CLASS**
For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.
- 3B. **INTERMEDIATE OPEN CLASS**
For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have won six first places in the same class with competition.
- 4A. **SENIOR NOVICE CLASS**
For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have not won six first places in the same class with competition. Handlers from the Intermediate levels progress to this class.
- 4B. **SENIOR OPEN CLASS**
For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have won six first places with competition in the Senior Novice Class and for any handler who has progressed through the Intermediate Open level and feels that he/she has enough experience to compete at this level.
5. **BEST OVERALL**

All dogs must be entered in one of the Official Classes or Exhibition Only on the day of the competition. Entry to be made at the show.

Best Overall Junior Handler will receive a \$1000.00 Education Bursary, donated by Purina.

Ribbons and Rosettes donated by MJN Show Services.

I continue to breed and exhibit my dogs as well as judging dogs in several countries. As well as judging in Japan I have been honoured to judge in Australia, Canada and New Zealand. As a dog lover I enjoy the experiences of judging world-wide and aiming to breed dogs of the highest quality.

Mr. David A. Ojalvo (Argentina)

David A. Ojalvo began his career in dogs 30 years ago as a breeder-exhibitor of Miniature Pinschers. His Min Pins include Best in Show dogs and top sires. Several of his Alba's Imperial Shih Tzu have won Best of Breed, Best in Show, and Best Dog of the Year.

Mr. Ojalvo and his partner, Enrique Filippini, were named "Best Breeders" and "Best Exhibitors," all breeds, in 1979, 1980, 1984, and 1989, becoming the first four-time winners of those honors in Argentina. He is also breeding Miniature Schnauzers.

For more than 15 years Mr. Ojalvo has been chairman of the Federación Cinológica Argentina. He was charged with the organization and direction of the 2005 World Dog Show (Argentina), and conducts seminars about different FCA breeds and groups. He is approved for all breeds, all groups, and Best in Show by the Federación Cinológica Argentina and the Fédération Cynologique Internationale. He is AKC-eligible for all groups and Best in Show. He has judged many times throughout South America, North America, Central America, and Europe. Highlights include Americas y el Caribe 2001 (Brazil), and the World Dog Show 2004 (Brazil) and 2005 (Argentina). Upcoming assignments will take Mr. Ojalvo around the world, including the World Dog Show, Mexico, 2007.

Dr. John Reeve-Newson (Canada)

Dr. Reeve-Newson is one of the most popular and successful people in the sport of dogs in North America. With Dr. Richard Meen, he established Kishniga Kennels in 1971. In partnership, they have bred Group and Best In Show winning Dobermans, Old English Sheepdogs, Skye Terriers, French Bulldogs, Borzoi and Harriers. They have also owned and exhibited Group and BIS winning Lakeland Terriers, Norwich Terriers, Standard Poodles, Scottish Deerhounds, American Foxhounds and Whippets.

He is licensed to judge all breeds, and has officiated at shows in Canada, the United States, Sweden, Finland, Norway, Belgium, Holland, Spain, Portugal, Australia, New Zealand, Columbia, Venezuela and Uruguay. He judged a number of breeds at Westminster in 1989 and 1999 and judged the Hound Group in 2004. Judged the 2005 AKC/Eukanuba Invitational and also judged the Terriers at Sweden's big end-of-year show 2004 in Hundfest.

He graduated from the Ontario Veterinary College in 1964 and soon after that returned to Toronto to establish The Animal Clinics One and Two, where he is still in active practice. He was also the founder and still serves as the CEO of the Veterinary Emergency and Referral Clinic Partnership of Toronto, the first veterinary emergency clinic established in Canada. He is a member of a number of dog organizations and professional associations, including the College of Veterinarians of Ontario, where he has served as Councilor and President. Judged Sydney Royal in 2006. Judging Melbourne Royal 2009.

Mr. Bo Skalin (Finland)

Mr. Bo Skalin has owned Giant Schnauzers since 1977 and Miniature Schnauzers since 1984. Breeding in Sweden over 50 Champions under prefix HassanHills during 1985-2004. He became authorized to judge international FCI shows in 1995. Over the years he has become an all-round judge for group 1, 2, 4 and 8. He is authorized to judge several breeds within group, 3, 5, 6, 9 and 10. He is a breed specialist for all varieties of Schnauzers and Pinschers. He has moved to Finland in 2005 and judges under the Swedish Kennel Club, in Swedish or in English languages.

He has been judging at Breed Specials in Sweden, Norway, Finland, Denmark, Spain, Italy and Russia. He also has judged at National and International shows in the Scandinavia, Greece, Germany, Portugal, Spain, Italy, Cyprus, Estonia, Latvia, Belgium, Slovenia and South Africa.

Mr. William (Bill) Shelton (United States)

Mr. Shelton has judged since 1992 for the AKC, and has also done so around the world including Canada. He has bred, owned and shown multiple Best in Show, and Specialty winning dogs. Today

specializing in Pembroke Welsh Corgis, having bred the top, and second top winning bitch in U.S. breed history. Coventry PWC have been nominated as "2011 Breeder of the Year" by *Dogs in Review* and their associates. When not showing, breeding or judging dogs Mr. Shelton continues to restore his 1914 Craftsman home and collecting the decorative arts and furnishings of the period.

Obedience and Rally Judges' Biographies

Karen Brearley (Canada)

I took my first obedience class with a Golden Retriever named Brew but never showed him. It wasn't until our first Tervuren in 1993 that I was introduced into the world of competitive obedience. My Tervs, Poms and Sheltie have brought home High in Class and High in Trial wins. We also competed in conformation, herding, agility and rally. Our newest addition, a Sheltie, finished her championship, earned a rally and herding title all before a year of age. More recently, she has finished 5 herding titles with 2 HIGH IN TRIALS and 2 RESERVE HIGH IN TRIALS, her American/Canadian CDX's and HIGH IN TRIAL in an ASCA obedience trial. At the Herding Invitation in October 2011 she placed 8th overall in Canada.

I am certified to judge in all levels of obedience as well as rally and am a CGN Evaluator. I volunteer as an instructor for the Junior Kennel Club and also as an evaluator for the St. Johns Pet Therapy Program. Ember is a member of a K9 Vaudeville act who performs and visits in care homes and hospitals. I love that my dogs can make people smile.

Marie-Johanne Cloutier (Canada)

My first dog, "Uschi", a German Shepherd Dog, came into my life in 1977. We took our first obedience classes with Conformation judge Hazel Slaughter and never looked back. Uschi was the first of 10 German Shepherd Dogs I have trained and competed with in Canada, the U.S. and Bermuda. Along the way we have accumulated 29 Obedience and Rally titles. "Jimmy", my present young German Shepherd Dog finished his Championship and has a PCD.

I am Training Director for the Lakeshore Dog Training Association in Montreal. I have been judging since 2001 and the sport of Obedience has taken me all over Canada, some parts of the U.S.A. and Bermuda. It has allowed me to meet great people, super dogs and clubs along the way.
