- Bitches in season will not be eligible to compete and are not allowed on the test grounds.
- Ducks, pheasants, chukkars and/or pigeons will be used.
- Rosettes will be awarded to all dogs who pass the test.
- A draw for running order will be held at the home of the Test Secretary.
- It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- There is no concession available.
- By attending this test, competitors and spectators acknowledge that The British Columbia Labrador Retriever Club (1995) Society, test officials and landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors, dogs or spectators.

Entry

Listing fee: A **\$10.50 (inc GST)** listing fee as established by the CKC must accompany the entry of a dog for which no valid CKC individual registration, an ERN or PEN is shown on the entry form.

Payment: Please make all cheques, money orders or drafts payable in **Canadian funds** to the British Columbia Labrador Retriever Club (1995) Society (abbreviated: "**B.C.L.R.C.**"). US funds must be in the form of a Canadian money order (US funds at par).

PLEASE NOTE: THE NON MEMBER PARTICIPATION FEE WAS EFFECTIVE JANUARY 1, 2011
AN ANNUAL NON-MEMBER PARTICIPATION FEE for awards and titles will be charged to a **CANADIAN NON-MEMBER OF CKC**. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee.

Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
