**Judges Briefing at 8:30 AM, First Dog on the line at 9:00 AM,**

**DOORS OPEN AT 7:30 AM**

**Trial #1 – Judge: Meredith McMichael**

Instinct - 6 Entries – 1002 to 1008 - Running Order: Catalogue order

Novice – 25 Entries – 2001 to 2030 - Running Order: Catalogue order

Each competitor will do Container immediately followed by Interior, back to back

After conclusion of all Container/ Interior runs, competitors will proceed to Exterior search

Trial #1 – No move-ups, no day-of entry is available

There will be a Lunch break between Trials to permit resetting as needed for Trial #2. **Lunch will be available on site,** home cooked BBQ pulled pork on a bun, slaw and potato chips \$5.00, Drinks \$1.00

Tim Horton's is about 10 minutes from the event location.

**Move-ups:** A dog that fulfills the requirements for a title in accordance with the rules during the first Trial of the day, may be moved to the next level of competition for the Second Trial, if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler *at least 30 minutes* before the start of the Second Trial of the day.

**Trial #2 – Judge: Meredith McMichael**

Instinct - 2 Entries – 1001, 1007 - Running Order: Catalogue order

Novice – 20 Entries – 2001 to 2030 - Running Order: Catalogue order

Each competitor will do Container immediately followed by Interior, back to back

After conclusion of all Container/ Interior runs, competitors will proceed to Exterior search

Open Level, if needed, will follow at the conclusion of Novice.

Note: Dogs will be judged in catalogue order to the extent that it is practical to do so without undue delay.

### Important Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

1. **No outdoor shoes allowed on the turf.**  
**Please bring a clean, dry pair of indoor only shoes for the Container & Indoor components.**
2. Only park in the designated area. There will be signage.
3. Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
4. Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
5. Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
6. Please do your best to keep barking to a minimum, keep dogs out of planted fields.
7. **No smoking, vaping or Cannabis anywhere on the property.**
8. Crating is limited. Please no ex-pens, shade tents may be setup outside.

Judges are not required to wait for dogs. The Handler of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of locating dogs that are not brought into the ring when required.
