

## EPS Tracking & Rally trials, June 1-2, 2019.

Rally trials and HQ are at: 808 Memorial Park Dr, Powassan, ONT.:  
Take exit 316 from Hwy 11, turn right at top of exit ramp onto Clark St.,  
Take Clark St. in to town. Clark ends at Main St.  
Turn right on Main and take first left: Memorial Park Dr.... #808 is approx.  
3.8 km east of Main St.

**PLEASE PARK ON PAVED DRIVEWAY between the fenced training area and west pond....GRASS IS TOO WET AND SOFT TO PARK ON. Please keep dogs out of the fenced area - it is needed for the Rally trials.**

Brunch each day is pot luck - so bring your favourite dish to share!  
Coffee, donuts, snacks etc available at HQ all day from about 8.30am on Sat  
and 8.15am on Sun.

Outhouse is at HQ, but no facilities at track test sites.

Dogs are welcome to swim in the pond, but must be under control - the swans  
don't fly....and the Canada's have young.

It is recommended that Urban exhibitors make sure they have gassed up before  
getting here....currently about \$1.37 a liter and more here. Two local gas bars  
have limited hours on the weekends.

For anyone staying over, there will be suppers at a local restaurant on  
Friday evening, and Saturday evening following the Rally trials... Everyone
