

Judging schedule for May 26 2019 Sprinter Trials

Thank you for entering our Sprinter trial held at the Red Barn Event Centre, 8464 County Road 27 Barrie.

There will also be a copy of this confirmation letter on the Red Barn Event Centre's website at www.redbarneventcentre.com If you owe money, entry fees MUST be paid ASAP. Send your etransfer NOW! A couple people still owe the online fee you and you can pay that in cash when you check in. Please remember that we accept day of trial entries.

The fun run will be starting at 8:00. There is a maximum entry of 40 dogs for the fun run so please check with the trial secretary at dlmagility@gmail.com if there is room if you have not received a confirmation of entry. There will be a second fun run (weather permitting with a 25 dog limit) during the lunch break, please check in with the trial secretary if there is room. Afternoon roll call will be announced and posted at the Sprinter Ring as soon as morning trial finishes.

This trial will be held outdoors rain or shine.

Roll call for the **OFFICIAL SPRINTER EVENT** is 9:00 am. It will take place at the entrance to the Red Barn, outdoors. Please bring your dog to Roll Call when you arrive so we can finish ASAP.

All dogs must be present at roll call. This is a CKC rule and cannot be altered. All dogs will be checked for lameness or bitches being in season. You will NOT run your dog if you miss roll call and there will be no refunds for missed roll call. Handlers briefing will take place AT THE SPRINTER RING AT 9:15. We aim to start running dogs at 9:30 am.

We will have a 'holder' at the sprinter start line, but you can bring your own holder. Owners MUST be ready (with a spare leash) at least 3 dogs ahead and head to the finish line. If you aren't, you will run at the very end.

Fencing is used along the 100m track and E-timing will be used. Please note that shade is not provided. If it is a sunny day, please bring your own shade. Dog cooling pools will be provided if it is hot.

If your dog is hard to catch, you MUST disclose this and you will run at the end. Also dogs must be on leash at all times unless currently running the sprinter course. If you do not disclose a hard to catch dog or your dog is off leash and disrupts the sprinter course, you will be fined \$20.

Results will be indoors. Ribbons and awards will be given at the Sprinter Ring outdoors unless it is really raining, at the end of EACH Official Sprinter Event. New title ribbons are available at \$8.00 each.

The guaranteed pizza lunch will be available for those who pre-purchased lunch. Cost is \$5 for 2 slices of pizza and a pop. You can buy a ticket when you check in in the morning if you have not already ordered lunch.

To make everyone's visit a safe and enjoyable one, we have just a few rules:

1) PLEASE drive slowly down the long driveway. 10 km limit! Anyone not in compliance with this will be asked to leave with no refund of entry fees.

- 2) There is a private residence at the front of the property. Do not walk your dogs down the driveway towards the residence as it upsets the dogs who live there.
- 3) Only park in the designated parking area.
- 4) Dogs must always be on leash, except when competing on the track. No exceptions.
- 5) Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is friendly.
- 6) Please pick up your dog's waste. Disposal bags and sites are readily available.
- 7) Please clean up after yourself. There are waste containers for your trash.

- 8) No smoking anywhere on the trial site.
- 9) Please do your best to keep barking to a minimum
- 10) Be nice to our judges and volunteers. Remember if you want to be treated with respect give others the same respect.
- 11) If there is anything we can do to make your trial experience better, please let us know.
- 12) Sprinting is a fun sport so please leave prong collars and other correction gear at home. We do not allow prong collars on the Red Barn property.

NEXT Sprinter Trial is June 9th. Entries open at this trial. You can enter ONSITE and pay cash discounted rate of 2 runs for \$40 (you must bring your cash to get this rate). All other entries will be 2 runs for \$50 to cover online, banking, extra labour and HST expenses.

<u>Directions to The Red Barn Event Centre</u>: 8464 County Road 27, Barrie, ON L4M 4S7

<u>From the 400</u>: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

<u>From Hwy 27</u>: When traveling North on CR 27 you must turn left shortly after passing through the town of Thornton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that's your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn is on your left at the bottom of the hill.
