Sanction Matches: sanction matches may be required to become approved to hold approved events for new clubs or for existing clubs that have not held that approved event within the required time (per event rule book)

Last Event Held: there is a limited number of years that a club can go without holding an approved event in each event category - if that number of years is exceeded, the club must hold the required number of sanction

matches again or be deemed non-event holding and, if required, apply for a status change

Event Date Applications: event date applications must be submitted 180+ days prior to the event - late applications may be subject to a \$200 late fee (per event)

Explore Judges: for conformation events judges are contacted up to 3 years prior to the event - the contact time may be shorter for different event types, but should be addressed a year or more in advance of the event date

judging panel applications to CKC are due 120+ days prior to the event, and if there is a foreign judge on the panel the application is due 180+ days prior to the event - late applications may be subject

to a \$200 late fee (per event). If you are experiencing any delays with your applications, please refer to the FAQ section.

Premium Lists: required 60+ days prior to event

Event Supply Order: 60+ days prior to event - if 21 days or under a courier fee and a late fee of \$100 may apply

Judging Schedule: 6+ days prior to event - if under 6 days, may be subject to a \$100 late fee

Event Results to CKC: results must be submitted to CKC within 14 days from final event date (21 days for certain event types) - if under 14 days a late fee of \$200 may apply (per event)

Requests by CKC for Info: should CKC send a request for further information after results are submitted, the club has 14 days to resolve the issue
