# MESSAGE from the Board

## OUR COLLABORATIVE SPIRIT

A myriad of financial concerns will impact the participation of some of our CKC Members this show season. We all know the financial downturns from just about every source. CKC has been impacted by slow renewals this year. We will weather the storm in typical stalwart CKC fashion, as witnessed by our long history, but would be neglectful in not encouraging any members still wavering to join and ride out this economic storm with us. We are also quite aware, first hand, of the need to implement a “cut back mode”. CKC has implemented a salary freeze for our staff at the beginning of the year and continues to work to reduce costs at every opportunity. As a not-for-profit organization, cost cutting is not a concept that is new or even foreign to us. We will continue to practice economic conservatism while we provide our continued, high-quality support for members.

Your Board of Directors realizes that this climate translates into tough times for many of our members. It is impacting the budgets of every family, and with increasing travel/accommodation costs, plus higher dog food and veterinarian expenses, we need to look at coping with the economic changes we all face. The input we have gathered falls into three basic categories and the sooner we begin to make adjustments, the sooner we can bring the pleasure back to our world. The information we received has been distilled to the following:

**Get Back to the Basics...**seriously consider your reasons for being involved and focus your energies on those areas.

**Absorb the Bigger Picture...**realize that there are influences which impact many of your friends and colleagues and you alone cannot change them, but through collaboration with others, you will be able to influence the outcomes to your benefit in many instances.

**Adjust Your Lifestyle...**take advantage of the “value added” opportunities available and eliminate the frills which do not support the underlying purpose behind your involvement.

## ABOUT LEE STEEVES

### **CKC BOARD DIRECTOR, ZONE ONE - NOVA SCOTIA & NEWFOUNDLAND & LABRADOR**

Terriers and Sporting Dogs have been in my family all of my life. Among us, we owned Smooth Fox, an Airedale, a Miniature Schnauzer, a kennel of Springer Spaniels and Weimaraners and one great Beagle! With the addition of a Great Dane and a small Buick as a University graduation gift, my Dad pointed out to me that marriage need not come too quickly. Many years later, I met and married my great husband whose family too had dogs, including Rover the tree-climbing Newf around whom legends have been built and – an Airedale. It was not a stretch for us to add terriers to our life and to establish Regalridge Kennel in the early 1980's.

Airedales and later Welsh Terriers are the cornerstones of our breeding program with Norwich added for comic relief. We have worked closely with Tartan Kennels in Houston and with Norma Aprahamian's Chaos Kennel in Virginia to develop strong lines, building on our foundation stock from Cymbeline and Ledgerock and still actively show and breed. Regalridge has been a highly successful kennel in Canada and the US, with our dogs appearing in the top five of their breeds for most of the past two decades

During the past Board's term, I chaired the Responsible Dog Ownership and the Strategic Planning Committees, the Obedience & Rally Council and the Beagle and Basset Hound Council. In addition, I am past-President of the Welsh Terrier Association of Canada and the Atlantic Terrier Association.

From a professional perspective, I am 'retired' from Senior Management in the Federal Public Service. For ten years, I was a Labour Relations Manager, managed Recruitment, Human Resource Planning, Training and Employment Equity for an organization in excess of 2,000 staff. Leaving Transport, I was offered a more senior position with Public Works Canada as their Regional Business Manager. At that time, this area of government was challenged to function as a private business and my role was to develop and implement a process to effect that change. From Business Management, I moved to the Strategic Planning area of the Department after the amalgamation of Public Works and Government Services. During this period, I chaired Boards tasked with the mandate to author several National Policies and Procedures including the Federal Government's Accessibility Policy - a document of which I am particularly proud. In addition, I managed the strategic planning activities for land use planning, infrastructure acquisition and divestiture and Grants in Lieu of Taxes throughout Atlantic Canada.

After 'retiring', Ken and I became active in community affairs, having moved to rural Nova Scotia (15 minutes from Halifax airport). I have chaired the County's Regional Economic Development Board, the Board of the CAP Committee and have developed and offered Community-based Seniors Computer Skills training program, training over 100 Seniors in computer use. I am a professional writer and served on the Board of Pets Atlantic magazine as well as a part-time Communications Consultant in the areas of government and private sector policy and training.

## STANDING COMMITTEE & COUNCIL REPORTS

### Breed Standards Committee

#### MOTION # 03-09-08

MOVED BY Mr. Campbell: "THAT, the following amendments to the Barbet breed standards be approved as presented with a proposed effective date of **January 1, 2009** to read as follows:

#### BARBET

##### Size

Height at the withers:

Dogs: 22-25½ inches (58-65cm)

Bitches: 20-24 inches (53-61 cm)

With a tolerance of +/- 1cm

##### Coat & Colour

###### Skin: thick

**Coat:** long, woolly and curly, forming cords. The coat is profuse and, in its natural state, covers the entire body. That is a particular breed characteristic. Since time immemorial, the barbet has been clipped in order to ease his work and lifestyle. According to how he is used, the barbet can present different appearances.

**Colour:** Solid black, grey, chestnut brown, fawn, pale fawn, white or more or less pied. All shades of red-fawn and pale fawn are permitted; preferably the whole body should be the same shade.

##### Head

The coat on the head must fall to the bridge of the nose. The beard is long and ample; the profuse moustache covers the whole muzzle.

**Skull:** round and broad. **Stop:** pronounced. **Muzzle:** quite square. The bridge of nose is broad and short. **Lips:** thick, pigmented, completely covered by long hair. The pigmentation of the mucous membranes may be black or brown. **Jaws/teeth:** Jaws of equal length. Scissors bite. Strong teeth. Incisors well developed and well aligned. **Eyes:** round, preferably dark brown. **Ears:** set on low (in line with eyes or slightly lower), long, flat, broad, covered by long hair which forms cords. If the ears are held together across the noseleather, they reach (with the hair) at least 5 cm beyond it. The ear cartilage reaches beyond the corner of the mouth.

##### Tail

Slightly raised, carried above the horizontal when the dog is in action, low set, forming a slight hook at the tip.

##### Gait

Easy movement, the limbs moving in line with the body. Medium length foreleg stride with good thrust from the hindquarters.

##### Fault

Any departure from the foregoing points should be considered a fault and the seriousness with which the fault should be regarded should be exact proportion to its degree.

- Head fine and narrow; bridge of nose thin and long; lips thin.
- Light eyes.
- Ears high set (higher than eye level), thin, short and narrow.
- Neck long and thin.
- Top line hollow.
- Loin long and weak.
- Croup straight.
- Chest narrow.
- Tail high set on, curled over back.
- Lack of tail, stumpy tail.
- Shoulders upright.
- Upper arm thin.
- Lower arm fine boned. Forelegs fringed.
- Upper thigh flat; hocks straight; hind legs fringed. Dewclaws.
- Feet thin and narrow, lacking hair.
- Skin thin.
- Coat short, harsh, not woolly, not curly.
- Colours: Any colour other than those mentioned in the standard.

#### Disqualification

- Aggressive or overly shy.
- Any dog clearly showing physical or behavioural abnormalities shall be disqualified."

> **Amendment:** Moved by Mr. Bernier: "THAT, the proposed changes to the Babet breed standard be approved with the exception of the proposed disqualification and that the proposed disqualification be referred back to the Breed Standards Committee and that the Breed Standards Committee consult with the EOC with respect to the application of these proposed disqualifications by judges."

#### MOTION # 04-09-08

MOVED BY: Mr. Campbell: "THAT, the following amendments to the Dalmatian breed standard be approved as presented with a proposed effective date of **January 1, 2009** to read as follows:

#### DALMATIAN

##### General Appearance

The Dalmatian is a distinctively spotted dog; well balanced, strong, muscular and active, free from coarseness and lumber, capable of great endurance and speed compatible to its purpose. Clean movement and the ability to cover ground efficiently at a trot are most important in this breed.

##### Coat & Colour

The coat should be short dense and fine, slightly glossy neither woolly nor silky. The colour and markings are most important. There are two acceptable colours: white with black spots and white with liver spots. The ground colour should be pure white. Black spots should be as deep and rich as possible. Liver spots should be of a colour closer to chocolate than to tan or yellow. The spots may touch, or overlap slightly, but are preferably as round and well defined as possible, the more distinct the better; in size they should be that of a dime to a two-dollar coin, approximately 1.8 cm to 3 cm. The spots on the face, head, ears, legs, tail and extremities should be smaller than those

on the body. The tail should preferably be spotted. The ears should be spotted, the more profusely the better; solid black or liver is undesirable.

## Head

Should be of a fair length, in balance with the rest of the dog, exhibiting a moderate amount of stop, and not in one straight line from the nose to occiput bone. The top skull and muzzle should be approximately equal in length. **Skull** should be flat, rather broad between the ears and moderately well defined at the temple. It should be entirely free from permanent wrinkle. **Muzzle** should be long and powerful, never snipey; the lips clean, fitting the jaws moderately close. **Nose** in the black spotted dogs, should always be black; in the liver spotted dogs always brown. **Mouth:** The teeth should meet in a scissors bite. The incisors of the lower jaw touch very lightly the bottom of the inner surface of the upper incisors. **Eyes** - Should be set moderately well apart and medium in size, round, bright, and sparkling, with an intelligent expression. The eyes should be as dark as possible. In the black-spotted dogs, they should be black or brown; in the liver-spotted dogs brown or amber. Blue or partly blue eyes are undesirable and should be penalized. The rim around the eyes in the black-spotted dogs should be black; brown in the liver-spotted dogs. No dog should have flesh-coloured eye rims. **Ears** - Should be set on rather high, of moderate size, rather wide at the base and gradually tapering to a rounded point. They should be carried close to the head, and be thin and fine in texture.

## Forequarters

Shoulder should be well laid, not straight, and should be clean and muscular denoting speed. It should be laid flat against the body. Leg: The forelegs be perfectly straight, strong and heavy in bone; elbows close to the body. Pastern showing a slight angle when viewed from the side and straight when viewed from the front, with a slight forward spring. Feet: Forefeet should be compact, with well-arched toes and tough elastic pads. Nails in the black-spotted dogs should be black and/or white; in the liver-spotted dogs, brown and/or white. Nails in the black-spotted dogs should be black or white; or a nail may be both black and white; in the liver-spotted dogs, brown or white, or a nail may be both brown and white.

## Hindquarters

Upper thigh and lower thigh muscles should be clean, powerful and well defined. Hocks should be well let down. Stifle should be moderately well bent. Feet: As for the forefeet.

## Tail

The tail should reach the hock, being strong at the base and gradually tapering towards the end, free from coarseness. It should not be set on too low down and should be carried with a slight upward curve but never curled.

## Disqualification

Patches are present at birth. A patch is a solid mass of black or liver hair. Patches are appreciably larger than normal-sized spots, they are dense, brilliant in colour and have sharply-defined, smooth edges. Large colour masses formed by intermingled or overlapping spots are not patches; such masses should indicate individual spots by uneven edges and/or white hair scattered throughout.

MOVED BY: Mr. Campbell: "THAT, the following amendments to the Doberman Pinscher breed standard be approved as presented with a proposed effective date of **January 1, 2009** to read as follows:

## DOBERMAN

### Size

Height at withers—males **26 to 28 inches**, ideal 27½ inches (70 cm); females **24 to 26 inches**, ideal 25½" (65 cm). Males, decidedly masculine, without coarseness. Females, decidedly feminine, without over-refinement. Deviation from ideal height to be penalized in proportion to the amount of deviation.

### Coat & Colour

Smooth haired, short, hard, thick and close lying. Invisible grey undercoat on neck permissible. Allowed colours: black, red, blue and fawn. In each colour the more strongly pigmented coat is the more desirable. Markings: rust red, sharply defined, and appearing above each eye, and on muzzle, throat, forechest, on all legs and feet and below tail. White on chest not exceeding one-half square inch permissible. **Disqualifying Fault: Dogs not of an allowed colour.**

### Disqualification

- Shyness, viciousness.
- Overshot more than 3/16 in. (.5 cm), undershot more than 1/8 in. (.3 cm).
- Four or more missing teeth.
- **Dogs not of an allowed colour.**

## MOTION # 06-09-08

MOVED BY: Mr. Campbell: "THAT, the following amendments to the Pekingese breed standard be approved as presented with a proposed effective date of **January 1, 2009** to read as follows:

### PEKINGESE

#### Origin & Purpose

The Pekingese were originally bred in the Chinese Imperial Palace in Beijing, China. Chinese works of art depict the Pekingese as far back as 900 A.D. Five dogs were looted from the Summer Palace in 1860 and taken to England. Imports to the U.S.A. began in early 1900's and the first of the breed were registered in Canada in 1910.

The Pekingese toy size makes it a most endearing companion dog that will happily sit on a lap, go for walks or take part in obedience and agility.

#### General Appearance

The Pekingese is a well-balanced, compact dog of Chinese origin with a heavy front and lighter hindquarters. Its image is lion like, implying courage, dignity, boldness and self-esteem rather than daintiness or delicacy.

#### Temperament

A combination of regal dignity, intelligence and self-importance make for a good natured, opinionated and affectionate companion to those who have earned its respect. Can be stubborn. Its temperament is one of directness, independence and individuality.

#### Size, Proportion & Substance

The Pekingese, when lifted, has a centre of gravity towards its front end. It is surprisingly heavy for its size. It has a stocky, muscular body. All weights are correct within a limit of 14 lbs (6.3 kg). Overall balance is of utmost importance. The head is large in proportion to the body. The Pekingese is longer than tall when measured from the forechest to the buttocks. The overall outline is an approximate ratio of 3 high to 5 long.

#### Sleeve Pekingese

All aspects of the standard are the same for the sleeve with the exception of weight, which must be 6 lbs (2.7 kg) or under.

#### Coat & Colour

It is a long, coarse-textured, straight, stand-off outer coat, with thick, soft undercoat. The coat forms a noticeable mane on the neck and shoulder area with the coat on the remainder of the body being somewhat shorter in length. A long and profuse coat is desirable providing it does not obscure the shape of the body. Long feathering is

found on toes, backs of the thighs and forelegs, with longer fringing on the ears and tail. Presentation should accentuate the natural outline of the Pekingese. Any obvious trimming or sculpting of the coat, detracting from its natural appearance, should be severely penalized. Only trimming between the pads under the feet, to prevent slipping, is permitted. Removal of stray hairs poking the eyeballs is allowed. All coat colours and markings are allowable and of equal merit. Red, fawn, black and tan, sable, brindle, white and cream. The colouring of a particoloured dog must be broken on the body; white should be shown on the saddle. No large portion of any colour should exist.

A black mask or a self-coloured face is equally acceptable. Regardless of coat colour, the exposed skin of the muzzle, nose, lips and eye rims are black. Spectacles around the eyes with lines running to the ears are desirable.

#### Head

**Face:** The top skull is massive, broad and flat and, when combined with wide set eyes, cheekbones and broad lower jaw, forms the correctly shaped face. When viewed from the front, the skull is wider than deep, which contributes to the desired rectangular, envelope-shaped appearance of the head. In profile, the face is flat. When viewed from the side, the chin, nose leather and brow all lie in one plane, which slants very slightly backward from chin to forehead.

**Ears:** They are heart-shaped, set on the front corners of the top skull, and lie flat against the head. The leather does not extend below the jaw. Correctly placed ears, with their heavy feathering and long fringing, frame the sides of the face and add to the appearance of a wide rectangular head.

**Eyes:** They are large, very dark, clear, round, lustrous and set wide apart. They are placed frontally. The look is bold, not bulging or bolting. The whites of the eyes should not show when the dog is looking straight ahead. **Nose:** It is broad, short and black. Nostrils are wide and open, never pinched. A line drawn horizontally over the top of the nose intersects slightly above the centre of the eyes.

**Wrinkle:** It effectively separates the upper and lower areas of the face. It is a hair-covered fold of skin extending from one cheek over the bridge of the nose in a wide inverted V to the other cheek. It is never prominent or heavy as to crowd the facial features, obscure more than a small portion of the eyes, or fall forward over any portion of the nose leather. **Stop:** Deep, it is obscured from view by the over-nose wrinkle. **Muzzle:** It is very flat, broad, and well filled-in below the eyes. Whiskers add to the desired expression and should never be removed (so as to protect the eyes). **Mouth:** Level lips, not showing teeth or tongue; broad level under jaw. Tight flews. Lippyness undesirable. **Teeth:** undershot. Reverse scissors bite unacceptable.

#### Neck

It is very short and thick.

#### Forequarters

They are short, thick and heavy boned. The bones of the forelegs are moderately bowed between the pastern and the elbow. The broad chest, wide set forelegs and closer rear legs all contribute to the correct rolling gate. The distance from the point of shoulder to the tip of the withers is approximately equal to the distance from the point of the shoulder to the elbow. Shoulders are well laid back and fit smoothly onto the body. The elbows are always close to the body.

**Feet:** Front feet are turned out slightly when standing or moving. They are large and flat not round, well fringed, standing well up on feet not pasterns. The pasterns slope gently. Dew claws may or may not be present.

#### Body

It is pear-shaped, compact and low to the ground. It is heavy in front

with well-sprung ribs slung between the forelegs. The forechest is broad and full without protruding breastbone. The underline rises from the deep chest to the lighter loin, thus forming a narrow waist. The topline is straight. The loin is short, with longer loin being acceptable in bitches.

## Hindquarters

They are lighter in bone than the forequarters. There is a moderate angulation of stifle and hock. When viewed from behind, the rear legs are reasonably close and parallel, never cow-hocked or bandy-legged or straddled too far apart. **Feet:** The hind feet point straight ahead when standing or moving. They are smaller than the front feet. Dew claws may or may not be present.

## Tail

The high tail set is slightly arched and carried well over the back, free of kinks or curls. Long, profuse, straight fringing may fall to either side.

## Gait

**Fore-action:** slow, dignified, rolling gait caused by body being heavy in front and lighter hind-quarters, with forelegs being bowed and hindquarters being close and parallel. The typical rolling action is not to be confused with a roll caused by slackness of shoulders that will not flow freely. **Hind-action:** close, steady and free. Soundness essential. This motion is smooth and effortless and is as free as possible from bouncing, prancing or jarring. There is adequate reach and moderate drive.

## Fault

- Dudley, liver or grey nose
- Pinched nostrils
- Protruding tongue or teeth
- Overshot, level, scissors bite or reverse scissors bite
- Wry mouth
- Narrow underjaw or weak chin
- Light brown, yellow, blue or badly blemished eyes
- Ears set much too high, low or far back
- Roach or swayback
- Straight-boned forelegs

## Disqualification

- Weight over 14 lbs (6.3 kg)
- Liver colour or Albino

**Note:** Male animals should have two apparently normal testicles fully descended in the scrotum.

On undocked dogs, the first 3 vertebrae to be carried erect or semi-erect, the balance to be a sickle which may point towards the head. The tail set must be correct, not over gay. It is well-coated, but devoid of plume.

- An applicant must have personally trained, handled and completed a CKC Draft Dog Test title on at least one (1) dog for each level of competition at which he wishes to judge.**
- Prior to being licensed, an applicant must serve as a Draft Dog Test Chair or Chief Steward at CKC Draft Dog Tests which offer the DD and DDX. Documentation regarding these assignments must be verified in writing by the club and/or Event Secretary.**
- An applicant must provide written verification, with recommendation, from the club/organization, and/or participants with regard to any Draft Dog classes that he may

have instructed.

#### 3. Apprenticing

- Once the application and supporting documentation have been verified by Head Office, the applicant will be required to apprentice judge at a minimum of 8 CKC DD and 2 DDX tests, which may include Brace at either level.
- The apprentice judge will be required to observe and score the dogs/teams.
- The apprentice judge must ensure that the officiating judge completes a Report On Apprentice Draft Dog Test Judge, which must be returned to Head Office with the test results at the conclusion of the test.
- The apprentice judge must receive a minimum of two (2) satisfactory reports, for each level of competition.
- Upon completion of each apprenticing assignment, the apprentice judge is required to review his score sheets with the officiating judge.

#### 4. Licensing

Once all of the apprenticeship requirements have been completed and reviewed by Head Office and providing that the apprentice judge has successfully completed these requirements, the apprentice judge will be licensed."

- 11.2 Dates must be applied for not less than 60 days prior to the date of the sanction match. Dates are allocated on a first come first served basis. In special circumstances the Board member for the respective zone may waive the 60 day requirement.
- 11.3 A club or association must hold a separate match for each type of test, field or urban, and cannot apply for an urban test unless the field test is satisfactorily completed.
- 11.4 A club or association that is required to hold a match under section 2.1.2, that test will be observed by the zone Tracking Test representative or his appointee. At the completion of the sanction match the representative will submit a sanction match report to the CKC Head Office with copy to the club.
- 11.5 Sanction tests are conducted in accordance with section 4, 6, 7 10.7 and 10.9 of the Tracking test Rules and Regulations.
- 11.6 At the discretion of the Board member for the respective zone a club or association may be approved to hold more than one sanction test within a 3 month period.
- 11.7 Club's have the option of offering ribbons or prizes, if ribbons are offered they can be of any colour except blue and must be made of fabric.
- 11.8 The club must appoint a Tracking test committee as outlined in these rules whose members cannot enter the test. Members of the club may enter the test.
- 11.9 In the event a licensed judge is not available to judge the match an experienced tracking person may be asked to judge.
- 11.10 The person who plots the track must be the same person that

lays the track.

- 11.11 Old, soiled, used work gloves or articles that have been previously used for training cannot be used in a sanction match.”

Letters were sent to fifty-two (52) recognized kennel clubs requesting information on their policy for recognition of more than one (1) Kennel Club in a country. Out of the fifty-two (52) letters sent, forty-six (46) went to foreign clubs that are members of FCI and six (6) letters went to clubs that are not members of FCI. Fifteen (15) responses were received in which all stated that they recognize only one foreign kennel club per country for the purposes of reciprocal exchange.

The CKC officially recognizes the Korean Kennel Club (KKC) of Jung, Ku, Seoul, Korea, since September 2004, and both clubs have always enjoyed an excellent working relationship. It is the recommendation of the Registration Committee that the CKC responsibly honour our existing relationship with the KKC as we have already recognized this club. Unless political consideration overrides, it is recommended that CKC decline the application from the Korean Kennel Federation. The CKC has historically adhered to the practice of recognizing one club per country as do all FCI and non FCI countries that responded to our letter.”

  - (1) A copy of the stud book.
  - (2) A copy of the club's by-laws.
  - (3) A copy of the club's registration procedural requirements.
  - (4) Completed samples of each type of certificate of registration issued by the club.
  - (5) A list of those registry organizations (stud books) recognized by the foreign club and clubs with which it is otherwise associated.
  - (6) A list of registry organizations (stud books) that have officially recognized said foreign club.
  - (7) **A list of any competing registries in the country from which application is made.**

## (8) The history of the registry.

- b) To enable The Canadian Kennel Club to properly investigate the methods and regulations relative to the registration and transfer of dogs, also registration of litters, etc., the documents requested in paragraphs (1), (2), and (3) and (8) above, must be in the English language or translated to such, if necessary.

## c) The CKC will recognize only one registry per country.

### H. Artificial Insemination Regulations

#### 1. Definition

Processed semen refers primarily to frozen semen but it also includes fresh semen, chilled semen and/or extended semen. The following regulations do not pertain to the use of fresh unprocessed semen in situations in which the donor dog and the recipient bitch are on the same site.

#### 2. Approved Facilities

- a) With regard to canine artificial insemination and the collection, preparation, storage and distribution of canine semen, all matters pertaining to the type of technology used, the effectiveness of the technology, the quality of the services and any limitations of the technology or failure to fulfill expectations and/or guarantees remain a matter between the person(s) and/or corporation(s) which provide the technology and/or services and those who agree to use them. ~~The approval of a facility by The Canadian Kennel Club is not a guarantee of the facility's effectiveness in providing the services offered, nor will the Club be held in any way responsible for any failure on the part of such a facility.~~
- b) The Canadian Kennel Club accepts the principle that frozen semen can have an identity apart from the donor dog and thus individual units of frozen semen can be purchased and owned by person(s) distinct from the owner(s) of the donor dog. Person(s) who own such units of frozen semen ~~have the authority to~~ **must** sign in place of the owners of the stud dog on the Club's Application for Registration of a Litter if the litter was conceived by the use of frozen semen. ~~Appropriate forms shall be developed for the purpose of recording the details of the collection, the resultant number of units of frozen semen, their disposition and the subsequent transfer of ownership of such units. A fee will be charged for such transfers. Where a litter is conceived from artificial insemination utilizing semen imported to Canada, the owner or lessee of the sire, or owner of the semen must provide to The Canadian Kennel Club a statement certifying that the semen was collected from a sire which he owns or leases. In the event the semen was acquired apart from the ownership of the donor dog, proof of the means of acquisition must be submitted. Such certified statement shall be accepted~~

**by the Club in lieu of the owner or lessee of the sire signing Section B of the application (Application for Registration of A Litter from Semen Born in Canada).**

#### 3. Artificial Insemination With ~~Imported~~ **Processed** Semen

Any breeder who is in good standing with The Canadian Kennel Club may apply for registration of a litter whelped in Canada by a bitch that is registered in, or eligible for registration in the records of the Club, where a litter is the result of a bitch being artificially inseminated with imported semen. Such registration by the Club shall be subject to the following regulations:

- a) ~~Any person importing canine semen into Canada shall first obtain such permit(s) as required by Agriculture Canada at the time of importation. Application for an import permit is obtainable upon request from Agriculture Canada's District Veterinarian or from Agriculture and Agri Food Canada, Food Production & Inspection Branch, Room 205, 700 113 Street Edmonton, Alberta T6H 5T6 (403) 495 3075 or Agriculture and Agri Food Canada, Animal Industry Division, Ottawa, Ontario K1A 0C5 (613) 957 7078.~~
- ba) The semen must be from a dog of a breed recognized by The Canadian Kennel Club and individually registered in a stud book or foreign record recognized by the Club. The dog must be registered in said stud book or foreign record in the name of the owner or lessee, certifying the collection of semen as required in Section (e) of these regulations.
- eb) A duly completed application form (The Canadian Kennel Club Registration of a Litter Born In Canada) must be submitted to the Club, together with the appropriate **semen form** and registration fee; and,
  - (1) ~~When an import permit is required, the original permit issued by the Veterinary Director General, Ministry of Agriculture Canada, authorizing importation of semen.~~
  - (1) **The original A clear and legible copy of the** certificate, as required under the Animal Disease and Protection Act, of an official veterinarian of the country of export, or a certificate of a veterinarian endorsed by an official veterinarian of the country of export, that clearly identified the donor dog and shows the following:
    - (a) The semen was examined immediately after collection and was found to be of acceptable quality for processing and freezing.
    - (b) Sanitary precautions have been observed during the collection and processing of semen to prevent contamination by pathogenic micro-organisms.
    - (c) Each ampoule or vial of semen has been marked or labeled clearly to show the date of collection, the registration number and the registered name of the donor dog.
    - (d) The semen is in a container bearing an unbroken seal of the government of the country of export and is stored within the container in ampoules, straws or other receptacles that are marked in a permanent manner with the breed, name and registration number, colour and marking of the donor

- dog.
- d) The Canadian Kennel Club must also receive ~~an original~~ **a clear and legible copy of the** certificate signed by the person who performs the insemination certifying the following:
- (1) The breeder, name and registration number, colour and markings of the recipient bitch, and the tattoo number and/or microchip number.
  - (2) The date upon which the recipient bitch was inseminated.
  - (3) That the imported semen was in a container bearing an unbroken seal of the government of the country of export and clearly labeled with the breed, name and registration number, colour and markings of the donor dog.
- e) ~~Where a litter is conceived from artificial insemination utilizing semen imported to Canada, the owner or lessee of the sire, or owner of the semen must provide to The Canadian Kennel Club a statement certifying that the semen collected for export to Canada was collected from a sire which he owns or leases. In the event the semen was acquired apart from the ownership of the donor dog proof of the means of acquisition must be submitted. Such certified statement shall be accepted by the Club in lieu of the owner or lessee of the sire signing Section B of the application (Application for Registration of A Litter Born In Canada).~~
- d) The application for registration of a litter born in Canada, which is the result of artificial insemination with imported semen, must be accompanied by ~~an original~~ **a clear and legible copy of a** certified three-generation pedigree of the sire, **showing the registered name and number of every dog in the pedigree** issued by a stud book or foreign record, recognized by The Canadian Kennel Club, also ~~a statement from the secretary of such~~ **an original certification from the foreign** stud book or foreign record certifying registered ownership of the sire on the date of semen collection.
- e) In the event of irregularities in the documentation of an application for registration of a litter born in Canada as a result of artificial insemination of imported semen, the application shall be referred to The Canadian Kennel Club Registration Committee for review and for the purpose of recommending its acceptance or rejection by the Club.
- f) If circumstance occurs which is not, or which is alleged not to be provided for by these Regulations, the Registration Committee may deal with the matter and make such decision as it deems fit. Such decision shall be final and binding upon all persons affected thereby.

4. Copies of all documents submitted to The Canadian Kennel Club in compliance with the Club's Artificial Insemination Regulations shall also be provided to the American Kennel Club, upon its request, when the donor dog is domiciled in a foreign country other than the USA. The Canadian Kennel Club's compliance with said request is subject to an application having been received by the American Kennel Club for registration of a Canadian born dog whelped as a result of insemination with processed semen.

#### 5.4. Artificial Insemination With Processed Semen Collected Within Canada

- Any breeder in good standing with The Canadian Kennel Club may apply for registration of a litter whelped in Canada by a bitch that is registered in, or eligible for registration in, the records of the Club, where a litter is the result of a bitch being artificially inseminated with semen collected and processed within Canada. Such litter registration by the Club shall be subject to the following regulations:
- a) The semen must be from a dog of a breed recognized by The Canadian Kennel Club and individually registered with the Club. The dog must be registered in The Canadian Kennel Club Stud Book in the name of the owner or lessee, certifying collection of semen as required in **section (d), page 4:23** of these regulations.
  - b) A duly completed application form (The Canadian Kennel Club Registration of a Litter Born in Canada) **from fresh-chilled or frozen semen** must be submitted to the Club, together with the appropriate fee and full certification from the time of collection to the time of insemination.
  - c) Registration Committee
    - (1) In the event of irregularities in the documentation of an application for registration of a litter born in Canada as the result of insemination with processed semen, the application shall be referred to The Canadian Kennel Club Registration Committee for review and for the purpose of recommending its acceptance or rejection by The Canadian Kennel Club.
    - (2) If circumstance occurs which is not, or which is alleged not to be provided for by these Regulations, the Registration Committee may deal with the matter and make such decisions as it deems fit. Such decisions shall be final and binding upon all persons affected thereby.
  - d) Semen Collection
    - (1) The semen has been collected ~~by an authorized and approved~~ **stored at a semen** collection centre ~~within Canada.~~
    - (2) The semen was examined immediately after collection and found to be of acceptable quality for processing, freezing and storing.
    - (3) Sanitary precautions have been observed during the collection and processing of the semen to prevent contamination by pathogenic micro-organisms.
    - (4) Each ampoule, vial or straw of semen is sealed and clearly marked or labeled to show the date of collection and ~~other~~ identification (**microchip/tattoo**) to completely identify the donor dog and his owner.
    - (5) ~~The Canadian Kennel Club shall be notified~~



~~immediately by the person collecting and processing the semen. Such notification shall include the full information on the donor dog, number of breeding units collected, date stored, address of storage facility, and name and address of the owner of the donor dog.~~

e) Semen Storage

- (1) The semen shall be stored in tanks used only for canine semen. Complete records of each collection will be kept by the ~~semen~~ collection centre, ~~and the owner of the donor dog, and The Canadian Kennel Club. In the event that any or all of the frozen semen is transferred to a new owner, or to a new location, the Club shall be notified immediately of the following: identification of semen, number of breeding units relocated, date of transfer of ownership or relocation, address and name of new storage facility.~~

f) Insemination with Transported Semen

- (1) The semen must be fully identified by microchip and or tattoo in a sealed container and shipped directly to the person who is performing the insemination.
- (2) The person who is performing the insemination must inspect the container on arrival to ascertain that the seal is unbroken and that full information on the donor dog is given.
- (3) Certification from the person who is performing the insemination identifying the breed, registered name, The Canadian Kennel Club registration number, colour, markings, tattoo and/or microchip number and owner of the recipient bitch, must be included with the application to register the litter.

g) Registration of Litter

- (1) A completed Canadian Kennel Club litter ~~form~~ application for the registration of a litter conceived from ~~the use of processed chilled or frozen~~ semen collected and used in Canada, and ~~the appropriate semen form and registration fee. To obtain information visit the CKC website at www@ckc.ca and download the forms.~~

65. Identification of Semen

- a) The facility ~~which has been approved for the collection and storage of that collects and stores~~ the semen must ensure that every individual container used to store processed semen include the following identification:

- (1) Identification of the collection and storage facility.
- (2) Identification of the breed of dog.
- (3) Identification of the donor dog by name, Canadian Kennel Club registration number and tattoo and/or microchip number ~~(allowances will be made for dogs collected when noseprints were still a means of identification before these current identification requirements were implemented) or foreign club number.~~

- 11.1 A club or association wishing to hold a sanction tracking test field or urban must obtain the approval of the CKC by submitting an application for a match date, on the form provided by CKC, to the CKC Board member for the respective zone.
- 11.2 Dates must be applied for not less than 60 days prior to the date of the sanction match. Dates are allocated on a first come first served basis. In special circumstances the Board member for the respective zone may wave the 60 day requirement.
- 11.3 A club or association must hold a separate match for each type of test, field or urban, and cannot apply for an urban test unless the field test is satisfactorily completed.
- 11.4 A club or association that is required to hold a match under section 2.1.2, that test will be observed by the zone Tracking Test representative or his appointee. At the completion of the

sanction match the representative will submit a sanction match report to the CKC Head Office with copy to the club.

- 11.5 Sanction tests are conducted in accordance with section 4, 6,7 10.7 and 10.9 of the Tracking test Rules and Regulations.
- 11.6 At the discretion of the Board member for the respective zone a club or association may be approved to hold more than one sanction test within a 3 month period.
- 11.7 Club's have the option of offering ribbons or prizes, if ribbons are offered they can be of any colour except blue and must be made of fabric.
- 11.8 The club must appoint a Tracking test committee as outlined in these rules whose members cannot enter the test. Members of the club may enter the test.
- 11.9 In the event a licensed judge is not available to judge the match an experienced tracking person may be asked to judge.
- 11.10 The person who plots the track must be the same person that lays the track.
- 11.11 Old, soiled, used work gloves or articles that have been previously used for training cannot be used in a sanction match."
