BREEDER RELATIONS COMMITTEE:

a committee of 4 CKC members

The committee is responsible for the development of policy, standards, guidelines, and programs relating to breeders of purebred dogs. This shall include the development of a breeder education program, the development of appropriate standards, rules, & regulations for breeding and the development of an associated national breeder accreditation program.

Candidates for the committee must be able to demonstrate:

- a working knowledge & understanding of canine genetic issues
- current involvement in a successful canine breeding program or past experience with a successful breeding program
- Veterinary or genetic background is an asset but not required.

GENETICS AND MEDICAL COMMITTEE:

a committee of 3 CKC members

This committee is responsible for developing policy, standards, guidelines, and programs related to canine genetics and hereditary disorders. It includes the development of an advanced registry to assist in the future healthy development of purebred dogs. The committee will also develop policies, standards and guidelines related to medical and surgical action performed on dogs.

The committee will require individuals with specific backgrounds:

- 1 must be a veterinarian and 2 must have a background in genetics.

EVENT OFFICIATING COMMITTEE:

a committee of 5 CKC members

The committee is responsible for the development of policies, standards, guidelines and programs related to the training and accreditation of judges and event officials for all disciplines.

The committee requires:

- 2 with Conformation background
- 1 Obedience background
- 1 involved in Performance events
- 1 involved in Field Events

BREED STANDARDS COMMITTEE

a committee of 3 CKC members

The committee shall be responsible for reviewing and making recommendations to the Board regarding any proposed changes to the Breed Standards, including those changes which are proposed by the respective national breed clubs.

RESPONSIBLE DOG OWNERSHIP COMMITTEE

a committee of 4 Board members and 3 CKC members

The mandate of the committee shall be to further The Canadian Kennel Club's position on dangerous dogs and responsible dog ownership. Additionally the committee shall be responsible for all matters relating to the amendment or development of municipal, provincial and federal legislations which relates to the mandate of the committee.

MESSAGE

from the Board

SETTING THE PACE

January brought our new Board together for the first time to elect a Chair, establish committees, and generally get a "lay of the land" for upcoming business. With much ahead to accomplish and a genuine interest in member involvement, the following run down on how your input can be provided, may help explain how to be part of implementing change and setting the pace.

We know there are occasions when breed clubs, show or trial-giving clubs, or individual members, are presented with situations where they desire an immediate response from the CKC, whether that be from the staff, or the Board. The desired response may take the form of a policy statement, or a change to a policy or rule.

Staff implement the Policies and Rules as established by the Board; they cannot create, change, or amend either. The Board while able to change both Policy and Rules, can only do so within the framework as established by the By-Laws. The By-Laws can only be modified by a referendum, such as the one that took place in December 2008.

For the Board to change Policy, or a Rule, a motion has to be presented at a meeting. For a motion to be read at a meeting, it has to be on the agenda, with the requirement that it be submitted six weeks prior to the meeting. Failing that, a motion can be presented as 'new business', which is the last item on the agenda. As the last item, the time devoted to it is dependent on the size of the agenda, and the time necessary to process, and debate, the other items within the constraint of the two-day meeting.

Without a physical meeting, the Board cannot move or vote upon a motion. If an important

issue, demanding attention, occurs in the week after a scheduled meeting, it cannot be dealt with until the next Board meeting, unless a 'special meeting of the Board', as spelled out in the By-Laws, is called.

While the Chair, or a majority of the Board, have the authority to call a 'special meeting of the Board', the Board members may find it difficult to attend, given their individual schedules of employment, judging contracts, or family commitments. Additionally, while a special meeting may be called, it would only be done under the most dire of circumstances due to the concern of setting precedent, and not the insignificant costs involved.

Please consider the restrictions the Board is placed under, the next time you, or your club, feel that the Board or staff have not been responsive. We can only respond within the framework of our By-Laws, Policies, and Rules.

While these requirements may seem restrictive and cumbersome, and on some occasions detrimental to progress, they also prevent any person, or Board, from indiscriminately acting contrary to the purpose of the CKC.

Perhaps it is time for the By-Laws to be changed to allow a 'special meeting' to be held by teleconference. However, the next referendum, which could modify the By-Laws, won't take place until 2011.

The CKC By-Laws, Policy and Procedures Manual, and Rule Books are available on-line for members, we encourage all interested members to download and read them.

2009 FEE ADJUSTMENT

The CKC Board at the regular December meeting and subsequent to its review of the 2009 budget approved an annual fee adjustment to all current CKC fees by 1.5% effective April 1, 2009. A complete and revised schedule of fees will be made available in the March 2009 Official Section and posted to the CKC website.

OFFICIAL RESULTS OF THE 2008 REGULAR AND SPECIAL REFERENDUMS

Please note that CKC By-laws may be amended by a two-thirds majority (66 2/3 percent) affirmative vote of the votes cast. This requirement was met for the Special Referendum (Board-Proposed Amendments to By-laws) but not for the Regular Referendum (Member-Proposed Amendment to By-laws). In the case of the Regular Referendum, we only achieved 64 percent and, therefore, the proposal failed.

The Election Commission's report will now be submitted to the Minister of Agriculture and Agri-Food Canada to consider approving the Special Referendum and the membership will be notified as soon as the results are known.

REGULAR REFERENDUM

1) Proposed Amendment: It is proposed that Section 5.1 of the By-laws be amended as follows:

Add New Subsection: All dogs competing in performance or conformation events must be purebred according to the definition set out by Agriculture Canada and the Animal Pedigree Act and must be eligible for registration in the regular CKC registry or in the Miscellaneous List of purebred breeds as the regulations permit. The only exceptions will be for those purebred, unregistrable dogs competing in performance with a PEN number and eligible dogs under the current CGN program.

SPECIAL REFERENDUM

1) Proposed Amendment: It is proposed that Section 7.4, APPROVAL OF MEMBERSHIP, be deleted in its entirety:

~~DELETE 7.4 APPROVAL OF MEMBERSHIP If, within sixty (60) days of the receipt of the application, no objections have been received and the fee has been confirmed as paid, the applicant will be deemed to have been approved for membership in the Club.~~

For: 3982 Against: 386 Percent in Favour: 91%

2) Proposed Amendment: It is proposed that Sections 9.8, NO QUORUM and 10.4, QUORUM, be amended causing the sections to read as follows and Section 10.5, LOST QUORUM be deleted:

9.8 NO QUORUM In the event ~~all positions on the Board become vacant~~ **there remains less than a quorum of the Board in office** in a year other than an election year, the Chief Executive Officer and the Election Commission shall hold by-elections to fill all vacancies on the Board no later than forty-five (45) days following the day on which ~~all positions become vacant~~ **the quorum is lost**. In the event ~~all positions on the Board become vacant~~ **the loss of quorum occurs** during an election year, the Chief Executive Officer, **within the limits of the authority granted to him by the By-laws**, shall ensure the normal continuity of the business of the Club until such time as the next elections are held.

10.4 QUORUM A quorum shall be constituted by a number of Board members equaling fifty (50) percent plus one (1) of the total number of Board members. ~~Such quorum must have present one (1) Board member representing a zone east of the Province of Ontario and one (1) Board member representing a zone west of the Province of Ontario.~~

~~DELETE 10.5 LOST QUORUM Should circumstances arise where there remains less than a quorum of the Board in office, as otherwise described herein, the Chief Executive Officer shall appoint an Election Commission and together they shall have the authority to take the necessary steps to ensure the normal continuity of the business of the Club.~~

3) Proposed Amendment: It is proposed that Section 12.9, NO NOMINATION IN AN ELECTORAL ZONE, be amended; therefore, causing the section to read as follows:

12.9 NO NOMINATION IN AN ELECTORAL ZONE In the event that no nomination is received for an office in any electoral zone, the Election Commission ~~shall declare the office vacant as of October 1st of the election year. Subsequently, when the Election Commission prepares the official ballots, they shall prepare a ballot for such electoral zone which shall have a blank space left on the face of the ballot where the voting member may~~

write the name of the eligible member of his choice for that particular office. These “write-in ballots” shall then be tabulated by the Election Commission in the manner prescribed in Section 12.14.

4) Proposed Amendment: It is proposed that Section 26.6, IDENTIFICATION BY MICROCHIP TRANSPONDER IMPLANT, be amended by deleting subsection (b) in its entirety and by amending subsections (c) and (d); therefore, causing the section to read as follows:

26.6 IDENTIFICATION BY MICROCHIP TRANSPONDER IMPLANT ~~(b) Upon a dog being identified in this manner, the identification section of the application for the registration of a dog must immediately thereafter be signed by the person who actually and physically implanted the transponder, therefore certifying that the transponder has been scanned prior to and immediately following the implantation and that the characters appearing on the scanner, in both instances, were identical to those appearing on the bar coded label taken from the accompanying transponder package and applied to the registration form;~~

~~(e) (b) One (1) of the accompanying bar code labels which corresponds to the implanted transponder, shall be affixed to the application for registration purposes and the second accompanying label shall be affixed to the records of the owner or breeder. The bar code or the transponder number must appear on the application for registration purposes. One of the accompanying bar code labels shall be affixed to the application or in the case of on-line applications, the transponder number will be entered by the applicant.~~

~~(d) (c) A dog which resides in a foreign country, is owned by a non-resident and is to be registered with the CKC, may be implanted with a CKC approved transponder and the identification section of the application must subsequently be completed and signed and the bar code affixed to the application in the manner shall be provided as prescribed in (b) and (e) immediately above;~~

5) Proposed Amendment: It is proposed that Section 28.6, AGE, be deleted in its entirety:

28.6 AGE ~~No litter out of a dam under six (6) months or over twelve (12) years of age at the time of mating, or by a sire under six (6) months or over twelve (12) years of age at the time of mating, will be registered unless the application for registration is accompanied by an affidavit or evidence which shall prove the facts, set out in the application for registration of a litter, to the satisfaction of the Recording Office.~~

For: 3396 Against: 939 Percent in Favour: 78%

6) Proposed Amendment: It is proposed that Section 29.10, NAMES, subsection (g) be amended; therefore, causing the section to read as follows:

29.10 NAMES (g) Subject only to the provisions of subsection (e) ~~above~~, the Club shall have the authority to ~~prohibit~~ **refuse** the use of ~~any a~~ name, for the purpose of registration of individual dogs in the Club's records, if in the opinion of the Club, such name infringes on the rights of any person, partnership or company whose kennel name has been reserved by the Club **or if the name includes obscenities or words derogatory to any race, creed or nationality or transliterations of such words.**

7) Proposed Amendment: It is proposed that Section 30.5, IMPORTATION OF CANADIAN-BORN DOG FROM FOREIGN COUNTRY, subsection (c) be amended; therefore, causing the section to read as follows:

30.5 IMPORTATION OF CANADIAN-BORN DOG FROM FOREIGN COUNTRY

(c) The records of the foreign country must substantiate that the ownership of the dog has been transferred into the name of the new Canadian owner and that a certificate of registration, issued by the foreign country, has been issued in the name of the new Canadian owner. ~~The original of said~~ **A copy of the** certificate of registration must accompany an application to transfer the Canadian Kennel Club certificate of registration into the name of the new Canadian owner;

For: 4207 Against: 141 Percent in Favour: 97%

8) Proposed Amendment: It is proposed that Section 32.1, A GENEALOGICAL TABLE, be amended causing the section to read as follows and Section 32.2, THREE GENERATION PEDIGREE, be deleted:

32.1 A GENEALOGICAL TABLE PEDIGREES

A certified pedigree is a ~~certified~~ genealogical table showing the ancestral line of descent of a dog as indicated by the Club's registration records and such foreign stud books as may be in the Club's files. It is certified as being correct only to the extent that it reflects the ancestral line of descent as shown in the records and stud books available to the Club and no claim may be entered against the Club or its Recording Office in the event the information shown thereon is incorrect. **Each pedigree will include the registered name and number of all dogs in the ancestral line that appear in the pedigree.**

~~DELETE 32.2 THREE GENERATION PEDIGREE A three (3) generation pedigree is one that shows the registered name and number of the sire and dam, all grandparents, and all great grandparents of a particular dog.~~

9) Proposed Amendment: It is proposed that Section 36.1, AMENDMENT BY REFERENDUM, be amended; therefore, causing the section to read as follows:

36.1 AMENDMENT BY REFERENDUM These By-laws may be amended by means of a ~~two-thirds majority (66 2/3 percent)~~ **majority** affirmative vote of the votes cast in either a Regular Referendum ballot conducted concurrently with the triennial election of the Board, ~~and/or in~~ a Special Referendum ballot conducted at the discretion of the Board.

For: 3667 Against: 621 Percent in Favour: 86%

synopsis

The following is a brief synopsis of the key items of business that were addressed at the December 6th and 7th, 2008 Board meeting held in Etobicoke, Ontario. Please note that rules and policy changes shown below are paraphrased for the sake of brevity. In the event of dispute, the specific wording of such changes should be taken from the official minutes of the Board meeting. The detailed minutes of the December meeting will be formally approved at the next regular meeting of the Board.

1. Noting that this was the final meeting in the current Board's term of office, Mr. Dwain McLean, Chair of the Board, expressed his appreciation to Board members for their diligence and efforts during their tenure and he thanked the CEO and his staff for their support.
2. The minutes of the September 27 & 28, 2008 Board meeting were adopted.
3. The following gifts/donations were received:
 - a. The Junior Handler Manual (2nd edition) published by the Royal New South Wales Canine Council Ltd.
 - b. A photo of the ambassadors of the 2008 CKC Charity Event.
4. Correspondence was received as follows:
 - a. A letter from Dr. Roxane Pardiak DVM, BSc and Certified Animal Chiropractor re: The Finnish Veterinary Board.
 - b. A letter and an email from the Asian Kennel Club of the Philippines, Inc. re: Possible Affiliation with CKC.
 - c. Two letters from Augusto Beneficto S. Santos III, Chairman of the Board, The Philippine Canine Club, Inc. and one letter from Y. de Clercq, Executive Director, FCI confirming that The Philippine Canine Club, Inc. is a full member of the Fédération Cynologique Internationale (FCI) and is the only FCI recognized regulation organization in the Philippines.
 - d. The response from the CKC to Augusto Beneficto S. Santos III, Chairman of the Board, The Philippine Canine Club, Inc. re: The CKC Policy on Recognition of Foreign Registries.
 - e. A letter from Joselito Rosales, General Manager, The Philippine Canine Club, Inc. re: Information & Guidance for International Communications with their club.
 - f. A letter and the press release from The Kennel Club re: The BBC documentary "Pedigree Dogs Exposed" (BBC1 – August 19, 2008).
5. Mr. Joe Mauro, CEO, delivered the report of the Chief Executive Officer. As part of his report, Mr. Sonny Allinson, Manager, Communications presented a report on RDOGS.
6. The Board appointed Marion Postgate (Vancouver, BC) to serve as the obedience representative on the Event Officiating Committee and will re-advertise for applications for the vacancy of a conformation representative on that Committee.
7. Dr. Deborah Boyd, DVM, M.S.M., presented the concept of the Health Registry and fees for that Registry were approved.
8. A report was received from the Multi-Disciplinary Committee (Cropping and Docking Committee).
9. A report was received from the Legislation Committee.
10. Motions were adopted to include a provision giving the Appeal Committee Chair authority to grant postponements of hearings, similar to the provision currently found in Section 15.1, Discipline, subsection (f) of the By-laws. It was determined that this is best addressed in the Policy and Procedures Manual, Chapter XI, Regulatory, Section A, 5 and Chapter X, Committees, Councils & Appointments, Procedure CM-001 – Representation Before a Decision Making Committee.
11. A motion was adopted to delete Chapter VI, Shows & Trials, Section M, Conformation Events, Subsection 10, Cropped Ears from the Policy & Procedures Manual.
12. The Policy and Procedures Manual, Chapter XII, Legislative Policy Statements, Policy Statement – Cropping and Docking was amended to remove the word "aesthetic" and to replace the words "this cosmetic surgery" by "these procedures".
13. The Policy and Procedures Manual, Chapter XII, Legislative Policy Statements – Spay – Neuter and Overpopulation was amended. In the sentence: Spaying and neutering are simple, safe surgical procedures, the words "that have no adverse effect on the health and temperament of the dog" were replaced with "may provide health and temperament benefits".
14. An omnibus rule for the protection of dogs at CKC events was adopted for the rule books to include a provision regarding negligence or willful misconduct that causes a dog to suffer serious injury or death.
15. The following amendments were made effective January 1, 2010 in the Lure Coursing Field Trial Rules & Regulations:
 - a. An amendment was made to Section 1.1 to approve the eligibility of the Italian Greyhound to compete in CKC Lure Coursing Field Trials and an amendment was made to Section 2.1.1

- to accommodate the addition of the Italian Greyhound.
 - b. An amendment was made to better clarify Section 1.2.2.
 - c. An amendment was made to Section 6.1.1 to increase the number of hounds from 15 to 20 thus allowing a club to use only one judge due to lower entries in some areas.
 - d. An amendment was made to Section 9.4.3 (c) to allow for one of the two licensed lure coursing field trial judges to be provisional for any of the breeds giving the clubs a greater number of judges from which to choose.
 - e. An amendment was made to Section 9.6.4 to add a new Novice Courser title to encourage more entries into Lure Coursing Field Trials for dogs that cannot compete to achieve other titles. Amendments were also made to sections 9.5.5 and 9.5.2 to accommodate the placements and awards and colour of the ribbon awarded for the Novice Courser title.
 - f. Amendments were made to the Lure Coursing Field Trial Rules & Regulations to replace the term "Disqualification" with "Declared Ineligible" to distinguish between disqualifying a dog for viciousness and dogs that are disqualified for not running the event appropriately.
16. The following amendments were made effective January 1, 2010 to the Pointing Breeds Field Trial Rules & Regulations:
 - a. A new section 9.5 was added to Chapter 9 to require that a dog must be at least 6 months of age on the first day of the trial to enter Puppy and Derby stakes.
 - b. An amendment was made effective to Section 11.1.1 to provide clubs with the option on the number of field trial marshals appointed.
 - c. An amendment was made to Chapter 12 to add a section clarifying that points earned in an unrestricted championship do count towards titles.
 17. The following amendments were made effective January 1, 2010 to the Field Dog Test Rules & Regulations:
 - a. An amendment was made Section 6.8.2 to streamline the end of test procedures.
 - b. An amendment was made to Section 10.3.1 to level the playing field when there is a bye dog.
 - c. An amendment was made to Section 11.8 to clarify the section.
 - d. An amendment was made to Section 12.3 – Drawing & Bracing to provide that dogs must be judged by two judges.
 - e. An amendment was made to Section 14.1 – Field Test Marshal to change the requirement to appoint one or more Field Test Marshals.
 18. A report was received from the Responsible Dog Ownership Committee.
 19. A report was received from the Charity Event Committee.
 20. A report was received from the Audit Committee and minutes of the November 11, 2008 Audit Committee meeting were received as information.
 21. An amendment was made in the Tracking Test Rules & Regulations, 1.1, 2.1 and Chapter 11 to implement a sanction match requirement for tracking clubs that have not held a tracking test in 5 years.
 22. Third quarter CKC financial statements were accepted as presented.
 23. Third quarter Apex financial statements were accepted as presented.
 24. A motion was adopted to approve a 1.5% annual fee adjustment to all CKC fees.
 25. The 2009 CKC operating budget was approved as amended.
 26. The 2009 CKC capital budget was approved as presented.
 27. The 2009 Apex operating budget was received as information.
 28. The 2009 Apex capital budget was received as information.
 29. A motion was adopted to recognize more than one kennel club for any country unless otherwise provided in any agreement between the CKC and a recognized foreign kennel club.
 30. The Policy & Procedures Manual, section 2 of Appendix I to chapter VI was amended, effective January 1, 2010 to provide for recognition of the Dual Champion title (Pointing).
 31. An amendment was made to the Policy & Procedures Manual to increase the mileage allocation from 40¢ to 45¢.
 32. Previously adopted motions on priority rights/priority dates that take effect in 2010 or thereafter were rescinded (i.e., motions 10-06-07, 35-09-08, 11-06-07, 07-12-07, 79-12-07 & 08-12-07).
 33. The Board instructed the CEO to arrange for consultation with the membership, to obtain their views on how the Board should respond to the issue of a ban on cropping, docking or dew claw removal.
 34. The Board instructed the CEO to consider the advisability of establishing a system to monitor federal and provincial government legislation affecting dog ownership in Canada.
 35. The date of the 2009 AGM was changed to May 1st and 2nd.

REPORT OF THE APPEAL COMMITTEE

REPORT OF APPEALS DECISIONS REACHED BY THE APPEAL COMMITTEE

The following is a report of the decisions reached by the Appeal Committee at its meeting held November 8 and 9, 2008.
