REQUEST FOR PROPOSAL CKC CHARITY EVENT

The Canadian Kennel Club and the CKC Charity Event Committee is inviting bids for the provision of set-up and clean-up services for a three-day event to be held in Tillsonburg, Ontario, **March 13-15, 2009**. Sealed bids making provision for the services noted below should be forwarded by **January 15, 2009** to:

References may be required, and the lowest, or any bid may not necessarily be accepted.

1. Acquire, at cost to the Contractor, appropriate duct tape, wood shavings and plastic sheeting required for the show set up.
2. Provision of all required clean-up equipment, including an appropriate wet/dry vacuum for clean up in the conformation rings at no cost to the Committee.
3. Arrange for the delivery and pick up of the required matting, gating and common runs.
4. To be available for set-up by 9:00 a.m. on **Thursday, March 12, 2009**. Set-up will be completed as per directions of the Committee. This basic contract covers the set-up of one obedience ring and two common runs and any assistance requested in setting up the conformation rings, booths and grooming areas. Additional rings will be set up and torn down at a separate cost; please quote separately.
5. Supervision of any campers in the designated areas including locating said campers.
6. Clean up of all rings and entrances, the front of the booth areas, and the CKC area on an ongoing basis throughout the shows. This will include any vacuuming of the conformation rings during the show as directed. There are to be at least two personnel on duty at all times. The rings are to be vacuumed/mopped on the Thursday, Friday and Saturday evenings. Garbage containers to be emptied and bags replaced as required.
7. Removal and reassembly of ring dividers as required. Rearrangement of ring equipment/entrances as required.
8. Washrooms to be cleaned only on an emergency basis. This will not include replenishment of any sanitary material or conducting of any plumbing work.
9. Disassembling of the ring(s), common runs and club area after the completion of the show on **March 15** and loading of all respective equipment.
10. Removal of garbage from the entire rented area and sweeping of said area after the exhibitors, vendors and Committee members have departed.
11. Provide assistance in such matters as moving trophies, restocking refreshment coolers, and transferring material to the rings, as long as it does not interfere with the primary job of clean up.
12. Return of the matting, gating and common runs to the storage site.
13. All personnel to be appropriately dressed and to act in a professional manner at all times.
