# MESSAGE

## from the Board

### “DRIVE-THRU” DOGS

In a world of instant everything, a “drive-thru dog” is no exception. Consumers looking for instant gratification seek nothing less when buying a puppy. The concept of patience and diligence in this process seems to be lost on many consumers today. Our breeders may be caught in this swing and our long tradition of careful, concerned and considered placement of a pup could be at the opposite end of consumer needs. It is possible that this could put breeders in some jeopardy. Is the shift to the “doodle dog” and away from a reputable breeder a swing away from our sound practices, being driven by the psychology of instant consumerism? The following excerpt from an unsolicited letter, by an obviously spurned potential puppy buyer to the CKC Head Office, seems to indicate that we may be on a swinging pendulum:

Dear CKC,

*Breeders say they are doing what is in the best interest of the dog, however their actions do not always support this and I know I speak for a lot of potential dog owners. Sharing my experience with your members may enlighten them in the ways to deal more effectively with ultimate owners.*

*My purchase was unsuccessful, due to the breeders need for ultimate control of every aspect of the dog's life, from the time it was born, through to and including the duration of my ownership via lengthy unenforceable contracts with some ridiculous expectations.*

*You cannot control every moment of the dogs life, you cannot know what all of the purchasers of your dogs are doing with them every moment of every day.*

*You cannot contract the purchaser into agreeing they have no rights only conditions then expect that to be ok. If someone is willing to pay \$2,000 or more for a dog, plus medical bills, vaccines, food etc, consider they may feel they have some say in things. This person might actually care for the dog; otherwise they could simply go to the SPCA or on line where there are thousands of good dogs for sale at a fraction of the price.*

*This must say something about their intentions and credibility. You should not immediately dismiss their knowledge and understanding of the necessary care and upbringing. Breeders do not have exclusive knowledge so do not treat your clients in all cases as inexperienced and without knowledgeable in dog matters.*

*Do not act arrogant in the fact that only you should pick the dog because the potential owner could not possibly know anything about the breed and they should have no say at all, and be expected to accept it, and ante up the money. And if you selected the wrong dog for them, well that's their problem.*

*None of this is good for the animal. Some breeders do not have great reputations as you are well aware. Some may not care as much about the dog as the money they receive for them.*

*I would suggest (in most cases) that a reasonable common sense two-sided contract, an element of trust, and that the breeder do the very best they can to evaluate the potential owner would be enough then leave it at that.*

*I honestly believe if things continue to progress down the path of ultimate control, arrogance and dictation, it will only serve to harm the animals; reduce the interest in purebreds and ultimately revenues.*

*I would ask your members to think about the last time they put out a couple of thousand dollars for a purchase and were told they should take what they get and like it.*

*Swearing off - purebred breeders.*

If nothing else, these observations should foster some food for thought. By engaging visitors at summer shows, we have a good opportunity to do what we do best - promote and reinforce the value of purebreds, express why we do what we do and explain the pitfalls of instant gratification and “drive-thru doodle dogs”!

# synopsis

The following is a brief synopsis of the key items of business that were addressed at the April 30th and May 1st, 2009 Board meeting held in Moncton, New Brunswick. Please note that rules and policy changes shown below are paraphrased for the sake of brevity. In the event of dispute, the specific wording of such changes should be taken from the official minutes of the Board meeting. The detailed minutes of the meeting will be formally approved at the next regular meeting of the Board.

1. Minutes of the March 16th and 17th, 2009 meeting of the Board of Directors were adopted.
2. Mr. Joe Mauro, CEO, delivered the report of the Chief Executive Officer.
3. An amendment was made Lure Coursing Field Trial Rules & Regulations, Section 7.1.1 effective January 1, 2010 to allow dogs that are not yet 12 months of age to enter into a pre-certification where entries close prior to the trial.
4. A report was presented on activities of the Responsible Dog Ownership Committee.
5. A report was presenting by the Purina National Event Committee.
6. A report was presented by the Audit Committee.
7. CKC first quarter financial statements were accepted.
8. Apex first quarter report was received as information.
9. An amendment was made to Policy & Procedures Manual, Chapter X, I. 3 to add the University of Calgary Faculty of Veterinary Medicine (UCVM) to the list of vet colleges. The amendment ensures that all five Canadian veterinarian college deans will be part of the Honorary Vet rotation.
10. Mr. Harold Butler was appointed Honorary Chair for 2009.
11. Dr. Charles S. Rhodes, Dean, Western College of Veterinarian Medicine, University of Saskatchewan was appointed to be Honorary Veterinarian for 2009
12. A motion to amend Conformation Show Rules 10.16 and Appendix F which will result in a ramp being required was referred to Club Relations and the Event Officiating Committee.
13. A motion to amend Conformation Show Rules Appendix F Ramp Specifications was referred to the Event Officiating Committee.
14. An amendment was made to Policy and Procedures Manual, Chapter VI, 5, to add that critiques by the judges may be required by specialty show giving clubs.
15. A proposal to establish an ambassador program was referred to the Strategic Planning Committee.
16. A motion was passed to send the CEO and the Chair plus a speaker to the International Symposium of the Dog, July 6th & 7th, 2009.
17. A motion was passed to send the CEO, the Chair and a member of the Board to the 2009 World Show and the 2009 Eukanuba.
18. A motion was passed to produce a survey letter to be sent to the National Breed Clubs and all Specialty Clubs soliciting their input on a number of subjects pertinent to their breeds
19. Ann Radford was appointed as member-at-large on the Responsible Dog Ownership Committee.
20. A motion was passed to provide appropriate support for the Rhodesian Ridgeback Congress to be held in August 2012.
21. The Strategic Planning Committee was directed to report to the March 2010 Board meeting on the status of the dog industry in Canada, the position of the CKC within the industry and to make recommendations for improving that position.
22. A motion was passed to request that the Obedience Council revisit the combining of the rule books into one and also that they review the concept of Clubs holding Obedience Trials being required to host Obedience Events in order to host Rally Events.

Mr. Dwain McLean, Chair, called the meeting to order at 10:10 am (Central Time Zone).

The Chair reported that Immediate Past Honorary Chair, Mrs. Beryl Ramey had recently passed away. Attendees of the meeting were asked to stand for a moment of memorial silence.

## INTRODUCTIONS & OPENING REMARKS

The Chair introduced the Head Table and acknowledged special guests in the gallery. Mr. Joe Mauro, CEO, introduced the members of the CKC senior management team. Mr. McLean welcomed all members and guests to the meeting.

The 2007 Honorary Chair, Mrs. Avis Mackie, Alberta was introduced and she presented welcoming remarks.

Mr. McLean announced that at their meeting on June 12th, 2008, the Board of Directors had appointed Mrs. Heather Logan from Ontario as the Honorary Chair for 2008.

The Chair expressed appreciation to the Regina Kennel Club for their cooperating in organizing the Canadian Kennel Club 2008 Annual General meeting in conjunction with their dog show.

Dr. Tim Ogilvie, University of Prince Edward Island Veterinary College, the 2007 CKC Honorary Veterinarian was introduced to the meeting. Dr. Ogilvie presented remarks regarding emerging trends and developments in veterinarian medicine.

Mr. McLean introduced Dr. Charles Rhodes, University of Saskatchewan Western College of Veterinarian Medicine, who presented remarks regarding canine research underway at the University of Saskatchewan.

The Chair explained that the Honorary Veterinarian position rotates amongst the five Canadian veterinary colleges, and at their meeting on June 12th, 2008, the Board of Directors had appointed Dr. Jean Sirois from Université de Montréal as the Honorary Veterinarian for 2008.

The voting procedures were explained by the Chair.

## ADOPTION OF MINUTES OF 2007 AGM

## CORRESPONDENCE

Mr. Mauro reported that the office had received no outstanding correspondence to be brought before the meeting.

Mrs. Steeves reported that she had received correspondence from the Canadian Compassion Community with a request that it be presented to the Annual General Meeting. This item was tabled to be dealt with through the Responsible Dog Ownership Committee and that a report will be presented to the September 2008 Board of Directors meeting.

## PRESENTATION OF 2007 AUDITED FINANCIAL STATEMENTS

The 2007 Audited Financial Statements were presented by Mr. Rob Wilkes from the auditing firm of BDO Dunwoody. He commented that he was confident the reports are an accurate representation of the financial position of the CKC, and he reviewed the highlights of the statements. Mr. Wilkes concluded his report by noting that he had met with the new Chair of the Audit Committee, Line Champagne and he expressed his confidence that the organization in good hands moving forward.

MOVED BY Evelyn Mae Cameron (Regina, Saskatchewan) and seconded by Irene Waddell (Regina, Saskatchewan): "THAT, the 2007 Audited Financial Statements be accepted."

Before introducing the annual reports, the Chair reminded the meeting that this is the final year in the current Board's three-year mandate and that an election will be held in the fall. He encouraged members to participate fully in the electoral process.

## ANNUAL REPORTS OF COMMITTEES AND COUNCILS

The Annual Committee and Council Reports were presented to the meeting and the Chair invited comments from the member. Copies of the annual reports were available for the members.

The following questions and comments on the Annual Committee and Council Reports were received:

- Kathy Chorney (Saskatoon, Saskatchewan) questioned the process for a rule change and Mr. Furlan provided an explanation. Mr. Werle commented that a first step is to contact a local Board member or a committee or council representative with a request for rule change.
- Evelyn Mae Cameron (Regina, Saskatchewan) wanted to know how long it takes to get a new breed recognized by CKC. Mrs. Baborie provided an explanation and suggested that Ms. Cameron provide specific information on the breed she would like to have recognized and she will look into it. She added that new breeds are added once a year at the December Board of Directors meeting. Mr. McLean noted that there are 174 breeds currently recognized and that regulatory requirements are governed by the Animal Pedigree Act.
- Joy Hodgkinson (Carleton Place, Ontario) requested clarification of recognized breeds and rare breeds and Mr. Furlan elaborated on the registration process.

- Irene Waddell (Regina, Saskatchewan) commented that she had heard that CKC is considering having obedience open to unregistered dogs. Mrs. Steeves responded that as a dog community, we could have a greater reach and stronger voice in advocacy and educational efforts when we speak for all dogs. She reported that the Board is in the process of developing a strategic plan incorporating results of the membership survey and feedback provided by members. The information will be studied carefully by the Board as part of the process of forming the plan. She noted that it had been suggested that a subsidiary organization could be created to form an avenue for unregistered dogs and that this suggestion will also be considered as part of the process.

## NEW BUSINESS

The Chair opened the floor to members. The following items were discussed:

## DISCUSSED: CKC SPEAKING FOR ALL DOGS

### *Discussion highlights:*

Robert Whitney (Castleton, Ontario) thinks that CKC should speak for purebred dogs.

Donna Claude (Regina, Saskatchewan) requested clarification on the process for bringing concerns on this issue to the Board and was told that the best way is through her local Director.

Joy Hodgkinson (Carleton Place, Ontario) pointed out that the concept of including non-purebred dogs in events is accepted in some other countries.

Irene Waddell (Regina, Saskatchewan) commented that we will have to recognize non-purebred dogs because of the economics.

Shawn Nickols (Calgary, Alberta) believes that the CKC should be for purebred dogs and that perhaps a subsidiary of the CKC could recognize non-purebred dogs.

Susan Badick (Calgary, Alberta) commented that the more people we get under the umbrella, the stronger voice we have.

Linda Barnes (Regina, Saskatchewan) commented that conformation shows bring people together.

Tom Nesbitt (Gananoque, Ontario) remarked that the club has a mission and a charter. He noted that there is a perception that decisions are made by the Board and head office and there is some distrust about what is going on some committee meetings. He commented that it would be helpful to have more people involved in expressing their opinion and making decisions.

Joy Hodgkinson (Carleton Place, Ontario) pointed out that the Board meetings are open to a gallery and that members are welcome to listen to discussions and find out first-hand what is going on.

Kathy Churney (Saskatoon, Saskatchewan) remarked that performance events should be opened to non-purebred dogs and that the CKC and its members are a huge information resource that should be shared.

Mrs. Steeves pointed out that the Responsible Dog Ownership Committee has been working proactively with the Board and staff to develop an awareness program targeted at communities and that the first three modules of the program will be released soon.

Mr. Werle (Saskatoon, Saskatchewan) reminded the meeting that all members of the Board are dog people and he noted that the CKC is a democratic organization and there is no hidden agenda. He added that member feedback has been and will continue to be invited as the strategic planning process unfolds and that decisions made as part of the plan will be done collaboratively with all involved.

Mr. Bennett added that regardless of the Board's position on the open dogs and open events, it will go to a referendum and all members will have an opportunity to comment.

Avis Mackie read an excerpt from an e-letter she had received from Lonna Fisher, Secretary of the Alberta Kennel Club in which she expressed her opinion that a plan to include mixed breed dogs in performance events goes against what CKC is supposed to stand for.

## DISCUSSED: APPROACHABILITY/VISIBILITY OF BOARD AND STAFF MEMBERS

### *Discussion highlights:*

Rita Lewison (Winnipeg, Manitoba) would like the Board members and staff to be more approachable. She commended the Board for holding the AGM in conjunction with Regina dog show and expressed the hope that the meeting is held in conjunction with other shows in future.

Tom Tilford (Prince Albert, British Saskatchewan) commented that he attended the meetings this week and that he had found the Board and staff to be very approachable.

Bud Haverstock (Fort Saskatchewan, Alberta) remarked that everyone sitting at the Board table is very approachable.

## DISCUSSED: CONFORMATION JUDGES

### *Discussion highlights:*

Robert Whitney (Castleton, Ontario) congratulated the Board on bringing back mandatory education for judges. He noted that the observation program is very weak and he would like a standardized education program for observation judges.

Tom Nesbitt (Gananoque, Ontario) remarked that he supports a program to evaluate judges and added that when new breeds are approved an open book test should be conducted.

Joy Hodgkinson, (Carleton Place, Ontario) noted that she thinks it could be beneficial for people who are ring stewards to have a mentor.

Kim Campbell (Winnipeg, Manitoba) remarked that it would be really nice to have feedback on the learning process.

Mr. Furlan responded that an observation report is provided to permit judges.

Mrs. Jones noted that there appears to be a need for people who fill out permit reports to make them more meaningful and that various judging groups set up in zones of the country could learn from each other and pick up pointers. She remarked that the Event Officiating Committee is working on it and all comments will be taken into consideration.

David Schwartzentruber (Milverton, Ontario) wanted to know if a program exists to promote permit judges on panels and questioned how new people get known.

Mrs. Jones commented that permit judges are not allowed to solicit and CKC cannot dictate to a club who they should have on their panels. In her zone, she actively promotes that all zones should have permit judges on their panel.

Pauline Gaudette (Saskatoon, Saskatchewan) questioned how to get more exposure for permit judges and suggested that they could partner with someone in an area on a permit. Merle Milsom (Sherwood Park, Alberta) remarked that it is already being done effectively in obedience and is an excellent idea.

Robert Whitney (Castleton, Ontario) noted that there was a program for three years and only one permit judge applied.

Mrs. Jones remarked that a mentorship program could be useful if looked at for specialties and that she will take the idea back to EOC.

## DISCUSSED: NEW CKC FOUNDATION

### *Discussion highlights:*

In response to a question regarding the CKC Foundation, Mr. Joe Mauro, CEO explained that the Foundation has been established and that the Board was appointed at the Foundation's inaugural members meeting held on June 13th, 2008. He noted that the applicants and successful appointees will be notified and following that, an official announcement will be made on the website. He commented that the Foundation is a charitable organization that will work independently of the CKC.

Robert Whitney (Castleton, Ontario) requested clarification on how the Foundation Board is structured and was told that the first term of Directors is on a staggered basis.

## DISCUSSED: COMMUNICATION VEHICLES

### *Discussion highlights:*

Merle Bannister (Saskatoon, Saskatchewan) would like to have more written materials provided to members who are not on the internet.

Mr. Mauro responded that the office is trying to provide information through more mediums so more people can have access to it. All information provided electronically is also available in written form.



## DISCUSSED: GENERIC RIBBONS

### *Discussion highlights:*

Linda Barnes (Regina, Saskatchewan) would like the CKC to consider allowing clubs to provide ribbons without a club logo so they can be recycled.

Mr. Furlan will take the suggestion to Council for consideration.

Mrs. Cairns noted that the Conformation Council did bring forward a proposal to use cards instead of ribbons and that the motion was lost. However, if enough members requested it, it could be revisited.

## DISCUSSED: ALTERED DOGS

### *Discussion highlights:*

Merle Milsom (Sherwood Park, Alberta) commented that it is a good idea to promote them. Robbie Pattison (Delisle, Saskatchewan) agreed and added that they showcase the product of a kennel. She questioned if there is any interest in setting up a new category to eliminate the three-generation requirements.

Mrs. Bahorie responded that it is a very complex issue and that it will be taken into consideration.

## CLOSING REMARKS

The Chair expressed appreciation of the opportunity to represent members. He thanked his colleagues at the Board table for their diligence in carrying out their work and the staff for their support.

Mr. Mauro commented that the experience of holding the Annual General Meeting in conjunction with the Regina Kennel Club dog show had been very positive.
