## PROFILING YOUR DIRECTORS

### **KIM HAMEL CKC DIRECTOR ZONE 8, MANITOBA**



Like many of us, Kim started in dogs with a pet quality dog. She started with a Springer Spaniel and was hooked almost immediately. Since those early days of wishing she had a 'show dog' like those being presented in the ring, Kim is now considered almost an old timer in dog show circles. Kim and Richard started out with English Springer Spaniels and one of their first Springers taught her many things about dog care, dog shows, breed standards, etc.

Kim became involved in the Winnipeg show scene in the late 80's, by competing in conformation and obedience. At that time she acquired her first Cavalier King Charles Spaniel. Kim was so new to the sport and breed that she didn't realize how good a dog she actually had until a few years later, when she had been active in the breed and learned so much more. During this time, Kim became a member of the National Springer club. She was also a member of the CKC SCMWC (Cavalier King Charles Spaniel Club of Mid Western Canada) and learned by way of working at various events how dog shows are run. Since that time until the present, Kim has been on the executive of the Cavalier, MSDA (Manitoba Sporting Dog Association) clubs. She is also part of the executive of the Fort Garry Kennel Club. In 2007, she successfully wrote her initial conformation exam and is now licensed for first half of the toy group and is on permit for the second half.

Both Richard and Kim continue to breed Cavaliers under the Bloomfield Affix. They keep a small number of dogs in their kennel and on occasion look after client's dogs.

When not involved with dogs, Kim works part time as an insurance broker and Richard still works at CNR (Canadian National Railroad), but after a long career is thinking about retirement. They have two grandsons which they visit when they can and who perhaps one day, will be encouraged to carry on in dogs.

Kim appreciates the opportunity to work on behalf of purebred dogs for the Manitoba members. She joined CKC many years ago because she wanted to learn more about purebred dogs. Now it is a passion that continues to guide her journey in dogs.

# MESSAGE from the Board

## MEMBERSHIP IN THE CKC IS OUR HERITAGE

The CKC is us – you, me and the 25,000 other individuals who belong. We are 'dog people'. We are breeders, judges, exhibitors, trial enthusiasts, pet owners and folks who simply admire The Dog. Most of us share our lives with at least one dog and often live in a multi-dog household. Every day we make decisions about our own needs and those of our family, but also decisions based on the dog(s). That is who we are and that is what defines us, on the surface, as CKC members.

Now, why did we join the CKC; why do we maintain our memberships – some of us for more than 50 years – and why are new folks joining every day? For many of the same reasons that we are dog people, in fact, we have decided to band together with like-minded people.

The CKC's mandate from the federal government under the Animal Pedigree Act is as a registry. We don't have to be members to register our dogs but we do pay a significant premium if we are not members and we receive a significant monetary benefit for this membership if we are breeding and registering dogs. Fiscally, it simply makes sense for a breeder to be a CKC member. And for those who no longer breed dogs, breed dogs only occasionally or will never breed a litter, what benefit do they derive from membership. Pride of association!

We are not a particularly large contingent of folks at 25,000 but we have a huge background that makes us experts in dogs – in their identification, their husbandry, their behaviour and their needs. That means our voice is a strident and common one, when we speak as one. It is CKC members that the media turns to when there are dog related issues to be discussed; CKC members who sit in Council chambers fighting for the right to own dogs in municipalities across the country. It is CKC members who work with rescue organizations internationally to regain control of dogs in sub-optimal situations and who pay to support these dogs through a system to find them new homes. It is CKC members who work with SPCA's and Humane Societies to bring a reasoned and knowledgeable voice to their many board-room tables. And it is CKC members who offer a hand and advice to the dog owners they encounter who are struggling and simply need a kind word or a helping hand. We are part of a large community and we are its cornerstone in all matters Dog.

Our society is less tolerant of dogs than it used to be. Media is not always kind to the dog owner who makes a mistake and it is downright lethal in dealing with dogs that it deems

to be problems. Unfortunately, much of this media is ill-informed and quick to label a dog without any background in identification. It is our job to be the 'go-to' people for journalists by giving them facts. It is our job to enlighten politicians on dog behaviour and support them in creating legislation that will benefit society rather than restricting our rights as owners of dogs. It is our job to be ambassadors for the dog – to ensure we are good and reasonable neighbours and that we care for our pets so that others do not feel they are encumbrances. It is our job to lift the dog's profile to a level that it is seen to occupy a valued place in our communities and to bring an obvious benefit to others as well as us who own them. It is no longer enough to go to shows and breed good dogs. We are the dog fancy and we must, in this day of instant information and critical thought, publicly portray our dogs as necessary to a civilized and caring society.

As CKC members, we have the strength of a 25,000 person organization behind us and the knowledge of generations of dog men and women who have preceded us in this organization. To diminish the organization is to diminish our value as breeders and fanciers. Never has it been more important to band together and speak as one voice. We can do this only as CKC members and we can do it mightily well.

There is a myriad of services provided by the CKC. We develop and support events for our dogs that would not be available without this organization. We are the largest dog organization in the country, we testify in court rooms in support of responsible ownership and in support of good legislation. We are the dog fancy and the dog fancy is the CKC in Canada.

So in the supermarket lines, at places of worship, in restaurants and at the daycares, please talk about your dogs and their value in your life. It is incredible the impact we can have simply by positive communication on an on-going basis, taking every opportunity to shore up our image and dispelling the negative myths of bad breeders, bad ownership and bad dogs. We are the CKC, each one of us and it is up to us to take on these roles so that the generations to follow will have the tremendous benefit of owning dogs.

The Canadian Government has changed the entry requirements for a number of countries, with regards to visitor entry into Canada. In the past few months, we have experienced a number of situations wherein foreign judges have not obtained the required documents (visa) in a timely manner. As a result, these judges were unable to fulfill their assignments.

The Canadian Kennel Club wishes to remind clubs hiring non-resident judges, to ensure that those judges apply for the proper travelling documentation, if required, well in advance of the event. There are many countries and territories whose citizens require visas in order to enter Canada. Each country may also have different requirements, as well as time limitations for the application.
