The Discipline Committee usually meets on weekends three times a year. Committee members are reimbursed for any expenses incurred.

Background in the legal field or some experience working with tribunals due to the quasi-judicial nature of the Committee will be an asset.

Subsequent to the 2009 December Board Meeting, the following criteria were approved:

Candidate Selection Criteria for Discipline and Appeal Committees

- (A) Integrity:
 - avoidance of impropriety and appearance of impropriety;
 - (2) freedom from personal bias;
 - (3) ability to decide issues based on CKC by-laws, policies, rules and the facts without regard to the identity of the parties or counsel, the popularity of the decision, and

without concern for or fear of criticism;(4) impartiality of actions;

(B) Judicial temperament:

- (1) open-mindedness and a willingness to listen
- (2) respect for litigants and their representatives
- (3) patience
- (4) flexibility
- (5) compassion
- (6) sensitivity to the rights and concerns of individuals
- (C) Knowledge and understanding of the by-laws & policies of the CKC:
 - (1) the issuance of legally sound decisions;
 - (2) understanding of the substantive, procedural, and evidentiary laws applicable to quasi-judicial bodies;
 - (3) attentiveness to the factual and legal issues before the committee;
 - (4) the proper application of judicial precedents and other appropriate sources of authority.

(D) Ability to communicate:

- (1) clarity of rulings and other oral communications;
- (2) quality of opinions with specific focus on clarity and logic, and the ability to explain clearly the facts of a case and the club precedents at issue;
- (3) sensitivity to impact of demeanor and other nonverbal communications.

(E) Preparation, attentiveness, dignity and control over proceedings:

- (1) courtesy to all parties and participants;
- (2) willingness to permit every person legally interested in a proceeding to be heard, unless precluded by law or rules of courts.

(F) Punctuality:

- (1) devoting appropriate time to all pending matters;
- (2) discharging administrative responsibilities diligently;
- (3) where responsibility exists for a calendar, knowledge of the number, age, and status of pending cases.
- (4) the prompt disposition of pending matters;
- (5) meeting commitments on time and according to rules and procedures of the committee.

CKC BOARD OF DIRECTORS MEETING



SYNOPSIS OF THE DECEMBER 5 AND 6, 2009 BOARD OF DIRECTORS MEETING

The following is a brief synopsis of the key items of business that were addressed at the December 5 and 6, 2009 Board meeting held in Etobicoke, Ontario. Please note that rules and policy changes shown below are paraphrased for the sake of brevity. In the event of dispute, the specific wording of such changes should be taken from the official minutes of the Board meeting. The detailed minutes of the meeting will be formally approved at the next regular meeting of the Board.

- Minutes of the September 19 and 20, 2009 meeting of the Board of Directors were approved.
- 2. The following correspondence was received:
 - a. The Kennel Club enclosing a copy of their 2008 Annual Report
 - Letter from Rankin & Bond re: Genetic Problems in Dogs
- 3. The Board reviewed the Strategic Plan for 2009-2011.
- 4. Mr. Joe Mauro, Chief Executive Officer presented the CEO report. As part of that report, Ms. Ann McDonagh, Publisher, Apex Publishing Ltd. presented the Apex Publishing report.
- 5. The following Committee and Council reports were received:
 - a. Responsible Dog Ownership Committee
 - b. Multi-Disciplinary Committee (Cropping and Docking)
 - c. Breeder Relations Committee
 - d. Legislation Committee
 - e. Junior Kennel Club Council
 - f. Purina National Event Committee
- The following amendments were made effective January 1, 2012 to Conformation Show Rules & Regulations:
 - a. Section 4.3.3 was amended to add clarity.
 - b. A new section 6.3.6 was added to allow judges some discretion in the judging schedule in special circumstances.
- 7. The following amendments were made in the Policy & Procedures Manual:
 - Chapter VII Judges, Section B, 1 Applicant Conformation Judges (Eligibility Requirements New Applicants) to clarify that an applicant must be mentored by a CKC judge who is licensed for all breeds.
 - A housekeeping change was made to Chapter VII -Judges, Section B, Applicant Conformation Judges, 4 Permit Process, b) (ii) Breed Standards, to remove the words "origin and purpose including faults".

- c. A housekeeping change was made to Chapter VII Judges, Section B, 6 because of duplication.
- d. Chapter VII Judges, Section B, Applicant Conformation Judges, 8. Licensing Maintenance for All-Breed, Groups and Breed Judges to make the self-directed program of professional development more specific based on new types/formats of education that are being offered to judges.
- e. Chapter VI, Section U, 3, a, 4 was amended effective immediately to remove the reference to the Miscellaneous Class List.
- 8. A motion was adopted to defer seeking appropriate By-law amendment to make microchip identification mandatory for purpose of registration and recovery until two-thirds of the dogs CKC registers in a year have been identified by means of a microchip and additional research is reviewed with respect to microchip implantation in animals.
- The following amendments were made effective January 1, 2011 to the Agility Rules & Regulations:
 - a. Housekeeping amendments in section 12.6, 13, 14, 15 and Appendix B – Obstacle Construction Specifications (Details of Obstacles).
 - b. Appendix A was deleted because the Handbook for CKC Agility Judges explains this section in more detail.
- 10. Lure Coursing Field Trial Rules & Regulations, Section 6.1.2 was amended effective January 1, 2011 by adding a new section c) stating that "an apprentice report may be completed if apprentice requirements are met".
- 11. A report was received from the Audit Committee and minutes of the November 11, 2009 Audit Committee meeting were received as information.
- 12. Third quarter CKC financial statements were received.
- 13. Third quarter Apex financial statements were received.

- 14. The 2010 CKC operating budget was approved as amended.
- 15. The 2010 CKC capital budget was approved as presented.
- 16. The 2010 Apex operating budget was received as information.
- 17. The 2010 Apex capital budget was received as information.
- As part of the budget, the Board approved the inclusion of a \$4.00 fee to individual dog registrations for enhanced recovery services.
- 19. A motion was adopted to communicate to breed clubs whose standards currently require a docked tail to request a change in their standard on this one area, and to allow the acceptance of an undocked tail, and that neither variance be given preference.
- 20. A motion was adopted that liaison commence immediately with all other national breed organizations concerning the position being taken by some provincial veterinarian associations and the effect this would have on all cropped and docked breeds.
- 21. A motion was adopted to expand the Responsible Dog Ownership Committee to further the agenda of communication and public relations in the areas of a communication strategy, research and an action plan to respond to the challenges being faced by the purebred fancy as a result of the CVMA meeting, pedigree dogs exposed, television exposé, and the challenges being posed by our members.
- 22. A non member surcharge was endorsed effective June 1, 2010 to be applied to all CKC events.
- 23. The Board approved the skill sets criteria developed by staff for application in the assessment of candidates for the Discipline and Appeal Committees.

- 24. A motion was adopted that effective June 1, 2010 to change the current recording fees per entry per event to \$2.80 where a total entry is 125 and under and to \$4.05 where a total entry is 126 and over.
- 25. A motion was adopted that staff members appointed or assigned to sit on boards and committees are resources only and they do not have any voting authority.
- A decision was made to hold the March Board meeting on March 26 & 27, 2010 and the Annual General Meeting on March 28, 2010 in Winnipeg.
