MESSAGE FROM THE BOARD

THE DECLINE OF VOLUNTEER "ISM"

Within the many life cycles of an organization like the Canadian Kennel Club, we see an ebb and flow of active participation from the membership at large. This shifting state of involvement is common to all types of organizations that rely upon a volunteer work force to maintain operations and pump new life into an organization. The needs of the CKC are no different, but in a world where organizations are admittedly suffering because of declining membership, and therefore seeing a drop in their available volunteer force, we at CKC seem to be different! Even though there is less time available to people and even though the cost to an individual volunteer is often more than just time, we at the CKC can consider ourselves and our volunteer force to be at the top of the heap when it comes to rallying our troops.

There are at least forty or more permanent committees or councils supporting the overall work of the Club and each need "staffing" to make things work. If the average is approximately 5 permanent volunteer members per committee, the total quickly reaches somewhere in the region of some 200 plus active CKC members giving back to the organization on a regular basis throughout the year. These folks constantly give of their time and talents and this applies well beyond the scheduled meetings they attend. This estimated number of volunteers is the absolute minimum! It does not include ad hoc committees or the people who support the members of the committees, or the thousands of volunteers who are actively involved with club activities; organizing shows and trials, participating in their local areas with RDOG Day, supporting the Purina National, hosting CGN testing, providing seminars and educational events within their communities, or individuals working in similar capacity with both Apex Publishing and the CKC Foundation.

It does seem that our dedicated list of CKC volunteers just goes on forever in both the energy expended and pure absolute numbers of people who volunteer. We admittedly discuss amongst ourselves the need for more help more often and more bodies to fill the unlimited tasks, and maybe even complain about the few doing the majority. But let's just step back for a second. By comparison with other organizations, unable to source any volunteer support and crying out for help, consider how lucky we are and how fortunate to have passion as a core element within the make up of the individuals who are the CKC.

Recognizing the efforts of our peers and giving a huge "shout out" by acknowledging their efforts and giving the credit they are due is one of the most valuable investments we can ever make.

In a time when volunteer "ism" is seriously in decline, let's realize that the CKC is one of the organizations for others to look to re: how to do it right! We know how to get behind and support something we are passionate about. It is the passion that makes the difference and through every volunteer act, our passion rises to the surface as an example of who we are and acts as an inspiration to others.

Our volunteers are our heroes and thanks to you all!

Further details regarding the Discipline Committee's role and authority are in section 15 of the CKC By-laws accessible via the CKC website at www.ckc.ca under CKC Resources/CKC By-laws.

The Discipline Committee usually meets on weekends three times a year. Committee members are reimbursed for any expenses incurred.

Background in the legal field or some experience working with tribunals due to the quasi-judicial nature of the Committee will be an asset.

Subsequent to the 2009 December Board Meeting, the following criteria were approved:

Candidate Selection Criteria for Discipline and Appeal Committees

- (A) **Integrity:**
 - (1) avoidance of impropriety and appearance of impropriety;
 - (2) freedom from personal bias;
 - (3) ability to decide issues based on CKC by-laws, policies, rules and the facts without regard to the identity of the parties or counsel, the popularity of the decision, and without concern for or fear of criticism;
 - (4) impartiality of actions;
- (B) **Judicial temperament:**
 - (1) open-mindedness and a willingness to listen
 - (2) respect for litigants and their representatives
 - (3) patience

- (4) flexibility
- (5) compassion
- (6) sensitivity to the rights and concerns of individuals

(C) Knowledge and understanding of the by-laws & policies of the CKC:

- (1) the issuance of legally sound decisions;
- (2) understanding of the substantive, procedural, and evidentiary laws applicable to quasi-judicial bodies;
- (3) attentiveness to the factual and legal issues before the committee;
- (4) the proper application of judicial precedents and other appropriate sources of authority.

(D) Ability to communicate:

- (1) clarity of rulings and other oral communications;
- (2) quality of opinions with specific focus on clarity and logic, and the ability to explain clearly the facts of a case and the club precedents at issue;
- (3) sensitivity to impact of demeanor and other nonverbal communications.

(E) Preparation, attentiveness, dignity and control over proceedings:

- (1) courtesy to all parties and participants;
- (2) willingness to permit every person legally interested in a proceeding to be heard, unless precluded by law or rules of courts.

(F) Punctuality:

- (1) devoting appropriate time to all pending matters;
- (2) discharging administrative responsibilities diligently;
- (3) where responsibility exists for a calendar, knowledge of the number, age, and status of pending cases.
- (4) the prompt disposition of pending matters;
- (5) meeting commitments on time and according to rules and procedures of the committee.

VOLUNTEERS NEEDED FOR REGISTRATION COMMITTEE

The CKC Board of Directors seeks volunteers to serve on the Registration Committee.

The 5 member committee operates as a quasi-judicial body that adjudicates on matters pertaining to the By-laws, rules, regulations, procedures and policies of the Canadian Kennel Club pertaining to registration of purebred dogs. Further details regarding the Registration Committee's role and authority are in section 13 of the CKC By-laws accessible via the CKC website at www.ckc.ca under CKC Resources/CKC By-laws.

COMMITTEE VOLUNTEERS REQUIRED

The Registration Committee usually meets on weekends three to four times a year depending on the case load. Committee members are reimbursed for any expenses incurred.

While not a requirement, it will be seen as an asset if prospective candidates have a background in the legal field or some experience working with tribunals due to the quasi-judicial nature of the Committee. However, familiarity with the Animal Pedigree Act and the CKC registration process are critical in serving on this committee.
