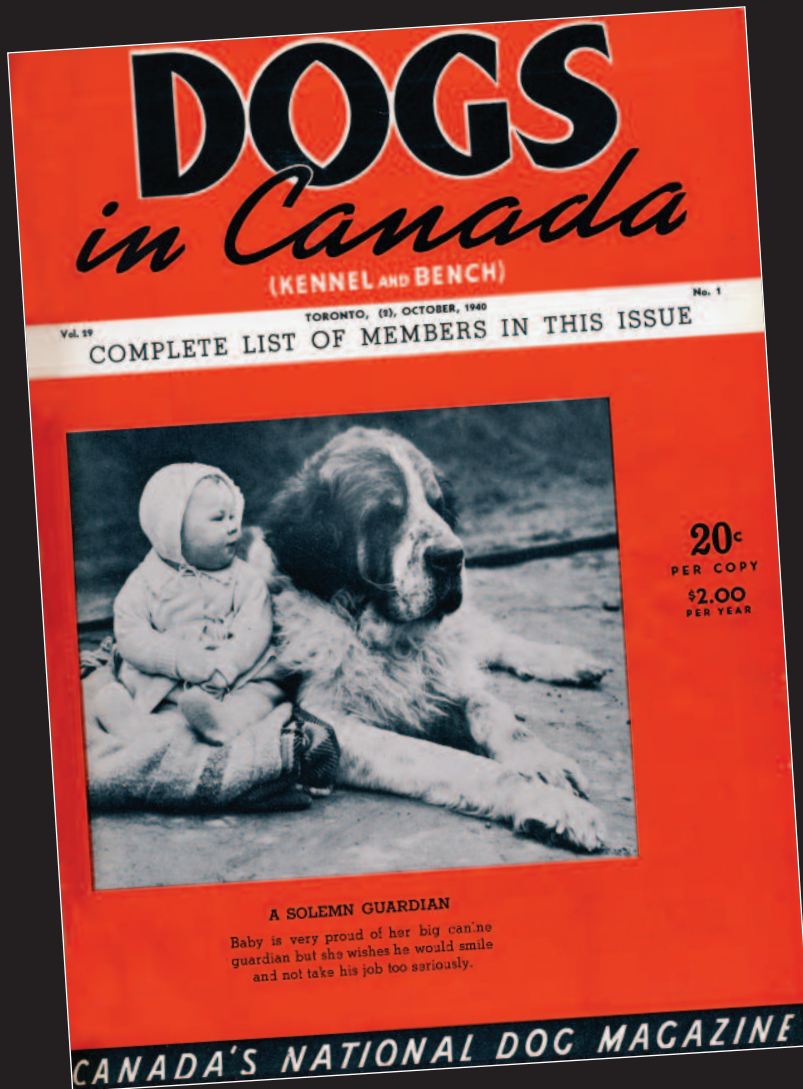

CKC MEMBER PROCESSING DISCOUNT

If all dogs from a Canadian-born litter are registered at one time, they may receive discounts of 5% to 10%, depending upon when and how they submit the applications to Head Office. *(Please see Registration fees at left)*. In order to qualify for the discounts, all unused computerized Individual Registration forms associated with the litter, including those for dogs that are deceased, must be returned to Head Office along with corresponding completed applications. Late submission or failure to include unused forms will result in no discount being applied. This discount is only made available to Canadian Resident Regular Members for registration of Canadian-born litters of two puppies or more. It does not apply to any associated transfer fees.

MEMBER RATES

Member rates and discounts are applied if the applicant is currently a Regular Member of The Canadian Kennel Club. Membership privileges are not transferable. In the case of co-owners, member rates apply only if all of the co-owners are Regular Members of the CKC in good standing; otherwise, non-member rates and rules apply.

METHOD OF PAYMENT

Regular Members

Current Regular CKC Members in good standing may pay by credit card when they login to our website at www.ckc.ca. Regular Members also have the option to make a payment via their personal financial institution, through web, telephone or in person. Payment may also be submitted by mail. Acceptable forms of payment are personal or business cheque, money order, Visa or MasterCard. Post-dated cheques are not acceptable.

Non-Members and Associate Members

Non-members, Associate Members and minors must forward payment with work submitted. Payment must be made in the form of certified cheque, money order, Visa or MasterCard. Personal or business cheques from non-members will not be accepted unless they are certified. Any non-member work received with a non-certified cheque attached will be rejected.

Non-Residents of Canada

Non-residents of Canada must make payment in Canadian dollars. Due to the constantly fluctuating currency rates, discounted cheques or money orders in foreign currency will not be accepted. U.S. cheques and money orders will be accepted at par.

Declined Cheques/Declined Credit Cards

A service charge of \$30.00 will be levied on all cheques and credit cards declined by the bank and no further work will be performed for the individual until such time as all outstanding amounts and service charges have been paid in full. Additionally, memberships, Member Credit Account privileges and use of all Club privileges may be temporarily or permanently suspended.

Cash

Please do not, under any circumstances, send cash in the mail.

Effective July 1, 2010, fees for goods and services delivered to BC will be subject to 12% HST; Ontario, New Brunswick, Newfoundland and Labrador 13% HST; Nova Scotia 15% HST.

Fees for goods and services delivered to all other provinces and territories are subject to 5% GST.

Neither GST nor HST is applied to purchases delivered outside of Canada.
