#### AMENDMENT TO CONFORMATION JUDGES POLICY NEW EDUCATION REQUIREMENTS FOR CONFORMATION PERMITS

At the September 2011 meeting of the Board of Directors, motion #18-09-11, amending the Policy & Procedures Manual, Chapter VII, Judges, Section B, 6, Additional Permits, was carried. This motion pertains to new judge's education requirements for Conformation Judges with respect to judging permits. The new policy is effective January 1, 2012. ## REPORT OF THE APPEAL COMMITTEE

#### REPORT OF THE APPEAL COMMITTEE

The following is a report of the decisions reached by the Appeal Committee at its meeting held October 13 and 14, 2011.

#### Appellant: Penny Bernas, Paris, ON, CKC Member (Respondent: Sheri Compton-Massi)

Registration Committee's Findings:

Reinstated CKC Non-Breeding Agreement for Barknbwild's Halloween Liberty, #RU052990, after finding that it had been cancelled without the proper signature on the Cancellation of Non-Breeding Agreement and directed that the resulting litter #RU052990XA and progeny be cancelled from CKC records.

Appeal Committee's Findings:

Dismissed the appeal and directed that the decision of the Registration Committee be upheld.

#### Appellants: Erik and Neel Mol, High River, AB, CKC Members (Respondent: Cathy Krpan)

Discipline Committee's Findings:

Terminated Erik and Neel Mol's membership for failing to abide by the Code of Practice for CKC Member Breeders and levied costs of the investigation and hearing in the amount of \$250.00 against each of the appellants.

Appeal Committee's Findings:

Dismissed the appeal and directed that the decision of the Discipline Committee be upheld.

#### Appellant: Laurie Hunter, Mountain, ON, CKC Member (Respondent: CKC)

Discipline Committee's Findings:

Terminated Laurie Hunter's membership and deprived her of the privileges of the Club for 90 days for knowingly submitting applications that contained material false statements, failing to provide certificates of registration and failing to properly identify dogs. Costs of the investigation and hearing were levied in the amount of \$150.00 against the appellant.

Appeal Committee's Findings:

Dismissed the appeal and directed that the decision of the Discipline Committee be upheld.

#### Appellant: Samantha Handley, Cameron, ON, CKC Member (Respondent: CKC)

Discipline Committee's Findings:

Terminated Samantha Handley's membership for engaging in the breeding of non-purebred dogs and levied costs of the investigation and hearing in the amount of \$250.00 against the appellant.

Appeal Committee's Findings:

Upheld the appeal and directed that the decision of the Discipline Committee be overturned in its entirety.

#### Appellant: Daniel Thomey, Port Hope, ON, CKC Member (Respondent: CKC)

Registration Committee's Findings:

Directed that litter #UJ226968XN be cancelled from CKC records as the litter and progeny are ineligible for registration.

Appeal Committee's Findings:

Dismissed the appeal and directed that the decision of the Registration Committee be upheld.
