APEX RESTRUCTURING TO FOCUS **ON WEB BUSINESS IN 2012**

At the regular September Board Meeting on Sunday, September 18, 2011 the Canadian Kennel Club Board of Directors was notified by the Apex Publishing Board of Directors that after months of consideration, it has been determined that there is no reasonable expectation of profit for Apex Publishing.

As a result, it has become necessary to close the publishing arm of the Canadian Kennel Club and to reduce the financial burden upon the parent company. The 2012 Dogs Annual and the December 2011 issue of Dogs in Canada Magazine will be the final issues to be published. This decision has come after many months of consideration and evaluation of the financial circumstances currently impacting Apex Publishing, the Canadian Kennel Club, the publishing industry in general and in particular, the hard copy production of periodical journals in Canada.

The decision to discontinue the monthly publication of *Dogs in* Canada Magazine and the Dogs Annual is solely financial and does not in any way reflect negatively on the dedicated contributions and professional services of Apex staff and their award-winning history in the production of the premier Canadian canine publication. Dogs in Canada Magazine has, for over a century, in various formats, served the dog fancy and has been a consistent, reliable source of information supporting responsible and informed dog ownership.

It is anticipated that the well-known Dogs in Canada brand will continue to have a strong web-based CKC presence and continue to provide a major on-line information source for the fancy, as well as for the pet-owning public.

It is with sadness that we advise the passing of CKC Director Anita R. Cairns on Sunday, October 23, 2011. Anita was elected to the CKC Board of Directors in 2003 and served the Club with dedication and acumen as she represented Zone 10: Alberta, Northwest Territories and Nunavut. During her time as a Director, Anita served as Chair of the Strategic Planning Committee, as well as serving on the CEO Review Committee and as Chair of the Conformation Council. Previously, Anita had also spent nine years on the Discipline Committee as well as being an active participant within the fancy. Anita was a Life member of the CKC, an All Breed Judge since 1966 and one of the founding members of the Collie Club of Canada. She owned, showed and bred the Top Winning Collies in Canada and sat on the Board of the Collie Club of America. Her success as a selfemployed business woman allowed her the freedom to be involved with other philanthropic endeavours beyond the CKC and serve as one of the first Board members of the CKC Foundation.

Anita Cairns passed away at the Southwood Hospice in Calgary and at her request there will be no service.

As there is no candidate seeking office in Zone 9, Saskatchewan, in accordance with Section 12.9 of CKC By-laws, the members in that Zone will receive a ballot where they may write the name of an eligible member of their choice.

Zone 12 - BC Interior and Yukon

To be considered eligible to seek office, a member must meet the following requirements as of September 15, 2011; that being the date the Official Voters List was created:

- (i) be a Regular Member in good standing;
- (ii) be resident in Zone 9, Saskatchewan;
- (iii) have completed 1 year continuous membership in the Club; and
- (iv) have attained the age of 19 years.

The Election Commission will tabulate the Zone 9 ballots and then communicate with the person having the greatest number of votes in order to obtain consent from the individual to accept the office. If written consent is given, this person will be declared elected. If this person declines, the Election Commission will communicate with the person having the next greatest number of votes. This procedure will continue until a member consents to accept the office, at which time the person shall be declared elected.
