

Please be advised that a Special Referendum will take place in late 2011 and will be held in conjunction with the triennial election for the Board of Directors in November 2011. The ballot for the Referendum will be enclosed with the mailing of the ballots for the election of the Board of Directors. Mailing of ballots to all eligible voters will take place on or before October 20, 2011, in accordance with the *By-laws*.

Special Referendum 2011 will be performed in accordance with Section 36.14 of the *By-laws* and it will be comprised of proposed amendments to the By-laws that have been recommended by the Legislation Committee. These recommendations were placed before the Board of Directors in June 2011 for their consideration and the Board subsequently gave approval for these proposed amendments to be placed before the membership for its consideration in a Special Referendum.

NOTES

- 1. At all times, the proposed amendments, as included in the actual referendum ballot, shall prevail as being the final and correct recommendation that is being proposed to the membership.
- 2. The format as it appears in the official referendum package may vary slightly from that which is presented here.

The following proposals are printed in this issue for your information only. No specific action is required until such time as all eligible voting members receive their Special Referendum ballot.

SPECIAL REFERENDUM 2011

Board-proposed amendments to the By-laws

SECTION A

AMENDMENT TO THE LIST OF RECOGNIZED BREEDS

In accordance with the Animal Pedigree Act (APA), in order to amend the list of Recognized Breeds under Section 25 of the By-laws, the membership must be polled and if at least 25% of the membership casts a ballot and of those who cast a ballot, two-thirds are in favour, the list will be amended as proposed.

PROPOSED AMENDMENT #1

AMEND THE SPELLING OF CESKY TERRIER TO CZESKY TERRIER

Proposed Amendment:

It is proposed that Section 25.1, RECOGNIZED BREEDS, be amended as follows:

"Cesky Terrier" to read "Czesky Terrier"

Explanation for Amendment: It is proposed that CKC make an application to Agriculture and Agri-Food Canada to amend our Articles of Incorporation and the By-laws to change the spelling of Cesky Terrier to "Czesky Terrier" under the list of Recognized Breeds set out in Section 25.1 of the By-laws.

The Cesky Terrier has already been approved for full recognition as a distinct breed in Canada under the Animal Pedigree Act and the breed is currently being registered with the CKC; however, the CKC has received a request to change the spelling to "Czesky Terrier". The addition of the letter "z" to the current "Cesky" allows for the correct pronunciation of the breed name as the "Czech Terrier", or more correctly, the "Czesky Terrier". This spelling has been adopted in breed literature and resource books worldwide.

SECTION B

BOARD-PROPOSED AMENDMENTS TO THE BY-LAWS

In accordance with Section 36.1 of the By-laws, the By-laws may be amended by means of a majority (more than 50%) affirmative vote of the votes cast in a Special Referendum ballot.

PROPOSED AMENDMENT #2

Proposed Amendment:

It is proposed that the INTERPRETATIONS section be amended by adding the following:

"Club Policy" means any policy or procedure that is adopted by the Board, and all Club Policies shall be consolidated from time to time in a Policy and Procedures Manual;

Explanation for Amendment: At present the word "policy" is used inconsistently throughout the By-laws. In various places in the By-laws, the following terms are used to refer to exactly the same thing:

"Club policy": Sections 7.1(a), 7.1(b), 25.3

"approved policy and procedures": Section 13.1(b)(iii)

"Policy and Procedures Manual": Sections 7.4, 10.6, 13.1(c), 13.2(a) and (b), 25.2, 26.2(a), 27.7, 33.1

The same term should be used throughout the By-laws to denote the same thing; therefore, it is being proposed that "Club Policy" be a new defined term in the Interpretations section. If this amendment passes, all uses of "Club policy", "approved policy and procedures" and "Policy and Procedures Manual" throughout the By-laws will be changed to the one common term, "Club Policy".

PROPOSED AMENDMENT #3

Proposed Amendment:

It is proposed that the definition of "dog" in the INTER-PRETATIONS section be amended as follows:

"dog" means a purebred dog of either sex, whether or not purebred, unless the context otherwise implies a male purebred dog;

Explanation for Amendment: At the present time our mandate is restricted to "purebred" dogs and by removing the word "purebred", we are broadening the Club's mandate to speak for all dogs in terms of the work we are doing in areas such as legislation and canine health, and even the transportation industry which impacts all dogs. This amendment also opens the opportunity for the Club to set-up a separate division to deal with non-purebred dogs in which these dogs would be allowed to participate in performance events (i.e. non-conformation events).

Proposed Amendment:

It is proposed that the INTERPRETATIONS section be amended by adding the following:

"electronic ballot" means the use of internet, telecommunications or other electronic means to conduct a vote or tally;

Explanation for Amendment: This amendment will avail the Club of the latest technology in voting and reduce the costs of elections and referendums.

PROPOSED AMENDMENT #5

Proposed Amendment:

It is proposed that the definition of "Official Publication" in the INTERPRETATIONS section be amended as follows:

"Official Publication" means the CKC publication that is sent made available to members monthly, under whatever name it may be known or published, and at whatever frequency as determined by the Board from time to time;

Explanation for Amendment: Given that the Official Publication is now posted online, the addition of "made available" is more appropriate wording and removes any obligation on the Club's part to have it "sent" to members. The second amendment to add the words "and at whatever frequency" allows the Club to avail itself of the most up to date communication.

PROPOSED AMENDMENT #6

Proposed Amendment:

It is proposed that the definition of "resident" in the INTERPRETATIONS section be amended as follows:

"resident" means a person who is a Canadian citizen or permanent resident and whose principal residence is in Canada for a total of at least six (6) months during any calendar year;

Explanation for Amendment: The deleted words are unnecessary.

PROPOSED AMENDMENT #7

Proposed Amendment:

It is proposed that Section 5, OBJECTS, Subsection 5.1 (e), be amended as follows:

- 5. OBJECTS
- 5.1 The Objects of the Club shall be as follows:
 - (e) Maintaining a system whereby clubs and associa-

tions wishing to do so may hold dog shows, obedience trials, field trials and other trials, tests and activities for **purebred** dogs under the auspices of, and in accordance with the rules, regulations, standards, policies and procedures established by the Club;

Explanation for Amendment: As set out in the Explanation for Proposed Amendment #3 in which it is proposed that the word "purebred" be removed from the definition of dog, this amendment broadens the Club's mandate to speak for all dogs in terms of the work we are doing in areas such as legislation and canine health, and even the transportation industry which impacts all dogs. This amendment also opens the opportunity for the Club to set-up a separate division to deal with non-purebred dogs in which these dogs would be allowed to participate in performance events (i.e. non-conformation events).

PROPOSED AMENDMENT #8

Proposed Amendment:

It is proposed that Section 7.1, MEMBERSHIP CATE-GORIES, be deleted and replaced by the following:

7.1 MEMBERSHIP

Upon receiving final approval, a Member shall have all the rights and privileges that may be provided under the By-laws, rules, regulations and Club Policy. There are four (4) categories of members: Junior, Regular, Premier and Life. Members, other than Junior Members, who are residents of Canada, may vote at any meeting or in any election or referendum and they may stand for election as a member of the Board of Directors if they have met all of the stated conditions as required under these By-laws. Club Policy shall specify the benefits of each category of Membership. Life Membership in the Club shall be granted to any member who has achieved thirty (30) years of continuous and unbroken service as a Regular or Premier Member and is at least fifty (50) years of age.

Explanation for Amendment: This amendment clearly defines in the By-laws the various categories of Membership while making it clear that Junior Members are not entitled to vote or stand for election as a member of the Board of Directors. An additional qualification is also being proposed in order to achieve Life Membership; i.e. one must be at least fifty (50) years of age in addition to having thirty (30) years of continuous and unbroken service as a Regular or Premier Member. Should this amendment be approved, subsection (b) Associate Member will be removed.

Proposed Amendment:

It is proposed that Section 7.6, ADDRESS AND TELE-PHONE NUMBER, be amended as follows:

7.6 ADDRESS AND TELEPHONE NUMBER MEMBERSHIP CONTACT INFORMATION

Members shall provide the Club with their eorrect and proper mailing address postal addresses, and telephone numbers and electronic addresses at the time of application. Any subsequent change of address and telephone number contact information shall be provided to the Club within thirty (30) days of such change.

Explanation for Amendment: This amendment takes into account current technology and paves the way for electronic communication with the membership.

PROPOSED AMENDMENT #10

Proposed Amendment:

It is proposed that Section 7.7, DELIVERY OF NOTICES, be amended as follows:

7.7 DELIVERY OF NOTICES

All notices Notices shall may be transmitted electronically or mailed or dispatched by a commercial carrier to the last known address in the records of the Club. Such notices shall be deemed to have been given at the time they are electronically transmitted or personally served or deposited with the post office or commercial carrier.

Explanation for Amendment: Not all by-laws specify the method for delivering notices; this amendment allows for electronic transmission.

PROPOSED AMENDMENT #11

Proposed Amendment:

It is proposed that Section 7.9, BY-LAWS BINDING, be amended as follows:

7.9 BY-LAWS BINDING

The By-laws of the Club bind each member thereof fully as though he had prescribed his name and affixed his seal thereto. These By-laws shall be **printed posted electronically to the CKC website** and **upon request** a **printed** copy of same delivered or transmitted to the member's last known address of record in the Club. No person, whether a member or not, shall be absolved from the effect of these By-laws on any allegation of not having received them, or of ignorance of the contents or meaning.

Explanation for Amendment: This amendment allows for posting the By-laws online while making it clear that a printed copy can still be provided.

PROPOSED AMENDMENT #12

Proposed Amendment:

It is proposed that Section 8.8, MINUTES, be amended as follows:

8.8 MINUTES

The proceedings of a General Meeting shall be recorded electronically and an audio **tape recording** of the meeting shall be retained as the official minutes of the meeting. Copies of the minutes in audio **tape** form shall be made available to any member at cost when ordering same.

Explanation for Amendment: This amendment reflects current technology given that audio "tape" is out of date.

PROPOSED AMENDMENT #13

Proposed Amendment:

It is proposed that Section 9.1, THE BOARD, be amended as follows:

9.1 THE BOARD

The Board of Directors shall establish and have authority over Aall general policies and long range objectives of the Club shall be established by a Board of Directors which shall consist of the numbers hereinafter provided, and such Board shall exercise such authority which has not, by these By-laws and/or by statute, been expressly reserved to the Chief Executive Officer and/or the general membership of the Club, shall be responsible for the hiring and dismissal of the Executive Director, shall have supervisory authority over the Executive Director and the exercise of the Executive Director's authority under Section 14.1, and shall have final authority over all operations of the Club.

Explanation for Amendment: Governance of and decision-making within the CKC is provided for by two provisions in the By-laws, being Section 9.1, THE BOARD and Section 14, EXECUTIVE DIRECTOR. Since the Legislation Committee is proposing an amendment to Section 14 giving the Board supervisory authority over the Executive Director and ultimate decision-making power, it therefore follows that Section 9.1 should be amended at the same time in order to make the exercise of powers by the Board and the Executive Director, which are related, clearer and more explicit.

Proposed Amendment:

It is proposed that Section 9.2, NUMBER OF BOARD MEMBERS, be amended as follows:

9.2 NUMBER OF BOARD MEMBERS

The Board shall consist of a sufficient number of elected members to ensure proportional representation. Such Board members shall be elected in the manner prescribed in Section 12. The Board shall consist of twelve (12) members elected in the manner prescribed in Section 12.

Explanation for Amendment: To allow for geographical representation.

PROPOSED AMENDMENT #15

Proposed Amendment:

It is proposed that Section 10.3, SPECIAL MEETINGS, be amended as follows:

10.3 SPECIAL MEETINGS

- (a) The Chair or a majority of the Board shall have the authority to call a special meeting of the Board by providing each Board member with at least forty-eight (48) hours notice; such notice to be delivered by telephone or electronic transmission.
- (b) The Board may determine that special meetings shall be held entirely by means of a telephonic, an electronic or other communication facility that permits all participants to communicate adequately with each other during the meeting.

Explanation for Amendment: In this day of internet and telecommunications the need for rapid decision-making is becoming more and more prevalent. This amendment allows the Board through a special meeting to deal with an urgent matter and render a decision in a timely fashion. At present the By-laws require all Board decisions be done "in person". This prevents the Board from dealing with a time-sensitive item and in those situations the Board appears to be ineffective because it was not dealing with the matter quickly.

With this amendment the Board will be able to conduct a meeting, vote and make decisions either by phone or over the internet. This amendment is not designed to replace regular meetings rather to give the Board flexibility in its response to time-sensitive issues.

PROPOSED AMENDMENT #16

Proposed Amendment:

It is proposed that Section 12.3, ELIGIBILITY TO VOTE, NOMINATE OR SEEK OFFICE, Subsection (a) be amended as follows:

12.3 ELIGIBILITY TO VOTE, NOMINATE OR SEEK OFFICE BE ELECTED OR APPOINTED TO OFFICE

- (a) To be eligible to vote, nominate or seek office be elected or appointed to office, a member must meet the following requirements on the day the Official Voters List is created and on the day the ballots are mailed:
 - (i) be a **Regular** Member in good standing;
 - (ii) be resident in the relevant electoral zone;
 - (iii) have completed one (1) year continuous membership in the Club; and
 - (iv) have attained the age of nineteen (19) years.

Explanation for Amendment: This new wording more accurately reflects the meaning of the section; i.e. an individual is "elected" or "appointed" to office as opposed to an individual who may "seek" office. The word "Regular" has been removed from subsection (i) to coincide with the amendment to Section 7.1, see **Proposed Amendment** #8.

PROPOSED AMENDMENT #17

Proposed Amendment:

It is proposed that Section 12.4, PROPORTIONAL REPRE-SENTATION, be deleted and replaced with the following:

12.4 ELECTORAL ZONES

The country is divided into twelve (12) electoral zones, each of which shall elect a director to sit as a member of the Board. The electoral zones shall be as follows:

- Zone 1 Newfoundland and Labrador, and Nova Scotia
- Zone 2 Prince Edward Island and New Brunswick
- Zone 3 Québec
- Zone 4 Ontario North
- Zone 5 Ontario East
- Zone 6 Ontario West
- Zone 7 Ontario Central
- Zone 8 Manitoba
- Zone 9 Saskatchewan
- Zone 10 Alberta, Northwest Territories and Nunavut
- Zone 11 British Columbia Southwest
- Zone 12 British Columbia Interior and Yukon

Explanation for Amendment: This wording is being brought in to simplify the election process and to ensure that we have geographic representation for directors mirroring the geography of the country. It also reflects current practice.

PROPOSED AMENDMENT #18

Proposed Amendment:

It is proposed that Section 12.5, SEXENNIAL ADJUST-MENT, be deleted and replaced with the following:

12.5 BOUNDARIES

Subject to Section 12.5.1, the boundaries of zones in British Columbia and Ontario shall remain as they were on January 1, 2008.

12.5.1 REVIEWING ZONE BOUNDARIES

When directed to do so by the Board of Directors, the Executive Director shall review the boundaries of the electoral zones not more often than every three (3) years.

12.5.2 REPORT

The Executive Director shall deliver a report to the Board no more than nine (9) months after receiving a direction pursuant to Section 12.5.1.

12.5.3 EFFECTIVE DATE OF RECOMMENDATION

Upon receipt of the report of the Executive Director, the Board may accept or reject the recommendations in whole or in part, and may approve such changes to the zone boundaries as it may determine. Any change to a zone boundary shall not come into effect until the first election that is at least eighteen (18) months after the Board approves such change.

Explanation for Amendment: These changes achieve fair and reasonable representation. This provides flexibility for the membership in that we would not have to wait for by-law changes in order to be able to adjust boundaries.

PROPOSED AMENDMENT #19

Proposed Amendment:

It is proposed that Section 12.6, NOMINATION PAPERS, be amended as follows:

12.6 NOMINATION PAPERS

On or before September 1ST in each election year nomination papers in such form as may be approved by the Board **should be mailed, postage prepaid**, **shall be provided** to any voting member who has requested same.

Explanation for Amendment: This is part of a package of amendments to allow for electronic voting.

PROPOSED AMENDMENT #20

Proposed Amendment:

It is proposed that Section 12.9, NO NOMINATION IN AN ELECTORAL ZONE, be amended as follows:

12.9 NO NOMINATION IN AN ELECTORAL ZONE

In the event that no nomination is received for an office in any an electoral zone, the Election Commission shall prepare a ballot for such electoral zone which shall have a blank space left on the face of the ballot where the voting member may write the name of the eligible member of his choice for that particular office ensure that a provision is made, in the electronic ballot provided for in Section 12.12, for any voting member to insert the name of and vote for any eligible member for that electoral zone. These "write-in ballots" shall then be tabulated by the Election Commission in the manner prescribed in Section 12.14.

Explanation for Amendment: This amendment is part of a package of amendments to allow for electronic voting.

PROPOSED AMENDMENT #21

Proposed Amendment:

It is proposed that Section 12.11, THE BALLOT, be deleted and replaced with the following:

12.11 VOTING

Voting for the election of the Board of Directors and for By-law amendments on regular and special By-law amendment referenda under Section 36 shall be by secure electronic ballot or paper ballot if requested by any member before October 15.

Explanation for Amendment: This amendment is part of a package of amendments to allow for electronic voting.

PROPOSED AMENDMENT #22

Proposed Amendment:

It is proposed that Section 12.12, MAILING OF BALLOTS, be deleted and replaced with the following:

12.12 ELECTRONIC BALLOT

The Election Commission shall ensure that all voting members have access to an electronic ballot. By October 30, or as soon thereafter as is practicable, the Election Commission shall deliver to every voting member an

REFERENDUM 2011

Electronic Voting Package (EVP) containing the following information:

- The voting time period
- Procedure for voting
- Voter verification method
- Personal Identification Number (PIN) to allow voter access to vote

If a voting member does not receive an EVP, the Election Commission shall provide a replacement EVP to the voting member. The failure of a voting member to receive an EVP or a PIN as provided in this section shall not invalidate an election of directors.

Explanation for Amendment: This amendment is part of a package of amendments to allow for electronic voting. New Section 12.12 provides that an Electronic Voting Package (EVP) shall be distributed to every voting member by October 30. If a member wishes to have a paper ballot, it makes sense that (i) the onus should be on the member to inform the CKC of that fact, and (ii) that the request should be made, at the latest, by October 15, so as to give the Club enough time to transmit the names and identification information to the Election Commission, and for the Election Commission to prepare paper ballots to be delivered to those members by October 30, which is the day before voting may begin.

PROPOSED AMENDMENT #23

Proposed Amendment:

It is proposed that Section 12.13, RETURN OF BALLOTS, be deleted and replaced with the following:

12.13 PAPER BALLOTS

In addition to the EVP, the Election Commission shall prepare a form of paper ballot. The ballot shall have the corporate seal of the Club printed thereon and each ballot shall be marked by the Election Commission for the purpose of identification and in counting the votes. By October 30 or as soon thereafter as is practicable, the Election Commission shall deliver to every voting member who has requested one, a paper ballot and a return envelope marked "BALLOT", pre-addressed to the office of the Election Commission.

Explanation for Amendment: This revision brings back (in simplified form) the necessary portions of Sections 12.11 and 12.12, which are required if paper ballot voting is still to be allowed.

PROPOSED AMENDMENT #24

Proposed Amendment:

It is proposed that Section 12, ELECTIONS, be amended by adding the following new section:

12.14 CASTING A VOTE

Voting members may vote at any time from November 1 until November 30. Any member who chooses to vote by paper ballot must return the marked ballot to the Election Commission so that it is received by November 30.

Explanation for Amendment: This revision brings back (also in much simplified form) the existing provision of Section 12.13 RETURN OF BALLOTS, which is required if paper ballot voting is still to be allowed.

Note: If this new section is approved, the balance of Section 12 will be renumbered and the reference in Section 12.9 to Section 12.14 will be amended accordingly.

PROPOSED AMENDMENT #25

Proposed Amendment:

It is proposed that Section 12.14 COUNTING AND REPORTING RESULTS, be amended as follows:

12.**14<u>15</u> COUNTING AND** REPORTING RESULTS

Following the close of voting as stipulated in Section 12.1314, and as soon as possible thereafter, the Election Commission shall proceed to the opening of the return envelopes and the counting of the ballots the Election Commission shall tabulate the votes.

Should any "write-in ballots candidates" be included, as per Section 12.9 receive any votes, as provided in Section 12.9, the Election Commission shall tabulate the results and then communicate with the person having received the greatest number of votes to obtain consent from the individual, in writing, to accept such office. If written consent is given, this person shall be declared elected. If the person with the greatest number of votes declines, the Election Commission shall then communicate with the person having the next greatest number of votes and shall continue this procedure until a member consents to accept the office, at which time the person shall be declared elected. If no person can be elected in this manner, the Board shall, at the next Annual General Meeting following the election, appoint an eligible member to fill the vacancy.

Any member residing in an electoral zone in which there is a "write-in ballot" shall, upon application to the Election Commission, be notified by the Election Commission of the number of votes, if any, cast for the individual on the "write-in ballot".



Explanation for Amendment: The reference to opening the return envelopes has been removed from the first sentence as we are paving the way for paper or electronic ballots. The language has also been simplified in the second paragraph. The section number has been changed from 12.14 to 12.15 to accommodate the addition of the new Section 12.14, CASTING A VOTE, as reflected in the above proposal; see **Proposed Amendment #24**.

PROPOSED AMENDMENT #26

Proposed Amendment:

It is proposed that Section 12.17, DESTRUCTION OF BALLOTS, be deleted and replaced with the following:

12.1718 DESTRUCTION OF BALLOTS

The Election Commission shall preserve all ballots that have been cast until April 1st of the year following the election, when they shall be destroyed.

Explanation for Amendment: The purpose of this provision is to ensure the Election Commission itself destroys the ballots, rather than employing a wholly unnecessary and cumbersome procedure of "depositing" the ballots with the Executive Director and having the Executive Director destroy them. Since all of the ballots – whether electronic or paper – will be received by the Election Commission, it is in the best position to destroy them. The section number has been changed from 12.17 to 12.18 to accommodate the addition of the new Section 12.14, CASTING A VOTE, as reflected in **Proposed Amendment #24**.

PROPOSED AMENDMENT #27

Proposed Amendment:

It is proposed that Section 14.1, RESPONSIBILITY AND AUTHORITY OF CEO, be deleted and replaced with the following:

14.1 RESPONSIBILITY AND AUTHORITY OF EXECUTIVE DIRECTOR

Subject to the authority of the Board of Directors as set out in Section 9.1, the Executive Director shall have overall responsibility and authority for all operations of the Club. Such authority and responsibility shall include the following:

- (a) The administration of Club operations.
- (b) The administration of matters relating to the Club's finances, including budget preparation and administration thereof, ensuring the Club's investment portfolio is properly administered and that monies are deposited in the bank account of record, ensuring that the accounts of the Club are reviewed and paid within the prescribed time limit and ensuring that all financial records are maintained in accordance with generally accepted accounting principles.

- (c) Exercising signing authority with respect to legal and financial matters subject to the limitations of the budget and the approval of the Board of Directors.
- (d) The administration of matters relating to staffing, including hiring and dismissal, reviewing performance, setting levels of compensation and benefits, designation of titles and the assignment of duties.
- (e) Acting as the Board Secretary, being responsible for the preparation, assembly and distribution of material, receiving responses to items published for comment, ensuring that the Board is kept informed of all matters requiring its attention.
- (f) Providing advice to the Board on matters which may affect the operations of the Club and to recommending any course of action which requires a decision from the Board.
- (g) Reporting to the Board of Directors on the general operations and financial condition of the Club.

Explanation for Amendment: As noted in Proposed Amendment #13, Section 9.1 is being amended giving the Board supervisory authority over the Chief Executive Officer (CEO) or "Executive Director" if this amendment passes. It therefore follows that Section 14.1 should be amended at the same time in order to make the exercise of powers by the Board and the CEO, which are related, clearer and more explicit. This amendment makes it clear that the CEO is responsible for the leadership and management of the organization based on the strategic direction of the Board of Directors. The job title is also being changed from "Chief Executive Officer" to "Executive Director" which is a more appropriate title for a non-profit organization such as the CKC. Should this proposal pass, all reference to "Chief Executive Officer" will be replaced with "Executive Director".

PROPOSED AMENDMENT #28

Proposed Amendment:

It is proposed that Section 15.1, DISCIPLINE, be amended as follows:

15.1 DISCIPLINE

Any person or persons contravening the By-laws, rules, regulations, procedures and policies Policy of the Club shall be subject to discipline procedures. All complaints, for a first alleged offence, relating to the non-delivery of certificates of registration as required under Section 30.1 shall be within the exclusive jurisdiction of the Executive Director, who may exercise all authority in respect of such offence as is set out in Section 15.1(b). All other matters of discipline shall be within the jurisdiction of the Discipline Committee and administered in the manner hereinafter described:

REFERENDUM 2011

Explanation for Amendment: As an association incorporated under the Animal Pedigree Act, the Club has a responsibility to investigate possible infractions of the Act and, where possible, try to bring about a satisfactory resolution. This is the case with complaints involving the non-delivery of certificates of registration which is the most common complaint adjudicated. In these cases the Club informs persons engaged in the sale of purebred dogs that they have a responsibility to ensure a certificate of registration is provided within six months of the date of sale. If a seller shows a lack of willingness to comply after having been made aware of the provisions of the Act, this is seen as a very straightforward offence and the requirement for an extensive disciplinary process is unnecessary. This amendment will simplify the process; reducing both timing and costs.

PROPOSED AMENDMENT #29

Proposed Amendment:

It is proposed that Section 15.1, DISCIPLINE, Subsection (f), Postponement of Hearing, be deleted:

DELETE

(f) Postponement of Hearing

It is at the discretion of the Chair of the Discipline Committee to postpone a scheduled hearing when the principles of natural justice are best served by doing so. Any request by the parties to a complaint to postpone a hearing shall not be considered unless it reaches the Head Office of the Club at least five (5) days prior to the date fixed for the hearing.

Explanation for Amendment: This is more appropriately addressed in policy.

PROPOSED AMENDMENT #30

Proposed Amendment:

It is proposed that Section 15.2, APPEAL, be amended as follows:

15.2 APPEAL

Any person, who is subject to any decision of the Discipline Committee or the Executive Director under Section 15.1, or the Registration Committee, shall have the right to appeal that decision. All matters of appeal shall be administered in the manner herein prescribed:

Explanation for Amendment: To bring Section 15.2 in line with Section 15.1; see **Proposed Amendment #28**. Since the Executive Director is being given the same authority as the Discipline Committee with respect to first time offences involving non-delivery of certificates of registration, it follows that those persons who are subject to decisions of the Executive Director be given the same right of appeal.

PROPOSED AMENDMENT #31

Proposed Amendment:

It is proposed that Section 26.7, IDENTIFICATION BY TATTOO, Subsection (i), be amended as follows:

26.7 IDENTIFICATION BY TATTOO

The following regulations shall apply when tattoos are used for the purposes of identification:

In circumstances where a foreign born dog has been imported by a Canadian and the dog has been previously identified with a foreign tattoo that complies with Section 26.7(a) and (b), the tattoo may be deemed as acceptable identification in an application to register an imported foreign dog. In order for such a tattoo to be considered; the application would have to be accompanied by a statutory declaration, letter signed by the applicant, certifying stating that the tattoo was applied to the dog prior to the dog entering the country and accompanying such declaration shall be a certification from a second party, confirming that the dog has been physically examined and that the tattoo combination represented on the application is present and appropriately located on the dog. Alternatively, the three (3) or four (4) generation pedigree issued by the foreign club and which must accompany the application for registration, shall contain the corresponding foreign tattoo combination as part of the permanent record. Upon confirming either of the above, and if the tattoo is not in conflict with any tattoo combination currently registered with CKC, the tattoo will shall then be accepted as an appropriate form of identification.

Explanation for Amendment: Since the registration process is based upon the honour system, it seems overly stringent to require an applicant to provide a statutory declaration and certification from a second party. This will simplify procedures as well as decrease costs for those registering dogs.

PROPOSED AMENDMENT #32

Proposed Amendment:

It is proposed that Section 27, GENERAL RULES OF REGISTRATION, Subsection 27.1, ELIGIBLE FOR REGISTRATION, be amended as follows:

27. GENERAL RULES OF REGISTRATION GENERAL ELIGIBILITY FOR REGISTRATION

27.1 **ELIGIBILE ELIGIBILITY** FOR REGISTRATION

Any dog born in Canada of a litter registered with the Club and any dog registered in any of the foreign stud books or records which are recognized by the Club shall be eligible for registration with the Club, upon applica-

tion in accordance with the terms of these By-laws. In order to ensure continued conformity with breed characteristics, the owner at birth of a dog of any breed for which registration is sought shall certify that both parents of the dog conform with the size, coat colour and characteristics, where applicable, of that breed as set out in the Club's breed standards.

Explanation for Amendment: The Canadian Kennel Club has been working with Agriculture Canada on some changes to the registration process. The above represents the first of several steps that will refer to breeding qualification characteristics. These characteristics have been determined within our existing breed standards and these characteristics will be able to be used for registration purposes.

In this age of concern for the genetic health of purebred dogs, it is imperative to preserve the intrinsic qualities that make each breed unique. To identify these qualities and to define what should and should not be encouraged, the CKC will be working with Specialty Breed Clubs to create the descriptors for each breed.

This new approach will bring with it modifications to the registration process. The aim of identifying breed characteristics is to raise the standard in the genetic health and the overall well being of our dogs. At a time where the purebred dog is often criticized by the public, Canadian breeders will now have a means to protect and defend their breeds by pointing to standards and controls in breeding practices.

This is a positive step taken by the CKC, working closely with Agriculture Canada, for the benefit of the purebred dog and their breeders.

PROPOSED AMENDMENT #33

Proposed Amendment:

It is proposed that Section 27.5, SPECIAL REGULATIONS – INDIGENOUS BREEDS, be amended as follows:

27.5 SPECIAL REGULATIONS – INDIGENOUS BREEDS

The Board may adopt and the Club may enforce special regulations designed to re-establish, or maintain, the following breeds: Canadian Eskimo Dogs, Retrievers (Nova Scotia Duck Tolling) Nova Scotia Duck Tolling Retrievers and Tahltan Bear Dogs. Such regulations on registration need not be consistent with customary registration procedures set forth in these By-laws but must be consistent with the provisions of the Act. No dog is to be considered automatically eligible for registration under this section. Each application shall be dealt with independently.

Explanation for Amendment: This amendment reflects the breed name as commonly used throughout the fancy.

PROPOSED AMENDMENT #34

Proposed Amendment:

It is proposed that Section 28.1, APPLICATION FOR REGISTRATION, be amended as follows:

28.1 APPLICATION FOR REGISTRATION

The owner, or owners, at the time of birth may make application for registration of a litter born in Canada. The form and manner in which such application is to be made shall be prescribed by the **Chub Board**. All such applications must contain the owner's, or owners', signature(s) as required in these By-laws.

Explanation for Amendment: This amendment makes it clear that it is the Board of Directors and not the Club that has the authority in accordance with Section 9.12 (c) of these By-laws to prescribe the form and manner in which applications are to be made.

PROPOSED AMENDMENT #35

Proposed Amendment:

It is proposed that Section 28.3, SIRE OF THE LITTER, Subsections (d) and (e) be amended as follows:

28.3 SIRE OF THE LITTER

An application to register the birth of a litter must contain the following information about the sire:

- (d) If owned by a resident of a country other than Canada and providing that the sire is not registered with the Club, a copy of the certified pedigree of the sire (showing a minimum of three (3) generations and the registered name and number for every dog in the pedigree), verified in writing by the owner as being current and accurate, must accompany the application for litter registration;
- (e) Where a foreign born sire is recorded in an American stud book recognized by this Club, the requisite copy of the certified three (3) generation pedigree shall be a copy of the pedigree issued in the country from which the dog was exported to the United States, verified in writing by the owner as being current and accurate.

Explanation for Amendment: The additional wording "verified in writing by the owner as being current and accurate" puts the onus on the owner to satisfy the Club that a copy of a document is both current and accurately reflects the original.

If this amendment receives approval, this additional wording will be added to the following sections of the By-laws in which reference is made to acceptance of copies: 29.3, 29.4 and 30.5.

Proposed Amendment:

It is proposed that Section 29.5, IMPORTED TO CANADA, Subsections (a) and (b), be amended as follows:

29.5 IMPORTED TO CANADA

A person resident in Canada who imports a dog may make application for registration of a dog imported to Canada provided that the following conditions can be satisfied:

(a) The application for registration of the dog is accompanied by a **copy of the** certificate of registration and additionally, in circumstances where required, **a copy of** an export pedigree, **verified** in writing by the owner as being current and accurate, issued by a club or organization whose stud book or record is recognized by the Club according to the provisions of Section 27 of these By-laws. The certificate shall include all of the following information: registered name of dog, foreign registration number, tattoo markings or microchip transponder characters (if dog was identified in its country of birth).

If the certificate of registration (or export certificate) sets forth the ownership of a resident of Canada, other than the resident of Canada who imported the dog to Canada, then the foreign certificate will shall not be accepted as a basis for registration of the dog in the records of the Club;

(b) The certificate referred to in (a) above includes, or is accompanied by an acceptable **copy of a** certified pedigree, which sets forth the known pedigree of the dog to a minimum of three (3) generations of ancestry, and that there is a registration number for every dog in the said pedigree;

Explanation for Amendment: The 2005 Special Referendum included proposals to amend various sections of the By-laws to allow for the acceptance of copies of certified pedigrees and registration certificates wherever reference was made to original documents. These proposals were approved by the membership and Agriculture and Agri-Food Canada on the understanding that the acceptance of copies does not impair the integrity of the registry and will simplify procedures as well as decrease costs for those registering dogs. Since Section 29.5 does not make reference to original certificates or pedigrees, this section was overlooked but for consistency sake it should be amended accordingly. The additional wording "verified in writing by the owner as being current and accurate" puts the onus on the owner to satisfy the Club that a copy of a document is both current and accurately reflects the original.

PROPOSED AMENDMENT #37

Proposed Amendment:

It is proposed that Section 29.11, AGE A FACTOR, be amended as follows:

29.11 AGE A FACTOR

Application for registration of a dog born in Canada three (3) years of age or over, which was not identified when less than one (1) year old, shall not be considered unless an affidavit by a letter from the first owner accompanies the application. Such affidavit letter shall set forth the reasons why the dog was not registered at an earlier date and must be satisfactory to the Recording Office. If the dog is not then in the possession of the first owner, identity must be established by the first owner and the owner shall also furnish the affidavit a letter which must be satisfactory to the Registration Committee.

Explanation for Amendment: Since the registration process is based upon the honour system, it seems overly stringent to require an applicant and owner to provide an affidavit. This will simplify procedures as well as decrease costs for those registering dogs.

PROPOSED AMENDMENT #38

Proposed Amendment:

It is proposed that Section 30.4, APPLICATION FOR CHANGE OF OWNERSHIP, Subsection (e), be amended as follows:

30.4 APPLICATION FOR CHANGE OF OWNERSHIP

The following rules apply to every application for registration of a change of ownership of a dog:

(e) Where ownership of a dog is transferred for a dog that is already registered, is transferred, the person selling the dog may request on the Application for Transfer of Ownership form that the new certificate of registration be sent to the new owner, in which case the Club shall do so. the Club shall send the new certificate of registration to the seller, who shall then be responsible for delivering the certificate to the new owner. If the certificate is returned to the Club, the Club may then send the certificate directly to the new owner.

Explanation for Amendment: In view of the Club's new business practice of mailing the certificate back to the sell-er/applicant rather than to the new owner in the case where a dog is already registered, it is necessary to amend this provision.

Proposed Amendment:

It is proposed that Section 31.4, CANCELLATION OF NON-BREEDING AGREEMENTS, be amended as follows:

31.4 CANCELLATION OF NON-BREEDING AGREEMENTS

A non-breeding agreement may be cancelled by applying in writing to Head Office on the appropriate form. Such application shall be accompanied by the required fee and the original registration certificate; the latter of which shall subsequently become the permanent property of the Club. The application for cancellation must be signed by all persons who were parties to the original nonbreeding agreement, therefore indicating that they are all in full and complete agreement with the cancellation of the non-breeding agreement. If the dog was returned to the initiator of the non-breeding agreement, only the consent of the original vendor of the dog shall be required to cancel the non-breeding agreement. In addition In all other cases, the consent of any or all intervening owners of the dog may also be required, if such owner(s) so indicated in the appropriate section of any subsequent non-breeding agreement(s) which they, as intervening owner(s), may have obtained at the time of any of the respective sales. Cancellation of a non-breeding agreement with regard to any particular dog does not prohibit the subsequent recording of another such agreement with regard to that same dog.

Explanation for Amendment: This amendment simplifies the wording and allows the initiator of a non-breeding agreement to cancel an agreement when a dog is being returned without having to seek the approval of any interim buyers in order to do so.

PROPOSED AMENDMENT #40

Proposed Amendment:

It is proposed that Section 34.3, LEASE NOT VALID FOR SHOWS AND EVENTS, be deleted:

DELETE

34.3 LEASE NOT VALID FOR SHOWS AND EVENTS

Leases are not accepted for the purpose of entering a dog of either sex in dog shows or other CKC events. The right to exhibit a dog cannot be transferred by the person who actually owns the dog.

Explanation for Amendment: This is a contractual matter between two parties and has no place in by-laws.

PROPOSED AMENDMENT #41

Proposed Amendment:

It is proposed that Section 35.2, NOTICE OF FEE INCREASES, be amended as follows:

35.2 NOTICE OF FEE INCREASES CHANGES IN FEES

The Board shall have the authority to set new fees and **revise change** current fees for any and all services provided by the Club. Upon any of the fees being changed, notice of such changes shall be published in the Official Publication and such notice shall be published sufficiently in advance so as to provide at least **sixty (60) thirty (30)** days advance notice of such changes.

Explanation for Amendment: In general, the same wording should appear in both the heading of a provision and in the body or text of the provisions, and it should also be consistent within the text. In the existing text, two different words are used to mean the same thing – "revise" and "change". The change to thirty (30) days from sixty (60) days reflects the ability to publish the information much more quickly given that the Official Publication is now posted on-line and there is much less lead-in time for material to be submitted. Thirty (30) days is considered to be a reasonable period of time to provide notice to the membership and because the by-law reads "at least", the Board has the authority to direct that more advance notice be given if deemed necessary.

PROPOSED AMENDMENT #42

Proposed Amendment:

It is proposed that Section 36.6, ELIGIBILITY TO VOTE IN REFERENDUM, be amended by removing the word "Regular" in (a) and anywhere else it appears as "Regular Member" in the By-laws, with the exception of Section 7.1 – see **Proposed Amendment #8**. Section 36.6 would then read as follows:

36.6 ELIGIBILITY TO VOTE IN REFERENDUM

In order to be eligible to vote in a referendum, a member must first meet all of the following requirements on the date the Official Voters List is created and again on the date the ballots are mailed:

- (a) be a **Regular** Member in good standing;
- (b) be a resident of Canada;
- (c) have completed one (1) year continuous membership in the Club;
- (d) have attained the age of nineteen (19) years

Explanation for Amendment: To bring Section 36.6 in line with Section 12.3 (i) in which reference to "Regular" has been removed given the proposal to amend Section 7.1. See **Proposed Amendments #8 and #16.** If the amendments to Sections 7.1, 12.3 (i) and 36.6 (a) pass, all reference to "Regular Member" in the By-laws, with the exception of Section 7.1, will be replaced with "Member".

Proposed Amendment:

It is proposed that Section 36.7, TIMING OF REGULAR REFERENDUM BALLOT, be amended as follows:

36.7 TIMING <u>AND VOTING</u> OF <u>IN</u> REGULAR REFERENDUM BALLOT

A Regular Referendum ballot on proposed amendments must be distributed along with and at the same time as the ballots in connection with shall be conducted at the same time as the election of the Board under Section 12, and Sections 12.11, 12.13 and 12.14, and the first sentence of Section 12.15, shall apply to such Regular Referendum.

Explanation for Amendment: To bring Section 36.7 in line with Section 12 should the proposed amendment of that Section pass.

PROPOSED AMENDMENT #44

Proposed Amendment:

It is proposed that Section 36.8, THE BALLOT, first paragraph be amended as follows:

36.8 THE BALLOT

Under the direction and supervision of the Election Commission and after August 31ST in the year of the triennial election of the Board, the following arrangements shall be made for the **printing distribution** of the referendum ballot and so far as possible, the ballot should take the following form:

Explanation for Amendment: This gives the option of a paper or electronic ballot.

PROPOSED AMENDMENT #45

Proposed Amendment:

It is proposed that Section 36.10, MAILING AND RETURN OF REGULAR REFERENDUM BALLOTS, be deleted:

DELETE

36.10 MAILING AND RETURN OF REGULAR REFERENDUM BALLOTS

Since a Regular Referendum ballot must be distributed at the same time and along with the election ballot, as per Section 36.7 of these By-laws, the mailing dates and closing dates for the referendum shall be the same as that for the election and as referred to in Sections 12.12 and 12.13 of these By-Laws.

Explanation for Amendment: This is now superseded by the proposed new wording to Section 36.7 – see **Proposed Amendment #43**.

PROPOSED AMENDMENT #46

Proposed Amendment:

It is proposed that Section 36.11, COUNTING THE BALLOTS, be amended as follows:

36.11 COUNTING THE BALLOTS

The Election Commission shall forthwith, after the last day for receiving referendum ballots, open the envelopes and proceed to count the votes; or with the Board's approval, counting of votes may be delegated to Head Office staff under the direction and supervision of the Election Commission.

Explanation for Amendment: This gives the option of a paper or electronic referendum ballot.

PROPOSED AMENDMENT #47

Proposed Amendment:

It is proposed that Section 36.14, SPECIAL REFERENDUM AMENDMENTS, Subsections (d), (e) and (f) be amended as follows:

36.14 SPECIAL REFERENDUM AMENDMENTS

Notwithstanding anything herein contained, whenever in the opinion of the majority of the Board, early amendment of an existing By-law, or the enactment of a new By-law is considered desirable, the Board shall have the authority to order a Special Referendum ballot. The process of proposing Special Referendum amendments to the membership is as follows:

- (d) The Election Commission shall be responsible for the mailing distribution, receipt and counting of the ballots or, with the prior approval of the Board, counting of votes may be delegated to Head Office staff under the direction and supervision of the Election Commission;
- (e) Balloting for Voting in a Special Referendum shall not close less than be open for at least thirty-one (31) days after the ballot was mailed distributed;
- (f) In the event that a Special Referendum is held in conjunction with an election, the mailing date and closing date for the Special Referendum shall be the same as that for the election as referred to in Sections 12.12 and 12.13 of these By-laws of the Board under Section 12, Sections 12.11, 12.13 and 12.14, and the first sentence of Section 12.15, shall apply to such Special Referendum.

Explanation for Amendment: Revisions to bring in line with Section 36.7 – see **Proposed Amendment #43**.
