#### **PURINA NATIONAL:** A CKC CHARITY EVENT UPDATE

The Purina National: A CKC Charity Event has been put on hiatus for 2013 due to budgetary constraints imposed by lead sponsor Nestlé Purina.

Purina advised the CKC of a change to its funding formula and restated their objective of maintaining the same level of elegance and marketing value for the show. The CKC and the Purina National Committee analyzed many scenarios under these reduced circumstances but were unable to meet Purina's sponsorship goals without undertaking unacceptable risk to CKC.

CKC then presented corporate sponsorship opportunities for the National to both Procter & Gamble and Royal Canin, but neither could seize the opportunity due to time and budget constraints. Please check the CKC website for updates.

### REPORT OF THE APPEAL COMMITTEE



The following is a report of the decisions reached by the Appeal Committee at its meeting held October 31, 2012.

#### Appellant: Gwen Haynes, Calgary, Alberta, CKC Member (Respondent – Deborah Haynes)

#### Registration Committee's Findings:

Gwen Haynes' request to transfer the dog, Maplemore Aru the One Evrmor, into her sole ownership was denied.

#### Appeal Committee's Findings:

Dismissed the appeal and upheld the decision of the Registration Committee.

#### Appellant: Pamela Legault, Princeton, BC, CKC Member (Respondent – Jillian Taylor)

#### Discipline Committee's Findings:

Reprimanded for failing to abide by the Code of Ethics. Furthermore, the Discipline Committee levied costs of the investigation and hearing in the amount of \$100.00.

#### Appeal Committee's Findings:

Upheld the appeal and overturned the decision of the Discipline Committee in whole. Furthermore, the Appeal Committee directed that the appeal fee be refunded.

# Appellant: Jillian Taylor, Cambridge, Ontario, Non-Member (Respondent – CKC)

#### Discipline Committee's Findings:

Membership terminated for 8 years commencing October 20, 2010, for failing to abide by the Code of Practice for CKC Member Breeders and acting or performing in a manner deemed as contrary to the basic principles and Objects of the Club and contrary to the best interests of the Club and its members.

#### Appeal Committee's Findings:

Upheld the appeal and varied the penalty from 8 years to 6 years membership termination as of October 20, 2010. Furthermore, the Appeal Committee directed that the appeal fee be refunded.

# Appellant: Johnangel Voyager, Villa Nova Waterford, Ontario, CKC Member (Respondent - CKC)

#### Discipline Committee's Findings:

Debarred for 90 days for exhibiting dogs in the Stud Dog & Get Class that had not been entered in a Regular Class. Furthermore, the Discipline Committee levied costs of the investigation and hearing in the amount of \$250.00.

#### Appeal Committee's Findings:

Dismissed the appeal and upheld the decision of the Discipline Committee; therefore, Johnangel Voyager was debarred for 90 days commencing November 16, 2012, and assessed \$250.00 administrative costs.
