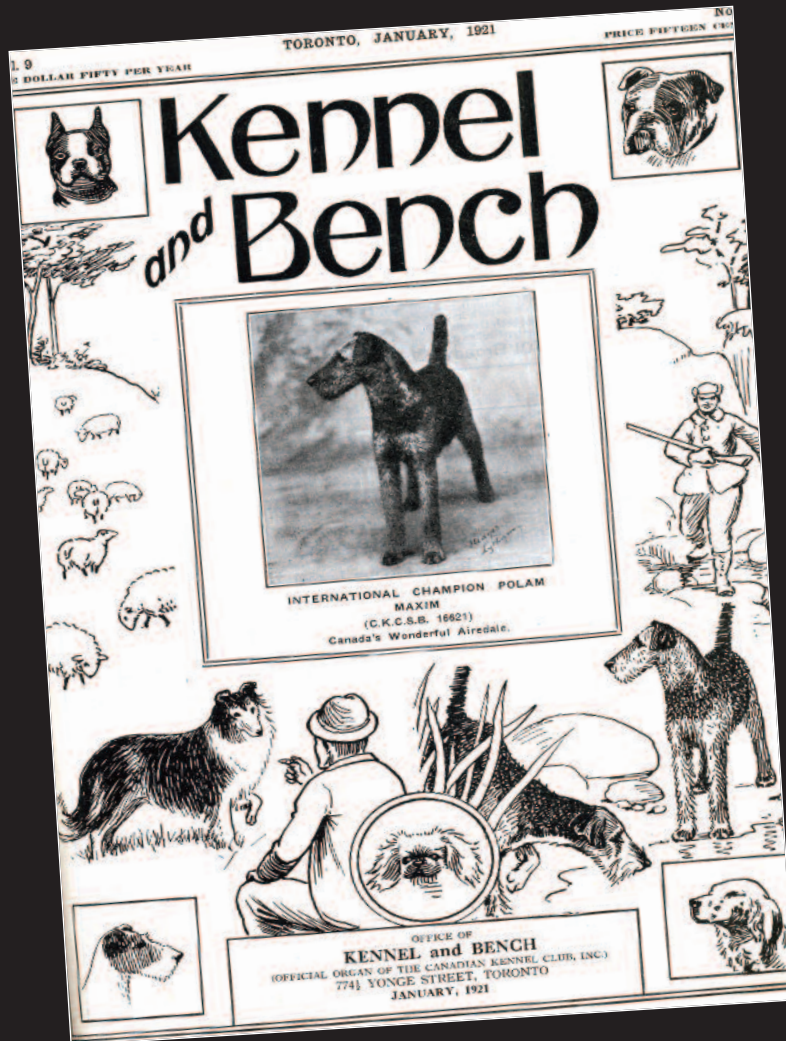

## OFFICIAL RESULTS FOR THE 2011 SPECIAL REFERENDUM

CKC received a majority (more than 50%) affirmative vote of the votes cast in this Special Referendum ballot and, therefore, Proposed Amendments #2 - #47 passed.

Proposed Amendment #1— Amend the Spelling of the Cesky Terrier to Czesky Terrier, failed because the required support as set out in the Animal Pedigree Act was not achieved.

The Election Commission's report will now be submitted to the Minister of Agriculture and Agri-Food Canada to consider approving the Special Referendum and the membership will be notified as soon as the results are known.
