#### AMENDMENT TO POLICY AND PROCEDURES MANUAL RE: JUDGING CONFLICTS

Attention: CKC Conformation Judges

Please be advised that at the March 2012 meeting of the CKC Board of Directors, the following Motion was passed.

"THAT, effective July 1, 2012, the Policy and Procedures Manual, Chapter VI, Section Q, be amended by adding a new section to read as follows:

- 7. Judging Conflicts
  - (a) Conformation judges accepting assignments with non CKC clubs in Canada will be required to report such assignments to CKC Head Office. Failure to report such assignments will be subject to 4.2.2 of the Conformation Show Rules & Regulations.
  - (b) The report must contain the name of the Club, the show location and all breeds and/or classes to be judged.
  - (c) Assignments with non CKC clubs will be subject to Section 4.2.2 of the CKC Conformation Show Rules & Regulations. An administrative charge as set by the Board will be levied against any judge who violates this provision in the rules. Disciplinary action and possible loss of judging privileges may be taken against repeat offenders."

CKC licensed Conformation Judges should report this information directly to the Event Planning Department, in the Shows and Trials Division, via mail, fax, or e-mail (contact information below). Please ensure that there is a subject line at the top of the page that states "Judging Conflicts".

#### AMENDMENT TO POLICY AND PROCEDURES MANUAL RE: EVENT SUPPLIES

Attention: CKC Accredited Event Holding Clubs & Event Secretaries

Please be advised that at the March 2012 meeting of the CKC Board of Directors, the Board passed the following motion with respect to Event Supplies.

"THAT, the Policy & Procedures Manual, Chapter VI, Section H, Show Supplies, be amended effective July 1, 2012 to read as follows:

- H. Event Supplies
  - (a) Upon approval of Judging Panel Applications the club will be provided with a Supply Requisition Form. The Supply Requisition Form will be forwarded electronically; however, it will also be made available on the CKC website.
  - (b) Clubs will be responsible for completing the Supply Requisition Form, and submitting it to the Order

Desk at Head Office for processing a minimum of 60 days prior to the first day of the event.

- (c) The Canadian Kennel Club shall issue the appropriate certificates for each event.
- (d) The Event Secretary will be required to ensure that the owner/handler of the eligible dog is given the appropriate certificate. The certificate will contain the name of the award and the remainder of the certificate will be left blank.
- (e) Orders for event(s) supplies received within 3 weeks (21 days) of the event(s) will be shipped, in the most reasonable and cost effective manner. The club will be charged for a courier if required. All requests for supplies ordered within 21 days of the event(s) will be charged a handling fee of \$100.00 plus tax.

In order to ensure that your event supplies are received on a timely basis and to ensure that sufficient quantities are in stock, we ask that clubs order their supplies a minimum of 60 days prior to the start of the event. When supplies are ordered within 21 days of an event, forms may not be available and orders are held up in order to print. This then causes other orders to be set asisde so that the late orders can be fulfilled.

The handling fee will only be charged to clubs when the order is received within 21 days of the event(s). The handling fee will be invoiced to club account.

We will continue our practice of not charging for supplies or handling fees, providing the order is not received within 21 days of the event(s).

#### AMENDMENT TO CONFORMATION SHOW RULES RE: PUPPY GROUP

#### Attention: Clubs Holding Conformation Shows

Effective September 1, 2012, clubs may elect to offer four Group placings in the Puppy Group. This information must be printed in the Premium List.

The following amendment to the Conformation Show Rules, Section 12.3.1 (h) was passed by the Board in March:

- 12 BREEDS, CLASSES, AWARDS & SWEEPSTAKES
- 12.3 Awards
- 12.3.1 The following official awards may be made at the discretion of the officiating judges following the judging of the regular breed class. No dog eligible to compete for

any of these awards may be withheld from competition except if excused by the Show Superintendent. Any exhibitor withholding a dog in contravention of this rule shall be subject to disciplinary action. Only those dogs which are defeated directly or indirectly are eligible to compete for the awards listed below.

(h) Best Puppy In Group

All Best Puppies in the breeds. Judging follows the group level judging. **Clubs may elect to offer four Group placings in the puppy Group. This information must be printed in the Premium List.** If a puppy is awarded a placing in the regular group, the Best Puppies in those breeds placing higher in the group level compete against that specific puppy for this award. A puppy awarded Best Puppy In Group is not required to stay for Best Puppy In Show.

## **TOP DOG AWARDS COMING SOON**

It's good to know that the CKC has undertaken the compilation of the Top Dog Awards previously prepared under the auspices of Dogs in Canada magazine.

The Dogs in Canada Top Dog award system has been going strong since it was established in 1963 and continues this summer as a valued and highly anticipated aspect of the Canadian dog fancy.

The 'unofficial' Conformation results will be released mid-June, followed by Obedience, then Agility, and wrapping it all up with Field Trial results, including Retrievers, Pointers and Lure Coursers.

Unlike previous years, when the Top Dog results were a major part of the summer/fall issues of Dogs in Canada magazine, this year you will be able to view the results online. The posting of the 'unofficial results' will allow a final check by the contenders and will be available publicly for a 30-day period before the 'official results' are confirmed and awards sent out. If there are any discrepancies in our 'unofficial results', those challenging the information will have the opportunity to register their concerns via a special email address and should provide documentation supporting their request for changes in any status.

We will be pleased to provide more details as the project unfolds, but the message today is that Top Dog Awards are coming soon...and that<sup>1</sup>s good to know!
