



## CKC UPDATE ON NEW BREED APPLICATIONS

The 2013-2015 Strategic plan for the Canadian Kennel Club calls for tactics to promote "Growth of the Canadian Dog Fancy". At the March 2012 Board of Directors meeting Director Alan Ewles, was tasked with heading an Ad-Hoc Committee to support applications for new breeds to the miscellaneous class that could lead to event participation and the potential of moving towards full recognition of the breeds. He reported that over the past three months he has received interest from owners of approximately 30 FCI recognized breeds wishing to be included on the list of CKC Miscellaneous Breeds.

<u>Procedure RG004 of the Policy and Procedures Manual</u> lays out the comprehensive process and information required for these applications. This policy should be reviewed by those interested in making an application.
