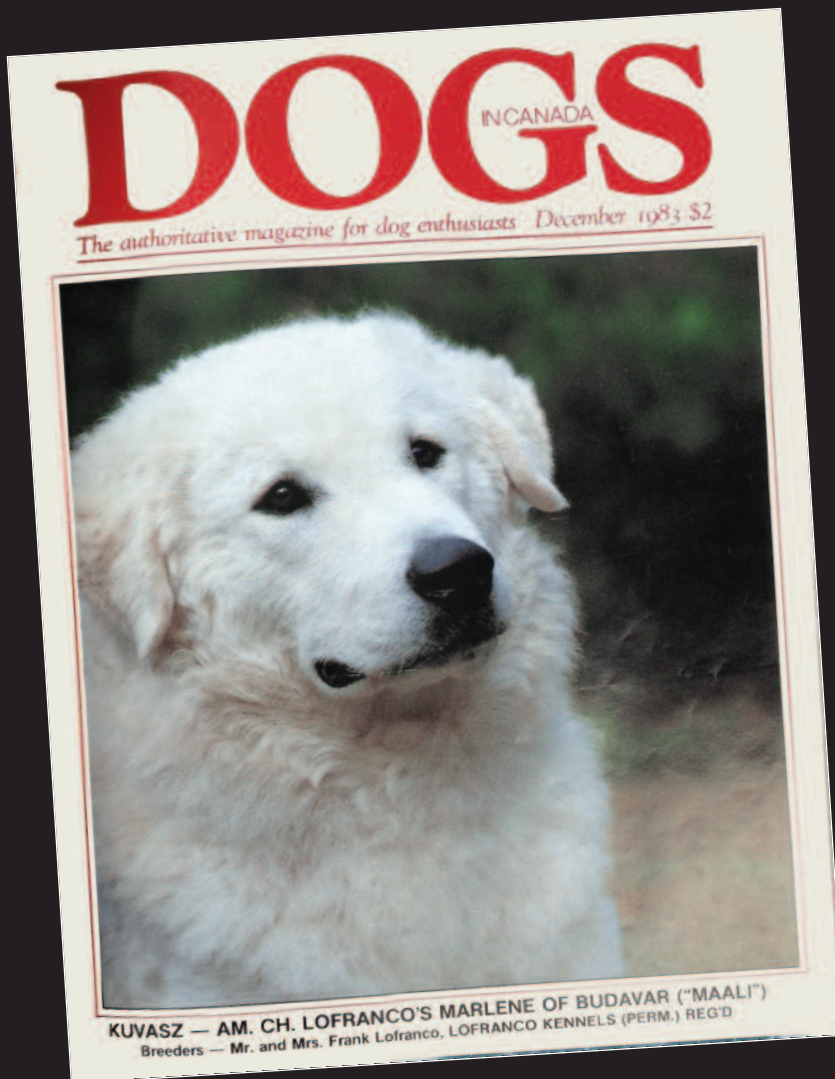

## WINTER AIR TRAVEL RESTRICTIONS FOR PETS

Due to chilly temperatures and increased passenger and cargo loads expected over the holiday season, Air Canada winter restrictions are in effect for the transportation of all pets, including shipments from breeders, kennels and freight forwarders.

Specifically, Air Canada and Jazz are unable to transport pets within North America as checked baggage or via Air Canada Cargo from December 15, 2013 to January 12, 2014. Also note that pets weighing less than 4.5 kg (10 lb) cannot be accepted as checked baggage on any Air Canada aircraft from November 1, 2013 to March 31, 2014 (or when the temperature is 0°C or less). Also note that at any time when the temperature is below 7°C, Air Canada Cargo may not be able to accommodate animals.

Holiday embargo dates also apply to pets travelling as checked baggage via WestJet. WestJet will not accept animals as checked baggage from December 15, 2013 to January 6, 2014. From December 11 to December 14, 2013, and from January 7 to January 10, 2014 a maximum of two animals will be accepted as checked baggage. Also note that WestJet Cargo is unable to transport pets from December 13, 2013 to January 8, 2014.

As many countries place restrictions on the entry of animals, be sure to contact the embassy or consulate of your destination country for specific requirements.

## UPDATE FROM THE RESPONSIBLE DOG OWNERSHIP COMMITTEE

The mandate of the Responsible Dog Ownership Committee is to further The Canadian Kennel Club's position on dangerous dogs and responsible dog ownership. Additionally, it is responsible for all matters relating to the amendment or development of municipal, provincial and federal legislations which affect dogs, dog owners and breeders.

In the past the Committee has been active in the following areas:

- Assistance to the membership in the monitoring of legislative agendas at all levels of government that impact responsible dog ownership.
- Provision of input to new/revised dog legislation informing the drafters of the impact on dog owners and breeders, and supporting their efforts to ensure the best possible fit with the dog fancy.
- Review of CKC Policy Statements related to Responsible Dog Ownership and recommend changes as needed.
- Building working relationships with industry organizations such as the Canadian Veterinary Medical Association, Veterinary Colleges, and the Canadian Federation of Humane Societies, among others.

In the coming year, the Committee plans to provide regular reports on its work, including staging a table of regional updates on related activities. As well, the Committee would like to hear from members who have specific issues and concerns they would like addressed. The Responsible Dog Ownership Committee is comprised of two Board members (Dwain McLean, NB and Larry Kereluke, MB) and three CKC members with the following credentials: one Dog Legislation Council of Canada executive member (Leeann O'Reilly, NL), one CKC Foundation Member (Dr. Rod Jouppi, ON) and one member with experience working on responsible dog ownership issues (Naomi Kane, ON).

## IN MEMORY OF JUDGE LAWRENCE "SKIP" STANBRIDGE



It is with great sadness that we must pass on the news that Lawrence "Skip" Stanbridge has passed away. Skip was the current Chair of the CKC's Event Officiating Committee and was one of the principal contributors to the development of the Advanced Judge's Seminar.

Born in Brantford, Ontario, Skip went on to work at Mohawk College in Hamilton, although he had been retired for many

years at the time of his passing. Skip began breeding Belgian Shepherd Dogs in 1960 and Schipperkes in 1969. He applied to become a judge in 1974 and became an All-Breed Judge in 1982.

Over the years Skip was a club officer for several breed clubs, including President of the Belgian Shepherd Dog Club of Canada and Vice-President of the Schipperke Club of Canada.

Chairman of the CKC Board Michael Shoreman had this to say about Skip, "I was proud to have him as a friend. He was a friend, teacher, and trusted mentor to many in Canada and throughout the world of purebred dogs. An internationally respected judge and strong supporter of the Canadian Kennel Club - he was known for his expertise, kindness and great sense of humour.

He will be missed by us all - we will continue to cherish our memories of Skip and be led by his example".

## REMEMBERING LINDA MILLMAN



We are sad to report the recent passing of CKC Life member and CKC Conformation Judge, Linda Millman.

Linda's passion for the fancy was reflected in her breeding and showing of purebred dogs for over 40 years - in particular, Irish Setters, German Shorthaired Pointers, Shetland Sheepdogs and Affenpinschers.

She was an active member of the purebred dog community and has held a number of roles such as CKC Dog Show Representative for Zone 7, for five years, as well as serving on the CKC Discipline Committee. More recently, Linda was the Register of Merit Canada Chair for the Canadian Shetland Sheepdog Association and Ontario West Director for the Canadian Dog Judges Association.

A highly-respected All-breed Judge, Linda was privileged to judge in Canada, USA, South Korea, Japan, Australia, New Zealand, Ireland, Malaysia, Singapore and Colombia.

# REPORT OF THE APPEAL COMMITTEE



The following is a report of action taken by the Appeal Committee at the meeting held October 24, 2013.

**Appellant:** Cindy Lougheed, Chatsworth, ON,  
CKC Member

**Respondent:** Linda Owens, Bognor, ON, CKC Member

**Discipline Committee's Findings:**

Dismissed the complaint that Linda Owens knowingly signed and presented applications in relation to the registration and transfer of ownership of dogs that contained material false statements or representations.

**Appeal Committee's Findings:**

Upheld the decision of the Discipline Committee.

**Appellant:** Tina Porter, Minesing, ON, CKC Member  
**Respondent:** CKC

**Discipline Committee's Findings:**

Deprived for 5 years for failing to abide by the Club's Code of Practice for CKC Member Breeders; failing to provide a certificate of registration within 6 months of the date of sale; and, failing to properly identify a dog. Furthermore, the Committee levied costs of the investigation and hearing in the amount of \$250.00.

**Appeal Committee's Findings:**

Varied the penalty from 5 years to 2 years commencing November 8, 2013, and upheld the costs of the investigation and hearing in the amount of \$250.00.

**Registration Committee's Findings:**

Denied Valerie Rodger's request to transfer ownership of a dog into her name in order to facilitate registration of a litter reflecting herself as the registered owner of the dam at birth.

**Appeal Committee's Findings:**

Upheld the decision of the Registration Committee.

**Discipline Committee's Findings:**

Debarred 90 days for exhibiting unsportsmanlike conduct at a Beagle trial. Furthermore, the Committee levied costs of the investigation and hearing in the amount of \$100.00.

**Appeal Committee's Findings:**

Upheld the penalty including the costs of the investigation and hearing.
