## CKC STUDBOOKS NOW UP TO DATE

The five-year project of publishing CKC stud books since 1985 is now complete. Converting all the data into a format that was suitable for publication was a monumental task. Once each of the studbooks for the Canadian born dogs was ready, all the data for foreign dogs registered in each given year, had to be produced, scrubbed and formatted, and then incorporated into the book. In total there were 98 books produced covering the years from 1985 to 2012. This makes the studbook library 100% "up to date".

The stud books cover over 170 different breeds, including dogs imported to Canada, registered in the records of the CKC. Congratulations to Leila Bahorie and Hayley Boam, who were the leads, on achieving this tremendous milestone.

## MILESTONES

### In memory of Fred Heal

We are deeply saddened to acknowledge the passing of CKC Life Member and Founding President of the Canadian Dog Judges Association, Fred Heal.

Born and raised in Toronto, Fred began breeding Dobermans in 1961 under the Jagermeister prefix and showed numerous Dobermans to top awards. His most famous Doberman was Ch. Jagermeister's Sevencomeleven, affectionately known as "Sonny".

Fred had travelled quite extensively during his tenure with the RCAF during 1952-1962. After leaving the air force, he was employed as a manager and director with a host of iconic Canadian businesses and public service organizations including De Havilland Aircraft, M. Loeb Limited, Digital Equipment of Canada, Agriculture Canada and Canada Post.

Fred started judging in 1974. During his years as an exhibitor and judge he wrote for *Dogs In Canada* submitting over 100 "Breedlines" articles. He was also a regular speaker and presenter on a wide range of dog and Conformation judging subjects.

In 2011 Fred was the first recipient of the Senior Judge's Gold Pin from the Canadian Dog Judge's Association which honours Judges who have attained All-Breed status for a minimum of 20 years. His last assignment was this past August, at the Edmonton Kennel Club where he judged the Doberman Specialty.

Fred leaves behind his wife Barbara, step-son Mark and step daughters Laura and Lisa Warf.
