SYNOPSIS OF THE DECEMBER 2013 BOARD OF DIRECTORS MEETING

The following is a brief synopsis of the key items of business that were addressed at the December 7 & 8, 2013 meeting of the Board of Directors. The meeting was held in Etobicoke, Ontario. Please note that rules and policy changes shown below are paraphrased for the sake of brevity. In the event of dispute, the specific wording of such changes should be taken from the official minutes of the Board meeting. The detailed minutes of the meeting will be formally approved at the next regular meeting of the Board.

- 1) Minutes of the Board of Directors meeting held on September 14 & 15, 2013 were approved.
- 2) The following correspondence was received as information:
 - a) Correspondence from James M. Campbell re: Emeritus judge.
 - b) Correspondence to Mary Jane Weir apologizing for the difficulty she had when trying to enter the CKC office building to attend the September Board meeting.
 - c) Correspondence from Jason Foucault, President, The Canadian Eskimo Dog Club of Canada, requesting that the CKC consider sanctions on any Canadian Eskimo Dog and Greenland Dog being imported from Europe with the requirement that DNA testing be provided as proof the dog being imported is indeed purebred.
 - d) Correspondence from Jan Carpenter re: Basset Hound Club of Canada.
 - e) Correspondence from the Finnish Lapphund Club of Canada re: The inaccurate description of the Finnish Lapphund in the recent issue of Dogs in Canada Annual.
 - f) Correspondence from Brian Taylor re: Board conflict of interest.
- 3) A presentation was made by the Canadian Eskimo Dog Club.
- 4) The following reports were received as information:
 - a) The Chair's report.
 - b) The Executive Director's report, including key performance indicators.
 - c) The Audit Committee report and third quarter financial reports.
 - d) A Business Case for E-business
 - e) The Executive Performance & Compensation Review Committee report.
 - f) A DNA Registry Business Plan Update.
 - g) An update presentation from the Strategic Planning Committee.
 - h) A report on the new United States Department of Agriculture Animal and Plant Health Inspection Service rule to provide for humane care and treatment of animals that are bred for commercial sale, exhibited to the public, used in biomedical research, or transported commercially.
- 4) The 2014 CKC operating and capital budgets were approved.
- 5) The 2014 Apex budget was received as information
- 6) A motion was passed directing staff to review the current policy of awarding a yearly bursary and report to the June 2014 Board meeting.
- 7) The following Breed Standards were amended:
 - a) Canadian Eskimo Dog. The amendment was made to remove "dewclaws on rear legs" as a DQ.
 - b) Chesapeake Bay Retriever. The amendment was made to remove "dewclaws on hind legs" as a DQ.
 - c) Leonberger. The amendment was made to allow for dew claws to be present or removed.
 - d) Belgian Shepherd Dog. The amendment was made to allow for dew claws to be present or removed.
 - e) Kerry Blue Terrier. The amendment was made to remove "dewclaws on hind legs" as a DQ.
 - f) Norfolk Terrier. The amendment was made to allow for a docked or undocked tail.
- 8) A motion was passed to grant permission to the AKC to register the Russell Terrier (both dogs and litters) in their records until such time as the breed is registered by the CKC.
- 9) The appointment of the legal firm of Gowlings was extended to include the year 2014.
- 10) A motion was passed to allow Stormont, Dundas & Glengarry Dog Association and Cornwall District Kennel Club to return to their historical priority dates for the year 2014: SD&G August 22, 23 and 24 and Cornwall August 30, 31 and September 1.
- 11) An invitation to host the March CKC Board meeting at the Ontario Veterinarian College in Guelph was received and will be considered further.
