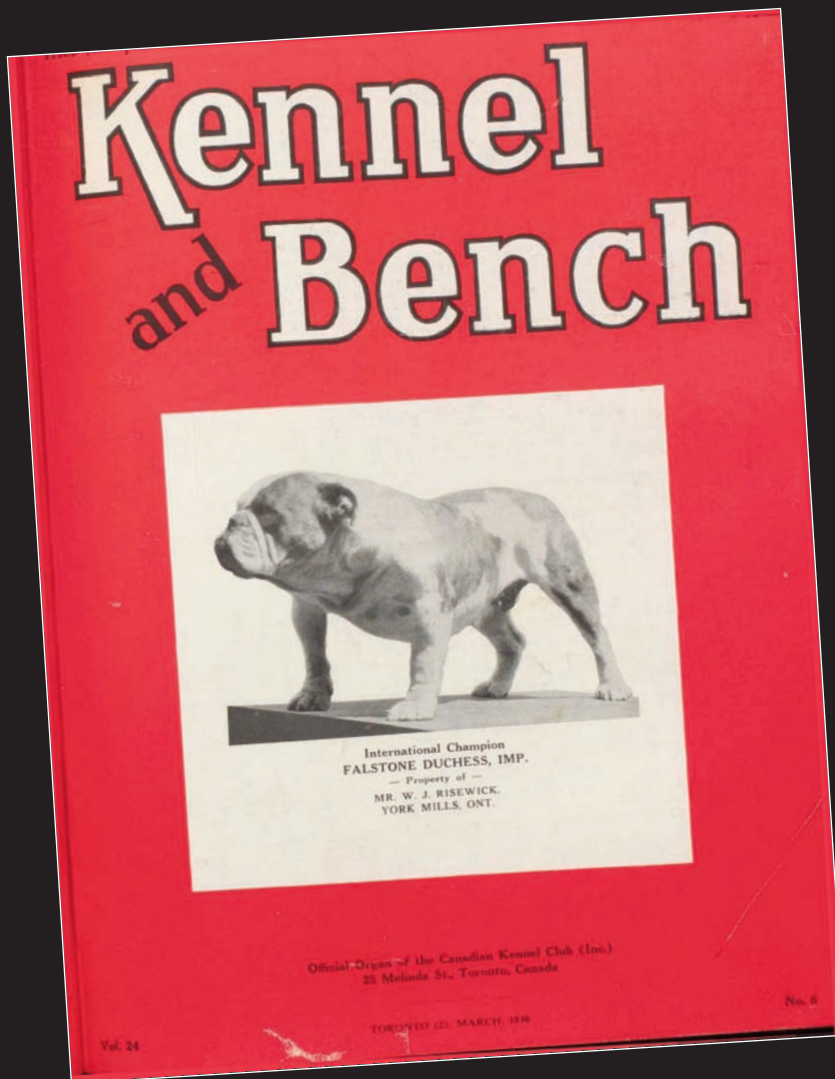

## UPDATED JUDGE'S DISQUALIFICATION/EXCUSAL FORM

The CKC has created a new Judge's Disqualification/Excusal Form to be used at Conformation Shows and Obedience Trials.

This new, triplicate form – which includes a copy for the Judge, handler and the CKC– will make the administrative process for Disqualified or Excused dogs more efficient for judges and exhibitors. The form now includes a list of reasons for Disqualification or Excusal (in accordance with the rules), which the Judge is required to indicate before providing a copy to the handler. The club must submit their copy for the CKC to Head Office with the event results.

The Judge's Disqualification/Excusal Form must be made available to each judge throughout the judging assignment. It is the judge's responsibility to complete the form if a dog is being disqualified or excused from the ring.

## 2012 TOP AGILITY DOG RESULTS NOW AVAILABLE



The CKC is pleased to announce that the results for the 2012 Top Agility Dogs are now available for review on the Dogs in Canada blogsite.

In the absence of a statistician and the inability to replicate the old methodology, the Agility Council devised its own point system. The CKC appreciates the consent of the Agility Council to premiere its point system and apologizes to Canada's top agility participants for the long delay.

The basis of the new point system was to acknowledge the efforts of as many teams as possible, by including participants from all levels of competition. With almost double the number of breeds represented in the 2012 stats, compared to 2011, the council's vision has been an unmitigated success.

The new system for the Top Agility Dog results will recognize the Top 10 all breeds, the Top 10 in each group and the Top 5 in each breed. Points are awarded to all Qualifying Scores earned in both Standard and Jumpers with Weaves classes at CKC agility trials based on the following point system: Novice, 2 points; Intermediate, 3 points; Excellent A (Excellent), 4 points; and Excellent B (Master Excellent), 5 points.

## TOP 10 CKC-REGISTERED BREEDS HOLD STEADY FOR 2013

The all-time most popular pick, Canadian indigenous breed, the Labrador Retriever, continues to rule the pack once again! The demand for this family favourite – also the most registered breed in the U.S. and U.K. – is so strong, that there was a small increase in Labrador Retriever registrations over last year.

The 2013 top ten list virtually mirrors the 2012 list, with two slight changes: the German Shepherd Dog moved back into the second spot – bumping the Golden Retriever back to third. The other change saw the Miniature Schnauzer move up to number nine, unseating the Bulldog – now at number 10.

## 2013 NATIONAL OPEN SPRINGER SPANIEL FIELD TRIAL CHAMPIONSHIP

The Central Ontario Spaniel Club was pleased to host the 47th Canadian National Open Springer Spaniel Field Trial Championship (CNOSST) October 12th, 2013 in Dornoch, Ontario. The Canadian National Open is considered to be the premier outdoor Spaniel event with game birds and is held in different locations across Canada each year.

With 66 entries from Canada and the U.S., the 2013 Canadian National Open featured some fine canine competitors, eager to flush out 559 pheasants that were planted throughout the trial.

Field Trial Chairman, Alex Smith and Field Trial Secretary Treasurer, Pat Epp, were on hand to start the trial - which consisted of five series on land and one at the water - and witnessed some fine performances from the canine contenders as they located and flushed out game, all while remaining steady (unmoving), until sent by their handler to retrieve the bird and deliver it to the handler.

The dogs' skills were really put to the test as the grounds were changed throughout the trial so that they could be judged under different conditions and wind directions.

All in all, the trial was a tremendous success, with thanks to Judges: Alice Stewart from Vermilion, Alberta and John Hapin of Vermont, U.S. for a job well done and special congratulations to the 2013 Canadian National Open Springer Spaniel Field Trial winners:
