

## **CKC LAUNCHES DIGITAL** ADVERTISING CAMPAIGN



The CKC Communications team is excited to share that CKC is once again investing in advertising in June and July with a goal of generating new interest in our Club and

new visits and awareness of The Puppy List.

To ensure visitors to the Puppy List have information on all CKC member breeders in Canada, we encourage Members to log into My Profile at www.ckc.ca/ckcmemberlogin.aspx, and opt in to have their information displayed online on The Puppy List.

The campaign began in Ontario in June with a full-page ad facing a full-page choosing-the-right-puppy editorial in the transit magazine On the Go, supported by PATH billboard advertising and one week on a big billboard on the Gardiner Expressway. This represented only 8% of the campaign budget.

The next phase of the campaign is an investment in digital advertising. Launched last week in English and French, this innovative campaign includes advertising on Facebook, Instagram and YouTube and targets Canadians who have already shown an interest in dogs through their use of social media, web searches and browser behavior.

## AKC SIRE VERIFICATION OF **OWNERSHIP ON CKC LITTER** APPLICATION

We are simplifying the registration process for Canadian breeders using AKC stud dogs for breeding purposes.

Currently, when using AKC-registered sires, Canadian breeders must submit the CKC Litter Application to the AKC for verification of the sire's name, registration number and ownership. The application will then be mailed from the AKC back to the Canadian breeder, unless the AKC is notified to mail the form directly to the CKC.

Going forward, once the litter application has been verified by the AKC, the AKC will forward the application electronically to the CKC for processing, only if a copy of the certified pedigree of the sire (showing a minimum of three (3) generations and the registered name and number for every dog in the pedigree) accompanies the litter application. The CKC will accept an electronic signature or approval stamp from the AKC on these applications.

If a copy of the sire's certified pedigree is already on file with the CKC, a note must be submitted with the litter application to the AKC in order for the application to be forwarded to the CKC. If the AKC receives the litter application without a copy of the sire's certified pedigree, or a note stating the pedigree is already on file with the CKC; the AKC will certify the application and return to the breeder.

This partnership will better assist our breeders with their litter applications sired by AKC-registered dogs.

## NOTICE TO CONFORMATION **CLUBS RE: LIMITED BREED SHOWS**

The following motion regarding Limited Breed Shows at Conformation Shows was passed at the June 2017 Board Meeting:

"THAT, the Policy & Procedures Manual, Chapter VI, Section M be amended by adding a new section to read as follows:

VI. SHOWS & TRIALS

M Conformation Events

## ADD NEW

- 1. Limited Breed Shows
  - A Club that has been approved to hold Multiple Shows, on any day of a 2, 3 or 4 day cluster will not be permitted to hold a Limited Breed Show at the same venue.

- An All-Breed Club requesting to hold a full group Limited Breed Show must obtain written permission from the Club Secretary or President of any full Group Specialty Club for the same breeds, which operate within 100 miles (160 km) of the venue for the Show(s). All Breed Clubs may hold Limited Breed Shows for specific 'Theme' breeds within CKC recognized Groups. These Limited Breed Shows cannot be for a full CKC recognized Group and must be based on a common thread within the breed specific characteristics. Written permission from Specialty Clubs is not required for Limited Breed Shows.
- Clubs holding regular All Breed Conformation Shows without limitations are permitted to hold either 1 Limited Breed Show for 1 full CKC recognized Group, or 1 Limited Breed Show for specific 'Theme' breeds within the CKC recognized groups per day. Clubs approved for more than 1 Limit Show, must include any combination of Limited Group Shows or Limited Breed Shows throughout the 2, 3 or 4 day event.
- All Limited Breed Shows must be approved by Shows & Trials Division in consultation with CKC Board member for that particular zone.
- Recording fees for all Limited Breed Shows will be the fee applicable to events where the total entry is 126 and over."

This motion is effective immediately. Therefore, Event Date Applications with Limited Breed Shows submitted to the CKC after June 9, 2017 will be approved in accordance with the above-noted policy.
