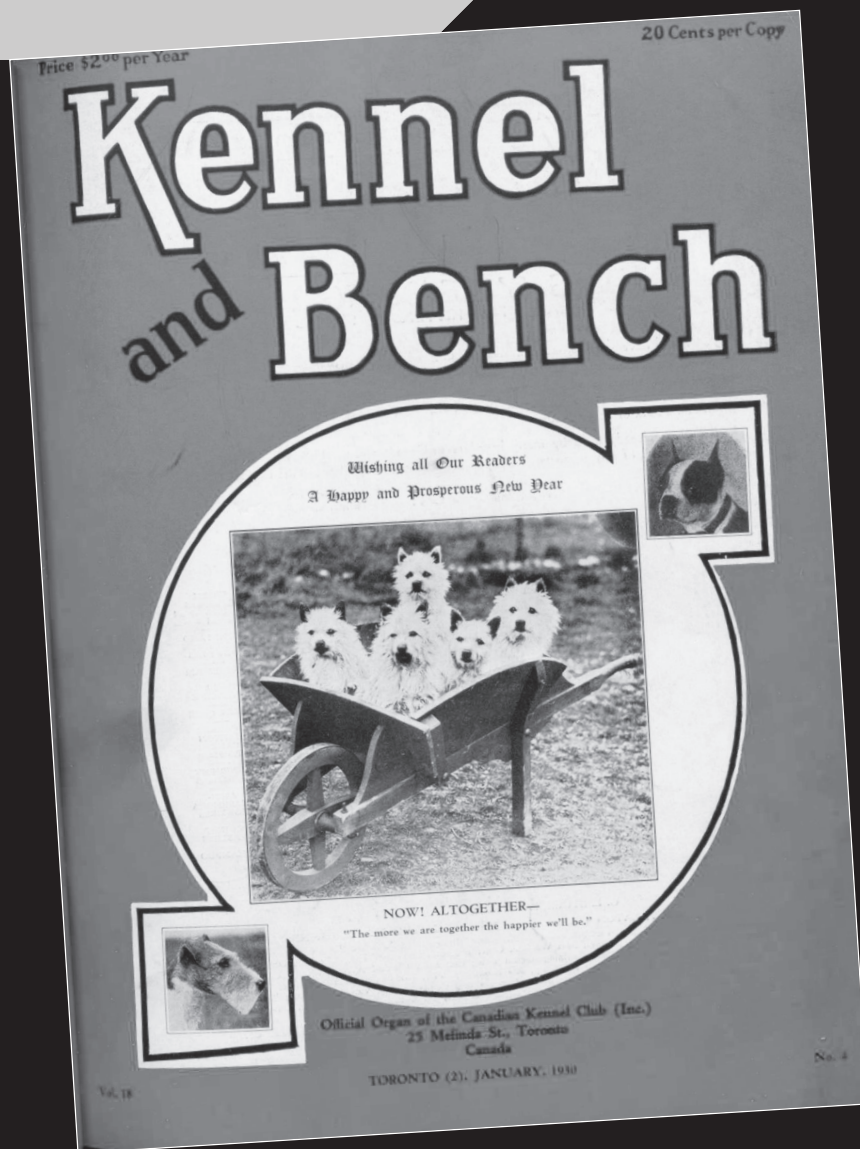

CKC SHOWS SUPPORT FOR MONTREAL SPCA LEGAL CHALLENGE TO BREED SPECIFIC LEGISLATION

Since breed-specific legislation was first proposed in Quebec and municipalities such as Montreal earlier this year, CKC has been working to affect positive change at the provincial and municipal level.

CKC opposes fear-based breed-specific legislation in favour of well-crafted dangerous dog legislation that is reasonable, enforceable and non-discriminatory. We believe that public awareness and education, stronger enforcement of existing bylaws and stiffer penalties for irresponsible owners is more effective at protecting the public.

In the spirit of collaboration, we have also reached out to like-minded organizations such as the Dog Legislation Council of Canada and the Montreal SPCA to build on our shared interests and mutual goals regarding BSL.

As you may know, the Montreal SPCA launched a lawsuit against the City of Montreal following the implementation of a breed-specific bylaw in September, seeking a judicial review and stay, to suspend the breed-specific provisions until a hearing on the merits could take place in Quebec's Superior Court. Despite a successful, though temporary stay, the breed-specific provisions of the bylaw were recently reinstated, but the Montreal SPCA plans to continue its efforts to fight the discriminatory Montreal bylaw and a hearing is expected sometime in the new year.

During recent discussions with the Montreal SPCA, CKC offered to promote their legal challenge and would like to ask our members to help CKC support this important initiative. For more information about how you can help, visit www.saferkindercommunities.com.

CKC CONGRATULATES MEMBER BREEDER ON WINNING PETS PLUS US BREEDER CHAMPION AWARD

CKC extends hearty congratulations to CKC member Carol Broadhurst and her kennel, Kortar Perm Reg. as the recipient of this year's Pets Plus Us Champion Breeder Award. "I am honored to be awarded the Pets Plus Us Champion Breeder Award," said Carol. "I am just so grateful to win it."

Carol has been breeding Siberian Huskies for over 45 years and Shiba Inu for 23 years. She is a life member of the CKC and

SHCC (Siberian Husky Club of Canada) and has enjoyed many highlights including the first Canadian Siberian Huskies to win International and World Championships, in addition to the oldest Siberian to be awarded BISS and BIS.

Carol has been actively involved with kennel clubs including serving as President of the Guelph Kennel Club, Co-Chair of the Cansave Dog Show Committee, director of both the SHCC and Shiba Inu Canada and President on two occasions of the Ottawa Kennel Club. She has also won the Pedigree Community Service Award.

The Kortar Siberians and Shibas have been successfully employed in non-traditional roles such as guide dogs and service dogs (both Shiba and Siberian). Carol recalls one noteworthy Siberian, Kortar's Kansee Kando, a Siberian was a guide dog and a special needs dog, who helped her blind autistic master to complete his high school diploma.

Carol is pleased to confirm that the donation associated with the award is going to Safepet Ottawa, an organization with which she has worked with since its founding and remains active on its board.

"We, as part of the board of Safepet Ottawa work with police, Rescue, veterinarians, social workers and shelters to provide a positive outcome," said Carol. "The model is now established and working and we offer to share the program with other kennel clubs in order to establish similar programs in their communities to promote a more positive attitude towards CKC breeders and clubs".

Carol explains that the Ottawa Kennel Club thought they could help SafePet Ottawa find shelter and provide safety for pets while their owners stayed in first stage shelters. Once they leave the shelters, owners are reunited with their pets. When Safepet Ottawa was founded, the Ottawa Kennel club hosted the first information meeting by police and shelters with invitations to veterinarians, breeders, boarding kennel owners and rescues to introduce the idea of a fostering program for pets for the period when a person goes into the first-stage shelters.

Carol further explains that many abused adults and children will not seek shelter because there isn't a place their pets can be protected from the revenge of an abuser when they leave, until the club offered a solution. "These animals are often the solace and friend, for both adults and children who have held them close in the stressful times. The pets are returned to the owners in better physical and mental health complete with some equipment to start their new lives when they leave the shelter."

Many volunteers are needed to make SafePet Ottawa work, from picking animals up at the vet offices where the owner takes the animals, transporting them to the foster home and returning them to the vet office for pick up. Volunteers such as coordinators of

volunteers and fosters, fundraisers and coordinators to oversee storage of donated items are essential for SafePet to be successful in helping the abused start their new lives.

"This donation will be of considerable assistance in helping SafePet Ottawa to continue its work," said Carol.

NOTICE TO PROFESSIONAL SHOW SERVICES AND CLUBS RE: SHOW SUPERINTENDENTS

Please note that the following motion was passed by the Board at its meeting in December 2016:

"THAT, the Policy & Procedures Manual, Chapter VI, be amended by adding a new section to read as follows:

VI. SHOWS & TRIALS

ADD NEW

Z. Role, Duty & Powers of the Show Superintendent

1. By definition, the Show Superintendent is in charge of the show (CSR Sec 5.1.2)
2. He takes direction from the Show Committee to guarantee the enforcement of all rules & regulations.
3. He must be familiar with all Conformation Show Rules & Regulations (CSR) and be able to answer questions on them from judges & exhibitors.
4. He should be on the site a minimum of 1 hour prior to the start of judging until 30 minutes after the completion of all judging, in order to accept any protest or complaint lodged under chapters 17 & 18. If he must leave the show site during the show, a responsible replacement must be appointed.
5. The Superintendent should make himself known to all the judges and inform them that he is the person to whom they should address any question.
6. The Superintendent must never attempt to discourage the lodging of any complaint or protest.

7. Specific references from Conformation Show Rules & Regulations (CSR):
- weighing dogs at request of judge (CSR Sec 4.6.1)
 - is in charge of the show (CSR Sec 5.1.2)
 - enforcement of all rules & regulations. Must have up to date rule book on site (CSR Sec 5.1.3)
 - removal of dog that bites or attempts to bite (CSR Sec 5.1.4)
 - removal of any person acting in an objectionable manner (CSR Sec 5.1.6)
 - may not be a judge at the show (CSR Sec 5.1.7)
 - must be a regular member in good standing with CKC (CSR Sec 5.1.8)
 - may not handle dogs at the show (CSR Sec 5.1.9)
 - shall file a report to CKC upon serious injury to, or death of, a dog due to negligence or misconduct (CSR Sec 5.1.10)
 - Amend errors on a judging sheet (CSR Sec 6.2.6)
 - removal of any person engaged in double handling (CSR Sec 9.4)
 - power to direct agent/owner to remove dog from crate of inadequate size (CSR Sec 9.7)
 - submit report to CKC regarding any hearing held regarding unsportsmanlike conduct (CSR Sec 11.5)
 - may excuse dog or exhibitor prior to official time of closing (CSR Sec 14.2.5)
 - endorse a veterinary permit for the removal of a dog due to illness (CSR Sec 14.2.5)
 - receive protest against a dog, before closing of show (CSR Sec 17.1)
 - receive complaint against person regarding rules & regulations, within 15 minutes of completion of judging (CSR Sec 18.2)

NOTICE TO ALL CONFORMATION AND OBEDIENCE CLUBS RE: PREMIUM LISTS AND JUDGING SCHEDULES

The following motion, regarding Chapter VI, Shows & Trials, Section Y, Judging Schedules, was passed at the December 2016 Board Meeting:

1. An administrative fee as identified in the Schedule of fees will be levied against any club that fails to ensure that the judging schedule is made available to exhibitors a minimum of six (6) days prior to the first day of the event. At the time of date approval, Head Office will remind clubs that they are responsible for ensuring that event secretaries post this information on line.

The fee was set at \$100.00 and will be posted in the Schedule of Fees.

Please note that clubs are required to provide the CKC with a copy of their Premium Lists and Judging Schedules. Effective

immediately, please forward a copy in PDF format, and we will post them on the CKC website at ckc.ca in the Calendar of Events. The Premium Lists and Judging Schedules should be forwarded to information@ckc.ca.
