## UPDATE ON QUEBEC BILL 128 AND BSL

Since breed-specific legislation was first proposed in Quebec and municipalities such as Montreal in early 2016, CKC has been working to affect change at the provincial and municipal level, and to offer our expertise and assistance in the development of alternative responsible dog ownership legislation that is reasonable, enforceable and non-discriminatory.

As you may be aware, the Quebec government recently introduced Bill 128: An Act to promote the protection of persons by establishing a framework with regard to dogs. The proposed laws include breed specific provisions that have the capacity to both ban dogs listed as “Potentially Dangerous” province-wide and ultimately provide a gateway for additional breeds to be added to this list at any time—potentially condemning all dogs in Quebec.

Dogs deemed potentially dangerous in Bill 128:

- pit bull, including American pit bull terriers, American Staffordshire terriers and Staffordshire bull terriers
- Rottweilers a crossbreed of a dog listed in points 1 or 2 and another dog
- hybrid dogs that are a cross between a dog and a canid other than a dog
- dogs trained to protect, guard, fight or attack

With the introduction of this Bill, CKC formed a Working Group that is dedicated to our advocacy plans in Quebec. CKC has also lent its support to a recent [DLCC campaign](#) to mobilize other like-minded organizations seeking to remove the breed-specific provisions of Bill 128, under the banner of Action Sécu. We have also collaborated with the National Companion Animal Coalition in seeking public consultations for Bill 128 and the opportunity to present to the Quebec Parliamentary Committee.

CKC has also engaged Quebec members, inviting them to take action and have their say about Bill 128, in support of well-crafted dangerous dog legislation and responsible dog ownership.

We continue to monitor activity surrounding Bill 128, including the development of regulations. Please watch for updates on our website as more information becomes available.

## TIPS FROM CDC\* FOR TRAVELING WITH DOGS TO THE UNITED STATES

If you're crossing the border with your dog, don't forget to pack its rabies vaccination certificate. Think of the certificate as your pooch's “passport” to enter the country.

Dogs entering the United States are required to be healthy and have proof of their rabies vaccination. Make sure to bring the

right documents or your dog might not be able to come home with you.

Five things you need to know:

- Dogs must be at least 3 months (12 weeks, or 84 days) old to get the rabies vaccination from a licensed vet.
- If it's the first time your dog is getting the rabies vaccination, you must wait 28 days before bringing it into the United States to allow the vaccine to take effect.
- If you're not sure or don't have proof your dog was vaccinated before, have your dog vaccinated, then wait 28 days before traveling.
- If your adult dog's rabies booster is current, you can travel without waiting 28 days.
- When your dog gets the rabies vaccine, ask the vet to give you the vaccine certificate. The rabies vaccination certificate must be valid when you're bringing your dog into the United States.

A valid rabies vaccination certificate has:

- Name and address of owner
- Breed, sex, age or date of birth (if known), color, markings, and other identifying information for the dog
- Date of rabies vaccination and vaccine product information
- Date the vaccination certificate expires
- Name, license number, address, and signature of veterinarian

Having the right documents for your dog allows you both to enjoy safe and worry-free travels.

## NOTICE TO CONFORMATION CLUBS RE: LIMITED BREED SHOWS

The following motion regarding Limited Breed Shows at Conformation Shows was passed at the June 2017 Board Meeting:

“THAT, the Policy & Procedures Manual, Chapter VI, Section M be amended by adding a new section to read as follows:

- VI. SHOWS & TRIALS
- M Conformation Events

### ADD NEW

1. Limited Breed Shows
  - a. A Club that has been approved to hold Multiple Shows, on any day of a 2, 3 or 4 day cluster will not

- be permitted to hold a Limited Breed Show at the same venue.
- b. An All-Breed Club requesting to hold a full group Limited Breed Show must obtain written permission from the Club Secretary or President of any full Group Specialty Club for the same breeds, which operate within 100 miles (160 km) of the venue for the Show(s). All Breed Clubs may hold Limited Breed Shows for specific 'Theme' breeds within CKC recognized Groups. These Limited Breed Shows cannot be for a full CKC recognized Group and must be based on a common thread within the breed specific characteristics. Written permission from Specialty Clubs is not required for Limited Breed Shows.
  - c. Clubs holding regular All Breed Conformation Shows without limitations are permitted to hold either 1 Limited Breed Show for 1 full CKC recognized Group, or 1 Limited Breed Show for specific 'Theme' breeds within the CKC recognized groups per day. Clubs approved for more than 1 Limit Show, must include any combination of Limited Group Shows or Limited Breed Shows throughout the 2, 3 or 4 day event.
  - d. All Limited Breed Shows must be approved by Shows & Trials Division in consultation with CKC Board member for that particular zone.
  - e. Recording fees for all Limited Breed Shows will be the fee applicable to events where the total entry is 126 and over."

This motion is effective immediately. Therefore, Event Date Applications with Limited Breed Shows submitted to the CKC after June 9, 2017 will be approved in accordance with the above-noted policy.

A dog record will contain all of the key information for that dog on a single screen. Examples of dog information include:

- Registration information
- Emergency recovery information
- Lineage including links to the dam and sire records
- Links to litters that dog has produced
- List of associated contacts such as the breeder and owner(s)
- Links to all associated documents such as pedigrees, litter and dog registration
- List of all titles and the dates they were awarded and links to certificates
- List of titles being worked on including current point totals
- List of events that the dog has participated on including points

Data clean-up, in preparation for data migration, continued and, as “data” is your Member information, Members can help this process by reviewing and updating their Member Profile at <https://www.ckc.ca/ckcmemberlogin.aspx>.
