

CKC PARTICIPATES IN FINAL STAGES OF BC CONSULTATIONS RE: PROPOSED STANDARDS OF CARE FOR BREEDERS AND SELLERS OF DOGS AND CATS

Since April 2016, CKC has been in talks with the BC government regarding the development of new animal welfare laws that will assist the BC SPCA in monitoring and taking action against irresponsible breeders. CKC members were also invited to participate in a BC government survey regarding dog and cat breeding to ensure their interests were well represented. The BC Consultation Summary Report revealed high CKC member engagement and spoke volumes about the dedication and commitment of our member breeders.

Prior to the introduction of <u>Bill 7 - 2017</u>: <u>Prevention of Cruelty</u> to Animals Amendment Act in March 2017 and throughout the consultation process, CKC has raised concerns about a BC government-proposed licensing or registration system. We have stressed that licensing and registration regulations would provide an unnecessary burden to CKC members in terms of cost, duplication and an extra layer of governance, as CKC members must already adhere to the CKC Code of Practice and Code of Ethics in order to retain membership. We also note that the CKC regulatory process has established very clear procedures with regard to enforcement and compliance to CKC by-laws and policies.

Earlier this month, CKC participated in the final round of consultations, with the submission of a consultation document regarding the Proposed Standards of Care for Breeders and Sellers/Brokers of Dogs and Cats in BC.

CKC reminded the BC government that most of our member breeders are hobby breeders and do not sell to pet stores or any third party retailer. We have made it clear that CKC cannot support regulations that do not include clearly defined terms for "Puppy Mill", "Seller" and "Commercial Breeder", resulting in all breeders being categorized as the same, whether they are responsible or not.

CKC has reiterated its expertise as a national representative of CKC member breeders and exerts that exemptions be made for CKC member breeders in good standing from any licensing or registration requirements in BC. We also recommend that the BC government adopt the CKC Codes and policies instead of developing and maintaining separate regulations.

BC government staff are now working on a summary of all consultations and proposed regulations will be submitted to the Ministry of Agriculture for approval shortly. The Ministry is looking to implement regulations by end of summer or early fall 2018. Please watch for an update on our website as more information becomes available.

CKC JUDGES OBSERVATION PROGRAM

Further to the Event Officiating Committee communication requesting volunteers for the new Conformation Judges Observation Program, we are pleased to announce that Area Coordinators have been selected. This new program was developed in an effort to maintain the integrity and high standards expected of CKC Conformation Judges. It will ensure consistency for conformation judges as well as exhibitors. There are Seven (7) Area Coordinators as well as observers in each of these areas. There is specific criteria identified in the policy to apply for these positions: an All-Breed judge, or a CKC

licensed judge with 3 or more groups, or CKC members with 10 years of breeding and exhibiting experience as well as 5 years' experience either as a show chair, show superintendent, show secretary or ring steward at conformation shows. REMINDER RE: CHANGES TO APPLICATION PROCESS TO IMPORT **DOGS UNIMMUNIZED AGAINST** RABIES INTO THE U.S.



As you may know, under limited circumstances, the U.S. Centres for Disease Control and Prevention (CDC) may issue a permit for a dog that has not received a

rabies vaccination, to allow dogs into the United States when requested in advance and when specific criteria are met.

For those who may not be aware, the CDC announced changes to the application process to bring a dog that is unimmunized against rabies into the U.S. effective August 18, 2017.

Under these changes:

- · Dog owners or dog owner's agents must apply online for a Permit to Import a Dog Inadequately Immunized against Rabies at least 10 business days before arriving into the United States with an unimmunized dog through this online system.
- Permit applications to import an unimmunized dog are no longer available at the port of entry and no permits will be issued at the port of entry.
- Unimmunized dogs arriving at a port of entry without an approved permit will be denied entry into the United States and re-exported to the country of origin at the owner's expense.
- If a permit application is denied, applicants may submit an appeal for further review by CDC.

Rules that remain unchanged:

Unimmunized dog permits are only given to US residents (or dog owner/dog owner's agent with a valid US address) and visitors staying 30 days or more in the United States.

It takes 30 days for a dog to be fully immunized. CDC will not issue an unimmunized dog permit for a temporary visit less than 30 days.

• This permit will include a **confinement agreement**, which is a legal document stating you will confine your dog in the United States until your dog is fully immunized against rabies.

Unimmunized Dog Permit Approval

CDC will review a permit application within 3–5 business days of receiving the application. If the application is approved, CDC will email the permit to the dog's owner. Only one permit per dog, per trip. You must provide a printed copy of your permit to a US Customs and Border Protection officer and your dogs will be inspected to confirm they are healthy and that the documentation reflects the age and look of the dog.

Standard Rabies Vaccination Requirements

Aside from the limited exceptions mentioned above, CDC regulations require that dogs must be fully immunized against rabies before being imported into the U.S. from a country where rabies is present. These requirements apply equally to all dogs, including puppies and service animals. The rabies vaccination must be administered no earlier than 12 weeks of age of the dog and at least 30 days before arrival at a U.S. port of entry. Therefore, the youngest that a puppy may be imported to the U.S. is 4 months of age. All dogs must be accompanied by a current, valid rabies vaccination certificate.

Dogs that have never been vaccinated against rabies must be vaccinated at least 30 days before arrival. Adult dogs older than 15 months of age that previously received a rabies vaccination given no earlier than 3 months of age and that has since expired may be imported immediately after booster vaccination, without the need to wait 30 days.

Other Regulations

Please note that owners/agents must also comply with regulations from both the US Department of Agriculture and your destination state. See ASPHIS' Pet Travel site.

To avoid disappointment at the border, breeders that transport dogs to the US are encouraged to confirm all importation rules and regulations prior to finalizing a contract with puppy buyers.

IT4YOU UPDATE: INTRODUCING **PAY-AS-YOU-GO PURCHASING**

As you likely know, CKC is moving forward with a completely revamped computer system, known as IT4YOU, which will offer members a much more enhanced user experience with tools that make doing business with CKC much simpler and faster. The new system will be pay-as-you-go, which requires a credit card, Visa Debit or cheque. It's fully secure and offers immediate turnaround for credit card and Visa Debit purchases, while those paying by cheque will have their applications held pending receipt of payment.

Beginning July 1, 2018, all orders must be paid up front and member credit will no longer be available. In order to ensure a smooth transition with the new system, we are requesting that members who have an amount owing, please settle their account before July 1, 2018.

For any members who have a credit balance on their account, there are three options:

- · Request that the credit be transferred to the new system (credit must exceed \$10).
- Donate the credit balance to CKC Foundation, for which a tax receipt will be provided (for donations of \$20 or more).
- · Request a refund be mailed to you.

CKC REMEMBERS DOREEN NEVRAUMONT



We at the Canadian Kennel Club are deeply saddened by the recent passing of Doreen Nevraumont.

As a CKC member for 48 years, Doreen gave back to the Club, serving as a CKC Board Director for Manitoba from 1985 - 1999. Doreen was also a past Chair of the CKC Conformation Council and the CKC Breed Standards Committee.

A passionate breeder, Doreen raised and showed Smooth Fox Terriers for approximately 35 years under the prefix "WishBone" and was very much involved in the former Smooth Fox Terrier Club of Canada.

Doreen was also a pioneer of the Red River Terrier Association, joining in 1969, and throughout her time was president for four terms and secretary at other times. No matter her position, Doreen was essential to the smooth running of the Annual specialty. The Red River Terrier Association remembers Doreen as a wonderful mentor and a great "terrier-woman".

Doreen was an incredible advocate as reflected in her work as a member of The Standing Committee on Agriculture in 1996, when she helped design Manitoba's Animal Care Act. She was also a contributor to the University of Saskatchewan's Companion Animal Health Fund and founded the canine tattoo registry in Manitoba for lost and stolen dogs.

Doreen's tremendous contributions to the CKC and the purebred world will always be remembered and she will be missed terribly. Our thoughts are with Doreen's family and friends at this difficult time.
