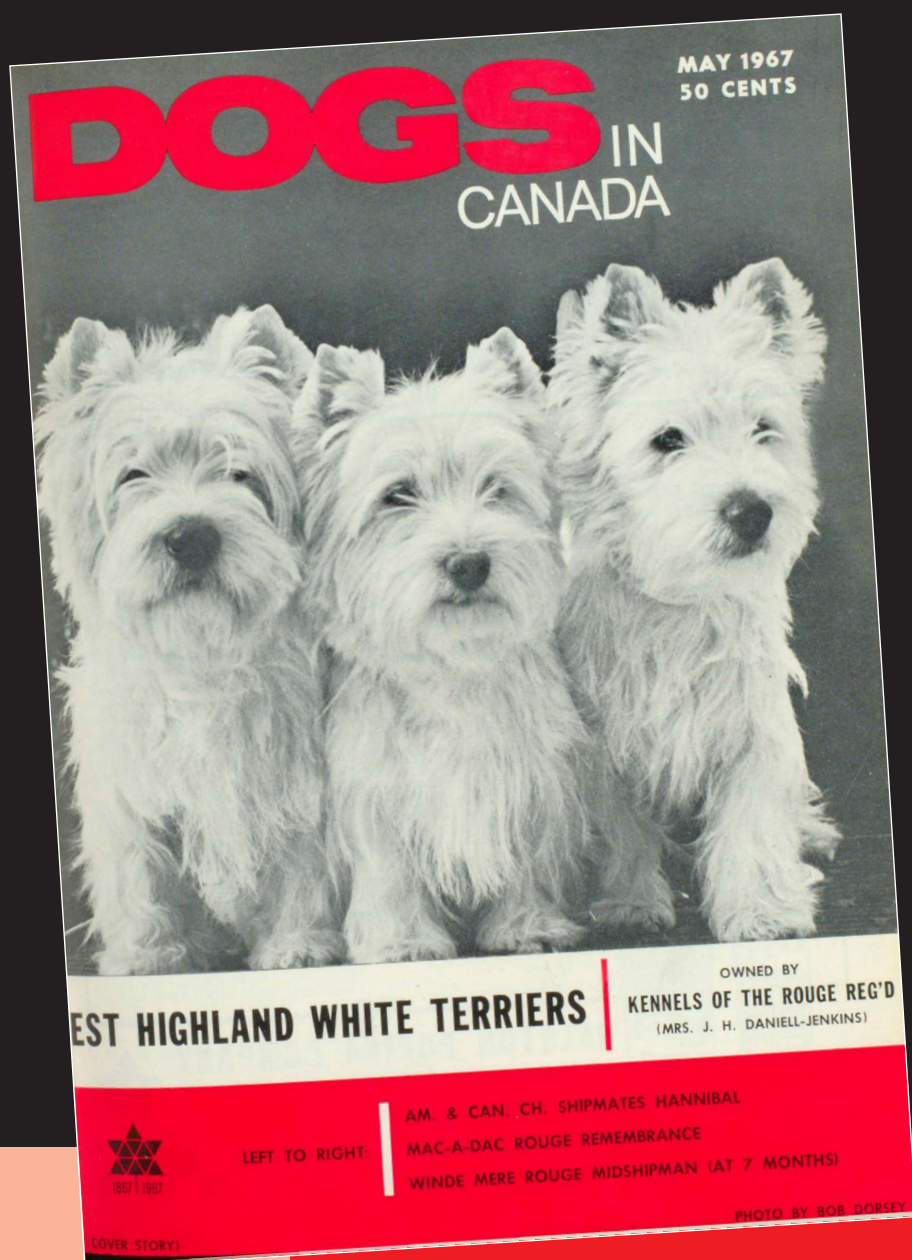

POLICY CHANGE RE: CONFORMATION EVENTS - MARKING OF JUDGING SHEETS AND TABLE AND RAMP BREEDS

Please note the change to the Policy and Procedures Manual that was carried at the March meeting of the CKC Board of Directors. The change affects the marking of the judging sheets with regard to dogs examined on the table or ramp. The change is effective January 1, 2019.

Policy and Procedures Manual, Chapter VI, Shows & Trials, Section M. Conformation Events

“THAT, effective January 1, 2019, Chapter VI, Shows & Trials, Section M, Subsection 12 of the Policy and Procedures Manual, be amended as follows:

DELETE

12. Marking Puppies on Judging Sheets

- a. All puppies that are entered in adult classes must be marked by the Show Secretary on all copies of the judging sheets including those of the Ring Steward.

REPLACE WITH

12. Marking Judging & Stewarding Sheets

- a) Marked judging and stewarding sheets supplied by the Show Secretary will include:
 - (1) all puppies that are entered in adult classes;
 - (2) the breeds to be judged on the table or a ramp with the exception of Toy Breeds.”

PUREBRED DOGS WELL-REPRESENTED AT QUEBEC BILL 128 HEARINGS

The Canadian Kennel Club—represented by Quebec CKC members Lise Trottier and Serge Bilodeau—was pleased to present to the Quebec Parliamentary Committee during special consultations and public hearings for Bill 128, which took place from March 20-22, 2018.

Bill 128 was first introduced in early 2017 and proposed laws that include breed specific provisions with the capacity to both ban dogs listed as “Potentially Dangerous” province-wide and with the potential to add breeds to this list at any time—essentially threatening all dogs in Quebec. In addition, the Bill does not prevent municipalities from adopting stricter standards set out in the Act and regulations.

It was important for CKC to attend the Quebec hearings, to defend purebred dogs (both those listed in the proposed legislation and all breeds that may be at risk), and promote responsible member breeders who are bound by the CKC Code of Practice and CKC Code of Ethics. It was especially important to speak out against the breed specific legislation in favour of well-crafted dangerous dog legislation that is reasonable, enforceable and non-discriminatory—in support of responsible dog ownership.

The CKC presented a united front alongside many like-minded organizations and reinforced that public awareness and education, stronger enforcement of existing bylaws and stiffer penalties for irresponsible owners is more effective at protecting the public.

The province must now review all of the input provided during the consultations and hearings as we await a new draft of the legislation in the coming months. Please watch our website for an update as more information becomes available.

CKC extends sincere thanks to Ms. Lise Trottier and Mr. Serge Bilodeau for their invaluable service to CKC and to the advancement of purebred dogs.

AIR TRAVEL RESTRICTIONS FOR PETS THIS SUMMER

If you plan on flying with your dog or shipping your pup this summer, be sure to check with your airline carrier as there may be pet travel restrictions due to high temperatures and heavy loads during peak summer travel periods.

WestJet accepts pets as checked baggage during the summer, with the exception of select locations from May 15 to October 31. WestJet Cargo planes are temperature controlled and can transport pets during the warmer months on domestic flights only. For more information, including details about shipping dogs, please call WestJet at 1-888-937-8538 or WestJet Cargo at 1-866-952-2746.

Air Canada is not able to transport pets as checked baggage from June 20 to September 10. However, Air Canada Cargo is specially equipped for the transportation of animals during the summer months and will accept pets during this period with the exception of select cities. Importantly, Air Canada Cargo does not accept warm-blooded animals for transport when the outside ground temperature is higher than 29.5°C (85°F). If the temperature is 29.5°C or higher at the departure city, the destination, or any point in between on a route with connections, animals will not be accepted and will therefore be rebooked for the next available flight(s).

Just a reminder that Air Canada and Air Canada Cargo does not accept Brachycephalic breeds on any flights, due to an increased risk of heat stroke and breathing problems.

NEW EVENT "SPRINTER" LAUNCHES AT CKC



The CKC is excited to announce the launch of Sprinter on July 1, 2018. Sprinter is a fun event open to all dogs to enjoy the challenge of running a 100-meter dash.

All dogs entered will receive a handicap score based on their height, and their time to finish will be converted to kilometers per hour. Titles are awarded upon the dog accumulating a given number of points.

CKC Recognized Lure Coursing Clubs are approved to hold Sprinter Events. All other CKC Recognized clubs that are interested and have the resources available may apply to shows & trials to host the event. They must have the equipment, experienced lure coursing operators and the proper location to hold a safe event.

In order to jump-start this program, the CKC is waiving all late fees for clubs applying to hold this event in 2018. A club may hold unlimited number of events, but a maximum of 2 per day. Book Your Sprinter event now by contacting the Shows & Trials Division.

CKC WELCOMES THERAPY DOG AS A TITLE RECOGNITION PROGRAM

Effective January 1 2019, CKC will be recognizing Titles from CKC Approved Therapy Dog Organizations. Therapy Dog organizations may apply for approval with the following form located under Forms>Club Forms and forward to the CKC Shows & Trials Division. <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Club-Forms/Therapy-Dog-Organization-Application-for-Recognition>.

The purpose of this program is to recognize dogs and their owners who volunteer their time to helping others. A Therapy dog team improves the lives of those they have visited in schools, hospitals, and nursing homes for example. The CKC is thrilled to be able to adopt this Title Recognition Program beginning in January 1 2019.

Titles earned through the therapy dog organizations are based on the required number of visits for each title. The record of visit form can be found under Forms>Exhibitor Forms: <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Therapy-Dog-Record-of-Visits-Form-No-150-37-71>.

In order for your dog to obtain a CKC Title and Certificate, your dog must have earned a Canine Good Neighbour Certification along with one the following:

A CKC Registration Number, a Performance Event Number, a CCN Number, a Miscellaneous Certification Number or an Event Registration Number, along with providing CKC the fee of \$20 plus applicable tax and completion of the CKC Therapy Dog Title Application Form located on our website under Forms>Exhibitor Forms. <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Therapy-Dog-Title-Application-Form-No-150-37-70>.

AMENDMENT TO THE ELIGIBILITY FOR CRUFTS 2019

We are thrilled to announce the amendment to the eligibility for Crufts 2019 to allow the top five dogs from each breed according to the Top Show Dog Point system. Previously, this only included the top five from each group. This change allows many more Canadians the opportunity to highlight their dogs at this prestigious event.

CANADA – The top five dogs from each breed according to the Top Show Dog point system, as well as the Best of Breed, Best of Opposite, Select Dog, Select Bitch and Award of Merit Winners at the National Specialties agreed by the Canadian Kennel Club. Additionally, all Group Placement Winners (1st, 2nd, 3rd & 4th in each group) at the Renaissance Dog Association held on Saturday, April 14 2018 are eligible.

IT4YOU UPDATE: INTRODUCING PAY-AS-YOU-GO PURCHASINGS

As you likely know, CKC is moving forward with a completely revamped computer system, known as IT4YOU, which will offer members a much more enhanced user experience with tools that make doing business with CKC much simpler and faster.

The new system will be pay-as-you-go, which requires a credit card, Visa Debit or cheque. It's fully secure and offers immediate turnaround for credit card and Visa Debit purchases, while those paying by cheque will have their applications held pending receipt of payment.

Beginning July 1, 2018, all orders must be paid up front and member credit will no longer be available. In order to ensure a smooth transition with the new system, we are requesting that members who have an amount owing, please settle their account before July 1, 2018.

For any members who have a credit balance on their account, there are three options:

- Request that the credit be transferred to the new system (credit must exceed \$10).
- Donate the credit balance to CKC Foundation, for which a tax receipt will be provided (for donations of \$20 or more).
- Request a refund be mailed to you.
