

ELIGIBILITY REQUIREMENTS AND INSTRUCTIONS

<p>Purpose</p>	<p>A Canine Companion Number (CCN) allows mixed and purebred dogs of breeds not recognized by the CKC to participate in some CKC Performance Events.</p>
<p>Definitions</p>	<p>Mixed Breed Dog: is a dog of unknown ancestry that is not the result of selective breeding.</p> <p>Unrecognized Breed: is a dog of known ancestry not on the CKC list of recognized or miscellaneous breeds, and that is registered with a Registry recognized by the CKC.</p>
<p>Eligibility requirements for CKC Canine Companion Number</p>	<p>Eligibility Criteria:</p> <ul style="list-style-type: none"> • Mixed breed dogs must be spayed/neutered. Verification of spay or neuter must be provided to the Canadian Kennel Club. • Purebred dogs of a breed not recognized by the CKC do not have to be spayed or neutered. For dog breed code, contact the registry kennel club (attach registration certificate from a CKC recognized registry). • The dog must be identified with a Canadian Kennel Club approved microchip. • No wolf-dog hybrid will be permitted a CKC Canine Companion Number.
