CKC MEMBER PROCESSING DISCOUNT

If all dogs from a Canadian-born litter are registered at one time, they may receive discounts of 5% to 10%, depending upon when and how they submit the applications to Head Office. (Please see Registration fees at left). In order to qualify for the discounts, all unused computerized Individual Registration forms associated with the litter, including those for dogs that are deceased, must be returned to Head Office along with corresponding completed applications. Late submission or failure to include unused forms will result in no discount being applied. This discount is only made available to Canadian Resident Regular Members for registration of Canadian-born litters of two puppies or more. It does not apply to any associated transfer fees.

MEMBER RATES

Member rates and discounts are applied if the applicant is currently a Regular Member of The Canadian Kennel Club. Membership privileges are not transferable. In the case of co-owners, member rates apply only if all of the co-owners are Regular Members of the CKC in good standing; otherwise, non-member rates and rules apply.

METHOD OF PAYMENT

Basic, Membership Plus and non-members
All applicants must submit payment with their work and may pay on-line by credit card at www.ckc.ca. Payment can also be made in person at CKC Head Office; by calling Membership Services at 416-674-3699 or 1-855-DOGS-CKC with credit card details and through internet and telephone banking at major banks. Accepted forms of payment include personal or business cheque, money order, Visa or MasterCard. Post dated cheques are not acceptable.

Non-Residents of Canada

Non-residents of Canada must make payment in Canadian dollars. Due to the constantly fluctuating currency rates, discounted cheques or money orders in foreign currency will not be accepted. U.S. cheques and money orders will be accepted at par.

Declined Cheques/Declined Credit Cards

A service charge of \$30.00 will be levied on all cheques and credit cards declined by the bank and no further work will be performed for the individual until such time as all outstanding amounts and service charges have been paid in full. Additionally, memberships and use of all Club privileges may be temporarily or permanently suspended.
