Please note that if it is necessary for supplies to be shipped by courier or express post, the club will be invoiced for these costs. All requests for supplies ordered within 21 days of the event(s) will be charged a handling fee of \$100.00 plus tax. If there is more than 1 club the fee will be applied to each club. Credit Card information for payment can be submitted with the Supply Requisition Form.
