

ELIGIBILITY REQUIREMENTS AND INSTRUCTIONS

Purpose	A Canine Companion Number (CCN) allows mixed and purebred dogs of breeds not recognized by the CKC to participate in some CKC Performance Events.
Definitions	<p>Mixed Breed Dog: is a dog of unknown ancestry that is not the result of selective breeding.</p> <p>Unrecognized Breed: is a dog of known ancestry not on the CKC list of recognized or miscellaneous breeds, and that is registered with a Registry recognized by the CKC.</p>
Eligibility requirements for CKC Canine Companion Number	<p>Eligibility Criteria:</p> <ul style="list-style-type: none"> • The dog must be either a mixed breed or unrecognized breed as defined herein. • Mixed breed dogs must be spayed or neutered. Unrecognized breeds are not required to be spayed or neutered. For dog breed code, contact the registry kennel club (attach registration certificate from a CKC recognized registry). • The dog must be identified with a Canadian Kennel Club approved microchip. • No wolf-dog hybrid will be permitted a CKC Canine Companion Number.
