NOTES AND COMMENTS

New Year's Greetings: We hope it may not be considered too late to acknowledge the many tokens of good will received by the editor during the past three weeks. We appreciate these remembrances; they seem to say we are not overlooked, and to Mr. Geo. H. Carley, Mr. W. M. Stephens, Mr. Fred T. Miller, Mr. Frank C. Watkins, and many others, we extend our thanks.

New Years Cockers: Mr. H. C. Davis, Dundas, got six dark red Cocker babies as his New Years gift. There are three of either sex, and as they are from the good red bitch Dolly Varden, that he showed at Toronto last year, and his Chauncey D., he will be disappointed if more than one good red one does not grow into a winner. Two bitches from Mr. Jackson's kennel at Hamilton have visited Chauncey, and Mr. Davis' sales have been quite active, including a black dog eighteen months old, to a Chicago breeder; a red bitch puppy to Mr. Walker, Dundas, and others.

New York Show: An advance copy of the premium list shows a wealth of specials that must make Mr. Oliver Twist Kent's eyes open. There are cups for best team and for best brace, we suppose an unavoidable complication. They certainly do bring the entries, but are the mischief to judge. There are cups for best specimen in most breeds. Something worth trying for is the \$150 prize, cash or plate, for best pack English Foxhounds, five couples, the property of a Hunt Club, to be shown under special conditions. The same amount is offered for American Foxhounds, and \$75 for Beagle pack of five couples. In addition, the Beagle Clubs have the opportunity of winning a second prize of \$50. The entrance fee for these pack specials is \$25.

We notice these specials appear again under the breed headings, but there doubtless is but the one competition. The specialty clubs have all dealt liberally with the show, and there are a host of individual specials of varying value. American or Canadian bred is quite conspicuous, and gives the Dominion an amount of publicity that has a real tangible value.

Mr. Oldham judged at Portland, Me., a show that more of our eastern breeders might patronize if given some publicity here.

Seems to be very lively in Boston circles in U. S. Breeders evidently think that publicity helps a breed, although that same publicity may not, as in this case, always be of the choicest sort.

The A. K. C. has decided to refer the express rate question to the Interstate Commerce Commission.

Donald Monroe, the sturdy Scotsman who has frequently piloted the Warren Fox Terriers to Canada, is reported very ill from heart trouble. He put on no frills, hence we like him here, and would be sorry to lose him.

This is the club's first attempt, and the list will be made attractive by the addition of handsome silver cups and other specials. Mr. M. P. Carlock is the secretary, and Mr. Walter Armbruster, superintendent, of the show.

New York Show: The great annual dog show held in Madison Square Gardens, New York, is slated this year for February 12th, 13th, 14th and 15th, 1907, entries closing on January 24th. This will be the thirty-first show given by the Westminster Kennel Club, and will no doubt be equal in extent and influence to the large shows of past year if it does not, indeed, excel in these points. Temagami will remain at stud in Collingwood, where there is good accommodation for visitors, and at the fee of \$15 is an extremely cheap proposition.

Made in Canada: It may not be generally known that the "Scottie" puppy that won at the late Philadelphia Show, Leeds Heather, was bred by Mr. Goodwin,

and indeed is the puppy that won for him at the Toronto Show.

Poms, too: An addition to the Vinemount Pom. Kennels is a full sister, bought from Mr. Wylie, of that gentleman's winner of two firsts, a second, and reserve championship at the last Edinburgh show. Mr. Goodwin's puppy is of a later litter, and looks like turning into as good a specimen as her winning sister.

Boston Show: The following notes have been supplied us by the show secretary. When we read them first we opened our eyes and questioned, is this Boston the staid and steady beantown, don't-kiss-your-wife-on-Sunday, or the other fellow's either, Boston? A second glance at the letter heading showed the notice to have "really and truly" emanated from the big Massachusetts city. and second best dog or bitch and a liberal distribution of \$5 specials through the novice classes. Hustling for specials without string attachment has been the aim of the Dog Show Committee, and the result has been most surprising.

Friends of W. J. Green, of Philadelphia, who will judge Bostons, have launched a movement to make the entry in that breed such as will wrinkle "Billy's' visage with smiles. Several of them forwarded a few days ago an assurance for one special of \$50, two of \$25 each, one of \$10, and several cups. The \$50 will be for the best exhibit of Boston Terriers \$25 for best in the puppy class, \$25 for the best in the novice, and \$10 for the best dog or bitch from Philadelphia.

The Boston Terrier trophy, which will be placed in competition by a leading Boston banker, will cost \$350 instead of \$250, as first reported. It is an elegant sample of the silversmith's handicraft, and looks every ounce its worth. That the entry of Boston Terriers will be a remarkable one there seems to be no doubt. Mr. Green has the confidence of the fancy, and knows the dog from pad to ear and back again, and his entire attention, while judging, can be depended upon to be on the log end of the lead.

Another Philadelphian, Mr. William H. Whittem, will also be seen in the judging ring. He will scan the Airedales for their prize winning qualities, and there will be in that class specials good enough to make the entry worth the while for as good an Airedale man as Mr. Whittem.

The Spaniel classes all of which will be made especially enticing to exhibitors by a liberal distribution of plate and money specials, minus strings, will be judged by Mr. William T. Payne, the Pennsylvania expert, who drew such a large entry at Toronto. Fanciers who have recently turned attention to Irish Water Spaniels may be pleased to know that a full classification has been made for that very interesting and long-neglected sporting dog.

Among the all-rounders who will contribute to the gaiety of the show are: James Mortimer, James Watson, Harry Lacy, and Maj. J. M. Taylor. It is understood that Wililam B. Earle, of New York, will take the Bulldogs in hand; that L. W. Campbell, of Woonsocket, R.I., will judge American Foxhounds; that F. G. Davis, of Boston, will be given French Bulls; that H. T. Peters, of New York, will preside over Dalmatians and Old English Sheepdogs; that a San Francisco gentleman, Irving Ackerman, will hand out the wins in the Fox Terrier classes, and that James J. Lynn, of Port Huron, Michigan, will take the Irish Terriers in

The secretary for the show is J. N. Taylor, 244 Washington St., Boston., who announces that the premium list will be ready for the mail the first week in January. Entries will close January 30.

Wires in B.C.: The wire hair Fox Terriers that Mr. W. D. Bruce, Vancouver, brought from England last spring, are, he tells us, doing well, and he has a puppy or two that he wishes he had the opportunity of showing against the Eastern cracks of the breed. Can't some one with a chip on his shoulder oblige him?

Spratts' Calendar: We always look forward with interest to the receipt of the unique and original annual calendar sent out by Messrs. Spratts' Patent. That issued for 1907 is fully up to the effort of previous years. The dog subjects depicted are a Chow Chow on the front page and a Bobtail on one of the inner sheets. Feathers are also well looked after and the descriptive matter on the back of each picture is interesting.

From Nova Scotia: Mr. R. N. Clark's New Year's greeting takes the shape of a large calendar with a taking picture of a champion dog of his favorite breed, the Boston. It makes a very handsome hanging calendar for den or office.

Back to his "ain fireside: " Mr. Chas. Lyndon is safely back in Canada with his different canine charges and is loated in East Toronto, where he will remain for some months at least. He brought with him the famous Wandee Fox Terriers, both wire and smooth, so that breeders may have the services of these dogs so widely known, many of them of world wide reputation. The smooths are Norfolk Blue (late Eton Blue), still in full vigor, and Norfolk Splinter by the great Dark Blue ex the Don Cesario bitch Norfolk Nugget. Amongst the wires are Wandee Coast Guard, a champion both in England and America, and Norfolk Rebel, a 161-2 pound dog, a grand little Terrier, espe cially suited for over sized bitches.

Sheep killers: During the big Winter Fair, last month at Guelph, the evergreen subject of sheep killing dogs was again uppermost. It was stated by some of the farmers present that sheep breeding had almost died out in some parts of the province owing to the repeated depredations of roving, sheep destroying dogs. Mr. John Campbell introduced the question of legislation for protection of sheep from dogs, and took quite a fair view of the case. . . .

On another page we give in full the law relating to the subject as it as present exists The cancellation of clause 2 would make the taxation of all dogs compulsory, and not leave the decision as it now is, largely in the hands of a few voters in each municipality.

He stated that dogs, more than any other thing, prevented many farmers from keeping sheep. It was not the good dog that did the harm, but the "mongrel," that was no good to anybody. The chief fault with the present law was that it had too many loop holes wherein it could be evaded. A petition of 25 ratepayers in any township

will make the law inoperative. The tollowing are the opinions of many farmers as to how a sheep law should be oper-

1. It should be made compulsory for every municipality to put a tax on dogs.

2. The annual tax for one male should be \$1.00, and for a second male or bitch from \$5 to \$10.

3. Money collected from dog taxes should be available to pay damages by

4. Every council should appoint competent persons to adjudicate on losses.

5. Dog taxes should be a general fund for the county or province to pay for sheep killed or injured by dogs.

Lt.-Col. McEwen, in leading the discussion, stated that clause 2 of the present act should be struck out. Section 18, re paying claims, should be altered where a dog cannot be located. Every dog should be taxed and the money used to pay claims, the whole loss being paid and not two-thirds, as at present. He closed by a special plea for the good, useful dog on the farm.

In the general discussion it came out that many township councils are not living up to the law, by putting a maximum valuation on sheep killed by dogs. In one township, where a maximum valnation of \$9 per head is in force, over \$300 in dog taxes was collected during 1906, while only \$28 was paid out for damages. One breeder of pure bred Shropshires in this township had several sheep killed by dogs and only received 59 each for them, which was a hardship.

A resolution was moved by Mr. Campbeil and seconded by Lt. Col. McEwen, asking the legislature to strike out clause 2 and so amend the present act as to give the necessary protection to sheep owners.

28th September came duly to hand. I have delayed answering it till I heard from Mr. H. S. Rolston, Vancouver, whose letter I enclose you. I wrote Mr. Rolston of the changes in the C. K. C. rules, and asked him for his ideas on the subject, and also stating my own views on the matter.

I suggested that ten points for championship was satisfactory, but that the scale of points for western shows be as follows: 400 dogs or over, 5 points; 300 dogs and under 400, 4 points; 200 dogs and under 300, 3 points; 100 dogs and under 200, 2 points; under 100 dogs, 1 point; and that no winners prize be awarded unless there were three dogs of a breed in competition (this latter point Mr. Rolston does not agree with).

Mr. Rolston also wants some arrangement made for past wins at shows held under Pacific Kennel League rules. This has been a sore subject with a good many of our exhibitors since we have joined the C. K. C., and if some equable arrangement could be arrived at it would be appreciated by past exhibitors. Then there is the question of wins made during C. K. C. rules the past two years. I presume the C. K. C. will allow points for these shows, on the basis agreed on for future shows, and also wins made at A. K. C. shows in America—what about them?

There is another matter that I think might be profitably taken up by the C. K. C., and that is printing the C. K. C. rules in some standard size and selling them to the various C. K. C. clubs at cost price. These could then be inserted in prize lists and catalogues at a fraction of the present cost, and would be absolutely correct. As it is now, each club has to have these rules printed for

Dear Sir,—I am in receipt of your favor of the 5th inst. In reference to the letter from Mr. Donovan, and I certainly think we are entitled to a greater number of points in the West here than in the Toronto Show.

In reference to three dogs being up for competition, I do not agree with you in this matter, as in some varieties we have very good specimens, for instance, in Daschunds and Yorkshire Terriers; last year we had good enough dogs in these classes to win the championship in any competition, and it would not be fair to them to be debarred because there does not happen to be a couple of scrub dogs entered to make the class.

In reference to the wins, I think we ought to have a revision or make a new list of the shows which shall be recognized. We have had a number of shows in this country of P. K. L., which are

not recognized, and which we consider ought to be.

I fully agree with you that the number of points ought to be something as you state. I am sorry that the C. K. C. saw fit to advance the fees as it is a very difficult matter to get enough people interested to pay the rees as they were.

Dear Sir,—Since writing you some days ago I have spoken to a good many of our dog fanciers re the new winners' points, and explained to them the pro-

posal made by me to you in my former letter. The scale of points was satisfactory, only that most of our fanciers thought that they should be allotted for entries, instead of dogs, as proposed by me, remarking that at our last show, also Vancouver, we would have only been entitled to two points on our entries. This was true, and in making the proposal I did to you, I made it on the supposition that Vancouver and Victoria would get at least three points each towards championship honors. This is about as small a number of points as our shows out here would be satisfied with and I think that should the C. K. C. Committee decide to count dogs rather than entries, that for B. C. it would be more satisfactory to make the points as follows: 250 dogs and over, 5 points; 200 and up to 250, 4 points; 150 and up to 200, 3 points; 100 and up to 150, 2 points; less than 100, 1 point. This will, I think, be satisfactory to western shows.

Dr. C. Y. Ford, on whose motion the decision to amend the championship rule was made, writes:

"In changing the championship rule to "points," I trust the number will correspond with the number required by the A. K. C. This is what I intended in my motion."

Following is the rule No. VII., given in the American Kennel Club rules, governing dog shows, and dated January 1, 1907:

Rule VII.—The winners' class shall be open only to winners of first prizes in any regular class at the show, giving at least three of the before-mentioned classes, one of which must be the open class. The winners' class can be divided by sex, provided the required three classes are also divided by sex.

Winners' classes cannot be allowed where two or more breeds are combined. The judge shall withhold the award of "first" in this class should he be of the opinion that there is no dog of sufficient merit to justify such award. Before awarding "reserve" in this class, the dog or dogs having been placed second to the winner in any of the classes must be brought before the judge for competition with the remaining dogs in said winners' class. No class winner can be withdrawn or withheld from competition in the winners' class. No entry fee shall be charged for said competition in winners' class.

The winners of ten points in this class, under three different judges (at least three points of which shall have been won at one show), excepting, however, at fivepoint shows, when two wins under different judges will be sufficient, will thereby become a Champion of Record, be so regif registered in the Stud Book will be entitled to an American Kennel Club championship medal. Duplicate medals for champions cannot be issued.

"Applications of clubs for membership shall be made in writing to the secretary of the club, accompanied by a copy of the applicant's constitution and by-laws, a list of officers, and a full year's dues, and an election by ballot shall be held at the next meeting of the club, provided the said application shall have been filed with the secretary at least ten (10) days previous to said election. It shall

American Kennel Club (Incorporated).

The American Kennel Club, up to recent date, has not been an incorporated institution. It now is. Some of its membership clubs protest that sufficient notice was not given their delegates, and that the transfer of property, etc., was recipitate. At any rate an informal meeting was held in New York on January 3rd, at which twenty-three clubs and societies were represented. We have been asked to publish the signed minutes of this meeting, which we do.

We are open for enlightenment, but fail so far to see why the American Kennel Club Incorporated and so subject to the laws governing incorporated bodies, is or should be any more dangerous than the American Kennel Club unincorporated, and so in a way having no legal existence as a club.

The Canadian Kennel Club is an incorporated body; it can sue and be sued for debt or other cause; it is amenable to our laws which its officers may not break without penalty. On the other hand, its members, individuals in this case, are protected in their individual rights.

The report referred to is as follows: This meeting was held at the Ashland House, Fourth Avenue and 24th street, New York, at 3 o'clock in the afternoon, January 3, 1907.

"Section 1. Regular quarterly meetings of the club shall be held in February, May, August and November, at such time and place as shall be designated by the President; twenty (20) days' notice whereof shall be given and published in the 'Gazette.' ''

To amend the first paragraph of Article V., Section 4, by striking out the words "the annual" in the 9th line thereof, and inserting in their place the words "a regular," and striking out all of said paragraph after the word "delegate" in line 18 thereof, so that the said paragraph so amended will read as follows:

"Section 4. Each member of the club shall be represented by one delegate, who shall have all the powers of the club he represents. Such delegate must be duly authorized and his appointment certified to by his club secretary. Before such delegate shall be entitled to qualify in the club he must be accepted by ballot by the club at a regular meeting thereof, or by the Board of Directors at any stated meeting of the board. Each delegate to be voted on must file his credentials with the secretary of the club at least twenty (20) days previous to the date of the meeting at which he is to be voted for. A three-fourths vote of the members present at a meeting will be necessary to accept a delegate.'

To amend the second paragraph of Section 4, Article V., by striking out all of said paragraph after the word "be," in line 3 thereof, and inserting thereafter the words "filled by the club at any regular meeting," so that the paragraph as amended shall read:

"Vacancies in the delegates during the year caused by death, resignation, or otherwise, may be filled by the club at any regular meeting."

To amend Section 2 of Article VI. by striking out all of said article after the word "thirty," in line 3 thereof, and to add thereafter the words, "who shall be elected from the delegates annually at the regular February meeting of the club, and shall hold office for one year, or until their successors are elected," so that said section as amended shall read as follows:

"Section 2. The club shall have power to increase the number of its directors to thirty, who shall be elected from the delegates annually at the regular February meeting of the club, and shall hold office for one year, or until their successors are elected."

To amend Section 4 of Article VI. by striking out the word "annual" in line 5 thereof, and by inserting in its place the word "regular."

To amend Section 5 of Article VI. by striking out the same.

To amend Section 6 of Article VI. by changing the number thereof to Section 5, and to amend paragraph 2 of said section by striking out the words "three years" in lines 2 and 3 thereof, and inserting in their place the words "one year," so that the paragraph as amended shall read as follows:

"The aforesaid officers and chairmen shall hold office for a period of one year and until their successors are elected; if an election is held to fill a vacancy, such election shall be for the unexpired term of the office."

To amend Section 7 of Article VI. by changing the number thereof to Section 6 and by striking out all of said section after the words "directors" in line 2 thereof, and inserting in place of the words stricken out "shall be filled at any regular meeting of the club by a majority vote of those present," so that the section as amended shall read as follows:

"Section 6. Any vacancy in the Board of Directors shall be filled at any regular meeting of the club by a majority vote of those present."

To insert a new section in said Article VL, which shall be numbered Section 7. and shall read as follows:

"Section 7. Any vacancy in any Committee shall be filled by the Board of Directors by a vote of a majority present at any meeting thereof.'

To amend Article VII. by striking out the same.

Or charges may be preferred before said directors when the conduct of any individual has been, or is, questionable, provided such charges are made in writing. All such charges, except matters within the province of the Stud Book Committee to investigate, shall be heard at the first opportunity by the directors."

To amend Section 3 of said Article IX. by changing the number thereof to Section 2, and by striking out all of said section after the word "defense," in line 7 of the last paragraph thereof.

To amend Article XL by changing the number thereof to Article X., and to amend Section 1 thereof by striking out the words "within the specified time," in line 4 thereof, and inserting in their place the words "within thirty days thereafter," so that the section so amended shall read as follows:

To amend Article XIII, by changing the number thereof to Article XII., and to amend Subdivision 1 of Section 1 of said article by striking out the words "the Executive Committee at each meeting and to," in lines 6 and 7 thereof, so that said subdivision so amended shall read as follows:

44 I. A Stud Book Committee, composed of three members, which shall have the business management of the Stud Book, investigate all charges submitted to it, and shall render an account of its proceedings to the directors at their meetings.

To amend Subdivision II, of Section 1 by adding at the end thereof the words "and report to the club at its regular February meeting," so that the said subdivision so amended shall read as follows:

"I. A Finance Committee, composed of three members, to which all bills must be referred for approval, and which must audit and certify to the accounts of the Secretary-Treasurer in January of each year, and report to the club at its regular February meeting."

To amend Subdivision III. of said Section 1 by striking out the same and by inserting in place thereof a new Subdivision III., which shall read as follows:

"III. A Rules Committee, composed

of five members, to which must be referred all proposed amendments and changes to the rules."

To amend Subdivision IV. of said Section 1 by striking out the words "Executive Committee'' in line 7 thereof, and inserting in their place the word "directors," so that the last sentence of said subdivision shall read as follows:

"It shall be the duty of this committee to furnish the directors with its advice for action."

To amend the last sentence of Section 3 of Article XII. by striking out the words "Executive Committee" therein and inserting in place thereof the word "directors."


To amend Article XIV. by changing the number thereof to XIII., and to strike out the words "the annual" in line 2 thereof, and insert in their place the words "a regular," and to strike out the words "with the recommendation of the Committee on Constitution and Rules," in lines 6, 7 and 8 thereof, so that the said article so amended shall read as follows:

Article XIII.

"This constitution may be revised or amended only at a regular meeting, but notice of any proposed amendment or alteration must be given to the club at least thirty (30) days prior to the date of said meeting, the amendment to be published in the "American Kennel Gazette" prior to the holding of said meeting. A two-thirds vote of the members represented is necessary to the adoption of any revision or amendment."

A committee was elected, consisting of the representatives of the four clubs who signed the original call for the meeting, together with the chairman of this meeting, the duty of this committee being to acquaint all the delegates not present and the secretaries of all clubs, with the proceedings of this meeting, and the sentiments of the delegates present, and to take such action as they see fit looking to the adoption of the proposed amendments.

The meeting then adjourned. John W. Britton, II., Secretary of the meeting.

The Sheep Dog Law of Ontario.

Excerpts from Chapter 271, R.S.O.

- 1. Subject to the provision in the next section, there shall be levied annually upon the owner, possessor, or harborer f each dog, an animal tax of \$1 for a dog and \$2 for a bitch, provided, nevertheless, that the owner or possessor of : kennel of pure-bred dogs which are registered in the "Canadian Kennel Register" may pay to the treasurer of the municipality the sum of \$10 as a tax upon such kennel for the year.
- 2. Upon the petition of twenty-five ratepayers, the Council of any city, town, township, or incorporated village, may provide by by-law that the said tax or any part of it shall not be levied in said municipality.
- 3. The owner possessor, or keeper of any dog shall, when required by the assessors, deliver to them in writing a statement of the number of dogs kept by him; and for every refusal or neglect to do so, and for every false statement made in respect thereof he shall incur a penalty of \$5.
- 4. In cases where persons have been assessed for dogs and the collector has failed to collect the taxes authorized by this Act, he shall report the same under oath to any justice of the Peace, and such Justice shall require such dogs to be destroyed by the possessors thereof, or by a constable, and for the purpose of so doing any constable may enter on the premises and destroy such dogs.
- 5. The money collected by the municipality under the preceding sections shall constitute a fund for satisfying such damages as arise in any year from dogs killing or injuring sheep.
- 6. In case the Council of any city, town, or township, or incorporated village, deems it advisable that the tax by this Act established should be maintained, but that the application of the proceeds should be dispensed with, it shall be lawful for such Council by by-law to declare that such application shall be dispensed with; and thereafter during the continuance of such by-law the clauses of this extract numbered 4, 5 and 12 to 16 inclusive, shall have no force in the municipality.
 - 7. Any person may kill:
- (a) Any dog which he sees pursuing, worrying, or wounding any sheep; or
- (b) Any dog without lawful permission in any enclosed field on any farm which

- the owner or occupant thereof or his servant finds giving tongue and terrifying any sheep; or
- (e) Any dog which any person finds straying between sunset and sunrise on any farm whereon any sheep are kept;

But no dog so straying which is kept by the occupant of any premises next adjoining the said farm or next adjoining that part of any highway of lane which abuts on said farm, nor any dog either when securely muzzled, or when accompanied by or being within reasonable call of any person having the charge of said dog, shall be so killed unless there is reasonable apprehension that such dog, if not killed, is likely to pursue, worry, wound, or terrify sheep then on the said

- 8. On a complaint made before a Justice of the Peace that any person owns, or has in his possession, a dog which has within six months previous worried or injured, or destroyed any sheep, the Justice may require such person to appear before him to answer to such a complaint.
- 9. In case any person is convicted of having in his possession a dog which has worried or injured or destroyed any sheep, the Justice may make an order for the killing of such dog within three days, and in default thereof may impose a fine upon such person not exceeding \$20 with
- 10. The owner of any sheep killed or injured by any dog shall be entitled to recover the damage from the owner or keeper of such dog by an action before a Justice of the Peace, and such aggrieved party shall be entitled so to recover in such action, whether the owner or keeper of such dog knew or did not know that it was vicious or accustomed to worry
- 11. The keeper of any dog to whom notice is given of any injury done by his dog, shall within forty-eight hours after such notice cause such dog to be killed, and for every neglect so to do he shall forfeit a sum of \$2.50 and a further sum of \$1.25 for every forty-eight hours thereafter until the same is killed, if it is proved that such dog has worried or otherwise injured such sheep; but no such penalties shall be enforced in case it appears that it was not in the power of the owner or keeper to kill such dog.
- 12. In case the owner of any sheep so killed or injured proceeds against the

owner or keeper of the dog that committed the injury, and is unable on the conviction of the offender to levy the amount ordered to be paid, then the Council of the municipality shall order their treasurer to pay to the aggrieved party two-thirds of the amount ordered to be paid by the Justice under the conviction in addition to the costs of the proceedings.

- 13. The owner of any sheep killed or injured by any dog, the owner or keeper of which is not known, may within three months apply to the Council for compensation for the injury; and if the Couneil is satisfied that the aggrieved party has made diligent search and enquiry to ascertain the owner or keeper of such dog, and that such owner or keeper cannot be found, they shall award to the aggrieved party a sum not exceeding twothirds of the amount of the damage sustained by him.
- 14. After the owner of such sheep has received from the municipality any money under either of the preceding sections, his claim shall thenceforth belong to the municipality, but in case the municipality recovers from the offender more than they had paid, besides their costs, thye shall pay over the excess to the aggrieved party.
- 15. The owner of any sheep killed or injured while running at large upon any highway or enclosed land shall have no claim under this Act to obtain compensation from any municipality.
- 16. If the Council of any city, town, township, or incorporated village, by bylaw decided to dispense with the levy of the aforesaid tax, the owner of any sheep may, notwithstanding, sue the owner or keeper of any dog for the damage

GERMAN WAR DOGS; HOW THEY ARE TRAINED.

Since 1888 the German army has been experimenting with dogs trumed to do military duty; and now it is announced, officially that the results are excellent.

Perhaps one reason for the good behaviour of the animals is to be found in the rule for the guidance of their human trainers, which reads:

"Always, before you punish a dog, make sure that you yourself are perfectly calm and without anger. Never fail to praise a dog for good work. Use every opportunity to speak to the dogs, either praising of censuring them, as the case may demand."

It is no life of fun and play that awaits a puppy who is distinguished by being selected for the honor of becoming the member of a regiment. He must learn almost as much as a private soldier, and drill fully as hard.

The first taught the young dog is to walk exactly at the proper distance from the soldiers whom he accompanies, neither too far before nor too far behind them, and when thus on the march to be absolutely as grave and attentive as a man.

This training lasts till he is seven months old. Then the puppy must turn out every day and run races with the older dogs, to strengthen his muscles and chest. After he has done this for about five months, and when he is a year old, the real military work begins.

By this time the dog knows his own troop of men pretty well. But he must now learn to distinguish every man in it, even in the darkest night, so that he shall know by scent if a soldier who does not belong to his regiment tries to approach the camp.

This of course is one of the vital necessities for the war dog, because he is to be used both as a sentry and a messenger in war, and in each case he must recognize an enemy or a rriend at once.

Then he must learn to obey instantly, so that at the word he stops as if frozen stiff. Then he learns to drop to the ground and crouch low with his head between his forelegs the moment he hears the command "Down." And there he must remain, for hours if necessary, till he hears the regimental whistle that tells him that he is to come on.

Then comes another hard and long branch of learning. He must become so that he will carry articles in his mouth and hold on to them no matter what happens. The trainer gives him a cap or a glove at first, and sends him to carry it to some officer. The men turn out when they see the dog, go at him with shouts and make believe to attack him. At first, the new dog either drops what he is carrying to bark and snap at the pursuers, or he will stand over it and prepare to fight.

Now, of course, what is wanted in war is not that the dog should protect whatever he is carrying by fighting for it. In that case, his fight would be short, for the enemy would simply shoot him and then get the message or the ammunition with which he had been entrusted.

So the trainer bends all his efforts to teach the dog, first, that he must under no circumstances drop the parcel from his mouth, and, second, that he must dodge an enemy, keep out of sight, if possible, and under any circumstances run away from him without delay.

Now, as any dog, no matter how careful, may lose his parcel at times, the dog must be taught to search for lost articles. He is drilled into this until he gets so expert that most of the German army dogs can find a cap or a glove that has been lost anywhere along a line of march a mile long.

Now comes an important lesson. The dog must be taught to lie down along-side of any object that may be pointed out by the soldier, whether it be a button from a coat or a cannon, and stay there without uttering a whimper while his regiment moves on. Even if it be away for a day and a night, the dog must stay where he is.

This has two important reasons. One is that the men may wish to creep on an enemy without being encumbered by the dog; the other is that they may wish him to remain behind to guard a wounded man or some valuable part of the outfit.

Having learned this, he learns not to bark under any circumstances. Until this branch of his education has been finished he is unfit to accompany soldiers, for his bark would betray them to the foe.

The war dog that has been graduated never barks. When an enemy or a stranger approaches he crawls close to his masters and utters a low growl. By this time he has learned, also, that the only time to fight is when his life is in danger. At no other time will he attack any one who approaches. Thus,

of course, his masters are safe against betrayal through any act of his. He will lie as close and quiet as the human soldiers.

Besides acting as sentry, the chief use for the war dog is to carry ammunition or messages at a time when the fighting is such that no human being could be expected to pass through the line of fire.

To enable the dog to do it, he is taught to seek covered places whenever he goes anywhere. He learns to run along in trenches and sunken ways, to creep behind hedges and fences, and to slip past bodies of men, making himself as inconspicuous as possible.

The good army dogs have proved that they can go five miles with a message, passing all sorts of enemies and hindrances on the way. In these trials the dogs showed that however hard pressed they might be, they could evade capture with wonderful skill, and even in the tightest places they rarely turned tail to return, but always tried their pest to take their messages through.

So, perhaps, in some war to come, a dog may even earn the iron cross. Surely, if being faithful, true, and brave will earn it, men may be sure that the dogs will not be behind them in deserving it.—Our Dogs.

THE DOGS ACT, ENGLAND, 1906.

As the Dogs Act comes into operation on the 1st of January next, we think an epitome of its main features and provisions will be of benefit to the kennel community, and we therefore have pleasure in publishing them in this our Yuletide issue, which will act as a landmark whenever reference to the act is required. They are as follow: I.—Liabilities of owners of dogs for

I.—Liabilities of owners of dogs for injury to cattle.—34 and 35 Vict., Cap. 56.

1. The owner of a dog shall be liable in damages for injury done to any cattle by that dog; and it shart not be necessary for the person seeking such damages to show a previous muchievous propensity in the dog, or the owner's knowledge of such previous propensity, or to show that the injury was attributable to neglect on the part of the owner.

done by a dog, the occupier of any house or premises where the dog was kept or permitted to live or remain at the time of the injury shall be presumed to be the owner of the dog, and shall be liable for the injury unless he proves that he was not the owner of the dog at that time.

Providing that where there are more occupiers than one in any house or premises let in separate apartments, or lodgings, or otherwise, the occupier of that particular part of the house or premises in which the dog has been kept or permitted to live or remain at the time of the injury shall be presumed to be the owner of the dog.

 If the damages claimed under this section do not exceed £5 they may be recovered under the Summary Jurisdicttion Acts as a civil debt.

4. Where a dog is proved to have injured cattle or chased sheep, it may be dealt with under section two of the Dogs Act, 1871, as a dangerous dog.

II.—Power of Board of Agriculture to make orders about dogs.—57 and 58 Vie., Cap. 57.

- 1. The Diseases of Animals Act, 1894, shall have effect as if, amongst the purposes for which the Board of Agriculture and Fisheries may make orders under section 22 of that act, there were included the following purposes: (a) For prescribing and regulating the wearing by dogs, while in a highway or in a place of public resort, or a collar with the name and address of the owner inscribed on the collar or on a plate or badge attached thereto; (b) with a view to the prevention of worrying of cattle, for preventing dogs or any class of dogs from straying during all or any of the hours between sunset and sunrise.
- Orders under this section may provide that any dog in respect of which an offence is being committed against the orders, may be seized and treated as a stray dog.

III.—Seizure of stray dog.—53 and 54 Vic., Cap. 45.

- 1. Where a police officer has reason to believe that any dog found in a highway or place of public resort is a stray dog, he may seize the dog and may detain it until the owner has claimed it and paid all expenses incurred by reason of its detention.
- 2. Where any dog so seized wears a collar having inscribed thereon or attached thereto the address of any person, or the owner of the dog is known, the chief officer of police, or any person authorized by him in that behalf, shall serve on the person whose address is given on the collar, or on the owner, a notice in writing stating that the dog

has been so seized, and will be liable to be sold or destroyed if no claimed within seven clear days after the service of the notice.

- 4. Where any dog so seized has been detained for seven clear days after the seizure, or, in the case of such a notice as aforesaid having been served with respect to the dog, then for seven clear days after the service of the notice, and the owner has not claimed the dog and paid all expenses, incurred by reason of its detention, the chief officer of police, or any person authorized by him in that behalf, may cause the dog to be sold or destroyed in a manner to cause as little pain as possible.
- 5. No dog so seized shall be given or sold for the purpose of vivisection.
- 6. The chief officer of police of a police area shall keep, or cause to be kept, one or more registers of all dogs seized under this section in that area which are not transferred to an establishment for the reception of stray dogs. The register shall contain a brief description of the dog, the date of seizure, and particulars as to the manner in which the dog has been disposed of, and every such register shall be open to inspectino at all reasonable time by any member of the public on payment of a fee of 1s.
- 7. The police shall not dispose of any dog seized under this section by transferring it to an establishment for the reception of stray dogs unless a register is kept for that establishment containing such pariculars as to the dogs received in that establishment as are above mentioned, and such register is open to inspection by the public on payment of a fee not exceeding 1s.
- 8. The police officer or other person having charge of any dog detained under this section shall cause the dog to be properly fed and maintained.
- 9. All expenses incurred by the police under this section shall be defrayed out of the police fund, and any money received by the police under this section shall be paid to the account of the police fund.
- 10. In this section the expressions "police area," "chief officer of police," and "police fund," with respect to the city of London mean respectively the said city, Commissioner of City Police, and the fund applicable to the mainten-

ance of police in the said city, and with respect to any other place have the meanings respectively assigned to them by the Police Act, 1890.

IV.—Notice to police of finding of stray dogs.

Any person who takes possession of a stray dog shall forthwith either return the dog to its owner or give notice in writing to the chief officer of police of the district where the dog was found containing a description of the dog and stating the place where the dog was found and the place where the dog is being detained, and any person failing to comply with the provisions of this section shall be liable, on conviction under the Summary Jurisdiction Acts, to a fine not exceeding 40s. V.—Exemption of Sheepdogs, etc., from excise license.—41 and 42 Vic., Cap. 15.

- 1. The grant of a certificate under section 21 of the Customs and Inland Revenue Act, 1878, of exemption from duty in respect of a dog shall require the previous consent in England of a petty sessional court, and in Scotland of the sheriff or sheriff substitute having jurisdiction in the place where the dog is kept, but such consent shall not be withheld if the court is of opinion that the conditions for exemption mentioned in the said section apply in the case of the applicant, and the procedure for obtaining that consent shall be regulated in England by rules made by the Lord Chancellor, and in Scotland by acts of sederunt.
- 2. The rules and acts of sederunt shall provide for dispensing with the appearance of the applicant for a consent under this section except in cases where the application is opposed and the court sheriff or sheriff substitute considers the appearance of the applicant to be necessary for the proper consideration of the application. No fee shall be payable in respect of any application or consent under the section.

vI.—Burying of Carcases.

Any person who shall knowingly and without reasonable excuse permit the carcase of any head of cattle belonging to him to remain unburied in a field or other place to which dogs can gain access shall be liable on conviction under the Summary Jurisdiction Acts to a fine not exceeding 40s.

VII.—Definition of cattle.

In this act the expression "cattle" includes horses, mules, asses, sheep, goats, and swine.—Our Dogs
