A New Black and Tan: Mr. F. C. McLean, Hull, who for so many years has stuck manfully to the Black and Tan Terrier, has imported from Scotland a good young dog called The King's Son. Though not yet two years old, he is a proved stock-getter and is a litter brother to Sensation, one of the best bitches in England. He has a nine-inch head, is a rich black and sound tan. He should greatly help us in the breed here, and at a time that we need help.

Vancouver Show: The dates decided on for Vancouver show are March 27th to 30th, 1907, under C. K. C. rules. The premium list is now being prepared.

Mrs. Gordon's Collies: Mrs. Gordon's new importations consist of two young dogs, as yet unshown, by Champion Squire of Tytton, and a good one called Southport Star, by Champion Southport Summit. Southport Star has first prizes at Milton Mowbray to his credit.

Ontario Kennel Club Show: We give elsewhere many details of this coming show, which is being looked forward to with much interest. The list of judges is a notable one, and Grand's Repository is large enough to accommodate any number of entries that may be sent in. Not as it was last year, when several scores had to be refused.

The dates of the show are March 28th, 29th and 30th, so that the Good Friday holiday may be taken advantage of. Entries close on March 14th with the Secretary, Mr. F. A. Metcalf, P.O. Box 534, Toronto, and we bespeak for this progressive institution the very best entry that can be given.

Cocker Notes: Mr. Jackson's (Hamilton) good black bitch has whelped a nice litter, half blacks and half reds, to Mr. Davis' (Dundas) Chauncey D. Mr.

Bertram's Vinemount Black Diamond, has visited Chauncey, as has a good one, a red, of Mr. Price's, so that there should be many of his progeny coming along a little later.

C. K. C. Affairs: In this issue will be found printed the Constitution, By-laws, Show Rules and Regulations of the Canadian Kennel Club. The work of revision was at the last annual meeting placed in the hands of the Executive Committee. By the executive the work was passed on to a sub-committee consisting of those well-known dog men, Messrs. A. A. Macdonald, W. P. Fraser and R. H. Trimble. This committee was instructed to report to the executive. which the members did. The final report here covered is the work of the sub-committee, amended where needed, by the Executive, and finally adopted on January 25th, 1907. Besides occupying the time of the sub-committee at several meetings, the Executive spent no less than three lengthy sessions on the subject. The work should be well done, and was well done.

Some Changes: There were many changes made, in the rules especially. Many of these had been already authorized by the members at large, in regular meeting, so that in these cases the work of the Executive Committee was simply to put in force laws already passed by the club.

Constitution: The Constitution of the C. K. C. remains largely as heretofore, until we come to article four, where fixed dates have been set for Executive meetings, a long-felt want. The manner of election of officers remains the same, and each individual, no matter how far distant, present at the annual meeting or not, still retains his right to east a ballot for each officer. Section two of article four contain a slight change,

making no material difference in effect, The Secretary-Treasurer is not a member of the Executive, nor does the present encumbent desire to be. Indeed, it was at his request, some years back, that the change to the present reading was made. He has no desire to vote on the amount of his own remuneration, for instance, and takes it that his function is to suggest and not to lead or dictate.

By-laws: By-law number five sets forth in detail the privileges attaining to membership in the C. K. C., and surely they are many. Section ten of the by law was added to cover average cost of investigations, which the Club will now undertake, whether between its members or those who have not joined its ranks. No charge is made to members, an additional privilege. This, of course, is in addition to and does not conflict with any existing rule or rules, for instance, by-law number seven, sections one and two. The medals and cups offered by the club are now open to members only.

Registration: Registration has been narrowed down to the one condition, and that is that pedigree of each application must be given in full for three generations.

Show Rules: In rule two clubs are given the privilege of collecting listing fees, but this must be plainly stated in the premium list.

Classification: We find important changes here, the puppy and novice classes now being open to dogs bred in American. An American-bred dog is defined as one born on the continent of North America. Winners' class has been completely altered. Championships now depend on points, the number of points alloted to each show varying in accordance with the actual number of dogs

certificate is required in this connection. Western and Pacific Coast shows have been provided for, as have shows of one breed held under the auspices of specialty clubs. The winners ruling takes effect March 1, 1907, thus taking care of dogs that have already made partial wins towards championships. For instance, a dog that has made two wins under the rule may complete the desired number of wins under that same rule and so attain the coveted honor without any disturbance of his owner's rights.

Rule twenty-one has been slightly altered, the committee taking the sensible view-as an illustration-that there could not be two April 30ths in one year.

Regulations: These remain practically unchanged, other than a complete list of recognized breeds is given for the guidance of show committees. This list is the one intact adopted by the A. K. C.

Send For One: The whole material needed by dog owners and exhibitors, consisting of the Constitution and Bylaws of the Club, its Show Rules and Regulations, is to be printed in handy pamphlet form, so as to be readily available. These books may be had from the Secretary on request.

Mr. Dyke Resigns: Owing to pressure of other work, Mr. Geo. J. Dyke has been compelled to resign his position as Secretary of the Vancouver Kennel Club, much to his regret and that of his fellow-members in the Club. This was ex-

pressed by the Club at its meeting of Jan. 24th, the minutes of which meeting

"The President in some remarks feelingly said he regretted receiving the resignation of Mr. George J. Dyke, as Secretary-Treasurer of our Club, and said Mr. Dyke would be missed very much, although he was glad that Mr Dyke would still remain a member and work for the coming show. He knew that all the members of the Club would feel as he did to-night-very sorry. The First Vice-President and others also spoke regretfully, and in complimentary terms of Mr. Dyke, after which it was moved and seconded that the resignation of the Secretary be accepted with very great regret, and that a hearty vote of thanks be tendered him for his efficient and energetic services in the past to the club."

Mr. Dyke has not lost his interest in the Club and intends working for it as before, and for the coming show to be held in Vancouver.

Collie Babies: Mrs. Gordon reports the arrival about the turn of the new year of two fine litters. That of Southport Sarah consists of one dog and two bitches to Olympian, To Holyrood Clinker Nith Marvel whelped five, of which three are dogs. In color they are three sable and whites and two black, white and tan. Mrs. Gordon also intends keeping the King Edward Collie Kennels to the front as she has imported no less than four, three dogs and one bitch, from England.

Vinemount Vim: Mr. W. R. Goodwin gives us several Bulldog items of interest. The first is that he has purchased the well-known winner and stud dog, Black Mask, from W. C. Leach of Bradford. He has been most successful as a sire and has several championship winners in England to his credit in this respect. To none but good bitches will his owner allow him to be bred. Mr. Goodwin is also importing several good bitches, including one bred to Moston Bar-none. To Mr. G. A. Austin, Buffalo, Mr. Goodwin has sold the famous champion Vinemount Miss Aubrey, a bitch that we are sorry to see leave her Canadian home. She is in whelp to Moston Colonel, and we hope her new owner may have all sorts of good luck with her. The price was a satisfactory one, and Mr. Goodwin wisely reserved an interest in her litter.

A Big Litter of Russians: Eight must be considered a big litter for a Russian Wolfhound, and the rearing of six out of this number without much effort on the dam's part evinces the good care of Narcissus' owner, Mr. F. F. Rogers, Toronto. They were whelped on December 5, 1906, and the round halfdozen are strong vigorous, well nourished puppies. The bitch was put under a special system of dieting for from five weeks before the puppies came until they were six weeks old, and it has proved a success. Two of the puppies have been sold, the other four, consisting of two dogs and two bitches, Mr. Rogers intends to keep. The photograph that we print on the front page of the Gazetto

Stair Glen was imported for his strong individuality and fashionable blood. A black brindle in color, he owns a beautiful head with strong muzzle, ears up like darts, good bone, short back, with great quarters, hard jacket, and very short tail. A small Terrier, game and ready as can be. Though only a young dog, he has left some good puppies behind him in England, one named Oxhill Oxo showing especial promise. His pedigree is a study. Bannock O'Glen, his sire (and the sire of many winners) is by Champion Tosker, from Champion Ems Relic, a most beautifully-bred bitch by * Champion Heather Bob, who possesses the blood of Splinter II. (the tap root of all the good ones), sixty-six times over. South Tanfield Thistle, his dam, is by Heworth Chieftain, a remarkably grand Terrier by Champion Heworth Rascal, from Heworth Flora, by Champian Gair, while Scotch Lassie is by Prince O'Brae from Jenny O'Brae. Stair Glen is in-bred to Heather Prince and Seafield Rascal, the two greatest stud dogs of the breed for the last ten years.

Bloodhound Bits: The Dartmoor Kennels report another increase. That famous Bloodhound matron, Dartmoor Benefice, has whelped a fine litter of nine promising puppies. Benefice is a half sister to the world famous bitch Betsy Bobbet. Dartmoor Ulf, the sire of this litter, is out of the bluest blooded stock England can produce. His pedigree contains an unbroken chain of champions on the sire's side for seven generations. Messrs. Hall & Son report enquiries and sales very encouraging. Orders were received in advance for three of the puppies just whelped, one puppie going to Mount Vernon, Ind. Quite recently Messrs, Hall sold their Dartmoor King to a gentleman in Libertyville, Ill.

The New York show will be in progress when this month's Canadian Kennel Gazette is in the hands of your readers. In glancing over the list of entries of this, the standard show of America, we find a great deal of food for thought. Numerically, Boston Terriers, essentially an American production, head the lists, with a total of 248 dogs. As big prices are obtained, and as a large number of individuals make a living by dealing in this breed, the big entry is easily accounted for.

Next in order comes the now popular Collie, with 145 actual specimens. Of this handsome total we are especially proud, as our countryman, Mr. W. Ormiston Roy, has been honored by the judicial appointment. This year, Mr. J. Pierpont Morgan, whose multi-millions makes mere price a very secondary matter for anything he fancies, is likely to play second fiddle to another possessor of millions-the famous corporation lawyer, Mr. Samuel Untermyer -who must have a fortune invested in this year's exhibit. First and foremost comes Champion Squire of Tytton, conceded by all to be the best Collie ever bred. For this wonderful specimen Mr. Untermyer sent a cheque for \$6,500.00,

It is "best of all a record price. breeds'' that Squire of Tytton is pointed for. Another wonderful specimen, that accompanies the aforementioned, is Champion Sapho of Tytton, said to be the best of her sex, and in color a beautiful black, white and tan. The team is made up of Champions Southport Sculptor, Greystone Breadalbane, Parbold Prunella, etc., etc. Mr. Morgan will have on hand Champions Wishaw Clinker, Ormskirk Olympian, Moreton Hebe, Parbold Purity, and the recently imported Ormskirk Artist, for whom a big price was paid. What will remain after these trust magnates go through the classes is not likely to bring much gladness to the heart of the humble fancier of modest means,

To Mr. H. K. Bloodgood falls the lot of stepping into a veritable burning, fiery furnace of contention—the Cocker Spaniel ring. He will have 122 to look over—not a brilliant showing for Madison Square Garden.

A surprise that almost makes one think it is a typographical error is the paltry muster of 29—just think of it?—smooth Fox Terriers. For New York this seems incredible, and we should have thought breeders would have given Mr. J. J. Lynn better support.

Pomeranians have a grand total of 76 specimens—a flattering tribute to Mr. Reginald Mayhew, the judge.

Speaking of Pomeranians, reminds us that in the January 5th number of the Ladies' Field (England) appears a handsome picture of Mrs. A. A. Macdonald, with Champion Rederoft Darkie. Mrs. Macdonald is at present in quest of quietude and rest at Atlantic City, but will be on hand at New York with a representative entry of Toy Poms. We wish her all the success that she so richly deserves for her pluck and perseverance.

Mr. H. B. Hungerford, a Canadianbred himself—has sold for \$1,000 his young Collie dog Mountaineer Magistrate, who will make a strong bid for the American-bred specials at New York in Mr. Untermeyer's interests. This should encourage breeders to make an effort to breed only the best, and hence get the best prices.

Dr. Ford calls attention to his young stud Collie Otterburn Ornament, known in England as Ormskirk Marshall. This dog is a son of the wonderful Champion Squire of Tytton, whom he greatly resembles. He is siring big litters, and should be used by breeders who appreciate his great quality and fashionable breeding.

Canadian Kennel Club

Constitution

ARTICLE I. Organization.

Sec. 1.—This Club shall be known as the Canadian Kennel Club, with headquarters at Toronto.

Sec. 2.—The objects of the Club shall be to promote the breeding of thoroughbred dogs in Canada, to protect the interests of owners and breeders, to formulate rules for the government of Dog Shows and competitions, and in such other ways as it may see fit, attempt to guide and advance the welfare of dogs and their owners.

ARTICLE II. Membership.

Sec. 1.—The Club shall consist of members and patrons.

Sec. 2.—Application for membership, accompanied by the requisite fee, having been made in writing, shall be sent to the Secretary and passed on by the Executive Committee. One negative vote shall suspend the election until the next meeting of the Executive Committee.

Sec. 3.—Any person may be elected a patron by unanimous vote at any Executive meeting.

ARTICLE III. Officers.

Sec. 1.—The officers of the Club shall be a President, a First and a Second Vice-President, and one Vice-President for each Province, and Secretary-Treasurer; all of whom shall be annually nominated and elected as herein set forth, and shall hold office for one year, and until their successors shall be elected.

Nomination for office must be made at the nomination meeting in August.

Nomination may be made by letter addressed to the Secretary up to the day of the meeting, or by presence at the meeting.

When the nomination is closed, a suitable ballot slip, showing the nominations for officers and executive committee shall therewith also be sent by mail to each member, requesting him to signify his choice thereon and return the same to the Secretary, so as to reach him not later than the morning of the day of the election.

Ballots to be returned in a specially printed envelope marked "Ballot" and to be opened and counted at the annual meeting. Should only the requisite number be nominated to fill any office or offices, he or they shall be declared duly elected; but in the event of more than a sufficient number being nominated, a ballot shall be taken, when the candidate or candidates, to a number sufficient to fill such office or offices, receiving the highest number of votes, shall be declared duly elected.

Retiring officers shall be eligible for re-election if duly nominated.

The nomination or special executive meeting of the Club shall be held in Toronto the first week in August. Due notice of this meeting shall be given to every member.

In the case of a tie vote, the tie shall be decided by a majority vote of the members present at the annual meeting, or next Executive meeting, and in the event of an officer declining to serve, the member receiving the next highest number of votes shall be declared elected.

Sec. 2.—The Executive Committee shall have power to fill vacancies for the unexpired term.

See, 3.—An honorary solicitor and two auditors shall be elected at annual meeting.

ARTICLE IV.

Executive Committee.

Sec. 1.—The Executive Committee shall consist of the officers named, except Secretary-Treasurer, and twelve other members elected at the same time and in the same manner. It shall convene in September, during Toronto Show week, and on the second Friday in January, April and July, and as often besides as may be deemed necessary at the call of the President or the written request of six members of the Executive.

Sec. 2.—Any Club having at least ten members of the C. K. C., in good standing, may appoint or elect a representative to the C. K. C. executive.

ARTICLE V.

Amendments.

The Constitution or By-laws of this Club my be amended at any general or annual meeting of the Club, provided notice of the proposed change is given in the official organ (Canadian Kennel Gazette) of the Club, and provided also that two-thirds of the votes represented at the meeting are cast in favor of the amendment so proposed.

By-Laws

LAW I.

Duties of Officers.

Sec. 1.—The President shall order all meetings of the Club and Executive Committee, except as hereinbefore provided in Article IV, Sec. 1, and when possible preside at the same. He shall see that the affairs of the Club are managed according to the terms and spirit of the Constitution and By-laws; and shall at the annual meeting report on the working of the Club during the past year.

Vice-Presidents.

Sec. 2.—The First Vice-President, or one of the other Vice-Presidents, shall perform all the duties or the President in his absence.

Secretary-Treasurer.

Sec. 3.—The Secretary-Treasurer shall keep the minutes of all meetings of the Club, conduct the correspondence, and have charge of, and be responsible for, all the books and papers of the Club. He shall have charge of all monies of the Club, collect all fees, pay all accounts after being duly signed by the President or his duly authorized representative, and make a report on the same and on the general financial standing of the Club at each ordinary meeting of the Executive Committee.

The Secretary-Treasurer shall make an annual report on the affairs of the Club, including its financial condition. He shall keep a record of the names and addresses of all members of the Club. He shall furnish a Guarantee Company's Bond at the expense of the Club. His remuneration shall be fixed and determined upon by the Executive Committee.

Sec. 4.—Each officer on the expiration of his official term shall transfer all property whatsoever of the Club in his possession to his successor.

LAW II.

Duties of Executive Committee.

Sec. 1.—The duties of the Executive Committee shall be to endeavor to further the objects and purposes set forth in the Constitution, and to secure and maintain an efficient organization of this Club. It shall have power to provide for such committees as it may deem advisable. Five members shall constitute a quorum.

LAW III.

Auditors and Stud Book Committee. Sec. 1.—It shall be the duty of the

auditors to audit the Treasurer's books and submit a report duly certified at the first meeting of the Executive Committee following the annual meeting.

Sec. 2.-A Stud Book Committee shall be appointed by the Executive Committee at their first regular meeting.

It shall be the duty of the Stud Book Committee to scrutinize the registrations appearing each month in the Gazette, investigate each, and send them initialed to the Secretary for a final insertion in the Annual Stud Book; and all complaints of errors or omissions in the pedigrees of dogs registered shall be referred to this committee to investigate and report to the Executive Committee. Stud Book Committee to report at annual meeting.

LAW IV. Meetings.

Sec. 1.—The annual meeting shall be held at headquarters at such time and place as shall be appointed by the Executive Committee.

Sec. 2.—At the request of twenty members, the President shall call a special meeting of the Club. Twenty shall be a quorum at a general or special meeting.

Sec. 3 .- The meetings of the Executive Committee shall be ordinary and special.

At least ten full days' notice of all meetings of the Executive Committee and of the Club must be given by mail to each member of the Executive Committee. A schedule of all the

items of business to come under consideration shall be duly supplied with the notice of meeting.

LAW V.

Fees and Privileges of Membership.

- 1. Annual membership fee, \$3.00. (payable in advance).
- 2. Cost of registration, \$1.00 each. One free each year to members.
- 3. Cost of listing, 25 cents.
- 4. Fee for search of pedigree, 25 cents.
- 5. Copy of pedigree, 50 cents; to members, 25 cents.
 - 6. Transfer of registration, 25 cents.
 - 7. Registration of prefix, \$2.00.
- 8. Registration of kennel \$2.00.
- 9. Duplicate of certificate, 25 cents.
- 10. A fee of \$1.00, to cover average cost, is charged for the investigation of each complaint not arising out of misconduct at shows held under C. K. C. rules. No charge is made to members. (See also By-law VII.)

Additional Privileges.

In addition to the privileges noted above, members get the Canadian Kennel Gazette, each month, free.

Members get the Annual Stud Book, containing all registrations and wins for the year, free.

The Canadian Kennel Club offers at each show held under its rules, handsome silver and bronze medals for which none but members may compete.

A handsome silver cup is awarded each dog attaining championship

honors, where registered and when owned by a member.

LAW VI.

Registration.

Sec. 1.-No dog can be registered unless pedigree for three generations on both sides is given in full.

Sec. 2.—Duplication of names is not permitted.

Sec. 3.—Dogs not eligible for registration may be "listed," of which dogs a record shall be kept.

LAW VII.

Discipline.

Sec. 1.-The Executive Committee shall have full power by a two-thirds vote of those present at any of its meetings, to suspend, disqualify or expel any member, and the member so suspended, disqualified or expelled, shall have no claim against the Club, or be allowed to enter into any competition held under the Rules of this Club. Such members shall have the right to appeal to the Club from the action of the Executive Committee at the annual meeting, or at any special meeting, provided notice of appeal has been given to the Executive Committee. Suspension, disqualification or expulsion shall be either for a definite period, or for lite; and the member thus suspended, disqualified or expelled shall be reinstated only on application to the Executive Committee.

Sec. 2.—Anyone having personal knowledge of the facts, may prefer charges of improper conduct against any individual. 'The person making such charges must send them in writing to the Secretary-Treasurer of the Club. The charges thus forwarded must be accompanied by a deposit of \$5.00, as a guarantee of good faith, for each charge preferred, which shall be retained should the charges be deemed on investigation to be frivolous or malicious. In the case of non-members, a fee of \$1.00 shall be charged for investigation.

Sec. 3 .- Any individual or individuals found guilty of misconduct with dogs, shall be debarred from all privileges of the Club, including registration.

LAW VIII.

Official Organ.

The Canadian Kennel Gazette, Toronto, shall be the official organ of the Club, and all notices of meetings, etc., are to appear therein.

Rules

For the Government of Dog Shows as Adopted by The Canadian Kennel Club (Incorporated).

I.—The word "Dog" whenever used in these rules includes both sexes.

II .- Every dog must either be listed or registered with the Secretary of the Canadian Kennel Club (official blanks will be furnished on application to any show secretary, or by the Canadian Kennel Club, Toronto) previous to being exhibited. The cost of such listing is twenty-five cents each year, expiring December 31st, and for registration, \$1.00, and the penalty for non-compliance is cancellation of winning, except where a club states in its premium list "This club assumes the collection and forwarding to the Canadian Kennel Club of all listing fees." Exhibitors must abide by any errors made in entering their dogs.

III.—Every dog must be the bona fide property of the person making such entry on the day of closing the entries. The entry must clearly identify the dog to be exhibited by name, and, if known, its date of birth, name of sire and dam, and the name of its breeder. Should any of these particulars be unknown to the exhibitor, it must be so stated on the entry blank. If the dog is already registered in the Canadian Kennel Club Stud Book, the Stud Book number of the dog should be given with the entry.

IV.—If the name of a dog which has won a prize at any recognized show has been changed, the old name must be given on the entry blank and published in the catalogue until such time as it wins a prize under its new name. The name of a registered dog cannot be changed.

V.—If a dog has been entered without being identified as directed in Rules III. and IV., it shall be disqualined and forfeit any prize which may be awarded to it.

VI.—The breeder of a dog is the person owning or leasing the bitch at the time of her being bred.

VII.—The authorities of any show may decline any entries they see fit, or may remove any dog on account of disease, vice or other cause.

VIII.—A castrated dog or spayed bitch shall be disqualified and forfeit any prize which may be awarded to it.

IX.—Total blindness, deafness or lameness shall absolutely disqualify. If the judge or veterinary surgeon is satisfied that the deafness or lameness be temporary, the dog shall be allowed to compete.

X.—A dog found to be suffering from any contagious or objectionable

disease shall be at once removed from the show building. The regularly appointed veterinary surgeon shall alone decide as to the condition of the dog, and his decision must be given in writing.

XI.—A judge may disqualify a dog which, in his opinion, has been improperly tampered with, subject to the decision of the veterinary surgeon. Should the judge's disqualification not be sustained, the class must be rejudged.

XII.—Full discretionary power is given to the judge of each class to withhold any or all prizes for want of merit. The judge's decision shall be final in all cases affecting the merits of the dogs, and appeals can only be entertained where misrepresentation or breach of the rules is alleged.

XIII.—Should an appointed judge be unable to fill his engagement, the committee shall have the right to fill the vacancy. All the separate classes of any breed of dogs must, however, be adjudicated upon by the same judge, or judges, acting in conjunction.

XIV.—In any class where there is a limit of weight, the person in charge of a dog entered in such class may claim of the show committee the right at any time after the opening of the show and before the judging, to have the dog weighed, and the weight of the dog shall be registered and hold good at the time of judging.

Any competing exhibitor or handler shall have the right to demand the weighing or measuring of any dog during the judging of the class other than those whose weight has been officially registered. Any subsequent protest must be made in the formal manner provided for in these rules. The Club must provide scales for use of the exhibitors and judges and designate official weighers.

XV.—Bench Show committees may provide such classes for dogs of established breeds as they choose, providing they do not conflict with the undermentioned classes.

1st. The puppy class shall be for American bred dogs over six months and not exceeding twelve months of age, and no entry can be made of one under six months, or whose date of birth, breeder, sire or dam is unknown. An American bred dog is one born on the continent of North America.

2nd. The novice class shall be for

American bred dogs never having won a first prize at any recognized show, wins in the puppy classes excepted.

3rd. The limit class shall be for all dogs never having won four first prizes in said class at any recognized show, but no dog having been recorded champion shall be eligible for this class.

4th. The open class shall be for all dogs of any age over six months. No prize winner shall be debarred from competing.

5th. The winners class at any show shall be open only to winners of first prizes in any class recognized at that show.

Ten points, which must be won under at least two different judges, shall constitute a championship.

The number of points allotted at any show shall depend upon the number of dogs actually benched, as follows:

Not less than 650 dogs shall count five points.

Not less than 500 dogs shall count four points.

Not less than 400 dogs shall count three points.

Not less than 250 dogs shall count two points.

Less than 250 dogs shall count one

The scale of points for all shows held west of Port Arthur shall be as follows:

Not less than 300 dogs shall count five points.

Not less than 250 dogs shall count four points.

Not less than 200 dogs shall count three points.

Not less than 150 dogs shall count two points.

Less than 150 dogs shall count one point.

In the case of shows conducted by specialty clubs, and confined to one breed, the scale of points shall be as follows:

Not less than 100 dogs shall count four points.

Not less than 75 dogs shall count three points.

Not less than 50 dogs shall count two points.

Before awarding reserve in this class the dog, or dogs, having been placed second to the winner in any of the recognized classes, must also be brought before the judge for competition. No class winner may be withdrawn or withheld from competition in the winners class. No entry fee shall be charged for competition in this class.

Winners classes shall not be allowed where two or more breeds are com-

The winners class shall be divided by sex, provided at least the open class is also divided by sex.

The winner of ten points in this class shall thereby become a champion of record, be so recognized by the C. K. C., and will, if registered in the Stud Book, be entitled to a Canadian Kennel Club championship cup. In the latter case, however, all points must have been won while the dog was owned by a member of the C. K. C.

The above rule shall take effect on March 1st, 1907.

Any dog that previous to this date has partially qualified for the championship title, shall be allowed to complete its championship under the old rule which was in existence previous to August 31st, 1906.

A certificate of the number of dogs actually present, signed by the president or chairman of the Bench Show committee, and the secretary or superintendent of the show, and endorsed by one or more members of the C. K. C. Executive Committee, shall be sent

by registered mail before the close of the show to the Secretary-Treasurer of the C. K. C. Blank forms for this purpose will be supplied by the C. K. C.

6th. The miscellaneous class shall be open to all dogs of established breeds for which no regular class has been provided in the premium list. Entries in this class must specify the breed of the exhibit. Failure to comply with this condition shall cancel the award, if any.

XVI. In estimating the number of prizes a dog has won, the number of prizes won shall be calculated up to 12 p.m. of the day preceding the closing of the entries of the show.

XVII. If a prize winner is disqualified, the next dog in order of merit as placed by the judge shall be given the prize thus. forfeited, and the win shall count in every respect the same as if it had been the original award. An equal first prize shall be counted as a win for each dog, dividing first and second money, the dog next in order of merit receiving third money.

XVIII. No dog eligible for special prizes can be withdrawn from competition unless it has been stated on the entry blank, "Will not compete for special prizes."

XIX. Dogs may be entered for exhibition or for specials only, if so stated on the entry blank; but any dog entered for competition and received at the show building must compete in all the classes for which it is entered, and failing to do so, shall be fined an amount equal to the entrance fee for each class. Dogs competing for specials only must be entered in one of the regular classes in which they need not compete,

In judging "general specials" or specials, of a similar nature the competition shall be restricted to dogs that have won first in their respective winners' classes. In cases where a special prize has already been awarded for the best of a breed, only the winner of this special shall compete.

XX. No special prizes may be accepted or offered by a show committee after the regular judging has commenced.

XXI. The age of a dog shall be calculated up to and inclusive of the day preceding the show; for instance, a dog whelped April 30th shall not be eligible on April 30th of the following year to compete for dogs under twelve months

XXII. An objection to a dog may be

made by any exhibitor, or any member of a Club a member of this association, but must be in writing and be lodged with the Secretary within seven days of the last day of the show. No objection shall be entertained unless accompanied by a deposit of \$5.00, except the same is lodged in the name of the Canadian Kennel Club, which may be made at any time. (For subsequent proceedings in protest see Rule XIV. of club regulations.)

XXIII. A person guilty of misconduct of any kind in connection with dogs, dog shows or field trials, may be suspended by the President of the Canadian Kennel Club, or in his absence by the vice-President, or by the committee of the show or trial where the offence was committed. The disqualification of an owner shall apply to all dogs owned by him, or connected with the perpetration of a fraudulent act.

XXIV. No person under suspension or sentence of disqualification may exhibit to take a prize, act as agent for an exhibitor, or take a dog into the judging

ring, at any show, or be connected in any capacity with dog shows held under C. K. C. rules.

XXV. Entries made in the names of a kennel must be accompanied by the name or names of the actual proprietor, or proprietors, but not necessarily for publication. The partners in a kennel will be deemed equally culpable in the case of fraud perpetrated in their names.

XXVI. The person presenting the identification ticket shall be recognized as the agent of the owner in the latter's absence, and his receipt for prize money shall be binding on the owner, unless notice to the contrary is endorsed on the identification ticket.

Regulations

Governing Clubs Holding Shows Under C. K. C. Rules.

Any club or association may hold a dog show under Canadian Kennel Club rules, provided it abides by the following regulations:-

1. Applications for dates must be filed with the Secretary of the Canadian Kennel Club for approval by the Executive Committee or such sub-committees as may be empowered to grant

Such approval, however, shall be subject to the subsequent endorsement of the premium list as being in accordance with the requirements of the Canadian Kennel Club.

II. Sec. 1. Application for dates must be accompanied by a deposit of \$25.00, which will be forfeited in the event of the show not being held, or failure to comply with the requirements of the Canadian Kennel Club, as set forth herein.

Sec. 2. Shows not exceeding 250 entries will be charged a fee of \$10; 250 and under 350 entries, \$15; 350 and under 450 entries, \$20; and over 450 entries, \$25. The difference between these amounts and that of the deposit shall be refunded on publication of the entries.

III. Sec. 1. The show shall not extend beyond four full days.

See, 2. Entries shall close not less than seven days prior to the first day of the show, and a club accepting any entry after that date (unless postmarked on the date of closing entries) shall be subject to a fine of not less than \$10 for each entry so accepted. No alteration of the date of closing entries shall be allowed.

Sec. 3. The classification shall be confined to established breeds, which may be divided by sex and otherwise, as provided for in the dog show rules. No change in classification will be allowed unless announced before the date for closing entries, unless such change is covered by the published regulations of the show.

IV. Sec. 1. Every bench show must employ a qualified veterinary surgeon.

Sec. 2. A qualified veterinary surgeon is a graduate of a recognized college entitled to confer the degree of V.S., or one who, without having a diploma, has had at least five years' practical experience to fit him for the practice of his profession.

V. The premium list must contain the dog show rules of the Canadian Kennel Club, also a list of the officials under whose management the show is to be held, who, with the exception of the paid employees, shall be held responsible for the payment of all prizes within sixty days of the last day of the show, in default of which the said officials shall be suspended or disqualified for such time as the Canadian Kennel Club shall determine.

VI. No special prize can be offered ex cept for dogs of established breeds, and none can be offered, unless publicly announced before the regular judging has commenced.

VII. All prizes must be in accordance with their description in the premium list. Prizes of gold and silver must be of the purity of standard coin. Prizes in a given class shall be awarded regardless of the number of entries, except as otherwise defined in Rule XII.

VIII. No person under sentence of suspension, disqualification or expulsion may be employed in any official capacity, or exhibit, or take a prize, or act as agent for any exhibitor, or show a dog in any judging ring,

IX. No entry shall be accepted of any puppy under six months of age, either for competition or exhibition, subject to a penalty of \$10 for each under age puppy placed on exhibition.

X. No entry can be accepted or any dog not marked "listed" or "registered" on the entry form, as per dog show Rule II., subject to a fine of \$5 for each offence.

XI. A club may act as agent for exhibitors by accepting the fee for registration or listing, but must make immediate returns thereof to the Canadian

Kennel Club. A penalty of \$10 for each day will be enforced for any delay beyond ten days from the date of closing of the show, in making such returns to the Canadian Kennel Club.

XII. The catalogue of the show must give all the particulars required of exhibitors in entering dogs, as provided in Rules II., III., IV., XV. (section 6), of the dog show rules. It must also contain a list of the officers under whose management the show is held, together with a copy of the dog show rules and such other regulations as were aunounced in the premium list.

XIII. Only Canadian Kennel Club Stud Book numbers shall be used in the catalogue.

XIV. In the event of a protest being filed in accordance with Rule XXI. of the dog show rules, the mode of procedure shall be as follows:—

The show committee shall at once meet and decide upon any objections lodged during the show, and from their decision an appeal may at once be made to any member of the Executive Committee of the Canadian Kennel Club who may be available, provided such member is not on the show committee. If the second decision is adverse to the appellant, the deposit of \$5 is thereby forfeited to the show committee.

Immediately upon the lodging of a

protest with the Secretary during the show, it shall be his duty to request the judge to select reserve numbers, if he has not already done so, in order that any prize which would be affected by the disqualification of the protested dog may not fail of being awarded.

If the objection is lodged subsequent to the show, it must be decided by the committee within twenty days from its receipt. Five days' notice of the date and place of meeting for that purpose must be given to all parties interested.

From any such decision or decisions appeal may be taken to the full Executive Committee of the Canadian Kennel Club. But such appeal must be forwarded to the Secretary within seven days of the decision being rendered, together with a deposit of \$10. If the decision appealed from is sustained, the \$10 deposit shall be forfeited to the Canadian Kennel Club, but if the decision is reversed then all deposits must be returned to the applicant.

XV. In the event of the suspension by a show committee of any person for misconduct, as provided for in Rule XXII. of the dog show rules, notice of such suspension shall be forwarded within twenty-four hours to the Secretary of the Canadian Kennel Club, who shall at once notify the President, or in his absence the Vice-President, who shall investigate the case, and, if he sees fit, suspend the penalty until the next meeting of the Executive Committee. The Executive Committee must, at their first meeting thereafter, either remove the suspension or must impose a penalty of disqualification for such a period as they may decide upon.

The disqualification of an owner shall apply to all dogs owned by him or connected with the perpetration of a fraudulent act. The Executive Committee of the Canadian Kennel Club is, however, empowered to use such discretion in the enforcement of this penalty as shall protect innocent parties.

No person shall, however, be disqualified without due notice, and formal charges and specifications, and an opportunity given of being heard in his own defence.

XVI. Such regulations may be adopted for the government of any show as shall be considered necessary, provided they do not conflict with any of the foregoing or of the dog show rules.

Finally adopted.

Recognized Shows.

Wins at all shows under C. K. C. or A. K.C. ules will be recognized. (The latter at shows held outside of Canada only.)

Special Note.—As the Canadian Kennel Club recognizes all wins made under A. K. C. rules except in the case of winners classes, at shows held outside of Canada, owners should be careful to enter dogs in their proper classes.

Official Minutes of Executive Meetings held on January 18th and 25th.

At the meeting of the Executive Committee held in Toronto on January 18th, the President, Mr. Jno. G. Kent, occupied the chair. Mr. A. A. Macdonald reported progress for the Committee on Constitution and By-laws, Rules and Regulations.

The secretary was ordered to send a coupon for the free registration to each member who had paid his fees.

After full discussion, it was decided to accept no registrations on wins. In each case full pedigree for three ganerations must be given.

Mr. Jno. G. Kent and Mr. W. P. Fraser were elected delegates to the Canadian National Exhibition, Toronto.

Meeting adjourned to January 25th, same time and place.

At the meeting of January 25th Mc Kent was again in the chair.

Mr. Macdonald moved the adoption of the report from his Committee on Constitution and By-laws, Rules and Regulations, seconded by Mr. Fraser, and

after discussion and amendment, carried. The results of the committee's labors will be found printed elsewhere in this

It was decided to adopt the list of recognized breeds issued by the American Kennel Club.

Moved by Mr. Slattery, that a fee of one dollar, to cover average cost, be charged for the investigation of each complaint not arising out of misconduct at shows held under C. K. C. rules. No charge to members. Seconded by Mr. Tibbs and carried.

The cost of copies of pedigrees was made 50c, with a rebate of 50 per cent. to members.

Fee for search of any kind to nonmembers to be 25c. Free to members.

The allowance for rent and clerical

assistance was made \$600 per annum. The following letters were read:-

Alberta Kennel Club. Calgary, Jan. 11th, 1907.

H. B. Donovan, Esq., Secretary Canadian Kennel Club, Toronto:

Dear Sir,-Referring to your letter of the 5th November last, the managing committee of this club held a meeting on the 8th inst., and the following resolu-tion was passed:—"Taking into consideration the fact that it has been decided that Toronto will be allotted five points for championships, the Alberta Kennel Club would suggest the following points should be allotted for Alberta, provided all other shows west of Port Arthur are placed on the same footing:—

1 point for shows having 100 dogs or

under actually present.

2 points for shows having over 100 dogs and under 200 actually present.

3 points for shows having over 200 logs and under 300 actually present. 4 points for shows having over 300 dogs and under 800 actually present. 5 points for shows having over 800

dogs actually present.

A copy of this letter is being forwarded to the secretary of the Van-couver, Victoria and Western Kennel Club shows for their information.

Dear Mr. Kent,-A Happy New Year to you.

I understand there is to be a meeting of the Executive of the C. K. C. one of these days, and I suppose the matter of chamnpionship wins or ratings will be decided on. It seems a pity to make the points the same for all breeds at the one show. For instance, it seem to me only reasonable that the winners in such classes as Cockers, at the last Toronto show, should be awarded a championship without having to win at other shows. I know some people would object to a dog winning his championship at one show and under one judge, and possibly it would be well to withhold championships unless a dog won under at least two judges.

If it were possible to give champion-ship points according to the number of dogs present in the different breeds, say one point to every ten dogs exhibited, and the winner of ten points (under at least two judges) to be awarded the C. K. C. championship.

To adopt a rating on the lines of the A. K. C. while we have so very few shows a year, seems hardly fair to some breeds. For instance, owing to the sea-son of the year, it is hardly probable that Toronto is ever likely to have such entries in Collies as we have had in Mont-real—at a season when long-coated dogs are generally in full coat, and to give five points to the Collie winner at To-

ronto and perhaps three points to the Montreal winner seems unfair. It would be perhaps still more unfair the other way, to give the winner in Cockers at Toronto last year only five points, with the largest entry ever known in the breed, while perhaps the winner at Mont-real, with a very slim entry, would get three points. I hope the C. K. C. will devise some scheme to award their championships according to the dogs exhibited in each breed, and not as the A. K. C.'s championships are awarded on the total entry of all breeds.

The A. K. C. is "run" by a few, principally resident in or near this city.
The C. K. C., being composed of individuals, each retaining his individual right to vote as he sees fit, could never get into the position at present occupied by the club on this side of the line. other words, the C. K. C. is democratic, the Club of the people, while the A. K. C. is autocratic, the Club of the few, and (by incorporation) even that original few greatly reduced.

0 THE ORIGIN OF THE DOG.

A great deal has been in print in various publications, respecting the origin of our domestic dogs. Charles igin of our domestic dogs. Darwin says they are descended from wolves. A. Bartlett, late superintendent of the Royal Zoological Gardens, London, wrote an article for "The Leisure Hour," in which he says he is of opinion that dogs are descended from wolves. Previous to his appointment at the Zoo he was naturalist or taxidermist at the Crystal Palace, Sydenham. He then used to say that dogs were descended from the Arctic fox. That, in my opinion, is quite impossible, foxes being vulpines and not canine. Mr. Bartlett, I believe, never bred any dogs or wolves, neither did he ever, to my recollection, cross any welves and dogs together. I knew Mr. Bartlett all my life, and am, in fact, nearly related to him. My object in this article is to show and prove the fallacy of supposing that dogs are descended from wolves; also, the impossibility of such a thing. While engaged at Manchester Zoological Gardens I had a good opportunity of testing the matter. Some wolves had been bred there for years, consequently they were very tame and gentle. One of the fe-males had a litter of young ones, and when old enough I took a male away and treated him as a pet. He became just like an ordinary dog, followed me about, and I took him through the streets into houses, and the children used to play with him and I don't think he had any vice in him. When about 18 months old I tried several crosses with him and female dogs of different varieties. Some were complete failures. The first, a Mastiff, would have killed the wolf. She went for him, and we had a lot of trouble to get her away without seriously in-juring the wolf. I had an opportunity of trying the wolf with a Deerhound, who was still worse. Some time afterwards I tried him with a cross-bred Collie and Retriever, which was a success. five pups, all black, being the result of

the union. Some time afterwards I tried a very handsome black Retriever bitch. She was frightened of the wolf, lay down, howled, trembled, and could not be coaxed near the vulpine. I afterwards crossed him successfully with a cross-bred bitch of larger size. Result, three pups, all quite black. I afterwards crossed him with a cross-bred Collie and Greyhound. Result, all black pups. I sold some of the hybrids and gave some away. One I gave to a farmer, who was going to do wonders with him. I kept three myself, one male and two females, to experiment with. The one I gave to the farmer was a fine large animal, much larger than the parents, with a very long silky coat and a head like a fox, and fine bushy tail; in fact, they were all much alike, except in size. In that they differed very much. They also differed in their tempers and dispositions, some being gentle and affectionate, others cunning and so unmanageable that they had to be destroyed. They all had that objectionable smell so peculiar to the wolf, and no amount of soap and water would remove it. None of them barked, or were of any use as watch dogs. They would allow as much petting from strangers as friends, and did not seem to care who it was they licked or bit. When old enough I tried to breed from the farmer's wolf dog with three different female (dogs), but it was a complete failure. He would not take any notice of the bitches, and bad no notion what-ever of what was expected from him, not even right up to his death. I af-terwards tried to breed from my own hybrid, and it was the same in every way. The two females were sterile mules and would not breed. They would fly at any dogs brought near them, and were never in season. The wolf, the sire of the hybrids, could never be taken about with any pleasure owing to the smell that came from him. I kept him clipped and well washed for some time, but it never improved him; he smelt just as bad. The fact that the first cross between

wolves and dogs produces barren unles, in my opinion, proves the impossibility of dogs being descendent from wolves. The first cross will not breed again Then, again, where does our domestic dog get the bark from? Wolves never bark; they howl, but don't bark. Our domestic dog, if kept clean, has no objectionable smell. If dogs were descendents of wolves they would smell, and not bark or breed again.

I may here suggest that should any one wish to try the experiment of crossing the wolf and domestic dog together, the wolf must be the mate. Fe male wolves and dogs will not breed

together. I have tried that also. I brought up in a pen together a young female wolf and a mongrel larger-bred puppy, but nothing came of it. They were good friends, nothing more. This wolf afterwards bred with a wolf. The quarrelsomeness of the Mastiff and Deerhound before-mentioned proves that they have not a close affinity with the wolf, but, on the contrary, look upon him as their natural enemy. If a wolf and domestic dog are kept together in a pen, and the wolf is kept hungry for some time, he will kill the dog and eat him. If domestic dogs are kept together, no matter how hungry, they will never kill and eat each other.

I will only add in conclusion that to obtain a cross between the wolf and domestic dog is no easy matter; there is a lot of trouble attending it. the bitch has pupped to the wolf she does not pay that attention to the pups she should do, owing to the different smell, and she is glad to get rid of them as early as possible.-Francis T. Smith in Our Dogs.
