NOTES AND COMMENTS

Spaniel Club: What has become of the Canadian Sporting Spaniel Club? Where are its records, its books, its trophies? The C.S.S.C. was at one time a real live institution in Canadian dogdom, a club of influence with a large membership. That it should thus disappear into a mere visionary, ghost-like memory is to be greatly regretted. Surely there are a sufficient number of Spaniel breeders in Canada to support a reorganization. Men who are to-day interested in breeding and showing Cockers and other sporting Spaniels, let us hear from them. If a reorganization is possible, let us have it and at once. If it is thought better to begin all over again, let us say so and go ahead. In either case, if any encouragement is given we should be glad to see that the necessary preliminary office work was done.

Does any breeder know who has the documents and properties of the old Club? If he does, we should be glad to be made aware of the fact, so that we may have some basis to work on in case a revival is thought to be possible and desirable. Let us hear from the Spaniel men.

Here is another: Mr. George Robertson, of Ottawa, writes under date of Dec. 2nd:

You may discontinue the advertisement for the present. I have shipped H. Prince Chairlie to Mr. Strachan of Cantley, Que. His brother, H. Shepherd, which I had not advertised, is to go to New York State in a few days. The other two mentioned, H. Francie, and the sable and white bitch, H. Effie, I expect to ship shortly, as negotiations are just about closed for them. In the report of the Collie winnings at Ottawa in the last Gazette you credit H. Prince Chairlie with winning 3rd open; this is a mistake, as it was H.

Francie who won. In looking over the stud book just received, I find that H. Warlock is credited with 2nd puppy at Ottawa. This is a mistake, as Warlock won 1st puppy and Reserve winners the year before. The win should have been 2nd novice, as Warlock was too old for puppy class. In looking up Warlock's previous wins I notice that my bitch H. Morna is entered in the winnings as H. Mona in Vol. X.

I notice that the Canadian Collie Club is supposed to look over the Collie part of the stud book. Can you tell us through the Gazette who the Club is and what it is supposed to do. Several years ago I sent my application for membership to the Secretary, together with necessary fees, which were acknowledged. Since then I have never heard of a meeting, election, or anything else in connection with it. It seems queer that a Club devoted to such a grand breed as the Collie should keep so much in the background.

Our reply was as follows:—

"Replying to yours of Dec. 2nd, the win of Hazelbrae Prince Chairlie was published in the Gazette as it was recorded in the marked catalogue sent us by the Ottawa Kennel Club; also the name Mona was in the Stud Book as it was in the marked catalogue. We very much regret the error in the winnings of Warlock and will have a correction made for the next issue of the Gazette."

We know little about the Canadian Collie Club. Its meetings, if any are held, are not reported to us. Mr. A. Brosseau, Montreal, is the Secretary, and we feel sure will be glad to give further information.

Yet another: While on the subject of specialty clubs, we may be permitted

to ask what is the Canadian Fox Terrier Club doing? Does the Club hold any meetings? What is the date of last annual meeting? Perhaps Mr. Jacobi would rise up and make a few remarks. With the increased interest taken in Fox Terriers this old and respected Club should spruce up.

From the coast: It is our aim at all times and in all seasons to impress one fact on Ontario breeders particularly. And that fact is that the Canadian Kennel Club is in verity a Canadian Club in every detail and not a provincial institution. The long list of members that the C. K. C. has in the West and in the East proclaims this to be entirely true. As an example of how the C. K. C. is appreciated we may be allowed to use the following letter of thanks.

O. K. C.: The Ontario Kennel Club has had printed for distribution amongst its members the Constitution and By-laws of the Club. The pamphlet containing the material referred to is of nice size for enclosing in an ordinary envelope and is very neatly gotten up.

Dr. Jarrett's purchase: The Collie puppy that this gentleman purchased from the King Edward Kennels during his judging visit to Toronto in September is developing into such a good one that she is destined for New York show. We hope this daughter of Southport Star may prove as witching as a previous product of Mrs. Gordon's kennel did.

Glenholme Collies: Mr. Bulloch advises us that he has already disposed of all the Collie puppies he advertised in Gazette. With an increasing circulation, the Gazette appears to be reaching the people who have money to buy dogs.

New York Collie Judge: Mr. John Black, who made such a favorable impression as judge of Collies at Toronto last September, will officiate in the same capacity, at New York in February. This will be the fixture chosen by the Collie Club of America for its specialty show. Innumerable special prizes will be offered, and we are told that Canadian fanciers will be generously dealt with.

Otterburn sales: Dr. C. Y. Ford has sold Otterburn Opulence, a winner at Toronto, 1907, in whelp to Holyrood Professor, and Otterburn Olivia in whelp to the recently imported Strathcast Ralph. The former goes to Winnipeg, the latter to New Brunswick. Both are good ones and are sired by Otterburn Ornament.

King Edward Kennels: The amount

of kennel space available for the famous Collies of Mrs. Gordon's kennels, has been largely increased. The poultry house and runs erected by Mr. Hammall have been vacated by the feathered folk and the Collies have taken possession.

The puppy crop has grown apace and there are many now from four to five months old that are over all apparent danger. A quartette by King Edward Tytton ex. King Edward Albina, are most promising, as is the litter by Holyrood Professor out of Southport Sarah. Then, amongst a host of others are two by King Edward Tytton ex. King Edward Style that are looked upon to make history. Mrs. Gordon has found the demand for good Collies very brisk, and there are several to cross the border if Uncle Sam continues in a lenient mood.

The embargo on dogs: Dogs, we presume, must have some connection with the dreaded foot and mouth disease, otherwise the embargo recently placed on all live stock coming into Canada, even to canary birds, would not apply to them. The embargo is to remain, we learn, for a period of six months with a further extension if the powers that be think it necessary.

The Canadian Express Co. tell us that dogs are permitted to go from Canada to the United States by the International bridge at any rate, but how long this will remain so is uncertain. It will be a hardship on Canadians who desire to exhibit at New York and other shows, as even if allowed entrance to the United States, they will not be permitted to return to Canada.

Gazette sells dogs: The Clapton Kennels have received many inquiries regarding the young stock offered in the last issue of the Gazette, by Champion Sabine Resist, Mr. Bailey writes. He withdraws the ad. from this issue as he considers the whole four Terriers sold, having received replies from Toronto, Montreal, Winnipeg, Vancouver and many other points. "I con-

sider the Canadian Kennel Gazette the best salesman of them all," is the flattering comment of the above gentleman in his newsy letter to the Editor.

Aldon Trifle—Clapton Blue Blade: Mr. Charles L. Mewburn, Hamilton, Ont., has bred the smooth Fox Terrier bitch, Aldon Trifle, by Champion Aldon Tipster to that well known son of Ch. Warren Blue Blood, Clapton Blue Blade. The outcome of the mating will be watched with interest. Blue Blade is a direct outcross to Trifle. Judging from the individual results attained from the blending of such good blood.

B. C. Fox Terrier show: At the Specialty Show of the B. C. Fox Terrier Club, held last week in Vancouver 52 dogs were benched. We hope to have a report in this issue.

Bulldog transfer: We are asked to note the transfer of the Bulldog Homewood Blackstone, from Mr. L. Thomas to Mr. T. H. Trimble, both Toronto.

Fox Terriers in B. C.: Leander Clapton the excellent stud and show dog reported by Mr. W. D. Bruce, a gentleman who has done so much for Fox Terrier interests on the coast, has several grand puppies to his credit, in addition to being good all round Terriers, excel in bone and neatly carried small ears. His Ingartestone, too, is being used quite freely with good effect.

Mr. Bruce was in Toronto a few weeks since and is apparently as keen as ever in his love for a good Fox Terrier.

Popularity of the Boston.

The letter which appeared in your November issue, signed by Mr. G. A. Beaumont, was not altogether unexpected. It is pleasing to note that at last someone has come forward to supply the world at large with the doings and progress of the Boston Terrier fancy. In the course of his ramblings over ancient and modern history, Mr. B. goes so far as to accuse fanciers of other breeds with seeking to belittle the cause of his favorite. Now, as I am a breeder of the "largest class of all dogs," and also hold the position of press representative to a prominent kennel club, I have come to the conclusion that in some way or other my contributions to an evening paper have unwittingly aroused Mr. Beaumont's displeasure.

It is not recently, but some months ago, since I had occasion to repeat a certain question which had been put to myself by a prominent Boston breeder: Why are Bostons not enjoying the popularity in Toronto which they did some little time ago? Be the cause whatever it may, the fact remains that at least one fancier whose name was almost a household word in connection with this breed is contemplating seriously taking up the Bulldog cause, and dame rumour has it there are more to follow.

Now, Mr. Editor, you know what the

position of press representative is like, also the fact is borne to us every day that there are many among us whose short-sightedness will not carry their vision beyond their own back yard; whose chief delight is to pick up the work of a hard-working editor or otherwise busy press representative and find faults in all he sees, and when I told you that I have received four contributions in nearly as many months from the Boston fancy, it will be no trouble for you to shoulder the blame on to the right shoulder. If injustice has been done, the "grumblers" have only to bestir themselves, and by a little effort keep the kennel press posted with the doings and life of their favorites and they will find that one and all will receive their due share of notice.

Mr. Beaumont waxes warm in his outburst, and goes on to accuse press representatives and reporters in general with narrow-mindedness, etc. We can forgive our enthusiastic friend in his present state of mind. But when he oversteps the line and accuses the breeder of the "largest canine" with running down the Boston to further his own ends, I will don the cap (though the fit is not of the best) and contradict Mr. B.'s statement. The notes for which I was responsible and which touched on my favorite breed were sent to me from other centres than Toronto, sent by fanciers who are neither troubled with idleness, disinterestedness, or any other disagreeable failing in the canine cause.

However, most of us know what the symptoms are when one accidentally stumbles across a home-bred winner, and the breeder of Topsy B. has my most sincere wish for a speedy recovery. Like the peddler's "mule," he wanted to kick two ways at once and landed with both feet on the unoffending press. Sincerely yours,

Tuesday evening, December the 8th. The first item on the programme was the matches for puppies. Mr. E. Garner officiated as judge in the Bulldogs. In the dog puppies, Rolling Demon, owned by Mrs. R. Manders, of Hamilton, secured the honors. Mr. Dowling's Uncle was second, and Bert Stone, owned by Mr. E. Maybee, was third. Five in the class. Persistence, owned by Mr. A. A. Lees, of Hamilton, won the bitch puppy class. Snow-White, owned by Dr. A. A. Boulbee, was second. Mr. H. A. Wilson's Fair-play was third. Four in the class.

Mr. Charles Lyndon judged the Bull Terriers. There being only four competitors, one class was made for both sexes. General Buller, owned by Mr. J. Miles, got first, Mr. F. W. Cole's Countess II. was second, Stockwood Betsy, owned by Mr. Steve Gordon, was third. In the absence of Mr. Fairwell, Mr. Lyndon judged the Cocker puppies, both sexes in all colors in one class. Lilian, a nice black puppy, three months old, by Billy Obo, owned by Mr. P. H. Bonser, got the red ribbon. Mr. J. Hunt secured second place with a nice red, Parkside Bubbles. Mr. V. H. Annable's D'Arcy A. (red) was third.

The greatest interest of the evening centred in the competition for the Crowther Cup, put up to be competed for by the winners in each breed at the various monthly shows held during the year. Mr. Lyndon awarded the Cup to Inferno, the celebrated Bull Terrier owned by Mr. Miles, and his decision evoked considerable applause. Mr. Walter Sands had a close contender in his wire haired Fox Terrier, Broadway Double. Mr. Tibbs' Somerset Pride was placed third. This is the well known red Cocker stud dog.

Mrs. E. T. Andrew, of Hamilton, sent down a nice little Boston, Lady Carmine. Through a misunderstanding there were no competitors in this breed of puppies, however, in consideration of the fact that Mrs. Andrew had sent the bitch all the way from Hamilton, she was awarded a ribbon.

The annual meeting for the election of officers and transaction of other business will be held on December 22nd at 8 p.m., at Wolsley Hall. A large attendance of members is expected, as this will be the first meeting of members in the new headquarters.

The Boston Terrier Standard.

The general appearance of the Boston Terrier is that of a smooth, short-coated, compactly-built dog of medium station. The head should indicate a high degree of intelligence, and should be in proportion to the dog's size; the body rather short and well-knit, the limbs strong and finely turned, no feature being so prominent that the dog appears badly proportioned.

The dog conveys an impression of determination, strength and activity. Style of a high order, and carriage easy and graceful.

Skull.—Broad and flat, without pro-

and wide, with a well defined straight line between nostrils. The jaw, broad and square, with short, regular teeth. The chops wide and deep, not pendulous, completely covering the teeth when mouth is closed.

Neck.—Of fair length without throatiness, and slightly arched.

Body.—Deep and broad of chest, well ribbed up. Back short, not roached. Loins and quarters strong.

Elbows.—Standing neither in nor out.

Color.—Any color, brindle, evenly marked with white strongly preferred.

Markings.—White muzzle, blaze on face, collar, chest and feet.

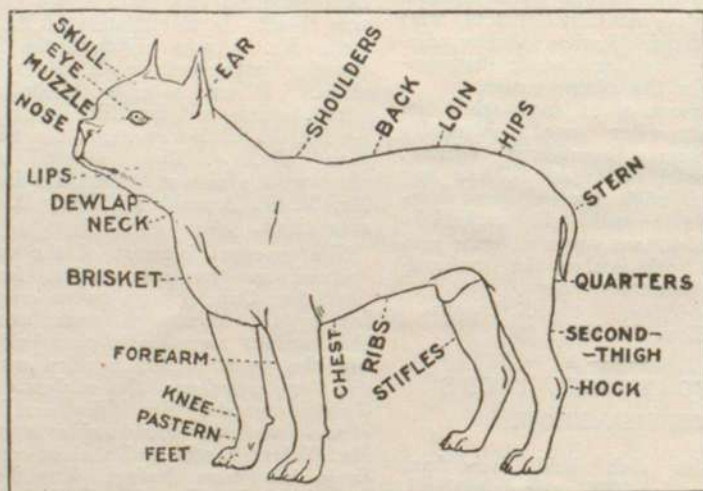
Coat.—Fine in texture, short, bright, and not too hard.

Weight.—Light-weight class 12 and under 17; middle-weight class 17 and under 22; heavyweight class, 22 and under 28 pounds.

Disqualification.—Docked tail and any artificial means used to deceive the judge.

minent cheeks, and forehead free from wrinkles.

Stop.—Well defined, but indenture not too deep.

Eyes.—Wide apart, large and round, neither sunken nor too prominent, and in color dark and soft. The outside corner should be on a line with the cheeks as viewed from the front.

Ears.—Small and thin, situated as near corners of skull as possible.

Muzzle.—Short, square, wide and deep, without wrinkles. Nose black

Fore Legs.—Wide apart, straight and well muscled.

Hind Legs.—Straight, quite long from stifle to hock (which should turn neither in nor out). Short and straight from hock to pastern. Thighs well muscled. Hocks not too prominent.

Feet.—Small, nearly round, and turned neither in nor out. Toes compact and arched.

Tail.—Set on low, short, fine and tapering, straight or screw, devoid of fringe, or coarse hair, and not carried above the horizontal.

SEND BITCHES IN GOOD TIME.

I would like to urge upon the several parties who have written and made arrangements or expect to send bitches to my stud dogs, the advisability of sending bitches along in good time. In no less than three cases in the past two months we have had to inform parties that they had held their bitches too long and that they had gone over their season. Now these gentlemen are out an expected litter of puppies, and incidentally we are out the stud fees. We have good and sufficient accommodation so send them along in good time as we don't mind looking after them, and it assures the breeder that his bitch will be served when she is properly ready at the proper time. I have been on a two months' trip through Saskatchewan and Manitoba, which is the cause of me not receiving your letter. However, in reply, I would say, the mistake in name of the two Collie bitches shown at Calgary and Winnipeg, was not mine. The bitch, Alberta Lassie, is a tri-color, which won in tri-color class only at Calgary. The two I sent to Winnipeg were both sable and white, Alberta Lady and Alberta Connie. My only reason for this error is this, when the Calgary dogs were entered for Winnipeg, not being present at the time, my entries were made by other members of the Club, and they, thinking I wanted to send my tri-color bitch, Alberta Lassie, they entered her, also Alberta Connie. On my return, and finding which two had been entered, I at once went to Dr. Smith, who had the Winnipeg entries, and asked him to change the entry of Alberta Lassie to Alberta Lady, which he agreed to do. I shipped the two, and nothing more was done until I wired Winnipeg for results the day after they were judged. The reply came back, Alberta Connie, 3 firsts; Alberta Lassie, 1 3rd. I thinking this was simply an error in name, thought nothing more of it until receiving your letter on this matter. However, I can assure you that both Alberta Connie and Alberta Lady (names I entered) are both sable and white.

In regard to your letter re dates of birth of Alberta Lassie and Alberta Clinker, also their breeding being identical, is most certainly an error. I bred them both and have dates of birth.

Alberta Connie and Alberta Clinker are from same litter, but Alberta Lassie is of entirely different breeding and date of birth, and was not shown at Winnipeg.

When I returned I found my entries had been made, but one bitch was entered I did not want to send, so went to Dr. Smith and told him of the fact and asked him to change it for me. The two bitches I sent were much alike in appearance, both sable and white. Alberta Lady and Alberta Connie. The one whose name was evidently sent in was a tri-color, Alberta Lassie.

Alberta Lady (Holyrood Conquest — Scottish Queen).

Alberta Connie (Holyrood Clinker — Woodmansterne Connie).

Alberta Lassie (Netherall Laddie — Alberta Queen).

Above is the breeding of the three in question, which I know to be correct, as I have bred and raised them all. If anything different is on the entry form it is not correct. 10. Ormiston Roy, vs. Ottawa Kennel Club: This correspondence is voluminous and follows herewith.

Montreal, 2nd November, 1908.

H. B. Donovan, Esq.,

Dear Sir,—I beg to appeal to your Club for its rulings in certain matters of dispute between the Ottawa Kennel Club and myself.

I enclose all the correspondence which I can lay my hands on, and which I trust explains the case.

I claim to have been unjustly treated on more than one occasion in my dealings with the Ottawa Kennel Club, and inasmuch as the case dates back to the Ottawa Show of 1904, I am not just certain of your Club's jurisdiction in the premises. In any case I would like you to take good care of the papers I enclose, and return them to me in order that I may, if necessary, take legal action, before my claim is prescribed by law.

A summary of the case from my point of view is as follows:—In 1904, while I was in kennel partnership with Mr. J. Cromwell Cox of Ottawa, and under the name of the Balmoral Kennels, I made certain entries at the Ottawa Dog Show, winning, according to advice I received later from the Club, the sum of \$26.50, which amount has never been paid to Mr. Cox or myself.

On the 11th January, 1905, I wrote asking the Secretary of the O. K. C. to remit to me the amount won by the Balmoral dogs in 1904, and received no reply.

A copy of my letter appears herewith as exhibit No. 1.

On the 5th Sept., 1905 (the day the entries closed), I mailed certain entries to the Ottawa Show, and told the Secretary to deduct the entry fees from the unpaid prize money due me since 1904. On the 7th Sept., 1905 (the day the entries closed), I mailed certain entries to the Ottawa Show, and told the Secretary to deduct the entry fees from the unpaid prize money (two days later), the Secretary wrote me saying that he had that day received my entries but regretted they were too late, as the show entries had closed, and expressing surprise that I had not received my prize money for 1904, as the amount was marked paid in the books.

His letter appears as exhibit No. 2.

This action appeared to me unjust, as my entries were posted in Montreal on the 5th of September, the last day allowed for making entries, but I did not deem the matter of sufficient importance to protest it. However, I wrote the Secretary the following day, on the 8th of September, telling him I thought it was understood my prize money had not been paid, as I had written asking for it, and had spoken several months before to Mr. Newton, whom I understood was a member of the Club. This letter I enclosed in a letter to Mr. Cox, my kennel partner, and asked him to forward it to Mr. Hillsdon if he had not received the prize money. (Exhibit No. 17 is an

extract from letter which I received from Mr. Cox in reply). The copy of my letter sent to Mr. Hillsdon through Mr. Cox appears as exhibit No. 3.

On the 19th January, 1906, I wrote Mr. Hillsdon, the Secretary, asking if there was any way for me to get the prize money in question and stating that if it was not settled I should reluctantly be compelled to report to the C. K. C.

(Copy of my letter exhibit No. 4.)

To this he replied (exhibit No. 5) in a letter dated 21st Jan., 1906, saying he had written me on the 18th Oct., 1905, asking for an affidavit, and enclosing copy of said letter of the 18th Oct. (which is marked exhibit No. 6).

On the 23rd Feb., 1906, I received letter (exhibit No. 7) from Mr. A. D. Ramage, then secretary of the O.K.C., asking for the affidavit, and stating the Committee wanted to have the matter cleared up.

On the 24th February, 1906, I wrote Mr. A. D. Ramage, asking him to inform me what amount of cash prizes the Balmoral Kennels won in 1904, in order that I might give the affidavit he requested.

(Copy of my letter exhibit No. 8.)

On the 8th March, 1906 following, Mr. Ramage wrote me saying \$26.50 was the amount I had won. (Exhibit No. 9.)

On the 25th April, 1906, I officially notified the Secretary of the O. K. C. that I had never received the prize money. (Exhibit No. 10.)

I received no further word from the Club on the subject, until I referred to the matter in a protest I forwarded to the Secretary, Mr. A. N. Payne, on the 25th September last, in connection with the last Ottawa show, and had I not been again the victim of what I consider unfair treatment in my dealings with the Ottawa Kennel Club, it is possible I would have let the matter of unpaid prize money drop. The protest referred to was in regard to the winner of the Earl Grey Cup, and I enclose a copy of my letter of the 25th Sept., which explains the case. (Exhibit No. 11.)

Exhibits Nos. 12 and 13 are the Secretary's acknowledgement of my protest, and his reply notifying me of his Committee's decision.

Exhibit No. 14 is a copy of a letter I wrote Mr. Andy Armstrong, Superintendent of the show, on the 25th Sept., and exhibit No. 15 is his reply thereto.

Exhibit No. 16 is my last letter to the Secretary of the Ottawa Kennel Club, and I think fully explains the stand I shall take to have the whole matter cleared up, first by appealing to the Canadian Kennel Club for its ruling in those points that may come within its jurisdiction, and later, if need be, to take such legal action as may be necessary to secure my rights in the matter.

If there is a formal way that should be followed to put the case before the Executive of the Canadian Kennel Club and if it is necessary that I should make a deposit in earnest of my good faith, please inform me and I shall comply with the rules at once.

I need hardly mention how very unpleasant a task it is for me to lay such complaints against any Club, but I think I have done everything within reason to have the matter settled out of court.

I may say that on our membership card and in our constitution it is distinctly stated that memberships expire on December 31st of each year. This means that while your fee was paid in 1907 it had lapsed, and you were not a member in good standing in 1908. We have had to enforce this rule on account of the abuse of entering as members at the last moment. I may say that this was done this year before the show and after the closing of entries, to several of our best hitherto members, but who had neglected to pay.

As regards your claim of this Club being in your debt, I may point out that this has been a matter of much controversy in the past, all of which is well known to yourself. I might also point out that last year you made no mention of this but came in as an ordinary member. Also that on your entry blank you did not make any such arrangement with the committee.

The list of members was posted up in the building the first day of the show, and no objection was made to it.

If such is the case I must enter a protest at once as I claim to be a full fledged member of that club, having joined it last year when I competed for and won the cup in question with my dog Champion Balmoral Baron.

Surely the Secretary was not short-sighted enough to strike my name from the list of members for non-payment of dues, without notifying me, and especially when the O. K. C. is so largely in my debt.

Unfortunately, I feel that this is not a matter that comes directly under the O. K. C. at this stage of the game or I should at once lodge a protest with that body.

In the meantime I am writing the Secretary of the O. K. C. and unless the matter is adjusted promptly and the Earl Grey Cup awarded to my dog, Champion Balmoral Rex, if he should have won it, and who I understand won the prize for the best Colie, beating his daughter, Mr. Binning's good bitch, who is credited with winning the cup this year, I shall place the matter in the hands of my lawyers without delay.

The whole question rests on my status as a member of the Ottawa Kennel Club.

Inasmuch as the Club is in my debt for over twenty dollars for arrears in prize money the idea of dropping my name for non-payment of dues is preposterous.

Unless the matter is settled forthwith and my name restored to the list of members in good standing and entitled to compete for Club Specials at your recent show, with full membership privileges, I shall take legal pro-

ceedings against the Ottawa Kennel Club at once, and if I am sustained in the courts I shall then appeal to the Canadian Kennel Club for its ruling regarding the winner of the "Earl Grey Cup."

I need hardly add that it pains me very much to be forced in this way to establish my standing in the Club, especially since Mr. Binning, the accredited winner, is a personal friend, and had my dog been allowed to compete and had his dog then won I would have been the first to congratulate him, and would have counted it no dishonor to be beaten by such a handsome Colie, and a daughter of my own dog to boot.

Dear Sir,—Your somewhat tardy reply to my protest came to hand on Monday the 26th inst.

Your letter, informing me of the decision of your Committee, bears no legible postmark, and is dated the 16th inst.

Needless to say I cannot agree with your Committee in its decision, and, as in my former letter, I take decided exception to the way I have been treated by the Ottawa Kennel Club.

I shall at once communicate with the Secretary of the Canadian Kennel Club, and ascertain what jurisdiction that Club has in such matters.

If, in regard to your Club's delinquency in paying past prize money, I have been too lenient, and have consequently allowed the time to lapse, during which I could appeal the case to the C. K. C., I shall then institute legal proceedings against your Club forthwith for the collection of the amount due me.

As for my standing in your Club, I shall endeavor to establish my status, by first appealing to the C.K.C. in the premises, if such matters come under its jurisdiction, and if not, I shall then institute legal proceedings in that matter also. I shall endeavor to show you that your actions, so far, in your

dealings with me, border a little too much on the order of sharp practice.

On the direct solicitation of different members of your Club in 1907 and 1908, I made large entries at your shows, while telling them at the same time that the O. K. C. was entitled to very little consideration from me, for the reason that they had not paid me my back prize money. These members and your Vice-President have, on several occasions, promised to do their utmost to have my claims adjusted, and your insinuation that my claims against your Club have been a matter of controversy, I distinctly repudiate. I have been informed, by different members of your Club that a former official had misappropriated some funds, including my prize money, but I never had it insinuated for an instant that I had received the money that I am now going to collect.

I shall also endeavor to show you that there are a few rules of common decency that apply to all clubs, in regard to the way they treat their members.

I do not accept your Committee's ruling, strike me off the list of members for non-payment of dues without notifying me that my membership was due, and if the matter does not come under the C. K. C., I shall endeavor to show you that the laws of the country protect members from any such high-handed action, and further, I made my entries in due form and stated on my entry that I was a member of the O. K. C., and you accepted them. I have seen no published rule about payment of dues, and your premium list and catalogue refer only to parties joining your Club.

I complied with your printed rule in 1907, because I was not then a member of your Club, but having joined and been accepted as a member in 1907, I claim I had no occasion to join again in 1908. All you had to do, and that only in common decency, was to notify me that my fees were due, and I would have paid them or told you to deduct the amount from what you owed me.

I have never been notified of any of your meetings, annual or general, and I would like to know if my name has been inadvertently left off your list altogether.

I would thank you for a copy of your Constitution and By-Laws.

As for the winner of the Earl Grey Cup, that can only be decided when my status as a member of the O.K.C. is established, and if your Committee's action in striking my name from the list of members because I was in arrears, and without notifying me in any manner, and while the Club was in my debt is upheld by the courts, then, of course I shall have absolutely no claim on a second win of the Earl Grey Cup.

I am very sorry to have to take such a stand in regard to a sporting club, but your committee's drastic action leaves me no alternative but to

appeal the whole case to higher authorities.

I am sorry if my former letter, written on the spur of the moment, should have antagonized any member of your Committee in any way, as I am informed it did.

I am also sorry that your Committee should have decided in the manner it did, in view of the fact that Mr. Binning, the accredited winner of the Earl Grey Cup, has done his utmost to have the matter adjusted amicably, and has informed me that he did not feel he was entitled to the win under the circumstances, and had told your Committee so. Full discussion ensued, when a vote being taken it was ruled that this committee consider charge proven and rule that Messrs. R. H. and T. H. Trimble be suspended for one year from this date.

Referring to alleged misuse of photo of Little Witch, the Secretary was instructed to lay a charge against Mr. R. H. Trimble in this connection to come before Committee at next meeting. Mr. R. H. Trimble volunteered to produce his bitch at the meeting and also the photo or picture from which cut was made.

6. Late Toronto show: The Secretary reported that listing fees, etc., had been paid. No action was taken in the other matters.

7. Late Ottawa show: Mr. Payne appeared and gave a satisfactory explanation as to wins, entries, etc. No further action was taken.

Re Foxhound wins: Decided that all wins made under entry of incorrect name of breeder be cancelled.

8. Late London show: Explanation judged satisfactory and no further action taken.

9. Secretary was instructed to send a copy of the correspondence in his report to Mr. Hull and to ask if he can give a satisfactory explanation.

10. Mr. Ormiston Roy vs. Ottawa Kennel Club: In addition to evidence produced above, Mr. Roy fyled a sworn declaration stating that neither he nor any one authorized to do so had received the prize money in question. Mr. Payne, who appeared for the Ottawa Kennel Club, said that in view of this affidavit he would recommend to the O. K. C. that the claim be paid. The committee of the C. K. TORONTO KENNEL CLUB.

The nomination meeting was held in Davison Chambers, corner Huron and College Streets, Tuesday evening, November 24th.

Mr. Arthur Atkinson was nominated for President, Mr. J. F. McFarland for 1st Vice-President, Dr. A. Boulton for 2nd Vice-President, Mr. H. S. Tibbs for Secretary-Treasurer and Dr. J. F. Bond for Veterinary Surgeon. There being only one nomination for each of these positions, the nominees were declared unanimously elected. There were ten nominations for the Executive Committee, six to be elected at the annual meeting on December 22nd. The nominees are Messrs. F. Jacobi, W. Sands, E. T. Campbell, V. H. Annable, E. J. D'Orsay, J. A. Meadows, E. Garner, Steve Gordon, J. Hunt and A. Greenwood.

It was decided to request Chief Justice Sir Glenholm Falconbridge, His Honor Lieutenant Governor J. M. Gibson and Controller Ward to be patrons of the Club for the ensuing year, and Messrs. John G. Kent, W. P. Fraser and A. A. Macdonald to be Honorary Presidents.

A. K. C. AFFAIRS.

The finances of the American Kennel Club are beginning to cause a good deal of uneasiness to the managers of that Club. It appears that the outgo now exceeds the income by about three thousand dollars per annum. It is easy to see what this will eventually lead to, if not changed.

As the business of the Canadian Kennel Club increases it will be necessary to provide a larger revenue, a matter that has been pointed out by the Secretary.

The following extracts from the report of the meeting of the A. K. C., held on Nov. 30th, shows the importance Mr. Belmont and others attach to the matter.

The Club's Expenses.

Chairman Belmont: I would like to interrupt you for a short time in your deliberations. I am very busy to-day. I could not get here to attend this meeting from beginning to end, but there is one matter that has been brought to my attention which I deem of great importance, and I hope if I am not able to remain with you, at all events you will take some action on the subject, and that is the expenses of this club. The fact is that we are spending more money in getting out our Gazette and publishing our Stud Book than we are getting in, and we are running on a basis that is eating into our reserve fund. That is something that we must correct at once. The work has very much increased.

The charges were very low for the sort of work done in times past, but somehow or other it could be done at that time. There was not so much material. For instance, the hunting up of the pedigree of a dog then was not anything like the work it is now, for the reason, I suppose, that the pedigrees have vastly increased. The Secretary can give you the details with respect to it, and I think this Board is competent to act upon the increase of the charges. In the first place, the Associate Membership receives more to-day than the club can afford to give them. It costs much more to publish the Stud Book. For \$5 they get a certain number of registrations, and then they get a copy of the Stud Book and Gazette. It costs the club more than it can afford, and I think the Secretary suggests that he may be able to show you that the Associate Members should pay \$7.50 instead of \$5.00.

The Secretary: The charges ought to be increased.

Chairman Belmont: The charges of this club should be so arranged that we can add to our reserve fund instead of eating into it. We are bound to destroy it, and that is an important asset for the club. That asset was looked upon as a matter for contention at one time, and you do not want to remove the chance of getting into discussion about that fund by letting it be destroyed or giving it away. I urge upon you to take action now and correct the evil at once, because you are running at a loss of from \$2,000 to \$3,000 a year fully if not more, and it has been going on for some time. Increase your charges. It is better not to do business at all than to do it at a loss, as all your business men must know. That is what I am here to say to you this afternoon, and to ask you to give that subject your earliest attention. I do not think it will take long because the Secretary has the figures ready for you and you are all sufficiently familiar with the charges, and what you give for them, to decide very promptly what would be a fair increase. You must increase them or you will run behind.

Mr. Hunnewell: In a matter as important as this would it not be wise to let it go to the Finance Committee and allow them to submit some plan?

It seems to me it is quite an important matter and ought to be gone over very carefully before any decision is reached. It is a very difficult thing to decide in an afternoon. I understand that the Committee of Twelve have some scheme on hand.

The Secretary: Yes, they have suggested something, but I would suggest that it might be a good idea to submit the matter to the different committees that have charge of it and let them bring in a recommendation.

Mr. Hunnewell: What is the Finance Committee for?

Chairman Belmont: It has not brought this matter before the club. Take any action you deem wise.

Dr. De Mund: I think we feel that is the position, but in the present status of the club can we take any action? It seems to me that this is up to the Committee of Thirty, if they ever meet, to take some action in regard to increasing the charges.

The Secretary: Notice is to go out for a meeting on December 16.

Mr. McGuire: That is a matter that has come up before the sub-committee, and has had more or less serious consideration. It has been discussed, and I believe when the committee does report it will have reached some recommendation to submit to the club, but I think it would be unwise to take any action at this meeting affecting the membership. The club, in its present status, can hardly afford that, although I realize that the matter which you have brought to our attention warrants immediate action.

Chairman Belmont: I would urge you, at all events, to pass a resolution recommending a committee to take such steps to insure to the club a sufficient revenue. You say it is up to the committee. I am a member of the Committee of Thirty, but I have never been called upon to attend any meeting.

Mr. McGuire: It is unfortunate that the chairman of the Committee of Thirty is not here. However, I think Mr. Moore is better informed than any other person on what the committee has done and is about to do, and I think, if he is so disposed, he can enlighten us very much. There are provisions in the constitution which tend to cure this very condition which you have mentioned.

Chairman Belmont: In your opinion, then, the matter is sufficiently in hand

as to, now need no action at all. I only know, as your executive officer, that that is what is happening.

Mr. Moore: I do not think there is any question about that. It has been discussed quite a number of times, but it seemed to be the sense of the members of the committee that it was not a good time now to make any positive changes; that when the new organization takes hold, and we know where we stand as regards this present organization, that the matter should be gone into very thoroughly and very carefully.

Chairman Belmont: In the meantime we are losing money.

Mr. Moore: It is unfortunate, but it may be better than to rush pell mell into something that we would have to change right after it was done.

Mr. Muss-Arnolt: We are publishing an absolutely unnecessary Stud Book. We could cut down the expenses one-half. There are entries of classes in it that have no recognition whatever in this club. We could cut down the Stud Book and the Gazette.

Referred to the Committee of Thirty.

Mr. Mortimer: The great trouble seems to be that nobody knows what the sub-committee is doing. I am a member of the Committee of Thirty, but I do not know what it is doing. The sub-committees have held meetings. I happened to be here one day last week when there was a meeting of the committee.

The Secretary: I have copies of the notice for a meeting of the Committee of Thirty to be held on the 16th day of December, in which enclosure I am sending out the original agreement of November, 1907, and the tentative constitution which the sub-committees have put together.

Mr. Hunnewell: I move that this matter be referred to the Committee of Thirty with a request that it act as soon as possible.

Mr. McGuire: As a member of the Committee of Thirty I have been asked frequently by various members of the club what progress the committee was making. I was away for quite a long time and was in no position to answer. Since the granting of the charter I believe there have been only two meetings of the sub-committees. The gentlemen who drew this tentative constitution, I believe, have devoted a

good deal of time to it. The Committee of Thirty always being entirely competent to act, I think that some suggestion might be had from the members. The Secretary has just told us he is about mailing this tentative constitution along with the agreement, and so forth, which is a very good thing, but I also think it would be a good thing not only to hasten the delivery of that tentative constitution to the committee, but at the same time publish it as soon as possible in the Gazette, thereby leaving the committee open to suggestions from members.

The Secretary: I would like to say that it would have been published in the Gazette before this had it not been for a rule in the constitution prohibiting any committee from reporting until they report to the Kennel Club. If the American Kennel Club direct it, then it is proper, because the constitution says that reports to be made by committees can only be made public by and through the American Kennel Club. If you pass a resolution to-day it will go in, but I cannot do it without a resolution.

Mr. Hunnewell: My motion was to refer this matter of the finances to the Committee of Thirty with a request that they act promptly. Motion seconded and carried.

When is a Champion not a Champion?

This is a question that is not easily answered. It should be, but it isn't. Type and quality as near perfection as possible should exist in all champion dogs. That these essentials to real "championship" do not appear in all champions is, alas! true.

That keen fancier, Mr. W. Ormiston Roy, of Montreal, and, indeed, other members of the Montreal Canine Association, too, have been exercised for some time with the question we propound. Some time last summer, Mr. Roy expressed to us the opinion that the number of points awarded at each show should be left to the individual judges' opinions. This he qualified with one or two minor reservations, but his main contention was that the judge is the one to pronounce directly, and that the total number of dogs at a show had really no bearing on any individual dog's claim to a certain number of points. Mr. Roy put up a good case, too, but one that has its

Chairman Belmont: I cannot see what the charges have to do with a new organization. We are talking business here. We are going to talk business together. It is only that we are going to change the method, perhaps, of doing so, but the charge for registration may remain the same, no matter what the organization is.

Mr. McGuire: This whole subject is now in the hands of the Committee of Thirty, and if this tentative constitution is made known it will be readily seen that they have time to make provision for just the circumstances to which you have called our attention. They will in all likelihood report in six weeks. I do not think that any action should be taken before they report. I think the constitution will provide for the dues and so forth, and if we have waited until this time we can afford to wait six weeks longer. The sub-committees that made up this constitution have gone over it carefully, and if it is put before the Committee of Thirty the members might possibly care to make some suggestions with regard to it. I suggest that we publish the constitution, and if any of the Committee of Thirty, or if a request is addressed to the Committee of Thirty as a whole by any member, it will receive consideration.

weaknesses. Judges, for instance, are unfortunately an unknown quantity, and their opinions must be largely based on the quality of the dogs their past experience has brought before them.

Mr. Roy has an interesting letter in a no less interesting number, that for December, of *Doglovers*, the magazine that Mr. James Watson recently took charge of. Mr. Watson editorially disputes Mr. Roy's contentions, and as both make most interesting reading and are germane to such a live subject, we reprint them here. We should be glad to have the opinions of our readers on this matter.

MR. ROY'S LETTER.

Dear Sir,—In your "Editorial Opinions" for November, you refer to a scheme I spoke to you about, when you judged at our Montreal Show last spring, in regard to changing the present mode of awarding championships.

I think it is admitted on all sides that the present system is absurd. A championship to-day has no real significance and how can it be expected to? Why, for instance, should a Collie be entitled to three points towards a championship at a show where he happens to be the best of a very poor lot of Collies, simply because there are sufficient Boston Terriers and other breeds to make up so many hundred dogs, all told? If we look up the dictionary for the meaning of the word "champion," we find it says: "First among all competitors or contestants" — "first rank or highest excellence in any respect," "unexcelled." Now, I hardly think that anyone can claim that the present means of competing for and winning a championship, in dog shows, come anyway near fulfilling the above definition, and consequently it is time that we devised some way of getting nearer to what a championship should mean. The scheme I outlined to you puts the whole responsibility on the judge, where it belongs, and he is the one man who, I maintain, is liable under existing conditions as well as under any system that may be devised. I think you overlooked several points which I tried to bring out in my "plausible suggestions which look pretty good on the surface," and not the least of these, to my mind, would be an exhibitor's opportunity of judging the judge. They would soon come to know what sort of a judge he was, by the rating he gave his winners, what types he favored, and if he gave the maximum number of points

to a dog of inferior quality, or gave a very low rating to a really good specimen, breeders would soon rate him, and cease to show under him.

You say in regard to my suggestions "the glaring weakness is in the weakness of judges, their inability to avoid glaring errors." Do we not suffer as much and pay the full penalty under our present conditions from the weakness of judges? No system can be devised to overcome "the weakness of judges" or "their inability to avoid glaring errors," but we can put the full responsibility of their errors where it belongs, and let the Fancy know who are the weak, and who are the strong judges, and that, to my mind, is the strongest link in the chain, although you seem to consider it the weakest.

Make a championship a real honor. Make it harder if you will for a good dog to win it. Make it so difficult that a poor one cannot get it. Make it necessary for a dog to win, say, 25 points, and under at least three different judges, and I venture to say three weak ones will be pretty hard to find. A judge to have the power to award up to 10 points at a show (necessarily the maximum would only be given to what he considers a perfect specimen, if ever he comes across one). That way, it would take a mighty good dog to win his championship at three shows, and a poor one, to which a judge could not conscientiously give more than a point or two, would have to travel so long that he would likely be dead of old age before he got half way on the journey. That is as it ought to be, if a championship is to be a real honor and not as it is now in many cases, a sham.

Whatever the scheme ultimately decided upon, let a championship mean something.

You cite a couple of glaring errors that have been made by judges and ask "what, for instance, might not happen with a judge who would withhold first in winners and give a reserve"? Why, what happened then? You say "we cannot allow men of that kind to gamble with points given in winners' classes," but are we any better off under present conditions?

The Kennel Club would, of course, see to it that none but dogs having won first in their classes could get a winners' rating, and reserves would be awarded, as they are now, by bringing

together all the first and second prize winners that have not already met. However, all this may stimulate discussion on the subject, and possibly a "championship," with dogs more worthy of the title, will be the outcome. I first thought of a scheme of allowing say one point for every ten dogs actually competing in one breed, twenty-five points won under at least three different judges being required for a championship. This has some of the disadvantages of the present system, inasmuch as they all might be pretty poor specimens of a certain breed, but there would be no Collie getting championship because he happened to win at a show where there were a lot of Cockers. There would at least be the satisfaction of having won the title against a stipulated amount of competition, therefore, partly fulfilling the dictionary's definition of being first among some certain number of competitors or contestants.

As a compromise, how would this do?

Let the judge say how many points a dog should score in each winners class, provided the points he gave did not exceed one point for every ten dogs actually competing, no dog to win more than ten points at one show. Twenty-five points, won under at least three judges, being necessary to championship. The judge could, therefore give, if some such sale as the following were adopted, one point in each breed where less than ten dogs compete, and an additional point for each additional ten dogs up to ten points for anything over 90 competitors.

Such a scale would limit the number of points a judge could give and at the same time allow him some discretion in the way of withholding a winners prize altogether, or giving as few points as he considered the exhibit merited.

MR. WATSON'S REPLY.

Letters from correspondents are always welcome when they are written for the purpose of elucidating a subject or with betterment as the object and no one must imagine that we are adverse to differences of opinion, because from an argument and discussion come beneficial results. It should be thoroughly understood, however, and there is a decided margin between

abuse and argument, and that letters unaccompanied by the writer's name, not necessarily for publication, are never considered. We gladly welcome in this issue the letter of Mr. Roy on the subject of championships, as it very fully sets forth his views as to what might be done toward attaining results in keeping with the desire for betterment.

* * *

In reply to Mr. Roy, it is first necessary to controvert the claim that the present method of deciding the title is "absurd" because there is a very wide distinction between that and the possibility of improvement. The present method has been in vogue for a number of years now and has been amended in but two respects, one the requirement of three judges' opinions, which was an improvement, and the other knocking out the clause providing for a show's minimum rating being predicated upon the attained rating number at its preceding show. That was a decided setback, and not that alone, but a breaking down of the club's inviolable dictum to its own members that prizes cannot be scaled, but that every exhibitor should know exactly what he was to get if he won. That has ever been the one great fundamental principle of the American Kennel Club in its rules adjudicating between exhibitor and show club, until it came to be a question as to what the A.K.C. was offering the exhibitor, whereupon a flatcatching suggestion, which seemed to fit one particular case then being considered, was put through to the detriment of many clubs.

* * *

That there are weak points in the armor cannot be denied, but the trouble is that every suggestion made thus far, if adopted, would wonderfully increase these weak points and not always in the direction of making the gaining of the title easier. Every person will admit that whatever rule we have it must be universal, and it must do the greatest good to the greatest number. If it fails in carrying out intentions here and there it is not necessarily a failure. Our very good friend, Mr. Spackman, wrote one or more very strong letters a few years ago anent ease of winning titles. But that was not the fault of the law, but the absence of competition in the case of his deerhounds. Would exhibitors in a similar position have been agree-

able to a rule of exclusion whereby no points could be scored in small breeds. Try that and see the results in the way of expostulating. One reason why no change has been made in the method of calculating points is not so well known as it might be, and that is that not one single suggestion has yet been made that was not thoroughly thrashed out by the Committee on Constitution and Rules. The committee then in charge of the rules was the most thorough the A. K. C. has ever had, and not only in committee, but between meetings every vital suggestion was talked over and thrashed out until the rule was moulded into shape and the record of that committee will show the highest percentage of adopted resolutions as proposed by the committee in the entire history of the committee from its original appointment up to the present time. Mr. Roy's suggestions were considered except that making the judge the sole authority as to the number of points to be scored by any dog getting first in winners. But that would have fallen down for the same reason that the suggestion of breed-grading did, i.e., that it was necessary to make a specific offer that entailed it being definitely known what the dog would get that won. Another reason was that it would call for a most complex system of bookkeeping to have the records complete and the great possibility of error. Still another reason was that quantity did not always mean quality, but the reverse was far too frequently the case. In other words, that any dog vastly superior, or any kennel that could make a sweep of the prizes made havoc with the entries from outsiders.

* * *

Mr. Roy was not so prominent in Collies when Mr. Morgan ruled the roost, as he is now, but when the Cragston dogs swept the boards, Collies went down to the minimum, and only the died-in-the-wool fancier held on and gritted his teeth. Take the present condition of Fox Terriers about New York, when there never was a time when we had better smooths and wires and you cannot get over four or five of each variety. It is the superlative goodness of the specimens shown that reduces competition at times through the improbability or poor chance of a win. You thus have all sorts of elements to consider, when you make a country-wide rule. What is wanted is stability, a certainty in announcing and of winning a specific reward and not guesswork as to the outcome.

* * *

How the present rule came into effect as to rating may not be generally known, but this was how it came about. The previous rule was three firsts in winners to count, that having been evolved from three wins in the challenge class, which was restricted to dogs which had scored so many wins in open class. The change from the

challenge class threw competition for the title open to all dogs competing at the show and prevented the walkovers of lucky dogs graduated at small shows into the challenge class. That was a big step in advance. Still the title was "easy," and only needed sending to a few small shows to get the three wins. The next step was differentiating the shows. It was manifestly out of the question to put New York and the Butterfly Association show on an equal footing, and the clue to the solution came about in this way. Mr. Vrendenburgh and I had discussed the problem from all points of view without reaching a conclusion that was tenable, till one day when talking over another problem the thought of grading shows occurred to me, and on suggesting it as a solution it was at once tested. The previous year's record was taken and as they were called off they were placed in one of five divisions, it being understood that New York was to be in the top division by itself. This done, the show records were taken up, and the number of dogs at each show entered against the show. Singular to say, the dividing lines between the shows as guessed at were just what they are today. All the small shows were under 250 dogs entered, the second division was over 250, the third division over 500, and two were over or verging on 750 dogs.

* * *

In a country of democratic principles it was manifestly impossible for the A. K. C. to arbitrarily say such and such clubs are only worth one point, and to such and such clubs we will give two points, and to these other three points and to these two four points. Notwithstanding the knowledge that such an arbitrary decision had justice behind it, the principle of making a division in that way would have killed the plan, so the only way was to make the shows sort themselves out by their own records.

* * *

The trouble that has ever existed lies in supposing that a dog that has attained the title of champion is necessarily a flyer and ought to be the producer of wonderful puppies. We Americans have the glamor of the record perpetually dazzling our perceptions, and place a false value entirely upon pedigree and valueless records. There are records that are essential, and fortunately we are awakening to their essentiality and the fact that the best of the coconut is the milk and not the hair outside. When we get to that plane of observation the title of champion assumes its proper proportion in the records. We find the same principle applied when an owner advertises "Ten firsts, including New York, open, and Boston, open." That man knows that his readers estimate by the shows and the difficulty of winning at large and important shows, and that if he did not specify New

York and Boston his dog ranked no higher than if his wins had been made out in Illinois or Missouri.

* * *

Then, again, breeds do not run alike in importance, or in numbers, and while a champion Collie, or Boston Terrier must of necessity be a pretty good specimen, it by no means follows that a champion Japanese spaniel is, and it is along this line that Mr. Roy's proposals run. One of his plans is to have the judge decide how good a Jap this dog is he is judging, yet this judge is only given the breed as a stop gap to a certain extent, unfortunately a necessity in small out of the way shows where thorough experts are not always available. His knowledge will doubtless prevent his going far wrong in placing two dogs unless very closely matched, in other words, he can tell a fairish one from a duffer. There he is good enough for the occasion, but ask him to rank his winner and he is in deep water at once. Such a man is not competent to do any such thing, and his errors will almost invariably be on the side of leniency and the dog will be marked far above his merits. Fancy the position of a judge, bad enough as it is when some exhibitors let their tongues run loose, when he has graded a lot of dogs all the way from 1 to 10 and has to explain why he did it. No, thank you, Mr. Roy, for you are only considering how it can be done in your one breed while there are fifty others to be taken into account.

* * *

Mr. Roy is too clear-headed a man to hold on to a suggestion when its fallacy is exposed and it will take but one illustration to show that his "compromise" of arbitrary rating with one point for each ten dogs of a breed is untenable. Take an ordinary 500 dog show in the New York district. There will be 100 Bostons, 70 Collies and Bulldogs, and so on down to five Fox Terriers, smooth, and four wires. The winners in Bostons, would rate 10 points, and Bulldogs and Collies 7 points, as a maximum, while the Terriers could not possibly rate over one point. Now we come to some all-round specials for best in the show, and up goes Warren Remedy, or Rowsley Courtney, or Miss Sand's exquisite blue Pomeranian, or Miss Senn's Yorkshire, all of them one-pointers because of lack of competition under the 1 for 10 rule. There is no symmetry in a rule of that sort, let alone the cumbersomeness of the working out and keeping the records.

Many communications were read, and among these were requests for specials for forthcoming bench shows; the Executive Committee declined to send any to the New England Kennel Club's show, unless special request is made by members who wish to show their dogs for the Challenge Cups and Trophies.

After the report of the last meeting and the Treasurer's report were accepted as read, the matter of the sixth annual show was discussed. Plans will be made to secure date for this show earlier than the last show held.

Specials for the Westminster Kennel Club's Show were as follows:—

Sterling medal, each, for the best Pomeranian, French Bulldog, Old English Sheepdog and Poodle, under usual conditions of competition.

Communications have been exchanged with the sister Association of San Francisco, that recently gave its "maiden" show with such grand success. Specials for the Philadelphia Dog Show Association were as follows:—

Sterling medals, each, for best Toy Spaniel, Irish Terrier, Welsh Terrier and Chow-Chow, under usual rules of competition. Two bronze medals to be placed as the Committee desire; open to all.

Resolutions on the death of Mrs. W. F. Higgins are to be prepared for the next meeting.

After a short talk on the dog, from a psychological standpoint, meeting adjourned to January 11th, 1909.

BOSTON TERRIER CLUB OF MONTREAL.

The adjourned meeting of the Boston Terrier Club of Montreal was held in the committee rooms of the M.A.A.A. club house on Nov. 16th, it being decided by the unanimous opinion of all those present that in the welfare and interests of this class of dog in Montreal, it would be advisable to form the above club.

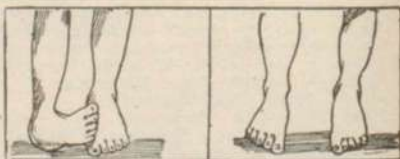
