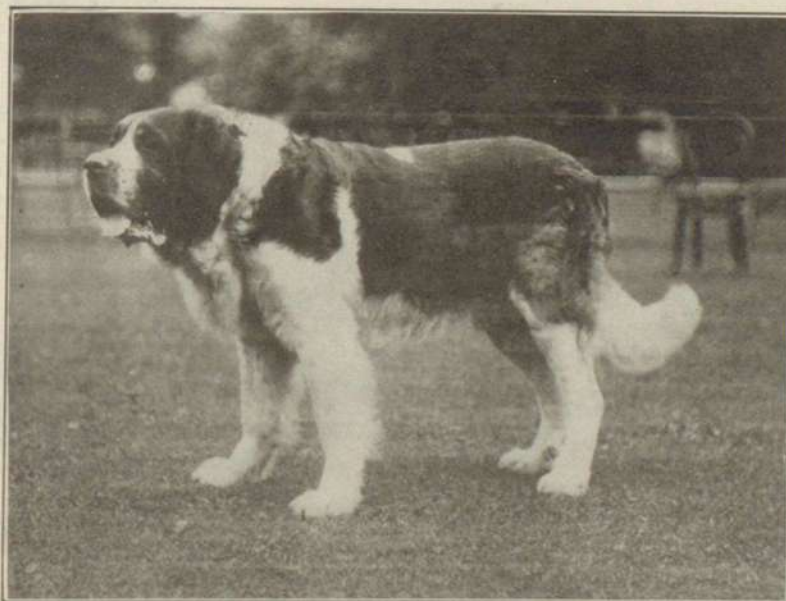

## NOTES AND COMMENTS

Winnipeg Dog Show: Dr. "Cruft" Bell is nothing if not original. In the following letter he gives us one or two new ones. Winnipeg will have a big show this year and competition enough to make the game interesting.

Dr. Bell writes:

"The prize lists for the dog show to be held in connection with the Canadian Industrial Exhibition at Winnipeg have been distributed, and doubtless most of your readers have received a copy. The cover is ornated with a very good picture of "Tickl'im Jock," America's champion dog. There have been some 28 classes added to those of last year, and uniform prizes of \$5.00 for first and \$3.00 for second, are given all through the entire classification. In addition to the many prizes there are a number of specials, chiefly from the Clubs. The Exhibition Association is giving in the main classes, where there is large competition, a \$5.00 special for the best kennel of three dogs.

Last fall the Association was unfortunate enough to have the building for the Dog Show, which was rehoused for 1910, destroyed by fire, including all their kennels and benches. This, of course, necessitated another structure which is to be built, 195 feet by 50, which will give ample accommodation for some 450 dogs. Possibly one of the best strokes that the Association has done has been the securing of Mr. Theo. Marples, Editor of "Our Dogs," Manchester, England.

Among the list of specials is the challenge issued by Mr. T. H. Moore, of Montreal, who will show six W. H. Fox Terriers against any other six shown by any one Society or Association; four of the dogs must at least be bred in Canada. This should make a competition in Fox Terriers, the

equal of which has not been seen in Canada for many a day, the idea being for each competitor to deposit \$50.00 with the Exhibition Association, and winner to take the entire sweepstake and also the cup offered by the Exhibition Association."

An old friend gone: It is with genuine regret that we chronicle the death of a very old friend, that of Richard Gibson, Delaware, Ont., who passed away at his home on May 7th. Mr. Gibson was one of the founders of the Canadian Kennel Club and ever an advocate of clean sport. At the time of his death he was an Hon.-President of the C. K. C., an office that he held for many years. In fact, the members of the Club would not hear of his retirement, though several times his resignation was in their hands.

Mr. Gibson had a keen eye for a good dog of most breeds, but Fox Terriers and Collies were his specialties. He many times judged both breeds, always acceptably, and at least twice judged the Canadian Fox Terrier Club specialty show in Toronto. This was several years ago.

He imported, bred and owned many a good Fox Terrier, and the old firm of McEwen & Gibson was one to con-jure with in Collie circles.

In other lines than dogs, too, he was a breeder and exhibitor of renown, notably sheep and shorthorn cattle. One of the sturdy, cheery Britons of the good old kind that somehow, in these hurried times, we fear are not being replaced.

No doubt some of his many old friends will add a note of appreciation and regret and be able to recount many little details that we may have overlooked.

Fox Terrier bone: Mr. Robert Vicary's very courteous letter in this issue of Gazette, we feel sure, will delight "Mount Royal" as much as it did us. After a careful second reading we are of the opinion that these gentlemen are not so very far apart in their opinions of what the desired Fox Terrier bone should be.

Going West: Mr. Albert Greenwood, Toronto, has a bad case of Western fever, and is about to remove himself and effects to Vancouver, B.C. From what we know of the Western fancy, we have taken it on ourselves to assure him of a right hearty welcome, especially in Airedale circles. Mr. Greenwood takes with him his old standby, Columbus, and the young dog, Bradford Prince. Possibly some others also.

Must pay for loss: We are gradually working up to a point where precedent may be given in most dog cases. Mr. Justice Archer, of the Superior Court, Montreal, recently handed out a decision of interest to both autoists and dog owners. It shows plainly the responsibility of the former as relating to dogs—and incidentally other live stock—and the right of the latter to recover.

"Thirty-one dollars for the loss of a dog, which had been run down by an automobile, was the decision handed down by Mr. Justice Archer. The case was that of Telesphore Gibeau vs. J. Corbeil. The former represented that during the month of August last, the defendant whilst riding in an automobile on Dorchester Street, had run over a dog belonging to him. He claimed that the car was running at high speed at the time of the accident, and that hence the defendant should be condemned to pay the damage. The defendant denied these contentions,



but the court decided that the car was running too fast at the time of the accident and that, therefore, the defendant should pay for the dog."

Coming back: It is good to hear that the Ottawa Kennel Club has been reorganized and will hold a show on September 12th to 15th next, under Canadian Kennel Club rules. These dates are the same as those announced some time ago for London, but the two cities are so far apart that no injury to either should accrue. It is in both instances a case of then or not at all, both shows being held in connection with the fall exhibitions in the two places.

Mr. R. Ronan is the new Secretary, and he tells us that it is proposed to expend some five hundred dollars in new benching and to put up a good prize list, one big enough to attract a large entry.

Irish items: Mr. J. T. Godfrey, of the Armagh Kennels, tells of the death by distemper in U. S. of his two winning Irish Terrier bitches, Armagh Judy and Armagh Betsy. This is a hard crack, but Mr. Godfrey takes the loss philosophically, calling it the "fortune of war."

As some recompense his Armagh Jessie has presented him with a litter of six, all bitches, by Armagh Idol.

That Winnipeg law case: Dr. Bell is kind enough to send us the judge's finding in the case of Coltart vs. Winnipeg Industrial Exhibition Association. We print it in full as giving plainly and in detail the responsibilities of both exhibitor and exhibition in the show game.

Dr. Bell, in the following, voices the sentiment of show managements in general:

"In 1909 this party was asked in the ordinary routine of business to make an exhibit of some Japanese Spaniels that they owned, at the Dog Show held in connection with our exhibition. The Spaniels, unfortunately, caught distemper, so he claims at the Exhibition, and on his return home he lost several. He instituted proceedings against us to recover the loss of the dogs.

"I send you a report of the judge, more in the interest of exhibitions as a whole, for on the finding of this judge no doubt would depend the future existence of exhibitions throughout the country, for there is no doubt that if the judgment had been given against the Association, that all shows with which there are associated stock, poultry, dogs, etc., would have been greatly handicapped, and in fact the Board of Directors made liable for damage due to some disease breaking out among the exhibits, and over which the Association had no control.

We feel that this was a test case, and as such, should be given a certain amount of publicity."

Otterburn Collies: Dr. C. Y. Ford has sold his well known stud Collie, Otterburn Ornament, to Mr. Hull, of Calgary, who will use him to breed to Holyrood Professor bitches.

At the Otterburn Kennels are two litters of Collies, ten weeks old, by Otterburn Diamond, ex. the winning bitch, Otterburn Overture, and a litter sister. These bitches are by Ch. Sir Roger Trelawney ex. imported Otterburn Constance. Each litter contained six dogs and two bitches, all well marked sable and whites and up to date there has not been a single death. They are an exceptionally good looking lot and much is hoped from them.

The new license law: Dog owners in Toronto and other places are up in arms at the withdrawal of the kennel license privilege for so many years in force in Ontario. In brief a kennel license was issued good for any number of registered dogs, the fee being ten dollars. This is not now compulsory on the different municipalities and they apparently have taken advantage of the situation to advance license fees beyond all reason. For instance the fees in Toronto now are: For dogs, two dollars; for bitches, five dollars each. Several meetings of the local kennel clubs have been held, and for the Canadian Kennel Club the Club's Hon.-Solicitor, Mr. G. F. McFarland, is doing all possible.

Mr. McFarland tells us that "the explanation of this matter is apparently simple. Under Statute R. S. O. Ch. 271, called the "Sheep and Dog Act,"

it is provided that a certain tax shall be levied in every municipality in Ontario, providing that the owner or possessor of a kennel of registered dogs may take out a kennel license, on payment of \$10.00. As you know, the City By-Law as it existed up to the 18th of April, 1911, made this provision for kennel licenses, in accordance with the Statute recited above. Unfortunately, however, at the session just closed the Legislature amended the Municipal Act by providing that where in any municipality the tax imposed by the municipality equals or exceeds that provided for by the "Sheep and Dog Act," the latter Act shall not apply to that municipality. The effect of this recent enactment, which is cited as 1 George 5th, Ch. 57, Section 8, is to entirely except the City of Toronto, from the operation of the "Sheep and Dog Act," and as this Act is the only one providing for kennel licenses, the city of Toronto is therefore free to eliminate that feature from their by-law.

As I mentioned to you in my former letter, however, it seems that the only thing that can be done is to bring pressure to bear upon the Police Commissioners to restore the kennel license."

The By-Law (No. 27), as amended, is given elsewhere in this issue.

Two of a kind: We hear that Mr. Sid Perkins is to join his brother, the Secretary of the Airedale Terrier Club of Canada, in Toronto. Mr. Perkins bred the famous Airedale, Rockley Oorang.

The Ladies' Show: In last Gazette we gave the judges' list of the Ladies Kennel Association of America Show, to be held in Mineola, L.I., on June 6th and 7th. Entries close on Saturday, May 20th, with the Superintendent, Mr. James Mortimer, whose address is Hempstead, L.I., N.Y.

The classification is an extended one. There are a host of specials, and early June on Long Island is an ideal time for an outing. Canadian exhibitors could not do better than take the show in, especially as we have no show scheduled for Canada around these dates.



## A NOTED DOG CASE.

## COLTART VS. WINNIPEG INDUSTRIAL EXHIBITION.

The plaintiff, who was the owner of kennels at Beulah, exhibited 12 Japanese Spaniels at the annual show held by the defendants in Winnipeg in July, 1909. Within a short time after being brought back to Beulah, these dogs, as well as other dogs belonging to the plaintiff, became ill with a violent form of distemper, in consequence of which 24 died and 3 were permanently injured.

The plaintiff now brings this action on the ground that she was induced to exhibit her dogs by the defendants' representations that certain arrangements would be made and certain precautions taken, that the defendants did not make such arrangements or take such precautions besides being otherwise negligent in their duties, in consequence of which her dogs contracted the disease by infection from other dogs at the fair, and she claims \$2525 for loss of the dogs and \$200 for medical and nursing expenses.

The defence, besides denying negligence, the special inducements alleged by the plaintiff, and all other allegations, sets up that it was a condition precedent to exhibiting that the plaintiff should, and that she did in fact, sign certain forms of entry whereby she agreed to abide by the rules and regulations under which the Exhibition and the Dog Show were held and that they are not liable under such rules.

In reply, the plaintiff denies that the dogs were exhibited under the said rules and regulations, of which she says she was not aware.

It seems to me, not considering for the moment the special conditions alleged that this case is one of bailment, in which the trust is for the benefit of both parties. I think that the pecuniary advantages — either the entry fee and door-fare received by the defendants, or the money prizes offered to exhibitors — may here be considered negligible, or at least secondary considerations. But the defendants were obviously interested in having exhibits, without which they could not perform their essential function, while exhibitors are moved to exhibit by the expectation of honorable commendation, either in the form of awards

or comments of the press and public, and therein lies the interest of both.

If this distinction is in order, it would perhaps tend, if anything, to lessen the bailee's obligations. But I will assume that this case is the ordinary one of bailment for hire in view of mutual benefit—such as, for instance, the agistment of cattle, with which this case has many other features in common,—and the duty and care to which the bailee is there bound is only the ordinary duty and a reasonable care: (Story, Bailments, para. 355; Bevan, Negligence, p. 812).

The defendants urge, however, that their duties were very much lessened in this case by the plaintiff's acceptance of the conditions laid out in the rules and regulations of the Exhibition and Dog Show. I find that the forms of entry which the plaintiff signed and without which she could not have entered these dogs, have this heading in large type: "Ninth Annual Dog Show Under Canadian Kennel Club Rules." In the left-hand corner of the forms the following also appears: "Every dog must either be listed or registered with the Secretary of the Canadian Kennel Club previous to being exhibited." The following words are also printed following the heading: "I agree to abide by the rules and regulations under which the Dog Show and Exhibition are held." Then at the foot of the form, the plaintiff has written in her own hand that she is a member of the Canadian Kennel Club. I hold that the plaintiff would be bound at all events by the Canadian Kennel Club Rules. But those rules, in my opinion, do not lessen the defendants' duties. The clause relied upon by the defendants is the following: "2. The Bench Show Committee will use due diligence for the care and safety of all dogs exhibited. Watchmen will be kept on duty day and night, but it must be distinctly understood by all exhibitors that the management will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other cause." I can realize that if this were a case where the bailee was required to use the greatest care, the bailor's acquiescence to such

a clause as the above would reduce that duty to one of ordinary care. But the duty required here is only the ordinary care; to still lessen that duty would go to the extent of protecting the defendants even against their carelessness, which the courts are averse to do unless driven to it. The clause at all events expressly provides that "The Bench Show Committee will use due diligence for the care and safety of all dogs exhibited." This is no way negated by the last part of the clause,—especially as in the last line "whether the result of accident or other cause," the three last words should be construed conformably with the rule "*noscitur a sociis*." Nor do I think that the Exhibition rules, which expressly provide (foot of page 9), that "the Association will take reasonable precautions," afford the defendants any greater indemnity. So that, in my opinion, there is nothing in either set of rules whereby the defendants' common law obligations are in any way lessened.

I now come to the assurances which the plaintiff's manager, who was her husband, says were given to him before exhibiting. It appears that about a month before Exhibition time, he met at Winnipeg, Mr. Waugh, of the Dog Show Committee, who seemed anxious that he should send his dogs down. He stated his objections; his dogs had to be treated in a special way because they were a different kind; they required special food and not dog biscuits; they were high, nervous and at a show there was the barking, and the people, and the dogs got excited. There was also the danger of mange and distemper, and he was thinking rather of bringing them down at the time of the Horse Show, which would avoid the risks of a dog show. He says that Mr. Waugh replied that the arrangements were perfect, that there were no risks, that there were disinfectants, that a case of distemper had never been known, that all precautions would be taken and that his dogs would be safe as in his own kennels. Mr. Coltart having gone back to Beulah, there was then an exchange of a few letters between him and Dr. Bell, Manager of the As-



sociation. In one of them Mr. Coltart again speaks of the danger of bringing distemper back to the kennel, in a letter indicating that he is well aware that such danger is always present, and on July 2nd, Dr. Bell writes to him: "As to the benching of your dogs, we have put in 30 new divisions this year for small dogs, and will take out the divisions so as to make one large bench for your dogs. \* \* \* We will allow you, if you desire, to disinfect your own bench, but as these are perfectly new, I do not think there will be much danger of infection. However, you may have this privilege if you wish it. The only serious objection I see in your letter is that of the removal of your dogs, but as they are young dogs this will be granted you." It seems also that in another letter Mr. Coltart was promised that he would have a separate cage.

Here again, except for the privilege that the plaintiff was to have a separate cage, and could use his own disinfectants and take the dogs away whenever he pleased, I see nothing whereby the defendants' duties were made stricter or more onerous; more especially is it beyond reason to say that they made themselves insurers. Of course such words as that the arrangements were perfect, and that there was no risk, etc., were used by Mr. Waugh; but these are expressions of general commendation which nobody is justified in taking literally. In fact, being experienced in the matter, Mr. Coltart was not at all led astray by such expressions; he knew there was always a risk in such conditions, and that his dogs could not be as safe there as in his own kennels.

The dogs at all events came down and were taken by Mr. Coltart to the dog show building, where a cage, made of board and wire netting, had been prepared for them. I think it was the only cage in the dog show, and it was placed in a favored position in the centre of the main aisle where they were isolated all around. Mr. Coltart says that, except at night, he was with his dogs or within a short distance, pretty well all the time that they were at the show.

The plaintiff complains of the conditions and management of the show, and sets out the particulars of the neglectful and omissions she complains of. With the exception of the

matter of inspection, which requires to be dealt with more fully, I think all the other grounds of complaint may be dismissed without much consideration, either as not proven, or as having clearly not contributed to the injury. It is, however, perhaps better to shortly review them one by one.

On the first ground of complaint, I find that the dog show building was sanitary, proper and adequate in every way. The ventilation had not been satisfactory the previous year, but a board was taken out under the eaves all around and an electric fan put in, which remedied the defect.

Mr. Coltart complains also that the bedding was not being kept clean enough and says that he had to change it twice a day himself. This may have been due to the fact that his dogs were in a cage, which, after the first day, could not be easily opened. That was at all events surely not a general condition, for out of the seven or eight witnesses called for the plaintiff and who attended the show as exhibitors, only one referred to this matter, and it was to say that finding once the bedding of his dog soiled he spoke about it to the attendant who changed it at once. For the defendants, abundant evidence was put in that there were several sweepers who came in three times a day and swept the place thoroughly removing any soiled straw. The City Health Inspector also says that it was sanitary in every way, and that he heard no complaints whatsoever.

With respect to the special disinfectant used by the defendants, there was on both sides the evidence of chemical analysts as to the degree of its germicidal power and effect on organic matter. I will come to no particular conclusion on that point. It is enough to say that that preparation is on the market, that it is generally considered as a disinfectant of sufficient strength as used, seems commendable on the whole as that to the contrary. Then, as regards his own benching, Mr. Coltart was given the privilege of using his own disinfectant and availed himself of it.

On the question of there being no proper food or water supplied to the dogs exhibited, the evidence is all strongly to the contrary. There was an abundance of good water, as well as of unusually good food, the dog biscuits being soaked, not in cold wa-

ter as seems to be ordinarily done, but in hot broth. Mr. Coltart's evidence on this point was directed to his own dogs only. What he says is that he found that the Association's food was not laxative enough; that he asked for milk and some lighter food, and that this not being forthcoming for a day and a half, he went himself to the tents and got milk and rice pudding and such food from that time. The night-watchman says that every night he gave the plaintiff's dogs milk, which he secured from the restaurants. But this is not material, unless it could be said that it so affected the dog's general health as to make them more susceptible to contracting the disease, which there is no ground to hold.

The attendants provided are not shown to have been otherwise than sufficient and efficient. Besides the president and other members of the Dog Show Committee who were there several times every day, and at least two veterinary surgeons who attended in turns, there was a superintendent of the dog show, with four day aids under him and one night watchman. There is evidence that one of the attendants was seen drunk there on one occasion, but it seems that he was not there on duty. One witness also says that the superintendent and two aids were "pretty well loaded up" one day. But be that as it may, on this point of attendance again,—except Mr. Coltart himself, and what he says is only with reference to his dogs—not one of the plaintiff's own witnesses say that the inside service was inefficient or that a single complaint was made.

The exercise yard and judging ring are also said to have been unsanitary. One of the plaintiff's witnesses said that it was dirty, with dog manure around, that you had to be careful how you stepped; and another said that after the first day, when it rained, it became filthy and no attempt was made to remove the excreta. But another of the plaintiff's own witnesses said that the exercise yard was satisfactory to him; four others who were there repeatedly were not questioned at all on this point, and there is independent evidence for the defendants that the yard was in "fair condition," in "very good condition," or "even better than usual at other shows and in kennels." At all events, Mr. Coltart having complained the



first day about the condition of the exercise yards was allowed by the superintendent the privilege of exercising his dogs in the judging ring, which I hold was very clean.

The plaintiff also says that she was not provided with suitable pens or benches and that her dogs were allowed to mix with other dogs. The evidence is that Dr. Bell offered Mr. Coltart several benches, but the latter thought that the dogs would be safer in a cage as they could not be chained, and they would thus be more isolated. Dr. Bell says that the cage was, by actual measurement, 9 ft. long, 3 ft. wide, and 2½ ft. high, which I hold was too small. Mr. Coltart's main grievance was, however, that the cage was not locked, that a nail was all that kept the door closed, that this nail got loosened by the dogs jumping up against the door, and that they got out several times and came in contact with other dogs. The defendants went to some trouble to give the plaintiff special accommodation; but I think her manager was bound to try and help himself too, and as he was attending the dogs every day it was an easy matter for him to secure a lock either on the grounds or down-town. Had he done so the dogs would not have been running around, and I may say at once that if the dogs contracted the disease at the Exhibition grounds, it is probably in that way that they became infected. As to mixing with other dogs outside, those other dogs were all led by a chain, and it is not the management's fault that the plaintiff's dogs were of a special kind which required that they should not be chained, and were thus allowed more scope to run about.

I now come to the matter of inspection on which the plaintiff specially relies, urging, first, that it should have been made at the door before any dog was allowed to go in the building, and second, that inspection by view alone is not sufficient in any case and that each dog must be handled by the inspection officer, which it is claimed was not done in this case.

The dog show lasted from Tuesday, July 13th, to Friday the 16th, both inclusive. A few dogs came in on the Saturday; a greater number on Sunday, generally sent from distant points; and by far the greater number, probably almost two-thirds, came in on

Monday. About 60, I should say, came in on the Tuesday morning, the day of the opening.

The plaintiff's main witness was Dr. O'Brien, a medical practitioner and dog fancier, owning expensive kennels. He says that every dog that goes to a show should be inspected before being allowed in, and that this should be done by an expert veterinary—to see that there is no running of the nose or eyes, or internal discharges; and that the coat is in good shape or rough; also as to his manner, being listless or dull, and shrinking; and pass his hand under the abdomen and inside the leg to see if there are postules or a kind of rash that accompanies distemper, and examine the eyes and lids as there is a catarrhal condition of the eyes or inflammation of the mucous membrane of the eyelid. He says he brought his dogs on the Monday, that he took them right in, with the help of his partner, and of attendants who were there; that he saw nobody making an inspection or systematically handling the dogs. Besides Dr. O'Brien and the plaintiff's manager, four witnesses (Moore, Brush, Degagnes and Wilkes), who were all exhibitors, state that they saw no inspection, nobody inspecting, or nobody handling the dogs. Two state that they did not know Dr. Rombough, and the others did not say whether they knew him or not.

The defendants do not claim, with respect to the dogs that came in before the opening day, that a regular inspection was made as they came in. But Mr. Spurgeon, the chairman of the Dog Show Committee, and a dog fancier, was there on the Saturday, Sunday and Monday, as well as every day of the show; and among the four attendants who helped take in the dogs before Tuesday, was one Shepherd who was a qualified veterinary surgeon in England. Although only acting as attendant, still he had the special knowledge, and he says that he kept nearly all the time near the door, showing the exhibitors where their numbers were, and looking at the dogs as they came in, and that they seemed all right.

Dr. Rombough, a veterinary surgeon, occupied an honorary position on the Dog Show Committee, and is the one to whom was assigned the duty of examining the dogs. He says that he arranged to have also the as-

sistance of two other veterinary surgeons, but it is not shown what part, if any, these two men took in inspecting. Dr. Rombough went to the show on the Tuesday morning, accompanied by the chairman of the committee, and was there from 9.15 a.m. until about 1.00 p.m., during which time he says he made his inspection. He says he also went to the show every day, to see if any symptoms of disease had since developed.

Dr. Rombough says his duties were to see if there were dogs there that suffered from contagious or infectious diseases, and to order them out of the building if there were. He states that he examined 20 or 30 dogs at the door as they came in, and all the others on their benches. He does not pretend to have laid hands on every one of them. He says: "It is not necessary to handle the dogs in all cases; the first symptom of distemper is a discharge from the eyes and nose and a disturbance of general conditions. Rash, which is on the belly and inside the legs, does not come in more than 25 per cent. of the cases in my experience. I don't recognize rash as one of the early symptoms of the disease. When you get that condition of the skin, as to postula or rash, you always have already the other symptoms, discharges, rough coat, strange behaviour, listless or dull, elevation of temperature, etc." Being put the question as to which is safest in his opinion, either to examine the dogs before they enter the show or after they are placed on the bench, he answered, "Before, of course." He says he only saw one dog, an Airedale Terrier, which was 10 or 15 feet from the plaintiff's dogs, that had symptoms of disease (which was on the Tuesday morning), and that he had it removed at once.

The Chairman of the Dog Show Committee, who, as such, was the first in charge there, and who, as stated, accompanied Dr. Rombough in his inspection, says that it was "satisfactory." F. T. Miller, another member of the committee, has exhibited in New York, Montreal, Philadelphia, Buffalo and Winnipeg, and thinks the inspection at Winnipeg was "most thorough."

Harold Dymont, of Barrie, Ontario, is a dog breeder, has exhibited at a number of shows all over Canada, and had three Cocker Spaniels at this



show. He came in on the Saturday, three days before the opening, and says that his dogs were examined the next day—which would be by Shepherd, as I understand. He saw about a dozen dogs arrive on the Monday, and although they were also ahead of time, he says they were examined the same day—again by Shepherd, I presume. He does not consider that a dog should be examined necessarily before going in the building; he says this is not always the rule, and he would be satisfied if they were examined when being put on their benches or within 3 or 4 hours after that.

A. R. Stewart, of Montreal, a dog fancier, exhibits at four or five shows every year, and had 43 St. Bernards and Cocker Spaniels at this one. He came on the Sunday, his dogs were examined at once before being taken in (by Shepherd) and again on the Tuesday by Dr. Rombough. He says the proper time to inspect is when the dogs are first brought to the show, but seems to consider as unavoidable the conditions created by dogs coming ahead of time, and would be satisfied if they were examined when the show opens. He says that according to show rules, this was not improper. At the same time he makes the broad statement that the proper time to examine the dogs is when brought there first.

H. P. D. Walker, owner of kennels at Calgary, has exhibited in several cities in the United States and Canada, and was in charge of about 30 dogs here. He came in on the Monday at midnight, and his dogs were examined the next morning as they went in, in a manner that was satisfactory to him. He says: "He examined their heads for distemper, and breath and nostrils. \* \* \* You can tell by a dog's breath. He turned up its eyes and examined its mouth and belly, and raised the tail and examined the rectum, and looked for mange under the forelegs and under the belly." As already stated, there is no contention that this was done in every case. At the same time, part of his examination taken "de bene esse" reads as follows:

"Q. What is the usual time to examine dogs when they are brought to the exhibition?"

"A. On entering the building, that is the proper time to examine dogs."

"Q. Is that the only safe time?"

"A. Well, it depends upon what you have got. Of course a dog might be in the building a little while and not do any harm and still suffering from distemper, but I would not want to put a young dog in the stall he had been in. I would not have exhibited here if the Exhibition had not been properly conducted. We don't make any money. It costs us money every year."

"Q. You would not care to exhibit unless there was an examination of all other dogs when they were brought in to the building?"

"A. Yes."

"Q. You would feel you were taking a greater amount of risk?"

"A. Yes."

"Q. The proper time to detect distemper is when the dog is brought into the building?"

"A. Yes, any contagious disease. It ought to be examined when brought into the building; certainly."

I may say here, though this does not come under this special branch, that these three witnesses who seem disinterested as they do not reside in Manitoba, and who are experts of unusual experience, say that with respect to sanitary arrangements, ventilation, cleanliness, bedding, space, exercising yard, attendants, water, food and inspection, this show compared most favorably with the best they attended in Canada or the United States, and in one or two particulars surpassed them.

It is urged, both as showing the defendants' negligence and as being the probable cause of the infection of the plaintiff's dogs that there were several animals suffering from distemper at the Show, and that one at least was removed only after undue delay.

Dr. O'Brien saw a St. Bernard which he says was apparently unwell, dull, out of sorts, and had a cough. He does not say it showed any signs of infectious disease. He says he did not notice any discharge, meaning a discharge of the eyes or nose, which would be one of the symptoms. It does not appear that he complained, although he had a number of most valuable dogs there. He says this dog was removed the day after it was taken in, but he does not say how long that was after he noticed it was sick.

There was an Airedale Terrier which its owner, John W. Lord, found on the

second day of the show listless, too weak to walk and exhibiting signs which according to him and another witness indicated distemper. According to A. R. Brush, it was taken out only an hour later, but according to three others, half an hour after being discovered sick, which would not be unreasonable. Its owner is positive that it showed no signs of illness when it was put in on the first day, and if it had contracted the disease at the Fair it could not show symptoms in less than a day.

Then, Dr. Rombough stated that there was that Airedale Terrier that showed symptoms of distemper when he examined it at the opening, and which he had removed at once.

There was also evidence of sickness by Brush, Nixon, Miller, Stewart, Elms and Dr. Smith, but I think it all refers to Lord's Terrier; so that at most only the three dogs above referred to were found with any symptoms of disease at the show out of the 317 exhibited.

There were three dogs taken ill a short time after being taken back from the show, of which I will dispose by saying that one, (John Wilkes), evidently contracted the disease from another of the same owner's dogs; that a second one (Degagnes') apparently suffered from mange and not distemper, and as to the third, the Exhibition inspector could not likely have discovered any symptoms about it, the fact being that Dr. O'Brien, its owner, an exceedingly careful dog expert, only discovered such symptoms one week after the show.

The great length at which I have dealt with the inspection and health of the dogs exhibited makes it unnecessary, I think, that I should comment on the same.

The following considerations, however, would seem to be in order:—

Almost all, or at least the very great majority of exhibitors of dogs, are breeders or fanciers, have a knowledge of their ordinary diseases, especially of distemper, and are proud and careful of their dogs, which are animals of pedigree and consequently of special value. This does not relieve exhibition managers from taking due precautions; but it is some ground for the probability that the great majority of dogs taken to a show are



not diseased, or at least do not show signs of disease.

Then, confining myself to distemper, I think it is established by the evidence that the symptoms of this disease are such that a dog that is sprightly and cheerful, with a bright eye and smooth coat, and does not show obvious discharges of the nose, may be passed at a mere glance as healthy. Of course it may be already infected, but no further examination such as is practicable or possible at a show, would reveal anything more at the time. I also accept Dr. Smith's statement: "Postula or rash is not always present; and when it comes the other symptoms are already there." Of course, it would be still preferable if every dog were thoroughly examined by a certificated veterinary before being allowed at all in the building. But then, as in all things, there are unavoidable conditions, such as the arrival of dogs as long as three days before the opening. Then I give due consideration to such examination as Shepherd made of the dogs as they arrived, and there is the statement of Mr. Dymont, who has such a large experience in dogs and dog shows, that he would be satisfied if the dogs were examined as they were put on their benches and within three or four hours after. On the whole, I am of opinion that in the matter of inspection also, the defendants satisfied their duty of exercising reasonable care.

But, assuming that the defendants were negligent, did the plaintiff connect the damage she suffered with such negligence? I think that, considering the extraordinary precautions taken by the plaintiff in sending her dogs to and bringing them back from the Fair, the perfect conditions of the kennels at Beulah, and the time that had elapsed since the dogs had come back from Winnipeg when sent down in June at the time of the Horse Show, there would be good ground for holding that the dogs contracted the disease at the dog show.

In *Connacher v. City of Toronto*, reviewed in *Beal v. Michigan Central*, (19 O.L.R. at p. 507), the plaintiff claimed damages on the ground that as a result of the defendants' negligently allowing garbage to collect at a sewer outlet adjoining his premises, members of his family contracted Diphtheria. Medical men testified

that the conditions shown would favor the development and propagation of the germs of Diphtheria at the sewer outlet and on the plaintiff's premises, but there was no evidence of the actual presence of Diphtheria germs, and the action was dismissed on appeal.

That case is clearly distinguishable from the present one, as there were undoubtedly germs of distemper at the Show, the two Airedale Terriers having been removed as suffering from that disease.

In another case also referred to in *Beal v. Michigan Central* (at p. 508), members of the plaintiff's household had contracted Typhoid Fever and the source of infection was alleged to be a pond which the defendant township had allowed to become rotten. Germs of typhoid wherein that case found in the water of the pond, but the trial judge held that though the germs were there, and while the pond might have been the origin of the fever, so to find would be mere conjecture and he accordingly dismissed the action.

But the consideration underlying the judgment seems to have been this: that the presence of typhoid germs is so common, that they are propagated in so many substances that we eat and drink or otherwise come in contact with, that all the conditions by which the disease might otherwise have been contracted, could not be eliminated, so as to leave the pond as the only source of infection. It is altogether otherwise with germs of distemper. They are generated only by animals. This has made it pos-

sible for the plaintiff, by showing the extraordinary precautions she took and all the other conditions, to eliminate fairly and reasonably all other probable or possible causes, and so come down to the conditions at the show where the germ was present, as the only cause.

There is, however, the further question: how did the plaintiff's dogs contract the infection at the show? Mr. Coltart says: "The nail of the cage got loosened, and after a while the dogs pushed it out playing, and the door would open, and the dogs would run all over the place." Dr. Jones says: "Once I opened the cage, and two jumped down and ran under the next bench." As I understand, this next bench was probably the one owned by Lord's sick Terrier. A. J. Moore says: "I saw the Spaniel running around Tuesday. They accidentally fell from the door, three or four anyway. We caught them as quick as we could and put them back again." Dr. O'Brien says: "I saw the Spaniels once running loose, one in the show ring and in the exercise yard, and saw one once running around among the benches." I think that almost any jury would find that these were most probably the occasions when the dogs became infected, if they contracted the disease at the show.

But the main consideration, as stated, is that the defendants seem to have exercised the reasonable care that they were bound to use.

The action will be dismissed with costs.

## Mr. Robert Vicary on Fox Terrier Bone.

Your able correspondent, "Philoktonistic Philosopher Abroad," in a paragraph on Fox Terriers at Cruft's Show, states that the ideal is wrong, in so far as the judges of the day lay stress upon bone. Peter Beckford, writing A.D. 1779, lays stress upon a boney sire, and says those light below the knee are worthless. Is it not so in every sporting breed? Horses, Hounds, as well as Fox Terriers, are invariably judged with a standard scale of bone. Those that fall below this standard are termed weeds and make the price of weeds. There is nothing the breeder finds more difficult

to obtain or easier to lose than quality bone.

Let us first consider what bone really means: it is bone plus its covering of tendons and muscles. So, considering the proportion of actual bone, it is a lack of sinew and muscle our friend P. P. is endeavoring to shield—or encourage.

It is not merely the amount of bone (that the Fox Terrier standard of years ago, when it was well drawn up by men second to none in their practical experience, advocates) but the quality, a big leg is not the desired point—it is the leg of strength,



in appearance as if made of ivory, and going in nearly one substance to the foot. That leg and foot have been the aim of Hound, as well as Terrier breeders, so far as that point is concerned. There are other points to call for breeders' care as well, be it remembered. The value of bone is high! Take a pack of Fox Hounds with grand bone, with another of equally good other points but decidedly light in bone, sell them at Rugby auction, probably the first named will bring sovereigns, while the others bring 2s. 6d.

What is your too-light-of-bone hunter worth? Even amongst race horses, most of the performers are well off for bone, and not weeds—the biggest boned horses amongst the very fastest sprinters. There are Fox Terriers in this country sold for £5, which with 20 per cent. more bone would make £100.

There is no need to carry any ideal to extremes, and certainly bone in our Fox Terriers in this country has not been carried to an extreme, and as certainly not in U.S.A. The big Beagle-looking leg known in my earlier days has gone quite out of respect. It is the clean, thoroughbred leg that looks all solid bone that is what we prize, and rightly.

The Fox Terrier in work with a pack of Fox Hounds—those that run, and are not led or carried—has plenty of use for strength. With my Hounds, when a M. F. H., the Terriers had, on the Dartmoor side, at least twelve or sixteen miles to meet, from 11 o'clock to 4.30, or much later, later in the season, on the go, up hill, down dale, soft ground, hard ground, all sorts of obstacles, and then travel often enough twenty miles home and reach there with their stern up. And this two or three days each week. I found only the well boned ones with deep back ribs and the best of necks, shoulders and loins, could put in anything like an efficient service; and as regards size, bless you, it was the heart! Given a reasonable size, which was the governing factor?

The Fox has a bigger leg (and a beautifully made one) than P. P. conjectures. Our ideal Fox Terrier is very much based upon the Fox—especially in head—but has a heavier frame to carry.

Perhaps, however, P. P. had in his mind's eye the wire-haired Fox Terrier,

but then they wear voluminous trousers for the most part, and really at times in the ring I cannot resist a smile at the well-meant and skilfully executed attempts to create an impression of extraordinary bone. Immersion in a pail of water would show a horrible shrinkage.

No one I know of advocates enormous bone, only sufficient substance of leg of the best quality. Any Terrier which decidedly fails in this respect is of little or no value.

To breed from parents light of bone

would soon land the Fox Terriers on a par with the Whippet.

To have a really grand specimen of humanity from a physical point of view bone is required to fill the eye: it is so with all breeds of animals. What grand bone lions and tigers put up; their legs and feet are grand; yet P. P. would say perhaps such bone was a handicap against strength and activity. But it is not so; the boot is on the other leg—it is a handicap greatly in favor! And so will say every practical, genuine sportsman.

## TORONTO DOG LICENSE LAW.

BY-LAW NO. 27, TO PROVIDE FOR THE LICENSING AND REGULATION OF DOGS. PASSED APRIL 23RD, 1898.

As amended by By-Law No. 46, passed Jan. 26, 1904; As amended by By-Law No. 67, passed March 23, 1909; and as amended by By-Law No. 75, passed April 18, 1911.

The Board of Commissioners of Police for the City of Toronto enacts as follows:

### I.

By-Law No. 24 is hereby repealed.

### II.

In this By-Law the word "dog" shall include "bitch" unless a contrary intention appears.

### III.

The owner, possessor, or harbinger of every dog shall, annually, on or before the 1st day of May in each year, or so soon thereafter as such dog shall attain the age of six months, cause the same to be registered, numbered, described, and licensed in the office of the Chief Constable, and shall cause the dog to wear around its neck a collar, to which collar shall be attached a metallic plate having raised, cast or stamped thereon the letters C.L.P. (meaning City License Paid), and the figures indicating the year for which the said license has been paid, and a number corresponding with the number under which the said dog is registered; and every such owner, possessor, or harbinger, shall pay for such license, metallic plate and registration for each dog the sum of two dollars, for each bitch the sum of five dollars; and every license shall expire on the 30th day of April next after the said first day of May.

### IV.

No license shall be required for any dog until he is six months old.

### V.

No person shall allow his dog to run at large in the City. For the purposes of this By-Law a dog shall be deemed to be running at large when found in a street or other public place, and not under the control of any person.

### VI.

Any dog running at large contrary to the provisions of this By-Law may be captured, killed or otherwise disposed of by such person as may be duly authorized so to do.

### VII.

It shall be the duty of the Chief Constable to appoint persons to capture dogs under the provisions of this By-Law, and dogs so captured shall be impounded in one of the pounds established by City By-Law, and be left in charge of the Pound Keeper appointed by City By-Law for such pound. It shall be the duty of the Pound Keepers to keep a record of all dogs impounded and how the same are disposed of, and to make a monthly return to the City Treasurer and to the Police Commissioners, showing the amount of moneys collected and the proceeds of the sale of dogs, and any other information which may be required by the Police Commissioners or the City Council from time to time respecting the working of this By-Law.

### VIII.

Any Police Constable, or any other person authorized by the Chief Con-



stable, may capture any dog found running at large contrary to the provisions of this By-Law, and may deliver such dog to the keeper of any dog pound, who shall impound the same subject to the right of the owner or possessor to redeem the same within forty-eight hours from the time of capture by paying for the use of the city two dollars for each dog or bitch, and also registering and procuring a license for such dog or bitch under section 3 of this By-Law, in case such license has not been previously obtained. All dogs impounded under this By-Law, if not redeemed within three days after such impounding, may be sold at the price mentioned herein for redemption or at such higher price as the Chief Constable may think proper. All dogs not so redeemed or sold shall, after five clear days from such impounding, be killed in such manner as this Board may approve.

## IX.

No person shall remove a collar or plate from a licensed dog.

## X.

No owner of any dog shall suffer or permit such dog to attack any person on a street or other public place, or do any damage whatsoever, and if any complaint thereof is made to the Police Magistrate, or Justice of the Peace acting in his absence, such Police Magistrate, or Justice of the Peace, may, if satisfied that such complaint is substantiated, order such owner to deliver such dog over to the Police at the nearest Police Station of the City in order that it may be destroyed, and if such owner or person shall refuse or neglect to deliver such dog over to the Police within twenty-four hours thereafter, he or she shall be liable to the penalties of this By-Law.

## XI.

Any dog known to be rabid shall be immediately destroyed.

## XII.

No person shall register a bitch as a male dog.

## XIII.

Any person convicted of a breach of any of the provisions of this By-Law shall forfeit and pay, at the discretion of the convicting Magistrate, a penalty not exceeding the sum of fifty dollars for each offence, exclusive of costs; and in default of payment of the said penalty and costs forthwith,

the said penalty and costs, or costs only, may be levied by distress and sale of the goods and chattels of the offender; and in case of there being no distress found out of which such penalty can be levied, the convicting Magistrate may commit the offender to the Common Gaol of the City of Toronto, with or without hard labor, for any period not exceeding six calendar months, unless the said penalty and costs are sooner paid.

## PREFIXES, AFFIXES, ETC.
