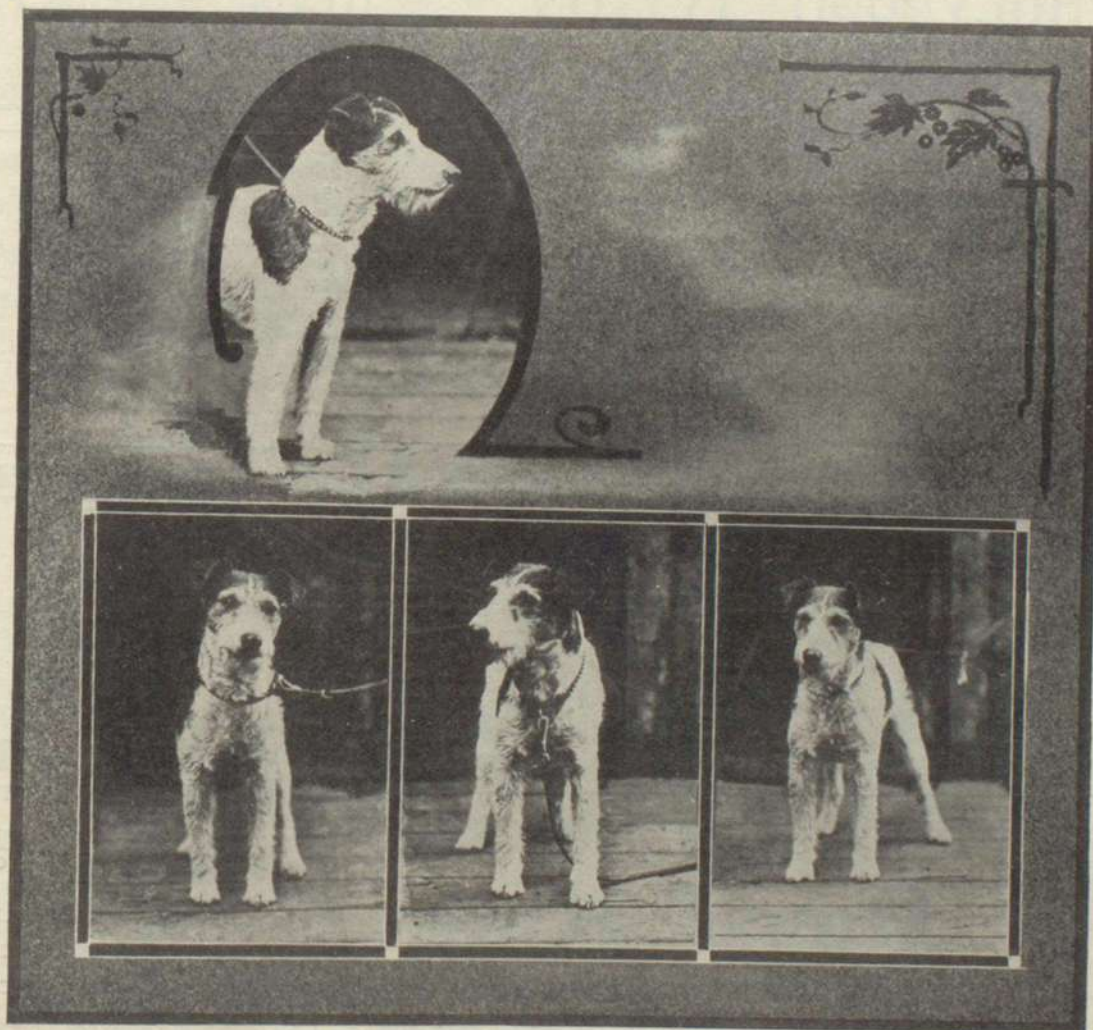

Brookdales: Mr. H. M. Dymant has advised us of the death by distemper contracted at the recent O. K. C. show, of his Cocker, Brookdale Nellie, 3rd in the Coronation puppy class at the O. K. C. Show.

Brookdale Irene, winner of 1st limit and open, parti-color bitches at the same show has been sold to Mr. H. J. Barr, of Winnipeg.

Winnipeg Show: Going to Winnipeg? They are offering big attractions and are preparing for a record entry for the West. It looks to us as though Winnipeg was destined to be the meeting place of eastern and western exhibitors.

Ontario will be represented by a carload, and there is no reason why Quebec should not join in with them.

### Winnipeg Dog Show.

Expenses Reduced to a Minimum.

Express Charges Done Away With.  
Toronto, June 3, 1911.

It has been suggested by a number of prominent fanciers who intend exhibiting at the dog show held in connection with the Canadian Industrial Exhibition at Winnipeg on July 18 and three following days that we should be able to secure entries enough from the exhibiting public to run a car, and thereby do away with the heavy express rates which is one of the chief objections to supporting any shows away from home.

Efforts are being put forward towards this end, and we would feel

grateful if you could see fit to support us.

The entire cost of sending, providing a car lot can be secured, would be \$5.00 per dog from Toronto to Winnipeg and return to Toronto, over and above the entry fee. No further expense would be involved.

Messrs. Bert Swann and James Scott have charge of the matter and assure all intending exhibitors that their dogs will have every attention and their personal supervision both on the car and at the show.

If you are interested, and you ought to be, as this is the largest show held in Canada, comprising 154 classes with cash prizes in each, and will sure be a 5-pointer, let us know at once.

Fantana: We think we are safe in stating that a reliable picture of Mr. Mason's famous Cocker Spaniel, Fantana, has not before been published. To those Cocker breeders who have not seen her it will come in the way of a revelation and prove of unusual interest.

To Fantana hangs a tale. (Please note, Mr. Comp., t-a-l-e.) She has the usual appendage also. Briefly, the

bitch got V.H.C. under a big judge, her owner gave her away, she was bought by Mr. Mason. Her career since then we know, at New York twice special for best Sporting Spaniel in the show; reserve for best in show, all breeds competing, last year, beating Tickle'em Jock, the winner, this year. If she isn't the best Cocker bitch, and the best Cocker, we have ever had, she is very close to it.

The photo has not been retouched or "improved," and hardly does the lady justice.

Trewanta Stopper: A western correspondent sends us such a breezy description of this home-bred wire-hair Fox Terrier that we give it as we got it.

Trewanta Stopper was bred by his owner, Mr. Reginald Hanson, Victoria, B.C., and is by Trewanta Pengelly; C. 11,042, ex. Trewanta Weaselle. Whelped Nov. 5th, 1909, his public career began at Duncans, B.C., where he was first in both puppy and novice classes. He took second puppy, reserve, limit and open, at Vancouver in August, 1910, and his recent wins at Victoria and Vancouver will be found in lists of awards in this issue.

It will be remembered that his dam, Weaselle's, portrait, appeared in this paper in August, 1910. She is the winner of about forty prizes, including several reserve winners.

"Stopper's" photos are good, but do not show the rich tan on his face. His forehead only is white—with tan over eyes and under to his cheeks, only a straight, narrow white line dividing his skull. He may be one of the team of six to represent the Province against a team from the east, at the Winnipeg show in July.

Winnipeg, too: Mr. A. P. Mutchmor, in sending us the following clip-

Here it is:

Dogs Cannot Roam Winnipeg Streets.

Drastic City By-Law to be Enforced This Week—Poundkeeper Not Called Upon to Hunt up Owners.

The long-expected and much-discussed dog edict went forth from the office of License Inspector Frank Kerr yesterday in the shape of special instructions to Poundkeeper Van-Norman, that the by-law respecting city dogs must be enforced to the letter.

Special officers have been hired for the fell work, and the biggest round-up of dogs in the history of Winnipeg is now well under way. The Board of Control, which started the trouble in response to a number of complaints from all parts of the city, has been notified by Mr. Kerr, possibly in the hope that the controllers may be induced to shoulder the responsibility when the howl from dogs and owners, starts as it is certain to do.

Read This.

Here is what the edict means, according to the by-law:

No dog may roam the streets, whether tagged or untagged, unless accompanied by and under control of owner or proper guardian. This sounds like the notices in trains and street cars about children, "accompanied by parents or guardians," but it is in the by-law that deals with Winnipeg dogs, and must therefore be enforced. Even if someone accompanies the dog, but the animal refuses to be controlled, it is liable to fall into the waiting net of the dog-catcher.

Once caught, it will be taken to the city pound. Its description will be publicly posted, and for three days the owner, if he knows where his dog is, may redeem it by paying \$2 if the dog already has a tag, or \$4 if he has not. If the dog happens to be of the female persuasion, redemption for the tagged will cost \$4, for the untagged \$8. After 72 hours in pound, the animal may be sold at a fair price to anyone who happens to fancy it. After six days it may, and probably will, be escorted to the lethal chamber, where it will end its doggy days as

painlessly as modern science will allow.

The strict enforcement of the by-law means that there will be no distinction made between distinguished dogs and just plain dogs, neither is a tag any protection if the dog is running at large. The poundkeeper is not required to hunt up owners and tell them to bail out their pets, so that it behooves the owner to get busy in a hurry should he miss anything from his kennel."

Still in it: Incidentally we learn that Mr. W. P. Fraser is getting a young Fox Terrier dog of high quality from Mr. R. Vickary, but with the Ontario Jockey Club Secretary's usual modesty he has failed to give us details.

Stud Book questions: "Will you please inform me through next month's Gazette: 1, If a dog who is listed and not registered can change its name and still retain its championship points won under the old name? 2, Also if a dog not registered but listed is entitled to be called a champion if he wins the full amount of points and the owner is a member of the C.K.C.?" Yours truly,

In answer to question 1, we should say yes. Provision for change of name is made in Dog Show Rule IV., which reads: "If the name of a dog which has won a prize at any recognized show has been changed, the old name must be given on the entry blank and published in the catalogue until such time as it wins a prize under its new name. The name of a registered dog cannot be changed."

The inference is that the dog, as an individual does not change, but his name may be changed.

Rule XV. covers this, or rather the paragraph that reads as follows does: "The winner of ten points in this class shall thereby become a champion of record, be so recognized by the C. K. C., and will, if registered in the Stud Book, be entitled to a Canadian Kennel Club championship cup. In the latter case, however, all points must have been won while the dog was owned by a member of the C.K.C."

This appears to be plain. A dog either registered or listed may attain to championship but none but regis-

tered dogs and where points are made while dog is owned by C. K. C. members, can get a championship cup.

\* \* \*

Calgary Show: A big advance has been made in the premium list of the seventh annual dog show of the Alberta Kennel Club. Good cash prizes of \$5.00 for first and \$3.00 for second are offered and most breeds are covered.

The entry fee is but one dollar first time of entry, 50c. each subsequent entry, and entries close on June 20th. The Club is liberal in listing all unregistered dogs free. The show dates are July 4th, 5th and 6th. Specials are many and some valuable.

Our old friend, Mr. W. A. Coats, of Vancouver, B.C., will judge all breeds and entries should be made with the secretary-treasurer, Mr. W. Forrest, Calgary, Alta.

A new building has been erected to accommodate the dogs, and in it provision has been made to bench over three hundred. Ample space is left for aisles, judging rings, etc.

\* \* \*

Dog license in Calgary: Dog owners in Calgary are in clover this year. Kennel licenses may be had at \$10.00, registered dogs are "tagged" at \$1.00 each, and bitches, \$2.00 each. As Secretary Forrest puts it, "Toronto's loss has been Calgary's gain." Nothing small about these Westerners.

A Canadian abroad: That good Bulldog man, Mr. A. A. Lees, of Hamilton, Ont., was honored in being asked to judge the Bulldog Breeders' Show, held on Saturday, May 20th, in New York. That he did himself credit goes without saying. "Dogs in America" for May 31st "cartoons" him, and in addition writes most warmly of his "judging on sound lines and with remarkable consistency on the question of type." The paper adds, "The visit of our Canadian friend was an entirely useful and successful one."

Airedale Items: Mr. P. Bawden, Ridgetown, Ont., one of our quiet and most consistent Airedale breeders, tells us that his Caerphilly Marvel is responsible for a fine litter of ten from his Beeg Pride. They were whelped on May 3rd.



Another bitch of Mr. Bawden's, and a good one, Caerphilly Nettle, has also been bred to Marvel, and he naturally is looking for something out of the ordinary from these two litters.

Mr. Bawden was breeding Airedales when the breed wasn't the popular one it now is.

Kennel manager: We have ample evidence in hand that "Kennel Manager," the Englishman advertising in this issue for a position of this nature, is all that he claims. We should be glad to put any owner in need of such an expert into correspondence with him.

New Bulldogs: Messrs. Adams and Cochran, Winnipeg, Man., have im-

ported from England a big winner in Mersey Bryn Admiral (late Bryn Admiral). He is a little over three years old and a winner of thirty-two firsts and twenty-eight seconds in England. A dark brindle with white markings, his sire is Lord Glamour (Moston Bar None — Miss Hesketh); his dam, Lady Hesketh (Lord Hesketh — Gertie).

Mr. Jemmet Brown, the well known Bulldog judge, says of him:

"Bryn Admiral is a quality brindle, with wide front, good bone and shapely body, with roach back. The skull is first class, being brick shaped, wide between the ears, and excellent length from eyes to ears, good eye placement, capital turn-up, lay back, and deep stop. The expression is Al. He is two and a half years old, and, al-

though not shown very much, has won twenty-two firsts, thirty-one seconds, and heaps of special prizes, including a silver tea-and-coffee service, and specials on various occasions for the best non-sporting dog in the show.

"As a stud he is held in very good opinion, and now in the Windsor Terrace Kennels sport two remarkably promising puppies by him, who show signs of turning into something very good."

Accompanying the dog came a bitch, also three years old, Mersey Sally (late Peppermint Sally). She is by the Dick Stone dog, Boldrewood Rex, ex. El Bini, by Darkest England. In color she is a light brindle.

Mr. E. M. Johns, Swansea, Wales, sent the pair over.

## ONTARIO KENNEL CLUB'S DOG SHOW.

BY THE JUDGE, MR. CHARLES H. MASON.

Three hundred dogs, six hundred and fifty entries, and only three hundred classes, with ribbon prizes in some classes and \$1 in many others, tells a big part of the story. My only regret is that I am unable to say as much for the management of the show as for the quality of the dogs. However, mistakes in the former are much more easily corrected than defects in the latter, and amateur management with fair entry fees is infinitely preferable to exorbitant demands on the exhibitor, who, at many shows in the States, enters his dogs for the benefit of high priced managers, paying a ridiculously high entry fee for the "honor" of competing for nothing but the specials offered by the club of which he is a member; and most of these specials have big chain attachments, making them safe against attack until finally they land where the donor intended when he offered them.

The entry fee at this show was \$1 for the first entry, and 50c. for each subsequent entry of the same dog, and why should it be any more than this with class prizes of trivial value? I am also in favor of home-made benches as used here, until governing bodies insist on permanent benches being disinfected and scraped and analyzed occasionally. The astounding loss of high class dogs from distemper

at the shows indicates conditions so disastrous and dangerous that I am surprised nobody has carried the matter higher up, as in the case of infectious disease amongst cattle. Scores of valuable dogs die after every show from distemper, and all that the breeder of exhibition dogs is permitted to do in the matter is to keep on paying taxes. How easy to scrape portions of the benching and submit these scrapings for analysis. The cost would be perhaps \$3. We have no money for the protection of our dogs and their owners, but we have lots to give away. In Canada your show profits revert to the dog breeder and the dog owner and your aim is to advance the interests of each. This is as it ought to be and as it will be here some day. In managing your own shows; in keeping managing and judging separate, and in using new benching you are years ahead of us, for you have less dissatisfaction and also less disease, whilst nothing even suggesting a parasite, like our Dog Show Trust, can be found amongst you.

As I write from memory I shall not attempt either a complete or critical report and, be it known, critical reports are not wanted in the States, however much they may be valued in the Dominion. Here our sole duty is to boom the judge and say nice things about certain dogs, so that the hand-

lers may unload them. To do otherwise means to step down and out and take your dogs along with you. The harder you maul those who are not in the Union and the better it is for you. Promotion quickly follows your loyalty to the bosses. But, alas! some of us refuse to write anything unless we are permitted to state facts, or what we believe to be such, and this is why we are so wicked. You see a man who states his convictions is liable to judge dogs in accordance with his convictions, and what would become of some of the Fox Terriers that have been boomed as the best in the world, to say nothing of the Pomeranians picked up in England and unloaded at \$1,500 a head, were a man to tell the truth about them? It wouldn't do at all! But you look for the truth and value it, and it is just as well you do in this case because I write that or nothing.

With twenty-one entries and quite some quality, St. Bernards deserve mention. Ingomar of Parkdale, a rough-coated puppy with lots of size and nicely put up, I sent through to winners, and all being well he will win again. Champion Lochinvar scored in open, largely by reason of his head qualities and massive body. Prince of Parkdale, Moss Sylvia and St. Peter, all possessed merit, especially the former. In the classes for the



opposite sex, F. & A. Stuart's Montphosa was hard pressed by Viola of Parkdale, a big one that lacked the massiveness and bone of the winner.

Of the eighteen entries in Newfoundland I regret not having seen one of the right type.

Great Danes, Greyhounds, Fox Hounds and Pointers were very light classes with little of merit amongst them.

English Setters—Lady Aberdour, not very typical in head and only fair in shoulders, won from Beauty II., that was close in point of merit. Neither is high class and the others are not quite show dogs.

Irish Setters, better than English. Lord Dufferin, first novice dogs, first junior, and second open, has grand color and just a fair head. His hind parts and gait do not appeal to me. Blarney Mike pressed him in each class. Montrose Marcus, with the best head and most quality, although moderate behind, won in open dogs and in winners. Brown Betty was the best of a poor lot of bitches, and what a name!

Cocker Spaniels mustered about eighty entries, or a few over, which was quite refreshing and in marked contrast with the suppressed figures of the so called circuit shows. But let it be known that we have the dogs, only we keep them at home, not caring to further encourage conditions which are intolerable. It is a mistake to suppose there are fewer dogs than in the past, because there are more than ever. The owners, however, are wiser than they were before the Trust got complete control of the shows—hence our light entries, as compared with yours. But to the dogs. First in puppy dogs won all the way from the long bodied Marcona that is not very much of a card for his sire, Martello Echo Peer third, I think got as much as he ever will get in the future, being moderate all over. In the novice for blacks Mr. F. W. Lewis supplied the first, second and third prize winners in Falto, Sir Benedict and Calmo Don Carlos. The winner would be a good one, but for his long body and Sir Benedict, had he a perfect muzzle, would also rank high in his class. The balance, including Dark Cloud and Galtimore, fail in head properties and I will not go beyond. In the any solid color, other than black, a good bodied red was

crowded by the puppy class winner that would have won had he been in coat. Brookdale Buster, not up to the Dymont standard in head especially, was third. In any other color Mr. Fred T. Miller, a name familiar to most of us, though not in recent years supplied the winner in Rellinderf Rube, a fair parti-color, whose head and front will prevent danger to Dare, a son of Champion Kildare, displaced Calmo Don Carlos and won third. Mr. Dymont in the any other solid color class, won with Brookdale Bonfire, that is well known by reason of victories at New York a couple of years ago. Prince Perfecto, the novice class winner, was second here, with Sandstone, just fair, third. In limit parti, St. Elmo, a big one by Jocks Ringwood, won. His attractive Setter markings are quite catchy and he shows some character in head. In length of body he fails considerably, and he may be over the 24 lb. limit. It would not surprise me to hear that he is a good stud dog. Rellinderf Ruby was second. Crescent Tippecame next but his sort does not appeal to me. Open blacks had Martello at the front, his better head landing him ahead of Sir Benedict. Pauline Dare third. Pauline Smith would be a queer name for a man. Open, any other color, had Speculator first. His faulty shoulders and front do not improve with age, and Brookdale Bonfire was a closer second than some supposed. Rellinderf Rube was third, with Prince Perfecto reserve and Sandstone V.H.C. Of the eight bitch puppies Brookdale Nellie and Brookdale Irene carried off the leading honors for Mr. Dymont. Their condition was most praiseworthy, as was that of all the dogs from this kennel. With a better muzzle the winner would be hard to beat. The third, too long in body and curly in coat, besides having a touch of chorea, possesses a grand head. All of the others were mentioned. In novice blacks Mr. Tomlinson's Nellie won despite her short neck and by no means perfect shoulders. Lady Felto, by Kildare, but not with a head like her sire, was second for Mr. Kynock, and Mr. Lewis supplied the third in Bell that looks like a brood bitch. All of the others possessed some merit. In the any solid color other than black, Brookdale Nellie scored again, Mr. Herd's Jenny Lynd a good second,

whilst a moderate looking daughter of Old Standard was third. Crescent Glow's good body landed the reserve over the V.H.C. Lady Rose and Toby R. Any other color had the parti, Brookdale Irene, practically alone, and in limit blacks Mr. Kynock supplied the first and second in Bessie Lee and Lady Felto, whilst Bell was again third. Limit for other solid colors was the best of all the Cocker classes and here Mr. Dymont won both first and second with the buff Brookdale Silver and the red Brookdale Red Lady, a brace of nice ones. The winner is not just right in either shoulders or in quarters and might have more neck to advantage, but she is fit for high class company, whilst Brookdale Red Lady is one of the best of her color. Bertha R. in third place, was several points behind these, and then came Crescent Glow, Lady Rose and Toby R. The parti limit had Brookdale Irene at the front with Mr. and Mrs. Gammon's Golden Buttermilk a good second. Open blacks was a repetition of limit, and Brookdale Silver scored again in any other color. In the winners classes Falto, Nellie, Speculator and Brookdale Silver were at the front whilst the latter won the special for the best Cocker in the show.

Colliers turned out in force with sixty-one entries, of which the flower of the flock was Colonel McEwen's Holyrood Tytton, a son of King Edward Tytton and Holyrood Trig, and bred by his owner. His structural defects are few and, if he does not develop coarseness he will beat better ones than he so easily defeated upon this occasion. He is a light sable, possessing both strength and size, and was put down in good shape. Campbell Boy, first in puppy dogs, needs more coat, and may have it later. He has far more quality than Glenhurst Bobs, especially in head, but the latter scored over him in coat. These were second and third in novice where Holyrood Tytton won, as he also did in limit, in open and winners. Skyboo Perfection, owned by Mrs. F. Bell, was second in limit and in open, whilst Ormskirk Oberon, by Seedley Surprise, and owned by Mr. W. Taylor, was third. Dr. Ford's Otterburn Operator was reserve, all being show dogs of more than ordinary merit, whilst behind them were four or five noticed ones, each possessing merit.



Mrs. F. Bell's Beauty went from novice to winners in the classes for her sex, and is a nice quality one, as is also King Edward Prunella that was second throughout. Others deserving of mention are Bellevue Lassie and Walden Valentine. There was only one Old English which I consider was a fortunate condition for him.

Bulldogs had fifty-nine entries and nearly all were up to show form. Some mixing of the numbers was most perplexing, and one or two dogs were absent from one class but managed to get into another, which ordinarily would indicate they had been overlooked in one class and awarded prizes in another. Rydal Squire that scored from novice to winners, is quite a nice young dog and was put down in good shape, which applies also to Fair Stone Rex. Others worthy of notice are Lee Bank Squire, Golden Star, Master Stone, Tremail Ted Stone and Woodcote Merry Boy. Silver Queen and Silver Empress scored highest in bitches, but several others were well up.

Many of the Terrier classes contained dogs that are able to hold their own in the best of company. Bull Terriers had twenty-two entries. The winner in dog puppies is quite promising and he scored also in winners, beating the over 30 lbs. limit winner, Inferno King, that was third at New York this year. Billy Gray, by Noross Patrician, was second to Inferno King, failing some in head, whilst Star of the East was third, losing also in head properties. Champion Inferno was for specials only, where he was easily beaten by Willowvale Bloom, a lovely light weight that won at New York, but failed to score in the winners at the latter show, where Inferno was considered the best of either sex. How that happened I cannot tell for she beats Inferno to a certainty and especially in head and in front. Mr. John Miles, owner of Inferno, took his medicine like the good sport that he is. Heward Bell and Epsom Countess Gray, the open class winners, are quite show bitches, although eclipsed by Willowvale Bloom.

With forty-nine entries Bostons were quite prominent and several good ones were to be seen. Lord Bellrock and Boylston Burney were especially noticeable in dogs, whilst Leading Lady and Lady Bellrock III. can hold their

own against many of the big winners in the States.

Forty-six entries in Airedales, with Grayston Growler the pick of the lot; a good sound one with the right texture of coat. Colne Edgewater Firebrand, first in puppy dogs, and second to Growler in other classes, is not any too good in feet and is also a bit weak in face and light in bone. Briar Lass was the best of the bitches, novice to winners, best type, best coat. Grayston Grisette, first in puppy class, not so good as her kennel mate, Growler, in head or in limbs or in coat. I would like to write about all of them because many deserve mention but space will not permit, and without notes the babies might get mixed.

Twenty-seven entries in Irish with Quarrywood Commander and Quarrywood Tim, the pick of the dogs, and Garfield Lass and Shiela, the best of the bitches. The breed is not making headway if judged by this show, and a number of very poor specimens were in evidence.

Scotties, Skye, Bedlington and Welsh were disappointing classes, but Black and Tans were fair, Golden Rod and Pearl Point heading the latter.

Fox Terriers had seventy-two entries of mixed quality and variety of types. Mr. Harlowe's Rolleston Jack, followed by Broadway Donor, were prominent in smooth dogs, whilst of the bitches, Aldon Mystery, was the best Terrier. But her condition was too bad to permit of her winning over Broadway Donation, that loses to her in head and in body as well. The wires were more numerous than the smooths, but they were not a very uniform lot and bad coats were quite conspicuous, as was also lack of strength and substance. Mr. Thos. Moore's Donington Jack was easily the gentleman of his classes, having the best head and type and coat and size, whilst Mr. Charles Hewlett's Riverdale Pearl was the leader of the bitch classes. Quite a few of the exhibits in these classes were dead out of coat and a wire haired Terrier without a wire coat should lay off until it grows one.

Mrs. J. A. Meadows showed two rather nice pugs in Dundee Prince and The New King and I preferred the former, a black that can hold his own in good company.

There were twenty-eight entries in Pomeranians, with the browns usually

at the front. Cairndhu Merrymaker was not in full coat, otherwise there was a lot of good in him. The first in puppies, Mr. Hanson's King Fox was reserve to this dog in winners. The best of the bitches were Mr. R. F. Ford's Coronation Echo and Mr. G. B. Foster's Orange Sabie.

Toy Poodles had eight entries and were much better than one usually finds. Mrs. John Crane and Mrs. F. R. Williams showed the best of them.

Toy Spaniels had sixteen entries. The Blenheims, King Charles and Prince Charles were not the equals of the Rubys, of which variety Miss Burnaby and Mrs. Jas. Scott showed nice ones. The two Japs exhibited by Mrs. Williams are much above the average.

Mr. Kenyon's Yorkshires were the best of the five entries. His Little Star, whilst too dark in body color, shows lots of quality and was put down in good shape.

Zettamy won very easily in Italians, having a tremendous advantage in the matter of size, and being more truly formed than Blue Bell, but her color, fawn and white, is against her when competing against solid colors.

There was a nice Whippet or two amongst the eleven entries, and Silver Dollar is an especially smart puppy. Rose Queen, the leader of the bitches, is of heavier build than I like.

Dear Sir,—Re Western Canada Kennel Club Show, Feb. 14-15-16, 1911, I beg to enter an appeal on the decision of the judge at the above show on my dog "Rass" shown in the Water Spaniel class and also seek a revision of the decision by the Committee to whom protest of the judge's decision was made and enclosed herein the fee, \$10.00.

The judge informed me that my dog was disqualified on account of his heavy curled top-knot or feather, which, he said, should be combed out.

In my opinion the judge was not posted on this breed of dogs, as the dog winning the winners prize had a large patch of white on his breast and also had hair to the end of his tail an inch long, which, according to the Standard rule of the Irish Water Spaniels, disqualifies him. You will see by the photos enclosed that it would be impossible to comb this dog's feather out. The point I ask you to decide is this: Is the Irish Water Spaniel going into the ring to be judged, liable to be disqualified on account of the heavy feather. My dog Rass has feather from 7 to 8½ inches long. This dog has been shown at the Winnipeg Exhibition the last two years and did well, winning last year open, limit, winner and special. He has just recently returned from Fargo, North Dakota, Show, where he swept everything. I request a ruling from your committee setting me right, as the four judges previous to this one, have always placed my dog among the winners.

I have taken great care and spent considerable money in trying to get on these dogs just what this dog Rass is disqualified for—feather. From the listing of the Western Kennel Club you will see that this breed had only three in their class.

At the last show at the Winnipeg Exhibition and through the efforts of myself and others, the entries at the show just closed had increased to 17, the dog Rass is closely connected to 10 of the 17 shown here. So your committee will see we are entitled to a definite answer.

I have had two photos taken of this dog which I hope will help you in making your decision. I do not want any ruling of the prizes or awards that were given here in this class, let them stand as they are.

The \$10.00 here enclosed I want you to use in getting any information to decide this point.

This dog I have been using as a stud dog, hence you can see my object in getting a decision of a body of men as your committee is composed



of. Had the dog Rass been placed in his class, I would have made no protest whatever, taking it the same as any other good sport should take it. I would refer you to the Blue Book of Great Britain and America and other Countries, by Stonehenge. Turn to page 120, where the breed is known as M'Carthy's and you will see by comparing his photo with the details given on the above page what class of dog Rass is.

The question I have asked to have you settle in my appeal is this—Is a dog disqualified on account of his feather? It is not my wish to have any awards changed whatsoever.

When my dog was at the gate of the ring a few moments before being called into the ring, one of the committee, namely, Dr. R. W. Kenny, informed me that my dog was going to be disqualified. That looked suspiciously as if it had been pre-arranged to disqualify my dog, and the said Dr. Kenny admitted to several of the Committee that he had informed me to that effect. Dr. Kenny was one of the ring stewards.

When the dogs were taken into the ring, the judge did not ask that they be moved or trotted around, neither did he go behind them, but took up all the time commenting on what should be done in combing and pulling out my dog's feather, my dog being the only dog in this Class having feather. Mr. Dole disqualified my dog Rass for the main feature of an Irish Water Spaniel, namely, feather. In the opinion of all our local and Western dog fanciers and judges, the dog Rass has the finest and best feather of any Water Spaniel in Western Canada.

Furthermore, as you know, this dog had just recently returned from the Fargo Show, and you will understand he was in excellent condition, as one would not send a dog to such a distance to compete with other dogs if he were not in the very best of condition, etc. He was in good shape at this show, and anything that is said to the contrary is doing the dog an injustice.

Any of the aforementioned matters you may wish to take up with me, I will be very pleased to give you any information in my power.

C. says I haven't any right to same, and will notify the Ontario Kennel Club of my claim. I will be in Toronto May 20th to 27th, and will attend the C. K. C. meeting. We hope Dr. Ford's extended tour will lead him north and west before September, so that he may not miss seeing Mr. Francis Redmond judge Fox Terriers at Toronto. He writes:

Mr. Robert Vicary, generally conceded to be the most eminent authority on smooth Fox Terriers past and present, had a few pertinent remarks to express on this breed as it appeared before at the last New York show. As the entry was highly representative of the best we have on this side of the Atlantic, the opinions expressed must carry much weight from such an unprejudiced source.

Mr. Vicary found the classes quite easy to judge, "no fight fits," as he aptly puts it. He found Sabine Rifle "far and away the best dog" (it will be remembered that Ch. Sabine Rarebit was in these classes). "Too much inbreeding" is a timely warning, as it results in "loss of bone and foreface." "A word to the wise," etc.

In Irish Terriers, Mr. Vicary believes he found two or three American-breds to beat the best in Great Britain.

"The Vicissitudes of Tickle 'Em Jock" would make a good title for a companion story to Mr. Richard Harding Davis' immensely popular "The Bar Sinister," whose hero it will be remembered, was the Bull Terrier "Cold Steel," whelped in Ottawa, exhibited at the National Exhibition in Toronto and subsequently purchased by Mr. Davis.

Champion Tickle 'Em Jock, the Scottish Terrier who was declared the best dog in the show at New York, has known the vicissitudes of life in his

meteoric career of three years. He was picked up for a modest "two quid" in a bird shop in Leadenhall market, London, by the well known professional Sam Wilson, who used to go from show to show all over the United Kingdom with the famous Irish Terrier, Bolton Woods Mixer, who, by his omnipresence earned the title of "breadwinner." "Jock" has had his ups and downs quite frequently receiving a modest V. H. C. or H. C. card by judges who did not like his type. Though beaten on several occasions since his importation he has carried all before him the past two years at Madison Square Gardens.

Another Scottie with a history was the late Champion The Laird. Discovered outside a barber shop in England by the astute George Thomas, and first exhibited at New York under Mr. W. P. Fraser, who put him at the top, a position he maintained till his death.

#### TREWANTA STOPPER. C. K. C. 11814.

Did you ever see Stopper at a dog show in the ring, under the judge's eye? It is worth while. He is Stopper, Trewanta Stopper, and he is aware of it. He knows his turn is coming—he looks at you eagerly, all alive as you come towards him, to fetch him off his bench into the ring. He rushes, dashes, strains on his lead to reach the roped off space that means so much to him and his master, whom he loves and serves.

Arrived in the ring his aspect changes. He knows where he is: the target of critical eyes; amongst the chosen of wire hairs, all boasting of high lineage and ring triumphs. He collects himself and takes in what there is against him. He braces himself, he puts on side, he is alert, he expands with pride, with courage, with swagger. High he holds his head, up he stands on his feet, high in disdain; he glares his eye around; he quivers with suppressed rage, as he poses and shows the white of his eye in warning to those noisy, excited worms, who come almost too close to him; he lifts and holds back the foot of one fore leg, ready for action. He with three legs is as good as those others on four feet. He slightly raises a quivering lip and shows his ivory tusk.

And now he plays up to the judge. He wags his tail, he looks with entreaty, with confident appeal into the judge's eyes. He stands calm with slackened lead. He has done his part. He asks for his ribbon and — and by George! by George!! he gets it!

Can't you see him!

# MR. CHAS. H. MASON.

JUDGE OF ALL CLASSES AT THE CORONATION SHOW OF THE ONTARIO KENNEL CLUB, TORONTO, 1911.

The following particulars of the early fancier career of Mr. Mason appeared in the Stock-Keeper (London), and are from the pen of the late George R. Krehl, the talented editor of that paper. A first prize in those days meant something because, as a rule, there were but two classes for each breed—one for dogs, the other for bitches, whilst at not a few shows dogs and bitches competed together in one class. It was not an unusual thing to find thirty or forty exhibits in one class, as was the case at Birmingham, 1876, in the Pointer and other classes. In the very popular breeds there were sixty to seventy entries in a class at some of the shows. Under the classification now in fashion it would be much easier to win two hundred and fifty first prizes than it was to win the eighty-four which Mr. Mason secured in 1880. Mr. Krehl's complimentary allusion to Mr. Mason's reporting means that Mr. Krehl considered the subject of these notes the best critic in the world because all of the leading lights in dogdom contributed or had contributed reports to the Stock-Keeper, from which we quote:

In 1871 Mr. Mason stepped into the ring at Halifax fully equipped in experience for the fray. Here he claimed the winning Italian Greyhound and soon after purchased the prize Clumber Douglas, and from the same kennel the Newfoundland Cabot, who accounted for many honors. In 1872 he was gaining ground and won first in Pointer bitches at Manchester. In 1873 he got into the midst of the prizes, winning in Scotland and England. In 1874 he exploited the north of England, playing havoc with the premiums by the aid of Pointers, Fox Terriers, Italian Greyhounds, etc. At Darlington this year he won with a Pointer of his own breeding. In 1875, still advancing, and his team almost invincible in the north, his Pointer Marquis winning at Birmingham and getting second to Wagg at the Crystal Palace. His kennel had become very strong in 1876, and not only furnished the firsts in heavy weight Pointer dogs and bitches at Birmingham, but bred two more of the prize Pointers at this show, which, in those days, was the

best display of Pointers in the country. In 1877 he was almost the largest winner of the year, and now included St. Bernards, Collies and Setters in his team. At Edinburgh he swept the benches.

Mr. Mason now took to the water, and cleared out the Belfast prize fund with his Pointers, Gordon Setters, Rough-Haired Terriers, Pugs, Collies, etc. In 1879 he had almost the premier kennel in England, the only combination that gave him any trouble being Messrs. Fletcher and Geo. Heliwell. He made a clean sweep of some shows, and was now also breeding Spaniels,

Mastiffs, Airedales and Bulldogs. The following year he was at the top of the tree with a truly grand lot and the list of first prizes, cups and specials would occupy more space than we could possibly spare.

The Fanciers' Chronicle of that day, now known by its superior title, the Stock-Keeper, made a note of Mr. Mason's glorious record, which amounted to eighty-four champion and first prizes, fifty-four seconds, twenty-one thirds, a fourth, and hosts of cards. His last English outing was at Liverpool in January, 1881, where he won again all along the line of Mastiffs, Newfoundlands, Pointers, Fox Terriers, Bull Terriers, Bulldogs, etc.

Before he left England Mr. Mason had reported for the Fanciers' Chronicle, Stock-Keeper (since its birth), The Field and Live Stock Journal. Mr. Mason tells us that he considers the greatest honor ever conferred on him as a fancier was when the Stock-Keeper described his report of the New York show as the best criticism that had ever appeared in its columns.

## BOSTON TERRIER CLUB OF MONTREAL SHOW.

DOGS PRESENT 56. WINNERS VALUE 2 POINTS.

The second annual show of the Boston Terrier Club of Montreal was a success in every way, though the tropical heat militated against a large attendance. We don't know what happened the weather man on May 20th, the date of the show, and a day or two previous to and after this date. He had it in for us poor mortals and our canine friends and both sweltered and suffered, the former especially.

The attendance at no time was great—it was a dog day, not a dog show day—and even with nothing to do but watch the judging, we enjoyed every privilege of a free Turkish bath. Our sympathies are with those actively engaged in the work of benching the dogs, getting them into the ring, etc. To be candid and to say the least of it the ring service was slow and the judging proceeded at rather a painful pace. On the other hand, the writing up of the awards was the best we have ever seen. The whole arrangement showed forethought and judgment. Briefly the classes were outlined on a large sheet of paper, the numbers of the classes running consecutively along the top. Down the left hand side of the sheet were the prizes, 1st, 2nd, 3rd, V.H.C., H.C. and C. No space was left for reserve, a detail easily added, and the "letters" were confined to one of each. Under the prizes were square blanks for each, in which it was but necessary to fill in the winning numbers. Thus, as the judging progressed, the awards were given, progressive, until completed, and every award in full view all the time.

We very heartily commend the plan to more pretentious fixtures.

The benching was new and neat, the whole show clean and sweet, and no necessary detail was missing.

We heard that one dog, the name has escaped us, from Brockville we think, was suffocated en route to the show.

Exception was taken to the condition of Maxman's tail. As the case comes before the C.K.C. we do no more than allude to it here.

### THE JUDGE'S REPORT.

The show held on May 20th in the Victoria Rifles Armory by the Boston Terrier Club of Montreal was a success in every way. While the entry was a bit disappointing to the officers of the Club (who, by the way, are a hard working enthusiastic lot of amateurs who are in the game because they love the dog), the quality, as a whole, was far superior to that of their first show held two years ago.

The show was neatly benching under the skilful eye of Supt. Innes, and was on the whole well managed.

Puppy dogs a rather ordinary lot, first going to a good son of Mr. Coghlin's Kweenee Spunk.

Green dogs brought in fourteen. Mikado, a good even dog, was first, the puppy winner second, and Jacobson's Punch, third. The latter, a



nicely marked dark brindle, rather long in muzzle.

Local novice dogs, Mikado first, Ellsworth Sir Edward second. This is a well made, good headed dog with uneven head markings, admirably shown by that veteran "Johnny" Campbell. Sir Noodles third here.

Local limit dogs, some quality here. The winner proved to be Revilo Yankee that afterwards went through to winners. A beautiful dark brindle with perfect markings, a bit full in cheek but a nice sound Terrier, the kind we all want to breed. Second to Maxman II., if his tail proves right, a strong headed dog, third to Walter Boy, quite a nice type. Kweenee Spunk, a nice Terrier, reserve.

Light weight classes were a repetition until the open was reached. Here the owner of Tom Boy asked that Lord Bell Rock be weighed and the sport was over as this good little dog had had too much breakfast and went past the seventeen pound mark.

Novice limit and open 17-22 lb. classes, were repetitions of former classes.

Heavy weight dogs were nothing out of the ordinary.

Winners dogs, Revilo Yankee first, Tom Boy reserve, the latter a nice little dog, showed tucked up and inclined to roach here.

Puppy bitches were superior to the dogs. Kweenee Rena, a handsome marked even bitch, first. Spangle, superior in muzzle, a trifle low set, second; Mlle Genee, untrimmed, and lacks markings, third.

Green bitches brought in a very neat sort, Topsy Dee first, Monopol Lady a nice well marked bitch, a trifle out in hocks, second, with the winner pup third.

Local novice bitches, Miss Purdy's Topsy Dee first; Winkles, a nice bodied little bitch, with a trifle too gay a tail, second; Edna D., third.

Local limit and novice bitches, 12-17 lb., were a repetition.

Limit bitches, 12-17 lb., was the real warm class of the show. All three of the winning bitches are well known and have won blue ribbons in the fastest kind of company. Arethusia first, a perfectly marked dark brindle, was cleaner in muzzle and better in hind quarters than Victoria II., second. The latter much improved in body since I saw her in Buffalo, but still an

indifferent shower. Monopol Happy Girl third (won first in New York in open Toys and shown in condition (under twelve pounds) has yet to be beaten. Wrinkles had to be content with reserve in this company.

Open bitches, 12-17 lb., was a repetition of limit.

Novice bitches, 17-22 lb., as well as limit, was won by Monopol Lady previously mentioned.

Open bitches, 17-22 lb., brought in a real good bitch all over in Lady Bell Rock III., that beat Monopol Lady at both ends.

Heavy bitches were few and just a fair lot of brood bitches.
