# NOTES AND COMMENTS

Bulldog Bit: Mr. Henry St. Lawrence's Trafford Bullacity has recently been on a visit to Messrs. Adams and Cochran's new dog, Messey Silver Shekel. Also, Mersey Brya Admiral has sired seven puppies, the dam being Twiggie Wigg, of which six are dogs. They were born on Nov. 19th, 1911, and are all doing well. There will be some Bulldogs in the West after awhile.

Moose Jaw, Sask., Show: The Saskatchewan Kennel Club will hold their next show on February 27, 28 and 29th and March 1st, 1912. The show will be held under Canadian Kennel Club rules. W. H. Munro, 1430 Hamilton Street, Regina, Sask., is Sec'y.-Treas. of the Club.

Rabies: Dr. Hastings, Medical Health Officer in the City of Toronto, in reporting to the Board of Control, handles this matter in a sensible way He reports that during the months of October, November and December that there had been ten cases of rabies among dogs in the city. The doctor stated that the matter of the control of rabies was purely a problem of the Federal Government, and he was asked to communicate with the Dominion Government authorities with reference to it. Dr. Hastings took occasion to state that in the past five years one death in Toronto has been attributed to hydrophobia, and the diagnosis was doubtful in this case, while in the same period 3,000 people had died of tuberculosis.

A good Boston gone: We were sorry to learn a few days ago of the death of that good Boston Revilo Yankee. He was a cracking good little dog and at the Montreal Boston Terrier Club show last spring won 1st limit, 1st open, 17-22 lbs., winners, also several specials.

Irish Wolfhound: Mr. J. C. Eaton, head of the big departmental store in Toronto, we understand, has imported an Irish Wolfhound named Abel Dirck, and a descendant from a long line of champions of a breed which but a short time ago threatened to become practically extinct. The dog is a big one and a good all round specimen.

B. C. Fox Terrier Club: This British Columbia Specialty Club has finally settled on Jan. 25th, 1912, for their next show. Mr. Stanley Dorrell will judge all classes. The show will, of course, be held under Canadian Kennel Club rules. This was not the original date chosen but it has been found so difficult to secure a decent location and proper building in which to hold the show that postponement till Jan. 25th became necessary.

P.C.A.B.: Mr. W. M. Coats, Vancouver, is acting as secretary for the Pacific Coast Advisory Board to the C.K.C.

Cocker Items: The Brookdale Kennel's Clark's Jessie, the dam of Ch. Le Noir, that Mr. Dyment bought from Mrs. Clark last fall, is in whelp to Ch. Danna Da. Champion Brookdale Silver has three nice blacks that are sure winners. They are stred by Uncle Billy, a full brother to Billie Obo. Mr. Dyment lost Brookdale Dolly the other day from apoplexy. She was the dam of two champions, Brookdale Violet and Silver, and he feels the loss of her very much.

Victoria K. C.: At a general meeting of the Victoria City Kennel Club, last week the dates for the spring show were selected for the third week in March, 1912, this being thought the most suitable time.

The secretary, Mr. E. Hill, was instructed to write Mr. Charles H. Mason, in regard to the judging of the coming show. At the meeting thirteen new members were enrolled, mostly all new arrivals in Victoria. Our front page portrait: Messrs. Adams & Cochran write us: "It will be of interest to the Bulldog men to learn that we have purchased the well known Bulldog, Mount Shekel, from Mr. R. W. Brunner, of Pittsburg, together with his brood bitch, Mount Daisy. Shekel is claimed to be the best dog of his weight living and is probably nearer to the true type than

any other present Bulldog of to-day. He possesses remarkable head qualities, having extra wide under jaw with turn up of the correct sweep. His face is exceedingly short, big nostrils and face full of substance. He has a very deep stop, dark eyes placed wide apart, a tremendous skull, rare cheek humps and any amount of wrinkle with best carried ears seen on any dog living. His body would be hard to improve upon, good shoulders, big barrel ribs, short back, good roach and light hind quarters and short screw tail. breeding is the study of years, having a double cross of Ch. Prince Albert and carries blood of such dogs as Ch. Rodnev Stone, Carthusian Cerebus and has been a winner every time shown. His winnings are silver cups, gold medals, seven firsts, seven specials, and champion. Mount Daisy's pedigree includes such grand parents as Ch. Silent Duchess and Ch. Heywood Duchess.

Shekel will be registered here and will be advertised at stud in the near future. His puppies are remarkable; some of them being big winners in the States. He is an imported dog, being Silver Shekel in England, where he was also a winner every time shown.

We feel that our new purchase will do a great deal towards improving the type of Bulldog in Canada. We have been trying for a year or so now to get what we wanted in the Bulldog line and now feel that we have succeeded.

We imported him direct ourselves from England and he is now nearly three years old and in perfect condition."

#### MEETING OF EXECUTIVE COMMITTEE HELD JANUARY 12TH, 1912.

(OFFICIAL MINUTES).

The President, Mr. Jno. G. Kent, occupied the chair at above meeting.

After routine business the Secretary-Treasurer's report, as follows, was considered:

> SECRETARY-TREASURER'S REPORT.

Mr. Chairman and Gentlemen :

As scheduled in regular printed notice sent out for this meeting, the following business is to come before you:

1.—The appointment of an Honorary Veterinarian. This matter was discussed and voted upon at the annual meeting and it was left for this meeting to make the appointment.

2.—Report of committee on rules. This committee was appointed by the annual meeting to report at this meeting. Committee's report is here for your confirmation or otherwise.

3. Judging of Pomeranians at the Montreal Kennel Club Co. Show, Oct. 5-7th, 1911. Following is the correspondence:

On Nov. 3rd we received the following letter, dated Oct. 23rd:

19 Highland Ave., Montreal. 23rd October, 1911.

To the Executive Committee, Canadian Kennel Club, Toronto, Canada.

Gentlemen :

At the dog show promoted by the "Montreal Kennel Club Co.," and held here on the 5th-7th inst., under Canadian Kennel Club Ru'es, I was an exhibitor of Pomeranians, and amongst other entries had included my exhibit for competition in the Brace Class, for which a special prize was offered to the successful competitor.

Owing to the decision of the judge not being in accordance with the rule governing those eligible for competition for this particular "special." (See Rule XIX.), I immediately lodged a formal protest with the Secretary of the company, accompanied by the necessary deposit of \$5.00, as provided for in your Rules.

As the "Montreal Kennel Club Co.," (which is a purely proprietary con-

cern), had not appointed the necessary Show Committee, my objection was not considered at the time same was lodged, but on the 19th inst. (12 days after the closing of the Show) I received a letter from the Company, of which the following is a copy:

Dear Madam :

Referring to your protest regarding the judge's decision in the Pomeranian Brace Class, the matter has been laid before Mr. Thomas, and after serious consideration, we feel that we must sustain the judge.

While we personally regret that there should have been any misunderstanding, we feel sure that you will understand the position we have taken.

You will note that this communication states that the matter was "laid before Mr. Thomas" (one of the proprietors of the "Company," and a member of the Executive of the Canadian Kennel Club) who decided that the judge must be sustained.

Having regard to the above, and to the fact that my objection was lodged owing to the judge deliberately breaking the C. K. C. Rules, I am sure you will appreciate the peculiar position in which I am placed by not having my protest adjudicated upon in accordance with your regulations, which provide that—

"A Show Committee shall at once meet and decide upon any objection lodged during the show, and from their decision an appeal may at once be made to any member of the Executive Committee of the Canadian Kennel Club who may be available, provided such member is not on the Show Committee."

The position at the present time is, therefore, that not only has my deposit been forfeited but my protest refused consideration by an independent committee, but that it has been decided against me by a member of your Executive Committee, having pecuniary interests in the Company, who by your own rules is the ONE person absolutely forbidden to decide any such objection. (Rule XIV.)

Should my protest not be sustained by the local committee authorized to deliberate on same (after my having the opportunity of stating the grounds for my objections to the judge's decision in accordance with the Rule that "all interested parties have five days notice to attend the meeting of such Committee") it is my intention to appeal such adverse decision and place the complete facts before you, but until I bear from you as to the legality of the position taken by the Montreal Kennel Club Company, I contend that I am unable to proceed, having no authoritative decision to appeal from. Yours of Oct. 23rd I find on my return to the city. I am writing Mr. Innes in the matter, as members of the Executive of the Canadian Kennel Club, other than Mr. Thomas, were, I presume, available. You do not send me a copy of your protest, and I am assuming that this is a matter for future consideration. Immediately I hear from Mr. Innes I will write you again.

On same day we wrote Mr. J. R. Innes, Sec'y of the Montreal Kennel Club Co., enclosing copy of Mrs. Gyde's letter, also a copy of our reply. Following is Mr. Innes' reply, received Nov. 13th, also our reply of same date:

Montreal, Nov. 10th, 1911. Mr. H. B. Donovan,

Sec'y-Treas. Canadian Kennel Club, Toronto, Ont.

Dear Sir :

Replying to yours of November 6th, regarding the alleged protest from Mrs. Helen Gyde, Montreal. I think I can explain the whole matter to your satisfaction and that of your committee and very briefly.

First.—The Montreal Kennel Club Co., as Mrs. Gyde states, is a proprietary concern, as is also the largest show in the world, Cruft's Show, of England. I would point out to you that we claimed our dates in the regular way, paid the regulation show fee, and both were accepted by the Canadian Kennel Club, as they undoubtedly should be.

Second.—The protest referred to reads as follows:

"J. R. Innes, Esq., "Montreal Kennel Club Co.

"I beg to protest the decision of the Pomeranian judge in awarding the brace specials.

"Helen Gyde."

You will notice that this protest contains no specific charge, and as the Canadian Kennel Club Rules state distinctly that the judge's decision shall be final, the Committee, after advisement, decided that the protest was absolutely irregular and could not be entertained. This protest was accompanied by a fee of \$5.00, which the Montreal Kennel Club Company had several times endeavored to return to Mrs. Gyde.

Third.—As to Mrs. Gyde's reference to my letter of October 17th, it is there stated that the matter had been laid before Mr. Thomas, and that, after serious consideration, we felt that we must sustain the judge. And "we" therefore can suggest nothing else than the show committee, consisting of Mr. Thomas and myself. Mr. Thomas, in this delivery, was acting in his position as a member of the Show Committee, and not as a member of

the Canadian Kennel Club. If appeal was desired, at least one other member, possibly more, of the Executive of the Canadian Club was available.

Fourth.—Our reply to Mrs. Gyde's letter, in addition to the above, is that no regular protest was received, and at any time since the receipt of the \$5.00 deposit, we have been willing, and are willing now, to return same.

Perhaps it is only fair for me to say that it is my opinion that the Committee of the Canadian Kennel Club would not consider an indefinite protest of this kind, which, from its wording, gives no cause for protest. You were also privileged to appeal to any other member of the Executive, which, apparently, you did not do. I regret the whole circumstances but can only advise you that you permit me to have your deposit fee returned to you by Mr. Innes, or, if you prefer, the transaction can be passed through this office, relieving you of further communication with the Montreal Kennel Club Co. On Dec. 12th we received the following letter from Mrs. Gyde, dated Dec. 4th:

Dear Sir:

I am in receipt of your letter of the 13th Nov. I have been expecting to hear the result of the deliberations of the Executive Committee of your Club on the communication I addressed to them on the 23rd Oct. as your letter merely records your personal opinions of the matters in dispute.

I may mention that the mere fact of my protest not being worded in a technically correct manner seems but a poor excuse for denying an exhibitor fair play at the hands of your association, and might indeed be characterized as not being dignified.

I should also like to draw your attention to a grave discrepancy in the statements made by Mr. Innes in his letter to me of the 17th Oct., and the one he has addressed to you under date of the 10th Nov. In the former communication Mr. Innes states that the matter was "laid before" Thomas," and in the latter (in which he makes an attempt to explain the irregular proceedings indulged in by his company) he says that "the Committee after advisement," etc. It is evident that one of these statements is incorrect, and as the whole question I have submitted turns on this point, I shall be glad to have the ruling of your executive as to whether my protest was adjudicated upon in the manner, and according to the procedure laid down in your rules.

As intimated in my former letter, if this point is decided against me, I intend to protest the judge's award with respect to the "Special Brace prize."

I must ask you to lay the whole correspondence before your Executive Committee at their next meeting, and advise me of their decision at your early convenience. Yours truly,

Dogs competing for specials only must be entered in one of the regular classes in which they need not compete.

"In judging 'general specials' or specials of a similar nature, the competition shall be restricted to dogs that have won first in their respective winner's classes. In cases where a special prize has already been awarded for the best of a breed, only the winners of this special shall compete."

# BOSTON TERRIER CLUB SHOW.

The Boston Terrier Club Canada 4th annual specialty show, held in St. Andrew's Hall, Toronto, on Monday, January 1st, 1912, proved a huge success and only urged the ardent working members on to a determination to surpass each preceding show. 124 entries were recorded and 51 dogs were actually benched. The quality in general was a big improvement over any previous show held in Canada. The Buffalo contingent came over strong, including Mr. J. E. Carroll, Mr. E. J. Bernhard, Mr. and Mrs. K. C. Spencer, Mr. W. W. Silvey and Mr. John Schreck, who handled Mr. Bernhard's dogs. Another familiar face, who looked over the exhibit with intense interest, was Mr. Frank Dole, the well known Eastern

Mr. A. E. Quaife, of Palmyra, N.Y., officiated as judge, and with the dissensions usually seen at shows, gave general satisfaction. The following is a review of the awards:

Junior puppy dog s — 1, Innis Arden's Kid's Boy, a nicely marked mahogany brindle, a bit coarse; 2 Clifton Rex, very dark with half white head, easily beat Coronation Tip; 3 nicely marked, a good headed puppy of the old type, but extremely long in tail.

Senior puppy dogs—1, Clifton Rex, previously mentioned; 2, Bungo; 3, Marcus, outclassed here.

Green dogs-1, Bob R., an extremely trappy little dog, good color, very cobby body, best of feet, legs and tail, good skull, but lacks in muzzle, almost a fiver; 2. Innis Arden's Kid's Boy; 3, Coronation Tip. Novice dogs, 12 to 17 lbs., 1, Glencoe, a rich seal brindle, well marked, a nice little dog, shown very thin, slightly long in body, a nice head, with a good eye and tail; 2, Bob R .: - 3, Coronation Tip. Limit dogs, 12 to 17 lbs., 1 Glencoe; 2 Yankee Doodle Due, an enterely different type, more in the bully order; 3, Klinker II., a fair little dog with a bad tail; we could not see why Ted Shongo was unplaced here, excepting that the judge may have mistaken him for Bob R., similar in color and previously handled by the same party. Open dogs, 12 to 17 fbs., 1 Wampagne Prince, the

importation, owned by Mr. Knapp, of Haileybury, Ont. This dog has done well in the east. He is very small, rich brindle, nicely marked, poor in expression, carries a gay tail and did not show well; 2, Glencoe; 3, Yankee Doodle Due. Novice dogs, 17 to 22 lbs., 1 Dallin's Pal, a big dog, apparently shown out of his class, was easily the best; 2 Bell Rock's Jimmy Boy, a nicely marked, good colored dog, losing to the winner in muzzle and general conformation: 3 Marcus. Limit dogs, 17 to 22 lbs., 1 and 2 a repeat of previous class; 3, Lord Roberts II., a little too much on the coarse side, too bully. Open dogs a repeat. Novice dogs, 22 to 28 lbs., 1 Sam Shongo, a nice sort, very clean for one of his weight, good color and tail, half white head; 2, Peach's Surprise, not so well proportioned as the winner, good color and markings. Limit dogs, 22 to 28 fbs., 1, Revilo Jack, well marked, good color and tall, coarse in cheek and shoulder, cropping might make big improvement, was lucky to beat Sam Shongo, 2; 3 Peach's Surprise, which had to step to beat Crackers. Open dogs a repeat. Winners dogs, 1, Wampagne Prince; reserve, Glencoe. Junior puppy bitches, 1, Shongo's Pride, a nice puppy, well marked, beautiful color, excellent head, good tail, rightly placed; 2, Oxonian's If, a black pup, half white head, trifle long in body, losing to winner in muzzle and general make-up; 3, Lady Betty, a pleasing specimen, good color and markings, somewhat timid. Senior puppy bitches: 1 Shongo's Pride; 2, Beautiful Beauty, good dark brindle, handicapped with half white head, easily outclassed by the winner. Green bitches, 1, Beautiful Beauty; 1, Jean Shongo, who could easily have changed places with the winner, a good brindle, evenly marked, a trifle light in muzzle but very even from end to end; 3, Innis Arden's Kid's Girl, a rich brindle, evenly marked, rightly placed. # THE POOR PARIAH.

BY GEORGE CECIL, LONDON, ENGLAND.

The Pariah Dog is to be found in every country east of Port Said; he slinks about the Egyptian and Arab villages; globe-trotters who have visited Constantinople carry away memories of the dejected-looking creature, and he is not unknown in the Straits Settlements. But India, if not his happy hunting-ground, is his home; though he does not exactly flourish in the "shiney," he certainly abounds there. With the fecundity - not to say, the foolishness - of their kind, pariahs make themselves responsible for infinitely larger families than they can support, the fatal result being that every bazaar, from Cape Comerin to the Afghan frontier, is overrun with the poor, half-starved beasts, many of whom - with their scarred bodies and horrid sores - present a truly hideous sight. And the thinness of the wretched, neglected brutes is almost beyond description; so clearly can the ribs be seen, that the creatutes' ill-kept bodies almost seem to be transparent. Maimed and halting, they pass their days more or less miserably; and unkind nature adds to the hardness of the pariah's unhappy lot by decreeing that he shall live the full complement of his days.

THE BRUTAL NATIVE.

Next to the Chinese, the natives of India probably are the cruellest people on the face of the earth. Outwardly pious, they refrain from taking the life of an animal that, according to their peculiar code of religious ethics. is sinful. The exceedingly adaptable Mahometan and Hindoo religion, however, permits them to ill-use beasts who cannot retaliate. "gharri-wallah" (cab-driver) wantonly beats his tired, underfed horses, taking no heed of sore backs and lameness; the cart-man twists the tails of his patient bullocks, and when the exhausted "bail" sinks to the ground, with a fiendish refinement of cruelty, to force the unhappy animal to rise, he lights a fire beneath it. Under these circumstances, the reader will not be surprised to learn that the pariah is the special object of the black brute's devilish attentions. Should the poor beast, not hearing the native coming, fail to get out of his way, a blow from a "lathi" (brass-headed club), or a series of kicks from the nail-studded ammunition boots which the bully proudly sports, conveys the intended hint. Nor is this all, for the colored driver of a vehicle thinks nothing of

wilfully driving over a dog which is in the way - indeed, he will even make a detour in the hope of being able to gratify his lust for cruelty. Although "torture — but slay not" appears to be the native's creed, when at certain periods during the "hot weather" dogs are supposed to be mad, the po-

lice authoraties are ordered to exterminate all the pariahs in the place. Mahomet Buksh and Ram all are in their element. For, armed with the before-mentioned murderous clubs, they join the rag tag and bob-tail of "bazaar" ruffians, and spend many a savage hour laying about them with might and main, in many cases purposely refraining from dealing the quietus to the poor "kutta," in order that it may crawl under cover to linger a few days before eventually succumbing to its wounds.

#### TEACHING THE YOUNG IDEA.

The ill-treatment of the pariah is not confined to adults: even the native children are encouraged to torment the poor scavengers of the "bazaar" as they painfully hobble about in the hope of lighting upon some morsel of food at which the lowest caste black man would turn up his nose. As soon as the pot-bellied atom of inhumanity can crawl, it is allowed to stalk the cowed pariah and to bury its puny fist in the wretched animal's lean sides. In fact, from his earliest years little Ibrahim is imbued with the idea that

the pariah has been specially created to be the object of his persecution. Consequently, long before he has reached his teens, he is an adept in making the poor brute's life a burden to it. A European parent chastises the child who is cruel to animals: the native beats the pariah who resents being bullied by the fiendish brat.

#### AN EXCEPTION TO THE RULE.

Despite the horrible life lead by the ill-starred, mangev pariah, one occasionally comes across a tyke who has fallen into good hands. Kind hearted soldiers adopt him, and if a well-to-do native requires a dog who, by barking. will notify the presence of burglars at night, he promptly "puckcroes" (annexes; the first animal he sees, and feeds it into a state of ferocity. Such gratifying exceptions, however, are rare. For every sleek, happy, wellcared-for pariah there are a thousand who, eaten up wieh disease and three parts starved, lead the most wretched existence. Daily bufferred from pillar to post, if the nine-hundred-and-ninety nine are capable of thinking with human intelligence they must lament the day they were pupped—and the cruel conditions which withhold from them the means of committing suicide.

#### A MONGREL LINEAGE.

The pariah, alas! is a mongrel of mongrels. Dashed with Fox Terrier or Bull Terrier, there are points about him which suggest the Tibetan sheepdog, the Irish Terrier, the Rampur hound, the imported Mastiff and the Jackal. But whatever breeds may be represented by this mixed blood, the animal usually is long of leg and short in the body; and whether the ears suggest the Terrier or the Hound, they invariably flap dejectedly.

#### EXPERT ADVICE.

Mr. F. T. Barton, M.R.C.V.S., (author of "Every-day Ailments and Accidents to the Dog," "Sporting and Non-Sporting Dogs," "The Dog," "The Retatever," etc., etc.) writes as follows:—

#### WEANING.

"Begin weaning puppies and kittens a few days after the youngsters are thirty-three days old, using Lactol from this time until they have turned three months. It is an erroneous, though nevertheless a popular idea, that the weaning process is attended with a lot of trouble, and so it may be if attention is not paid to certain minor details. Begin by offering the suckers a small quantity of Lactol twice dailynight and morning,-freshly prepared, and place it in a very shallow, flatbottomed tin, which they will probably wade in to begin with. The bitch will, however, lick all this away from them. During the first three or four lessons much headway will not be made; but after this they will begin to lap, and the lapping of Lactol affords such a degree of pleasure to them that they will be adepts in the art by the time they are six weeks old. Up to this period they should be fed on Lactol four times per day, viz., at 8 a.m., 12 noon, 4 p.m., and 8 p.m., or briefly put, at eight, twelve, four and eight. With liberal feeding on Lactol at the hours indicated, the youngsters ought to grow like cucumbers, and have neither rickets, worms, nor rheumatism,-all of which are the outcome of improper feeding, neglect or hous ing in damp quarters."
