CONSTITUTION AND RULES OF ENTRY.

THE CANADIAN KENNEL CLUB.

APPLICATION FOR INCORPORATION.

WE, THE UNDERSIGNED, hereby make application for incorporation as an Association or Club under the Live Stock Pedigree Act.

THE NAME of the Association is to be:

"THE CANADIAN KENNEL CLUB."

THE OBJECTS for which the Association is to be formed are:

- (1) To keep a record of the pedigrees of Dogs;
- (2) To collect, preserve and publish data, information and documents relating to Dogs;
- (3) To encourage the breeding of pure bred dogs in Canada and to protect the interests of owners and breeders, to make grants to dog shows and field trials and competitions, and in such other ways as it may seem fit, encourage, guide and advance the welfare of dogs and their owners.

The Constitution and By-laws of the Club are as follows:

Name.

1. The Club shall be "The CANADIAN KENNEL CLUB."

Objects.

2. The objects of the Club shall be:
 - (1) To keep a record of the pedigrees of Dogs;
 - (2) To collect, preserve and publish data, information and documents relating to Dogs;
 - (3) To encourage the breeding of pure bred dogs in Canada and to protect the interests of owners and breeders, to make grants to dog shows and field trials and competitions, and in such other ways as it may seem fit, encourage, guide and advance the welfare of dogs and their owners.

Members.

3. (a) Members shall be those persons, resident in Canada, who pay an annual membership fee of \$3.00 on or before the first day of January of each year, in advance.

(b) Application for membership shall be made in writing to the Secretary, accompanied by the requisite fee, who shall then submit the same to the next ensuing meeting of the Executive Committee to be voted upon. Voting shall be by ballot. Two-thirds of the votes of the members present must be in favor of the applicant before he can be elected.

(c) All partners of a kennel must be separately members of the Club in order that the kennel may be recognized and have the privileges of membership.

(d) All members shall as a matter of contract and except as hereinafter provided enjoy the same rights and privileges and be subject to the same liabilities as if each had signed the application for incorporation of this Club, or this Constitution as amended from time to time.

(e) No member who is in arrears for membership or other dues shall enjoy such rights and privileges.

(f) The liability of each member shall be limited to the amount of membership or other fees or dues which he may owe to the Club.

(g) Any member may, provided he is not in arrears for membership or other fees or dues, at any time withdraw from and terminate his membership in the Club by giving the Accountant of the National Live Stock Records three months' notice in writing of his intention so to do.

(h) If any member shall be in arrears for membership or other fees or dues for a period of three years, the Board of Directors may terminate his membership in the Club by resolution, a notice of which shall be mailed to him at his last known post-office address as on record in the books of the Club, but any member whose membership is so terminated, shall not again become a member unless arrears owing at time membership was terminated, are paid.

(i) Each member of the Club shall receive, free of charge, publications which are issued during each year of his membership, for which he has paid the membership fee.

(j) No member shall hold office or be entitled to vote at a meeting if at the time in arrears for membership fees.

KENNEL AND BENCH

(k) The Directors shall have full power by a vote of those present at any of its meetings to suspend, disqualify or expel for improper conduct any person, whether a member of the Club or not, and the person so suspended, disqualified or expelled, shall have no claim against the Club, or be allowed to enter into any competition held under the rules of this Club. Such person shall have the right to appeal to the Club from the action of the Directors at the annual meeting, or any special meeting, provided notice of appeal has been given to the Directors. Suspension, disqualification or expulsion shall be either for a definite period, or for life; and the person thus suspended, disqualified or expelled shall be reinstated only on application to the Directors.

(l) Anyone having personal knowledge of the facts, may prefer charges of improper conduct against any individual. The person making such charges must send them in writing to the Secretary-Treasurer of the Club. The charges thus forwarded must be accompanied by a deposit of \$5.00, as a guarantee of good faith, for each charge preferred, which shall be retained should the charges be deemed on investigation to be frivolous or malicious. In the case of non-members, a fee of \$1.00 shall be charged for investigation.

(m) Any person suspended, disqualified or expelled in accordance with the provisions of Section (k) of this by-law, shall be debarred from all privileges of the Club, including registration.

(n) Any person expelled from membership by any other Association incorporated under the Live Stock Pedigree Act, shall be ineligible for membership in this Club and if he is a member at the time of such expulsion, his membership shall thereupon forthwith terminate automatically, subject to appeal to the Club.

Offices.

4. The Head Office of the Club shall be at Toronto and the Office for the registration of pedigrees shall be the office of the National Live Stock Records, in the City of Ottawa, Ontario, under the supervision of the Record Committee of the National Live Stock Record Board.

Fiscal Year.

5. The fiscal year of the Club shall correspond with the calendar year.

Officers.

6. The officers of the Club shall be a President, a First and a Second Vice-President, and one Vice-President for each Province, and Secretary-Treasurer, all of whom, with the exception of the Secretary-Treasurer, shall be annually elected as hereinafter set forth, and shall hold office for one year or until their successors shall be elected.

(2) The Board of Directors shall consist of the officers named (except Secretary and Treasurer) and twenty-two other members, elected at the same time and in the same manner, of which two members who are residents in such Province, shall be elected as representatives for each of the Provinces of Manitoba, Saskatchewan, Alberta and British Columbia. It shall convene in September during the time of the Dog Show held in connection with the Canadian National Exposition, and in January, April and June, at such time and place as shall be nominated by the Board of Directors, and as often besides as may be deemed necessary at the call of the President, or the written request of six members of the Board of Directors.

(3) The Board of Directors shall exercise a general supervision over all the activities and affairs of the Club, and shall have, in addition to the powers specifically granted herein, full authority to take any action which in their opinion is advisable or necessary in order to carry out the objects set out in By-law 2, Sec. (3) of this constitution.

(4) All candidates for office must be nominated by a member in good standing. Nominations shall be made in writing and sent addressed to the Secretary to be in his hands 30 days before the Annual Meeting.

When nominations are closed, a ballot slip, showing the nomination for officers and Board of Directors, shall be sent by registered mail to each member with instructions to return same to the Secretary. All ballots must be mailed to members at least twenty-one days before the Annual Meeting.

All ballots must be sent to the Secretary, and be in his hands before 12 o'clock noon the day of the Annual Meeting.

Ballots shall be returned in a specially printed envelope, marked "Ballot," to be supplied by the Club, and shall be counted at the Annual Meeting, and result of elections announced.

All ballots must bear the initials of the Secretary-Treasurer.

In case of a tie vote, the tie shall be decided by a majority vote of the members present at the Annual Meeting.

(5) The Board of Directors shall have power to fill vacancies for the unexpired terms.

(6) An Honorary Solicitor, Honorary Veterinary Surgeon and Auditors shall be elected at the annual meeting without previous nomination.

(7) The President shall order all meetings of the Club and Board of Directors, except as hereinbefore provided, and when possible preside at the same. He shall see that the affairs of the Club are managed according to the terms and spirit of the Constitution, By-laws and Rules; and shall at the annual meeting report on the working of the Club during the past year.

(8) The First Vice-President, or one of the other Vice-Presidents, shall perform all the duties of the President in his absence.

(9) The Secretary-Treasurer shall keep the Minutes of all meetings of the Club and the Board of Directors, conduct the correspondence and have charge of and be responsible for all the books and papers of the Club, collect all fees, and deposit same in a chartered bank to the credit of The Canadian Kennel Club, or forward the same to the Accountant, National Live Stock Association, as hereinafter provided. He shall submit a report of the general financial standing of the Club at each ordinary meeting of the Board of Directors.

The Secretary-Treasurer shall submit at each annual meeting a financial report, up to the 31st of December of that year, which report shall be duly audited and certified to be correct. He shall also submit at the same time a report of the general condition of the Club.

He shall keep a record of the names and addresses of all members of the Club. He shall furnish a Guarantee Company's bond to an amount satisfactory to the Board of Directors, at the expense of the Club. His remuneration shall be fixed and determined upon by the Board of Directors.

(10) All accounts shall be submitted to the President or his duly authorized representative by the Secretary-Treasurer for inspection and approval,

and shall be paid by cheque signed by the Secretary-Treasurer and countersigned by the President or his duly authorized representative, and a complete report thereof shall be submitted to the next meeting of the Directorate.

(11) The National Live Stock Record Committee shall assign to this Club a person to act as Registrar, and fix his remuneration at such reasonable sum as may be proportionate with that of Registrars acting for other Associations in affiliation with the Canadian National Live Stock Records.

The duties of the Registrar shall be: To keep the Pedigree Register of the Club, to enter therein all pedigrees and transfers in such form as may be determined upon, to sign all certificates of registration and keep a record of the same and to perform any other duties or work in connection with this Club as may be directed by the said Record Committee.

Pedigree Committee.

(12) The President, Secretary-Treasurer and the Registrar shall be a Committee whose duties shall be to adjudicate all questions of eligibility of animals for registration. Their decision if unanimous shall be final, otherwise the question shall be submitted to the Directors for decision. Each decision of the Committee shall be reported to the Directors at the next meeting thereafter.

Examining Committee.

(13) The Directors may from time to time as occasion may require, appoint two members of the Club who shall during the time for which they are so appointed be an Examining Committee who shall examine and report on all imported animals for the registration of which application is made.

Auditor.

(14) The Club at each General Annual Meeting shall appoint an Auditor and fix his remuneration. His duties shall be to examine the books of account of the Club, vouchers for all payments and present the usual Report thereon to the next General Annual Meeting, accompanying his Report with a detailed statement of assets and liabilities and receipts and expenditures for the year.

Representatives.

(15) Delegates to the National Live Stock Record Board shall be appointed by the Directors.

Meetings.

7 (1) The Annual Meeting shall be held in February of each year.

(2) At the written request of twenty members, the President shall call a special meeting of the Club. Twenty shall be a quorum at a general or special meeting.

(3) Notice of all general meetings shall be given in the official organ of the Club, or by special notice to each member, published or posted at least twenty-one days before date of such meeting. At least ten full days' notice shall be given by mail to each member of the Board of Directors.

Expenses, Income and Property.

8. The income and property of the Club, from whatever source derived, shall be applied solely toward the promotion and furtherance of the objects of the Club and no part thereof shall be paid or transferred directly or indirectly by way of bonus or otherwise as profit or gain to members past, present or future of the Club or to any person claiming through any member; provided, however, that nothing herein contained shall prevent the bona fide payment of remuneration, to any Secretary, Treasurer, Registrar, Editor, Officer, Clerk, Servant or other person or persons for services actually rendered the Club whether such are members of the Club or not; and the expenses of the Directors or other officers incurred in doing the business of the Club.

Amendments.

9. The Constitution and By-laws of this Club may be amended at any general or annual meeting of the Club, provided notice of the proposed change is given in the official organ of the Club, or by special notice to each member, published or posted at least twenty-one days before the date of such meeting, and provided also that two-thirds of the members present at the meeting in person vote in favor of the amendment, and no amendments shall be valid until approved by the Minister of Agriculture for Canada and filed at the Dominion Department of Agriculture.

Registration and Membership Fees.

10. (1) All membership and registration fees shall be paid in cash to the Accountant, National Live Stock Records, and shall forthwith be deposited by him to the credit of this Club in a chartered bank arranged with

by the Record Committee of the National Live Stock Record Board.

(2) In case membership fees to the Club are received by the Secretary-Treasurer of this Club they shall be immediately forwarded to the Accountant, National Live Stock Records, Ottawa, for such deposit.

Corporate Seal.

11. The Seal as stamped in the margin hereof shall be the Corporate Seal of the Club.

Registration of Pedigrees.

12. (1) A Register shall be kept at the office of the National Live Stock Records. This Register, to be known as the Canadian Kennel Club Stud Book, shall contain a copy of the Constitution and may be examined by any member on demand on any business day during business hours.

(2) There shall be delivered to every person recording an animal a certificate of registration in such form as may be decided by the Directors.

(3) All certificates of registration shall be submitted for the approval of the officer appointed for that purpose by the Minister of Agriculture, and shall not be issued until so approved.

(4) Stud Books shall be published at such time and in such form as decided by the Directors.

(5) Any person expelled from membership shall not be allowed the privilege of recording pedigrees on the Books of the Club.

(6) Any member in arrears of membership fees shall not be allowed the privilege of recording pedigrees on the Books of the Club at non-members rates.

(7) Any member prohibited from recording pedigrees by any other Association incorporated under the Live Stock Pedigree Act shall not be allowed to record pedigrees in The Canadian Kennel Club Stud Book.

(8) The Club may allow the prefix "Champion" to be recorded and used in the Stud Book Record and Pedigree Certificate of any dog which has become entitled to the use thereof by winning at the bench shows authorized by the Club and held and conducted in accordance with such rules and regulations as may be handed down from time to time in that behalf by the Club, such number of points or such prizes as according to such rules and regulations entitle it to the use of such prefix.

Rules of Entry.

13. The following Breeds may be admitted to registry on application and payment of the requisite fee, and the following information duly authenticated:

Such applications must be made on the form supplied.

That the Live Stock Records Board be instructed to accept for registration all dogs with a pedigree of three generations, when approved form of application is properly filled in, giving the name and address of the breeder of the sire and name and address of the breeder of dam.

A dog already registered in the English Kennel Club Stud Book may be registered with only two generations of pedigree, provided the application is otherwise complete and the applicant submits the registration certificate from the English Kennel Club.

(2) No dog which is already registered in the English Kennel Club or American Kennel Club Stud Book shall be registered in the Canadian Kennel Club Stud Book under any other name than that under which it is already so registered.

(3) That registration of litters be required within 60 days of the date of birth, giving the number in litter, num-

ber of each sex, also the certification of the owner of the sire, the whole certified by the owner of the bitch at the time of birth, providing the litter is registered within 60 days of birth. This registration will be free of charge, but after 60 days a fee of \$2.00 be charged for such registration.

(4) The registered name of any dog may be changed on payment of a fee of \$5.00, subject to Sec. (2). Providing that if the application for change is received during the fiscal year of the Canadian Kennel Club in which the original registration was made, the fee shall be reduced to \$2.00.

Fees and Privileges of Membership.

14. The following fees shall be charged:

(1) Annual membership fee \$3.00, payable in advance.

(2) (a) Cost of registration \$1.00 each. One free each year to each member.

(b) Cost of listing, 25c each show.

(c) Fee for search of pedigree, 25c.

(d) Copy of pedigree, 50c.

(e) Transfer of registration, 25c.

(f) Registration of prefix, affix, and kennel name, \$3.00. Annual renewal of same, 50c.

(g) Transfer of prefix, affix and kennel name, \$3.00.

(h) Duplicate of certificate, 25c.

(i) Certificate for kennel license, 25c.

(j) Any other certificate or search, 50c.

(k) Exchange of C. K. C. certificate for Canadian National certificate, \$1.00.

The above fees (2) are for members in good standing only. To non-members they will be double in every case.

(3) A fee of \$1.00 to cover average cost is charged for the investigation of each complaint not arising out of misconduct of shows, held under Canadian Kennel Club Rules. No charge is made to members.

(4) Failure to renew prefix or kennel name shall involve the cancellation of the registration of same, but no prefix or kennel name so cancelled shall be re-registered until after the expiration of ten years from the date of such cancellation. At any time during the said period of ten years the person or persons in whose name or names the registration stood at the time of cancellation may re-register the said prefix or kennel name on payment of all arrears of renewal fees.

(5) The Annual Stud Book shall be supplied free to members.

Breeders and dog lovers when buying that new dog, be sure that if it is registered, that it is transferred in your name before the next show you are showing at, as there is a fine of \$1.00 imposed in the Canadian Kennel Club Rules and Regulations, VI., "When the name of the exhibitor differs from that under which it was registered." Also, when making your entries, be sure that you enter correctly in every detail.

COMING EVENTS

Record Entry for the Toronto Exhibition Dog Show

Through the courtesy of the superintendent, Mr. F. W. Jacobi, we are able to give our readers a little advance news regarding Canada's premier dog show. This year's event will be bigger and better than ever; entries have simply rolled in from all parts of Canada and the States and at the time of writing it was expected they would reach the 700-mark, so a 5-point show is practically assured. There is a very noticeable increase in the number of entries from the States, which in itself is evidence that the American dog breeders are beginning to realize that the Toronto show is of some international importance, besides stimulating friendly competition for canine honors between the two countries. Many of the leading kennels will be represented and, as usual, we shall be favored with a visit from the noted handlers, Ben Lewis and Alf Delmont, who are bringing up their respective "strings" of well-known dogs. Never before has there been such an entry of Canadian talent brought together, the Montreal "stars" will be in competition against the good ones from as far west as Winnipeg. Fanciers from near and far realize the importance of a win at this classic event and have entered their best home-breds to compete with the many that have been imported. There is an extra large entry in Cocker Spaniels and Bulldogs, Boston Terriers and Airedales are well represented. There is also a nice collection of Fox Terriers. Foxhounds and Setters, Russian Wolfhounds are the largest section in the big breeds. This year's entry shows an increase in the Toy classes, particularly the Poms and Pekes, which are exceptionally strong. There is little wonder at this event drawing a record entry when we consider the inducements offered by the management, who are alive to the requirements of the present-day exhibitors. Judging will commence promptly on Monday afternoon, Sept. 3rd, at 1 o'clock. W. H. Whittem, Esq., will commence with Airedales in Ring 1; C. H. Mower, Esq., will judge Boston Terriers at the same time in Ring 2, and the all-rounded, Dr. G. W. Clayton, will commence his task in Ring 3 (upstairs) with the Bedlington and will continue with the smaller varieties. In the evening at 7 o'clock A. C. Wilmerding, Esq., will commence

judging Spaniels in Ring 1, and Col. R. McEwan will make a start in Ring 2 with Collies.

On Tuesday morning at 9 o'clock Dr. Clayton will open up with Bull Terriers in Ring 1, afterwards commencing in catalogue order, while the other judges will adjudicate their unfinished classes. The superintendent, who is a past-master in the arrangement of dog shows, promises to have the various breeds judged on schedule so that exhibitors will know just what time their breeds will be given the "once over," but it must be understood that unforeseen circumstances are liable to arise and prevent such arrangements being carried out.

BOSTON TERRIER CLUB'S SUCCESSFUL MEETING.

That enterprising organization, the Boston Terrier Club of Canada held a meeting in Toronto on Aug. 8th for the purpose of electing a new president and vice-president. The retiring president, Mr. T. DISTEMPER AND ITS MANY PHASES—by J. A. Campbell, V. S.

(Continued).

No disease of animals has a greater assortment of remedies and cures than canine distemper. The treatments vary in the same proportion, anything from painting the nose with tar to administering powdered glass internally, every known drug has been tried. It is an ailment that offers a great opportunity of exploiting the wonderful curative effects of certain medicines. Distemper is considered by many to be the only disease a dog is subject to, no matter whether he has canker of the mouth or constipation, in many cases the trouble is always diagnosed as distemper. While the inexperienced owner may consider every ailment of the dog to be distemper, the experienced breeder and exhibitor is very apt to persuade himself, and sometimes others, too, when his dog has distemper to treat the matter lightly by saying, "Oh, he has a slight cold, he got wet the other night."

When a dog is off his feed and feeling out of sorts the owner seeing that he is sick, at once thinks his dog is suffering from the dreaded disease distemper; immediately gets a bottle of Dr. Dogman's Distemper Disperses. In a day or so the dog is quite well again, resulting in a great confidence being placed in Dogman's medicine, and in all probability an unsolicited testimonial is given.

Another fancier may use a distemper remedy on some seasoned animal that has mattery eyes and nose only, following the natural course these conditions soon dry up, with the result that the owner's implicit belief is in

the remedy as a positive cure for distemper, telling his doggy friends, "Got better in a few days, never went off their feed, etc."

Nevertheless, there are a number of medicines on the market that assist greatly in affecting a cure in many forms of distemper, but there is no remedy that is specific for the disease. Owing to the fact that although in the early stages it is a comparatively simple trouble and may remain so if the dog's power of resistance is strong enough to cope with it, but there are so many variations and complications usually succeeding. For instance, the pneumonia, the bowel and nervous forms. Such cases require individual treatment.

It is well to bear in mind in commencing the treatment that the dog is suffering from the germs that have gained an entrance into the system, and it is the presence of these germs and the poison generated by them that give rise to the sickness. The most natural way to treat an animal whose body has become invaded with disease-producing germs is to give that body every assistance to attack and overcome the infection, so everything should be done to have it placed in an environment which would be of assistance in keeping its strength and condition. Great care should be taken not to lower its strength by the giving of strong and objectionable drugs, which in the majority of cases has to be given after considerable struggling on the part of the dog. Not only is the actual administering of the medicine depressing to a dog, but those of a liquid nature are very apt to go down the wrong way and set up a mechanical bronchitis or pneumonia, aiding considerably to advance the progress of the invading germs, besides aggravating the cough, that is so frequently a symptom of distemper.

There is with most people an inherent belief in the charm of medicine for curing a disease, which leads them to depend solely on the use of a drug to cure the particular disease for which it is used, regardless of the greater benefit which is to be derived from systematic handling, good nursing, and feeding with a proper diet. This applies particularly to distemper, An-

other thing, better results have been obtained by a dog being cared for and treated by someone that it knows rather than by a stranger. Many people have great success with treating distemper, the secret being they are good nurses and gifted with patience, when it becomes a question of nursing versus dosing, nursing wins out every time.

Hints on Feeding (Puppies).

The ultimate welfare of dogs depends largely on their feeding and treatment as puppies, so the best food by far is the cheapest in the end, and it pays to give the best possible care. If it is worth while breeding dogs at all, it is worth while breeding the best one possibly can of their kind, and so feeding and caring for them that each attain to its full and perfect development and has at maturity the physique, health and qualities one would desire it to possess. When puppies are weaned it must be remembered that the mother's milk is far stronger and richer than cow's milk. A puppy's digestive organs are small, being adapted to the digestion of bitch's milk, and become deranged if fed on anything of a weaker nature, so it is easily understood that by feeding with less nutritious food the pups will have in consequence to eat several times the amount of his natural food to get an equal amount of nourishment.

This is the cause of so much mortality amongst puppies as it leads to over-distended stomachs, indigestion and diarrhoea. The kidneys also often get deranged owing to the extra work thrown upon them. All these troubles may be avoided by judicious feeding and care. Puppies require concentrated food, and to keep them healthy and in the best condition meat should form half their diet. The instinctive craving of puppies for this is prompted by a natural need for it as food. Commence first by teaching them to lap a little milk (boiled). This should be done when the pups are about three or four weeks old. Little and often should be your motto at this period.

When their stomachs are accustomed to this, mix in the milk a little stale brown bread or biscuits. A little later mix the bread with soup or gravy. Then meat should be gradually, not suddenly, introduced into their diet. At five or six weeks old puppies should be given small quantities of scraped, raw, lean meat, about a teaspoonful each day. Of course, the quantity must be varied according to size and breed. As they get older and stronger every alternate meal should be meat either raw or cooked. At four months old the meals can be reduced to three each day,

say, bread and milk in the morning, scraped raw meat at noon, and for the evening meal puppy biscuits soaked in gravy or soup. A large bone or dog biscuit should be given them occasionally, as it helps them during teething.

In the large breeds, where size and bulk are required, more meat should be given, and those who have a plentiful supply of eggs, will find that raw eggs, although costly, will help to increase growth. Starchy foods fill rather than feed them, and are not even a wholesome filling. Viewed from this standpoint one ceases to wonder that puppies fed mainly on sloppy foods suffer so much from indigestion, etc. Supply only just as much food as is eaten up eagerly. There should never be any thing left in the dishes. If there is it should be removed at once. Keeping food before them all the time will not induce them to eat any more. Feeding puppies together without any supervision may suit the two or three strongest, but the weaklings usually have to put up with so much, or so little, food as their more vigorous brothers cannot find room for. Give the little ones a proper chance to eat in peace or they are likely to grow up leavings themselves if they get nothing but leavings to eat.

If scrupulous cleanliness be ever important, it is so in the feeding of the young puppies, as milk foods soon decompose. Not only must the food be perfectly sweet, but the dishes should be quite clean also. Always mix the food fresh for each meal. If owners only realized the importance of keeping puppies growing all the time there would be more profit and less "bad luck" in the kennel business. A stunted pup may afterwards be made fat, but it never develops into a good and healthy animal. The very best system of economy to practise is that of keeping puppies growing all the time, the first year makes or mars them.

Feeding Toys.

The feeding of Toy dogs is one of the greatest cares to the owners. One of the questions our reader may ask is: How often should a Toy dog be fed? A light meal in the morning and a heavy one at night, and as near the same time each day as possible. Another question may be: What food is the most suitable? There is not much

difficulty in answering this as regards "suitability," but it becomes another matter when one considers the fastidiousness of the Toy or pet dog in relation to his viands. His palate is largely guided by the delicacies with which his master or mistress may supply him. However, be this as it may, there is what may be termed a rational food for Toy dogs.

Meat food and biscuits should be their staple diet, and the greatest possible variety should be given. Sheep's heads and hearts, well boiled, make excellent soup, into which can be mixed stale brown bread. Rice, well boiled, and mixed with gravy, is to be recommended at times. Fish is chiefly valuable as a change, its feeding properties not being very high, and a much greater quantity is needed than of meat. Table scraps are also very useful. All these foods should be minced or cut into small pieces. Raw eggs or cod liver oil will be found beneficial to the Toy that is run down in condition. All Toy dogs should be allowed bones to pick, selecting only the large-sized ones and those free from sharpness.

The periodical growing of a new coat is a very heavy tax upon long-coated dogs, and the quality and texture of the coat suffers when they are stinted in meat foods at such times. All dogs at this period need plenty of meat, out of which to grow the new coat and to keep up the strength of the body. No fixed rule can be formed for feeding Toy dogs. It is rather a matter of tact and judgment in adapting one's practice to the conditions obtaining in each case.

Feeding Sick Dogs.

In cases of serious illness of the dog nourishments may have to be given often and in small quantities. The life of the animal may depend upon care in this respect. Like human beings, they require a tempting, nourishing and easily digested food. Sometimes after a severe illness it is difficult to think of anything that can be offered to encourage the patient to eat. There is no doubt that a little food taken voluntarily does more good than a quantity poured down the throat against the dog's will. Avoid giving ice-cold foods. While the food should not be given too hot, the chill should be taken off, as where cold foods are given valuable

energy is wasted in warming up to blood heat in the body.

Milk diets are very useful, but are much better if raw eggs are beaten up in them. Finely-cut raw lean meat forms a valuable means of supporting weakly patients. Beef tea, Bovril, Virol, rabbit and chicken soup are very useful in cases where the dog is unable to eat. Beef essence is a preparation that dogs are very fond of and is an excellent diet for invalids when suffering from stomach disorders. Boiled arrowroot or corn-flour and milk, to which is added a teaspoonful of port wine, proves beneficial in the violent forms of diarrhoea. An egg beaten up with a teaspoonful of brandy or whiskey and given every two hours is an excellent form of nourishment.

Old dogs that are ill should be fed oftener than would be wise with those in middle life, small quantities of food being, of course, given at a meal. The older the dog the better care must be taken of him, for old blood is cold and runs slowly. When a dog is ill he should be removed from his kennel-mates if possible, whether his disease is contagious or not. In the former case the reason is obvious, but in all cases quietness and comfort is needed, and the patient can be better observed and symptoms more clearly noted. These few hints are not intended as an exhaustive treatise, but to give a few pointers on the feeding of invalids by a system of home treatment, and we trust it will be found useful to those who cannot obtain veterinary advice.

As a fact, the brimstone is as unchanged as a rock in the water, and is of no more value than a piece of stone there to improve the conditions of a dog's blood.

Mr. Bert Swann's old love for St. Bernards seems to be just as strong as ever. We hear of him purchasing the imported dog, David of Dufferin. This dog came from the old-time English expert, Mr. S. Jagger, and up to the present time has not been exhibited at our Canadian shows.

Our American friends are still "coming across the line" when they are in need of something good in canines. Amongst the many letters of appreciation that our fanciers receive we had the pleasure of seeing one the other day regarding a Bulldog that Mr. W. J.
