## A GENERAL MEETING

Of the Canadian Kennel Club will be held in the offices of the Club on May 8th, commencing at 8 p.m.

### Meeting of the Board of Directors of the C.K.C.

A meeting of the Board of Directors of the Canadian Kennel Club was held in the office of the Club, 774½ Yonge St., Toronto, April 18th, at 8 p.m., the president, Mr. Jos. Russell, in the chair. Other members present were Messrs. H. Clayton, C. W. Dickinson, P. Herd, F. W. Jacobi, John Kenyon, F. W. Lewis, T. E. Milburn, R. Scott Wilson, J. D. Strachan, N. K. Swire, G. Ward and D. Wheeler.

The minutes of the previous meeting were read by the secretary, and it was moved and seconded that they be approved as read.—Carried.

The secretary was instructed to publish in "*Kennel and Bench*" an itemized account of bills passed at each meeting.

The secretary read the replies received from the Live Stock Records, re Mr. Jos. Perkins case, and he was instructed to write to Mr. Perkins regarding same.

Mr. F. W. Davey having asked to have membership name changed from Mrs. Davey to Mr. Davey, the secretary reported that he found that Mr. F. W. Davey had been the original applicant for membership, but on the membership file cards this had been changed afterwards to Mrs. Davey. The secretary was instructed to find out how many registrations had been made in Mr. or Mrs. Davey's name and to write to the Live Stock Records and ask them to send us the original or copies of the applications for registrations made in each name.

Mr. P. Herd reported on the Mathews vs. Walker case. After consideration

the Board of Directors decided that the C. K. C. could do nothing in the matter.

It was moved and seconded that the following bills be paid:

## Constitution and By-laws of the Canadian Kennel Club

AS REVISED AND AMENDED AT THE ANNUAL MEETING HELD IN TORONTO ON FEBRUARY 6, 1918.

The Constitution and By-laws of the Club are as follows:

### 1.—Name.

The Club shall be "The Canadian Kennel Club."

### 2.—Objects.

The objects of the Club are as follows:

1. To keep a record of the pedigrees of pure-bred dogs and to publish a stud book record of the same.

2. To publish periodically an official organ devoted to the welfare of dogs and their owners.

3. To encourage and promote the breeding of pure-bred dogs in Canada.

4. To adopt and enforce rules regulating and governing dog shows and field trials.

5. To take action, not inconsistent with rules hereinafter set forth, to punish violations of all rules and regulations of the Club, by members of the Club or others, and to do such other things as the Club may see fit to encourage, guide and advance the welfare of dogs and their owners.

### 3.—Members.

1. There shall be two classes of members—

(a) Honorary members.

The Club at a general annual meeting may elect honorary members, but such honorary members shall take no part in the management of the Club's affairs, and their positions shall be purely honorary.

(b) Ordinary members.

Ordinary members shall be

(1) Those individual persons resident in Canada who pay an annual membership fee of \$3.00.

(2) Those kennels situated in Canada registered with this Club who pay an annual membership fee of \$3.00.

2. Membership fees in all cases are payable in advance and are due the first day of January each year.

Persons resident outside of Canada may become ordinary members on the approval of the Board of Directors.

Kennel memberships shall not entitle individual partners of a kennel to individual privileges, and each kennel membership shall only be allowed one vote at annual or other meetings.

A member in good standing is a mem-

ber who is not in arrears for membership or other fees or dues or suspended.

3. Application for membership shall be in writing on the form prescribed, and each applicant shall agree to be bound by the Constitution and amendments and all rules of the Club, but the Club shall have power to reject any application for membership.

Applications for kennel membership shall give the names of all partners, and specify the kennel partner authorized to vote, act or sign for the kennel.

4. All members shall as a matter of contract and except as hereinafter provided enjoy the same rights and privileges and be subject to the same liabilities as if each had signed the application for incorporation of this Club, or this Constitution as amended from time to time, but no member who is in arrears for membership or other fees or dues shall enjoy such rights and privileges.

5. The liability of each member shall be limited to the amount of membership or other fees or dues which he may owe to the Club.

6. Any member may, provided he is not in arrears for membership or other fees or dues, at any time withdraw from and terminate his membership in the Club by giving the Secretary of the Club or the Accountant of the Canadian National Live Stock Records three months' notice in writing of his intention so to do.

7. If any member is in arrears for membership or other fees or dues for a period of three years, his membership in the Club shall automatically cease, and any member whose membership is so terminated shall not again become a member unless arrears owing at time membership was so terminated, are paid.

8. Each member of the Club shall receive, free of charge, publications which are issued during each year of his membership, for which he has paid the membership fee.

9. No member shall hold office or be entitled to vote at a meeting if at the time in arrears for membership fees, and no member shall be entitled to vote who was not a member of the Club at

the time the notice was given calling such meeting.

10. The Directors shall have power to suspend or expel any person whether a member of the Club or not, who fails to observe any rule, regulations or by-laws of the Club, or whose conduct in their opinion is prejudicial to the interests of the Club, and the person so suspended or expelled shall have no claim against the Club or be allowed any of the privileges of the Club, including registration of pedigrees, or be allowed to enter into any competition held under the show rules of the Club. No person, however, shall be suspended or expelled until such person has first been notified of the alleged offence and has been given an opportunity to appear in person before the Board of Directors.

Such person shall have the right to appeal to the Club from the action of the Directors at an annual or general meeting, provided notice of appeal has been given in writing to the Directors, but reinstatement may only be made by the affirmative vote of two-thirds of the members thereof.

11. Any person expelled from membership or debarred from recording pedigrees by any other organization incorporated under the "Live Stock Pedigree Act" shall be ineligible for membership in this Club, and debarred the privileges of recording pedigrees, and if he is a member at the time of such expulsion, his membership in this Club shall thereupon forthwith terminate automatically.

### 4.—Affiliated Clubs.

Any specialty club or dog show organization having at least ten members in the Canadian Kennel Club in good standing may register the name of their organization with this Club for a fee of \$5.00. Each affiliated club shall, however, make a yearly return to the Secretary of this Club, proving its activities in the interest of the breed or breeds it represents, otherwise the affiliation shall automatically cease.

(b) National names such as "National," "Canadian," "Dominion," etc., shall not be registered as affiliated club names unless it is proven to the satisfaction of the Board of Directors



that the club applying is purely national in scope.

#### 5.—Offices.

The head office of the Club shall be in the city of Toronto, Ontario, and the office for the registration of pedigrees shall be the office of the Canadian National Live Stock Records, in the city of Ottawa, Ontario, under the supervision of the Record Committee of the Canadian National Live Stock Record Board.

#### 6.—Fiscal Year.

The fiscal year of the Club shall correspond with the calendar year.

#### 7.—Officers.

The affairs of the Club shall be conducted by a Board of Directors, consisting of the President, Vice-President, Second Vice-President and fifteen Directors, all of whom shall be elected as hereinafter mentioned and shall hold office until their successors are elected.

1. President.—The President shall be elected in each year, previously to the annual meeting of this Club by ballot of the members in good standing, on the 30th day of September preceding. Nominations for President shall be made in writing and shall be signed by at least two members in good standing, and shall be sent to the Secretary of this Club, so as to be received by him on or before the 15th day of November.

The President shall order all meetings of the Club and Board of Directors, except as hereinbefore provided, and when possible preside at the same. He shall see that the affairs of the Club are managed according to the terms and spirit of the Constitution, By-laws and Rules; and shall at the annual meeting report on the working of the Club during the past year.

2. Vice-President. — The Vice-President shall be elected in a like manner and at a like time to the election of the President.

In the absence of the President, the Vice-President shall perform his duties.

3. Second Vice-President.—The Second Vice-President shall be elected in a like manner and at a like time to the election of the President and Vice-President.

In the absence of the President and Vice-President, the Second Vice-President shall perform the duties of the President.

4. Directors.—Directors shall be elected in each year previously to the annual meeting of this Club, by ballot of

the members in each respective Province in the manner hereinafter mentioned, and shall hold office until after the close of the next annual meeting. Each Province of Canada, except the Provinces of New Brunswick, Nova Scotia and Prince Edward Island, which shall, for the purpose of this Club, be considered as one Province and be known as the Maritime Provinces shall be entitled to proportionate representation based on the relationship of its total membership.

Any Province, including New Brunswick, Nova Scotia and Prince Edward Island as one Province, having less than the unit of representation, shall be entitled to one Director.

For the year 1919 the Province of Alberta shall be entitled to one Director; the Province of British Columbia, two Directors; the Province of Manitoba, one Director; the Maritime Provinces, one Director; the Province of Saskatchewan, one Director; the Province of Ontario, seven Directors, and the Province of Quebec, two Directors; total, fifteen.

This representation shall stand for the years 1919 to 1923, both inclusive.

The following shall be the procedure in determining the number of Directors to which each Province is entitled. Add together the total number of members in each Province for the preceding five years and divide the total number in each Province by five. The number thus secured will be the average annual membership for that period, and this divided by sixty gives the number of Directors for that Province. Example: Suppose the total number of members in any Province for five years was nine hundred—this number divided by five gives the average yearly membership of one hundred and eighty. One hundred and eighty divided by sixty gives three. (Number of Directors, three).

The number of Directors to which each Province is entitled shall be adjusted at the end of each five-year period, based on the membership for the preceding five years, and any Province heretofore grouped as above having a sufficient number of members to make seventy-five per cent, of the then requisite unit, shall be detached from its group and considered a separate province.

In the year 1923 and at the end of each five-year period thereafter the

number of additional Directors to which each Province is entitled shall be adjusted based on the average annual membership for the preceding five years, except as herein provided for.

#### 8.—Elections.

A list of members in good standing as on the 30th of September in said year shall be published in the official organ.

Nominations for Directors allotted to each respective Province shall be made in writing and shall be signed by at least two members in good standing in the respective Provinces, and such nominations shall be sent to the Secretary of the Club so as to be received by him on or before the 15th day of November in the said year, on which date all nominations close.

When nominations are closed, a ballot slip, showing nominations for officers and Board of Directors, shall be sent by mail to each member, with instructions to return same to the Election Commissioner. All ballots must be mailed to members on or before the 30th day of November in said year.

All ballots must be sent by the voter to the Election Commissioner in a special envelope marked "Ballot", provided for this purpose, and must be in his hands on or before the 21st day of December.

A member in good standing in respect to voting or holding office is a member whose membership fee for the current year has been paid on or before the 30th day of September in the then current year.

Default, other than wilful default, by the Secretary of this Club in supplying a ballot paper to any member, or the non-receipt of such ballot paper by any member within the prescribed time, shall not invalidate an election held in the manner herein provided. Only those ballot papers bearing the seal of the Club and the initials of the Secretary, and which shall be received by the Commissioner, on or before the 21st day of December next, shall be counted. If a member votes for more than the number of candidates to which he is entitled to vote, this shall spoil his ballot.

The Election Commissioner shall forthwith after the last day for receiving ballot papers, open the same and proceed to count the votes, and he shall deliver to the President of the Club, his certificate sworn to before a notary



public declaring the result of the election, which shall be final and conclusive. In the case of an equality of votes the Election Commissioner shall have a casting vote.

The Election Commissioner shall seal the counted ballot papers in packages and deposit the same with the Secretary, who shall preserve the same until the first day of July following, after which date they shall be destroyed.

The Secretary shall notify by post, prepaid each person elected of his election and shall announce the results at the annual meeting.

The Board of Directors shall have the power to fill vacancies which may occur among the officers through resignations, death or otherwise.

Committees may be appointed by the Directors either from among themselves or the other members of the Club.

#### 9.—Secretary-Treasurer.

6. Secretary-Treasurer.—The Directors shall from time to time as occasion may require, appoint a Secretary-Treasurer, who shall have the power of managing-director, acting under the control and with the approval of the Board of Directors. His duties shall be to attend all meetings of the Club, of the Directors, and other committees, and to keep exact minutes of the proceedings of the same, to carry on all head office correspondence, to prepare all annual or other reports, to give notice of all meetings of the Club, of the Directors or other committees when so directed by the proper authority under the constitution, to receive moneys of the Club and the same to deposit in some chartered bank of Canada, or forward the same to the accountant, Canadian National Live Stock Records, as hereinafter provided, and to pay the same out again by cheque, countersigned by the President or his duly authorized representative, and to keep proper books of account containing entries of all such matters or things as are usually entered in books of account of similar organizations, to furnish from time to time such statements in detail of the affairs of the Club, or of such other matters as may be directed by the Directors, and generally to do such things and perform such duties as and when directed by the Directors.

He shall furnish a guarantee company's bond to an amount satisfactory to the Board of Directors, at the ex-

pense of the Club. His remuneration shall be fixed and determined upon by the Board of Directors.

All accounts shall be submitted to the Directors for inspection and approval.

#### 10.—Registrar.

Registrar.—The Record Committee of the Canadian National Live Stock Records shall assign to this Club a person to act as registrar, and fix his remuneration at such reasonable sum as may be proportionate with that of registrars acting for other organizations in affiliation with the Canadian National Live Stock Records.

The duties of the registrar shall be: To keep the pedigree register of the Club, to enter therein all pedigrees and transfers in such form as may be determined upon, to sign all certificates of registration and to keep a record of the same and to perform any other duties or work in connection with this Club as may be directed by the said Record Committee.

#### 11.—Pedigree Committee.

Pedigree Committee.—The President, the Secretary and the Registrar shall be a committee who shall have power to adjudicate all questions of transfer of ownership and eligibility of Canadian-bred animals for registration. Their decision shall not be inconsistent with the rules of eligibility and if unanimous shall be final, otherwise the question shall be submitted to the Board of Directors for decision. Each decision of the committee shall be reported to the Directors at the next meeting thereafter.

#### 12.—Auditor.

Auditor.—The Directors shall appoint an auditor and fix his remuneration. His duties shall be to examine the books of account of the Club, vouchers for all payments, and certify the usual statement of assets and liabilities and receipts and expenditures for the year.

#### 13.—Examining Committee.

Examining Committee.—The Directors may from time to time as occasion may require, appoint two members of the Club, who shall, if it is so required, examine and report on imported animals for the registration of which application is made.

#### 14.—Representatives.

Representatives.—Representatives to the Canadian National Live Stock Association and to the Canadian National

Live Stock Record Board and other bodies shall be elected at the annual meeting.

#### 15.—Election Commissioner.

Election Commissioner.—The Club at each general annual meeting shall appoint by a majority of those present and voting, an election commissioner, whose duty it shall be to receive and count all ballot papers for the election of President, Vice-Presidents and Directors. The election commissioner shall not be an officer of the Club, and he shall not be eligible for nomination or election. If for any reason he is unable to act, the Board of Directors shall appoint his successor.

#### 16.—Meetings.

1. The annual meeting shall be held in the city of Toronto; other general meetings shall be held at the time and place fixed by the Board of Directors. A notice of at least thirty days in advance shall be given in the official organ of the Club or by post, indicating the time and place of meeting. This notice, if by post, shall be given by a circular letter, postage prepaid, to each one of the members at his last known postoffice address appearing on the books of the Club.

2. Directors' meetings shall be held as follows:

Immediately following the annual meeting and on the third Thursday in each month and at such other times as the President may decide.

3. Notice of meetings of the Directors, other than those mentioned in the preceding section, shall be mailed postage prepaid, to each one of them, eighteen days at least before date of meeting, to his last known place of residence appearing on the books of the Club.

4. A meeting of the Directors may be held on shorter notice or without notice, provided all Directors have given their consent to the meeting being held. A minute of such consent shall be entered in the minutes.

5. For the transaction of the business of the Club at an annual or other general meeting, a quorum shall be twenty; at the meetings of the Directors a quorum shall be five.

6. At the written request of twenty members, the President shall call a special meeting of the Club.

7. Order of business at annual or general meetings—

The above may be replaced by any other order of business provided by the President.

#### 17.—Audit and Annual Report.

The Board of Directors at each annual meeting shall submit a complete report of its acts and of the affairs of the Club; it shall present a detailed statement, duly audited, of the receipts and expenditures of the preceding year and of the assets and liabilities of the Club. A copy of this report, a list of members, the officers elected, and also general information on the affairs of the Club, shall be sent to the Minister of Agriculture for Canada within twenty days after the annual meeting.

#### 18.—Expenses, Income and Property.

The income and property of the Club from whatever source derived shall be applied solely toward the promotion and furtherance of the objects of the Club, and no part thereof shall be paid or transferred directly or indirectly by way of bonus or otherwise as profit or gain to members, past, present or future, of the Club, or to any person claiming through any member, provided, however, that nothing herein contained shall prevent the bona fide payment of remuneration to any Secretary-Treasurer, Registrar, Editor, Officer, Clerk, Servant, or other person or persons for services actually rendered the Club, whether such are members of the Club or not.

#### 19.—Books.

The Club shall cause a book to be kept by the Secretary at the head office, and by the Assistant-Secretary at each branch office, if any, wherein shall ap-

pear a copy of the Constitution and By-laws, so that persons becoming members of the Club may at all reasonable times examine the said documents.

#### 20.—Amendments.

This Constitution and By-laws may be amended at any annual meeting of the Club by the affirmative vote of two-thirds of the members present, but no amendment shall be valid until approved by the Minister of Agriculture for Canada and filed at the Dominion Department of Agriculture. Notices of all proposed amendments must be given to the Secretary ninety days in advance of the annual meeting and they shall be included in the notice calling such meeting, otherwise the meeting shall have no power to deal with the same.

#### 21.—Registration and Membership Fees.

1. All fees shall be paid in cash to the Accountant, Canadian National Live Stock Records, and shall forthwith be deposited by him to the credit of this Club in a chartered bank arranged with the Record Committee of the Canadian National Live Stock Record Board.

The Canadian National Live Stock Records will send the Club at the end of each month an itemized statement of moneys received, a list of registrations and transfers made by each respective Province, and other information that may be required by the Club.

2. In case fees to the Club are received by the Secretary-Treasurer of this Club they shall be immediately forwarded to the Accountant of the Canadian National Live Stock Records, Ottawa, for such deposit.

#### 22.—Corporate Seal.

The seal as stamped in the margin hereof shall be the corporate seal of the Club.

#### 23.—Registration of Pedigrees.

1. A register shall be kept at the office of the Canadian National Live Stock Records. This register to be known as the Canadian Kennel Club Stud Book, shall contain a copy of the Constitution and may at all reasonable times be consulted by any member on demand.

2. There shall be delivered to every person recording an animal a certificate of registration in such form as may be decided by the Board of Directors.

3. All certificates of registration shall be submitted for the approval of the

officer appointed for that purpose by the Minister of Agriculture for Canada.

4. Books of record shall be published at such time and in such form as decided by the Directors.

5. Any person suspended or expelled from membership shall not be allowed the privileges of recording pedigrees on the books of the Club.

6. Any person prohibited from recording pedigrees by any other organization incorporated under the "Live Stock Pedigree Act" shall not be allowed to record pedigrees on the books of the Club.

7. The Record Committee of the Canadian National Live Stock Records shall have power for any cause which in the opinion of the committee seems proper, to suspend any member or refuse applications for registrations or transfers from any person whether a member or not, pending action by the Directors or a general meeting of the Club.

8. The Club may allow the prefix "Champion" to be used on a certificate of registration or printed in the stud book provided any dog has become entitled to the use thereof under the dog show rules of this Club, as they are in force or as they may be amended from time to time.

#### 24.—False or Fraudulent Statements as to Pedigrees.

Every person who wilfully signs or presents, or causes or procures to be signed or presented, to the recording officer of an association or to the accountant or other person in charge of the Canadian National Live Stock Records a declaration or application for registration of any animal by any association containing a false or fraudulent statement regarding the age, color, breeding or pedigree of such animal, shall be guilty of an offence against this Act, and shall upon conviction upon information laid within two years of the commission of the offence incur a penalty of not less than one hundred dollars and not exceeding five hundred dollars. (George V., Chap. 31, Sec. 17).

#### 25.—Kennel Names.

1. A member may register for his exclusive use the name of his kennel, to be used as a prefix or affix, or in combination, in naming his dogs. A particular kennel name will be allowed to one person or partnership only, and in registering such names priority in use



and in application for registration shall be considered. A fee of five dollars for each name so registered will be charged. In no case may national names, such as "National", "Canadian", "Dominion", etc., or the name of a postoffice be registered unless it was in use as a kennel name at the date of the incorporation of this Club under the

2. A kennel name may be transferred to another person or persons on payment of a fee of five dollars to the office of registration.

3. After the expiration of five years a kennel name will be forfeited if it has not been used in a stud book registration by the registered owner.

#### 26.—Rules of Entry.

1. The following shall be eligible to registry:

- a. Dogs recorded in the English Kennel Club Stud Book.
- b. Dogs recorded in the American Kennel Club Stud Book.
- c. Dogs recorded in the Livre des Origines Saint Hubert (Belgian Griffon-Bruuxellois, Chiens de berger belge).
- d. Dogs recorded in the Schweizerisches Hande-Stammbuch (Swiss).
- e. Dogs recorded in the Libros de Origenes Espanol (Spain).
- f. Dogs recorded with the Indian Kennel Association (India).
- g. Dogs recorded with the Societe Centrale pour l'Amelioration des Races de Chiens en France.
- h. Dogs recorded in Raad van Beheer (Holland).
- i. Dogs recorded in the Kennel Club Italiano (Italy).
- j. Dogs recorded in Svenska Kennelklubben (Sweden).
- k. Dogs recorded in Finsks Kennelklubben (Finland).
- l. Dogs recorded in the Society of the Emperor Alexander II. (Russia).
- m. Dogs recorded in Dansk Kennelklubben (Denmark).
- n. Dogs of a breed named in the schedule hereto whose sires and dams are recorded in the Canadian Kennel Club Stud Book.
- o. Dogs bred in Canada, provided their sires and dams and grand sires and grand dams and great grand sires and great grand dams are animals of the same breed. This rule is to terminate January 1st, 1920, and shall not be applied

for the registration of dogs from recorded ancestry.

p. Dogs of a recognized breed for which no foreign record has been established in the country from which they come may be inspected and approved for registration by an examining committee provided for in Article 13.

2. The Record Committee may at any time on the recommendation of the Board of Directors add additional breeds to the schedule hereto.

3. Applications for registration of dogs from other countries must be accompanied by certificates of registration showing that they are recorded in the name of the Canadian owner in the record of the country from which they come.

4. Birth registration of all Canadian-bred dogs shall be made within sixty days of date of birth. Applications shall state breed, name of breeder, name of owner at time of birth, number of males in litter, number of females in litter, day and month of birth, year of birth, name and number of sire if recorded, name and number of dam, if recorded. If sire and dam are not recorded, names of ancestry back three generations shall be given, with name and address of the breeder of the sire and the name and address of the breeder of the dam. All applications shall be signed by the person owning the dam when the litter was born and by the breeder of the litter and by the owner of the sire of the litter except as hereinafter provided. Applications for three generations litters shall be sworn to by the owner of the dam when the litter was born.

5. Application for individual registration will not be accepted until litter registration is made and shall state name of dog to be recorded, breed, color, breeder, name of owner at time of birth, day and month of birth, year of birth, name and number of sire if recorded, name and number of dam if recorded. If sire and dam are not recorded, names of ancestry back three generations shall be given with name and address of the breeder of the sire and name and address of the breeder of the dam. Applications shall be signed by the person owning the dam at the time of the birth of the dog for which application for registration is made. If the dog for which application for registration is being made has changed

ownership since birth, a transfer of ownership shall be filed for which the regular transfer fee will be charged.

6. Duplication of names for Canadian-bred dogs shall not be allowed, nor shall it be permissible to change the name of a dog after it has been recorded thirty days. Dogs from other countries shall be recorded with the same name they had in the country from which they come. Names for Canadian-bred dogs shall not contain more than twenty-four letter spaces. The word imported will follow the name of all imported dogs.

7. When the sire of a Canadian-bred dog for which application for registration is made, was not at the time of service owned by the breeder of such dog, the owner of the said sire shall sign the application form in the place provided for the purpose, giving date of service, with the name and number of the sire. Signature will not be accepted unless such ownership appears on the Canadian Kennel Club Stud Book.

8. The breeder of an animal is the owner or lease of the dam at the time she was served. The first owner is the owner of the dam at the time the litter was born.

9. Application for transfer of ownership must be made on form supplied and must give date of sale and date of delivery, and if the animal is a female and she has been bred the owner of the male to which she was bred must certify to service.

Transfers of ownership shall be endorsed on the back of the certificate of registration.

10. When the pedigree of an animal may have been admitted to the record, or ownership transferred through misrepresentation or fraud, the Board of Directors shall on the discovery of the same, declare the entry or transfer void, together with any entries or transfers of descendants of such animal, and subsequent application for entry or transfer dependent on the signature of any person implicated in such fraud, shall be refused.

11. In making application for registration of animals it is understood that the pedigree is to be accepted only on condition that the given particulars are correct, and if it should be ascertained previous to the publication of the succeeding volume that these particulars are in any way incorrect, the



Board of Directors may at its discretion, omit the pedigree or publish it in an altered form. It is further understood that should the pedigree be published in the Canadian Kennel Club Stud Book prior to the discovery of an error, the Board of Directors may cancel the entry or publish the correction in such form as they may determine. It is further understood that the Canadian Kennel Club will not be held responsible for any loss or damage that may be sustained through inaccuracy, omission, alteration or cancellation of an entry, whether occasioned by negligence or otherwise.

12. No duplicate certificate will be issued unless a statutory declaration is furnished, stating that the original is lost or destroyed and accounting as far as possible for such loss or destruction.

13. Nothing contained in any rule excepting the rules of eligibility shall prevent the acceptance of a pedigree of a Canadian-bred dog for registration where sufficient evidence of breeding is forthcoming and satisfactory to the entire pedigree committee.

14. No application for registration will be considered until fees are paid, nor will any number be assigned to a pedigree until every requirement has been complied with.

#### 27.—Fees.

There shall be paid into the hands of the accountant of the Canadian National Live Stock Records at the time of applying for registration or membership, fees as follows:

# Our Recent Shows

## Bulldog Specialty Show at Toronto

We predicted and expected great things for this show and it will go down in history as the best specialty show of Bulldogs ever seen on the American continent. There was a perfection of detail and a completeness all through that was very marked and tended greatly to the pleasure of everyone concerned, whether he be exhibitor or spectator. The untiring effort of the energetic secretary, Mr. J. F. Lakin, along with the able assistance he received from the committee, was responsible for this. Night sessions and a careful attention to every detail left no loopholes for mistakes, and the successful "carrying-out" of the many "new ideas" that were introduced should be an incentive to other show-giving clubs. The system of exhibitors wearing arm-bands showing the number of their exhibit is an excellent one, as it permits the ringsiders to see at a glance what dog is being shown. The placing of the judge's award slips in a conspicuous place was another "big idea", allowing as it does, anyone interested to get a complete list of the correct awards. The specials were numerous and costly and made the best collection ever seen at a show in Canada, over one hundred of them being tastefully displayed in a huge show case. A few of these, however, would have been better left unoffered, such "freak specials" as those offered for best "tail", best "ears", etc., serve no useful purpose and should be eliminated from our premium lists. What we want and what we are all striving to get are well-balanced dogs with that all-round conformation that the standard calls for, and the practice of encouraging any animal with but one redeeming feature should be abolished.

We have nothing but praise to offer Mr. "Alf" Delmont, of Pennsylvania, who gave us one of the best exhibitions of judging we have seen for many a long day. His task was no sinicure, 39 classes with an average entry of 9 per class was something to conjure with, but "Alf" was equal to the occasion. He was most painstaking in his work, examining every dog carefully before handing out the awards, which when given were satisfactory to

both victors and vanquished alike.

Everything in connection with this event passed off in clock-like order. All told, it was a real "live" affair, full of interest from start to finish, well conducted and will long be remembered as one of the best specialty shows ever held on this continent.

Following is a review of the show by our Hamilton representative, Mr. B. J. McKilliam:

"A fine show," remarked Mr. Alf Delmont, after he had finished judging. "There were a lot of grand dogs benched, but the bitches were a long way best."

Things have changed indeed within the last few years, when conditions warrant a judge in making such a remark as the above. It was a great day for the breed when fanciers wakened up to the fact that what was really needed in the country was an improvement in the class of bitches, and to the realization that a dog, however good he may be, cannot do everything.

At the specialty show held under the auspices of the Bulldog Breeders' Association of Canada on March 28th, not only was a bitch declared best in the show, but the best filled class of the day turned out in novice bitches, over 20 being judged.

In all 86 dogs were benched, and the committee are to be congratulated on the success attending their venture. A particularly attractive list of specials, consisting not only of cups and medals, awards bulletined immediately a class was judged, together with a judge who judged carefully and without favor, rendered success a certainty.

Mr. H. T. Gubbs' Ch. Chestnut Ginger, adjudged best in show, is a beautiful bitch, hard to fault in her present shape. It is only if one were looking for trouble that a little more distance from eye to ear might be asked for, and a trifle more wrinkle on top. Apart from her show points, we understand that this bitch is an excellent breeder and mother, and, this being so, Mr. Gubbs is to be congratulated on possessing something to be obtained but one in a lifetime.

Messrs. Hornsby and Rodgers' Jelliecoe, who went through to winners in

dogs, would create a much better impression if he received a bit more attention in the ring from his handler. A trifle on the leg he is none too loose in shoulder, and his showing accentuated those faults. He is a Bulldog, however, with a grant sea of legs and great bone.

Reserve winners in bitches went to Ch. Lady of Lambare, beginning to show age a trifle, and in dogs to Mr. J. F. Lakin's Heywood Marco, a short-backed brindle and white, with grand head and full of quality.

In open dogs (under 45 lbs.), Ch. Coster's Diamond, looking as well as ever, scored over Mr. J. F. Lakin's Kersal King, H. T. Gubbs' Regal Rascal securing third honors.

Kersal King (since sold for a big figure) is undoubtedly one of the finest specimens ever brought to this country. His head is a study, likewise his front, and practically everything else, but on moving he showed distinctly lame behind.

We understand that the judge remarked that the three placed dogs were all bad in this respect, but while Coster may move distinctly wide, and Regal Rascal throw in a trifle when moving, neither is by any means a cripple and the only course to pursue with a dog of Kersal King's calibre is to place him either first or nowhere.

We particularly like Regal Rascal. He is so level throughout, great expression and a grand shower.

In novice dogs, Edward Cobb's Devon Squire scored over H. Holgate's Glencairn Duke. The winner has wonderful head properties, but not so taking in body. The second is a showy brindle and white, just a trifle lightly got up all over.

Junior dogs saw N. W. Renwick's Toronto Lad, a typical fawn, to the front, with H. Wilson's Norwich Mickey, another good one, second, and Mrs. M. Briggs' Marcus Brutus a bang-up third.

Limit dogs (45 lbs. and over) saw Jellicoe and Heywood Marquis secure first and second honors respectively, third going to H. Wilson's Try Again William. The latter, an extra big fel-



low, is going to sire a storming pup one of these days.

Another nice dog is Bill Louvain, who took several seconds. He has come down a lot in front, has great bone and a lovely set of ears, but might have more face finish.

Limit bitches (under 40 lbs.) say Blue Diamond to the fore. This is a sweet little bitch, good everywhere, but almost a miniature. If this one weighed just 10 lbs. more!

Limit bitches (over 40 lbs.) went to J. F. Lakin's Hefty Mischief, a beautiful bitch full of character and quality.

Canadian-bred bitches saw Mrs. J. Graburn's Pudge defeat Blue Diamond. The winner is a nice bitch, but goes a long way back and the decision was a surprise to everybody.

Novice bitches saw the biggest class of the day parade, and the winner eventually turned up in an extra useful heavyweight, Dermott Beauty, a brindle, with extra bone and substance.

In puppy classes several promising youngsters were benched.

Roxton Boy, belonging to B. Copley, showed a trifle more finish in face than Percy Farrell's Prince Rowland, but was distinctly inferior in bone, substance and lowness to ground.

Mrs. A. B. Smith's Devon Prince Brutus, a taking brindle, will improve with age.

In juvenile bitches, Devon Lady scored over Devon Princess, with T. W. Dobinson's Water Lily third. The winner shows a great deal of character for her age, and should make a really good one when finished. Devon Princess, who moved up one in puppy bitches, is one of the shortest-faced that could be got, being a replica of her sire in this respect.

We were sorry to see that Harry Holgate had rather an off day—that is, for him. King Moston, King Jack and Glencairn Duke we looked over carefully and expect to see Mr. Holgate back in the limelight with this trier before long.

Taken all over, the show can only be described as a huge success and was characterized by the workmanlike and courteous methods of all concerned.

## BULLDOG SPECIALTY SHOW AT MONTREAL.

The first annual specialty show of the English Bulldog Club of Montreal, held March 30th in the Stanley Hall, was one of the successful enterprises for which Montreal is noted and an entry of 164 faced the judge, Mr. Arnold Lawson, of Egypt, Mass., and while his placings in the dog section did not please the ringsiders he did exceptionally well in bitches and in awarding the specials. As a whole the quality of the exhibits showed much improvement over those benched at past shows in Montreal, clearly indicating that the "short-faced" variety are on the boom in Canada. We noticed a number of new ones just over from England, and understand that several more are on the way. A bitch named Sallie, recently imported by Mr. Arsenaault, impressed us as an exceptionally good one and we predict a great future for her. Alban Nora, another new one, could easily have done better in her classes and should prove a decided acquisition to the breed. We renewed acquaintance with an old pal in Duchess of Elgin, a small white one that just missed being a flyer and in this company should have been at least reserve winners.

Mr. Charbonnier's brace, Kildare Silent King and Kildare Bunt, are two nice ones, the former is still a youngster, but showing great promise. Drummond Red Rose, a very nice typy bitch, went down through lack of condition, being brought into the ring entirely too fat. Properly shown this bitch will always be there or thereabout. Mr. Francis' St. Lamber's Duke was the unlucky dog, easily scoring over several dogs that were placed over him. We could not follow the judge's placings of this fellow at all. A nice cobby dark brindle, with good napper and plenty of bone, full of real Bulldog type and particularly sound.

Mr. Lakin's team, Kersal King, Haywood Marco, Hefty Blaze and Hefty Mischief, accounted for most of the winnings and specials, and rightly so. The latter accounted for winners bitches and best in show, either sex. Heywood Marco, reserve winners dogs, as a whole easily won the brace, trio and team classes.

Mr. H. A. Wilson's brace, Try Again William and Peaceful Diamond, went through nicely, peaceful Diamond doing particularly well, going as high as re-

serve winners, while the dog's many sterling qualities saw him placed in all his classes.

Tyneside Bella, owned by Mr. Irwin, of Ottawa, an all-white puppy bitch, started a landslide, landing four firsts and two seconds in hot competition and yet only eight months old. This little one has a great future in store and when she matures will trouble the best of them. The best we could figure for the winning dog, Drummond Sir John, was third in the limit and open classes, but Mr. Lawson seemed to fancy him, but received much well-merited criticism for the way he put the dog through, there being at least a dozen present that could top him easily.

The arrangement of the show was ideal and indicates much hard work and forethought on the part of the committee. A large and very critical audience was present and a great deal of enthusiasm was shown. We understand a nice sum was handed over to the Khaki League as the result of this successful venture.

Entries in other breeds filled well, over 200 were shown. Bull Dogs and Wires had the most numerous entries and a good crowd were on hand to watch the judging. The show was a financial success and was well managed.

The fifteenth annual show of the above club passed off in a business like manner and was a great improvement on several of its predecessors. This took place on Good Friday and Saturday, March 29th and 30th, and the officials who engineered this event are deserving of praise for their untiring efforts. Everything went off according to schedule, all the judges kept their appointments and the willing band of workers had everything ready. Superintendent DeGeer was the right man in the right place, obliging and courteous to all, and knows the requirements of the fancier from A to Z. Secretary McIntyre, along with the energetic committee, must have put in a lot of overtime to have the arrangements so complete. The building, although not an ideal one, was the best available, and every effort was made to make it as comfortable as possible for the exhibitors and their dogs. Sani-Tari, a new Odorless Disinfectant, was used and proved very effectual. The splendid classification and list of Specials drew a bumper entry. In all there were over 340 dogs benched, making it a two-point show. Collies with 103 entries made the largest section, followed by Cocker Spaniels, with 82 entries, and Bulldogs with 72. The Boston Terriers and Pomeranians were also well represented.

Jos. Hill, Esq., of Toronto, adjudicated his favorite breed, the Cocker Spaniels, and examined the dogs carefully before making his decisions. W. Armiston Roy, Esq., of Montreal, handed out the ribbons in the Collie section, and can be relied on for honest and conscientious placings. W. B. Levaek, Esq., of Toronto, made his debut as a judge and handled the Bostons with care and dispatch, his awards being well received. Mrs. W. Wylie, of Vineland, officiated over the Toy Section in her usual capable manner. Bulldogs being left in the capable hands of J. Cooper Mott, Esq., of New York, who made his first appearance in the capacity of judge at our Canadian shows. The remaining classes were left to the all-rounder, W. F. Livesey, Esq., of Caldwell, N. J., whose placings gave entire satisfaction.

Following are a few criticisms by experts on their respective breeds.

### COCKER SPANIELS

By the Judge, Joe Hill, Esq.

Cockers was the largest entry of any one breed in show and take them all through they were of exceptional quality, and I doubt if their equal has ever been seen at any local show.

Mr. Anderson brought out a new one in Master Laddie, a nice typical little cocker, good front and shoulders, good square muzzle, lots of lip and a good mover. Another good one by the famous old sire Billy Obo. Robin Hurst Kennels' Dark Secret, another good Black, with exceptionally clean-cut head, nicely coupled, good front, a real good cocker, but he is not as free a mover as Master Laddie, and not in as good a condition, otherwise there is very little to choose between them.

Dr. Campbell brought out a nice parti-colored in Oakley Jackdaw. This is a nice fronted and a wonderful shouldered dog, slightly plain in face, but a nice dark eye, which you seldom see in a parti, also nice expression, outside of a slight stiffness behind. He is really a high-class parti and will be heard from later.

Mr. Fred Lewis' Colmo Ido went through to winners in Red Females. She is well ribbed and lots of substance and a really nice mover, closely followed by Mr. Thos. Huckle's Red Bitch Eze. This is a real good fronted and shouldered bitch and later when she develops, which she will as she is quite young, it will take a good one to beat her.

Puppy Dogs—1st, Oakley Magpie, described above; 2nd, Obo Belmont, a nice young dog, good front, nicely coupled and should develop into a fair good dog; 3rd, Oakley Jackdaw, another real good pup shown very thin, when this one gets age and develops I look to hear from him later, a litter brother to winner and by the old stand-by, Calmo Don Carlos.

Novice Dogs, Black—1st, Master Laddie, described above; 2nd, Oakley Jackdaw; 3rd, Bruce Boy, a little over size, but bred right.

Limit Dogs, Black—1st, Master Laddie; 2nd, Robin Hurst Kennels' Dark Secret; 3rd, Calmo Perfecto, not in the best of condition, otherwise a fair one.

Open Dogs, Black—A repeat.

Novice Dogs, A. O. C. than Black—



1st, Oakley Magpie; 2nd, C. Bowerbank's Bingo, a nice dark Red, a little plain in face and a shade fine in muzzle but a good fronted and sound dog; 3rd, Lord Clyde, shown in very heavy coat, a nice coupled, well ribbed-up little fellow and would cross well to certain bitches as he has a nice square head, nice eye and good expression.

Limit Dogs (any solid color other than black)—1st, Sir Douglas Haig, nice front and shoulders, a very fair one; 2nd, Pat, not too good in front but lots of bone; 3rd, Oakwood Traveller, nice color, shown very thin, in bad condition.

Open Dogs, solid other than black—1st, Bingo; 2nd, Paderewski; 3rd, Sir Douglas Haig.

Limit Dogs, Parti-color—1st, Oakley Magpie; 2nd, Lord Clyde; 3rd, Robin-hurst Lucky, coarse in head, bad shoulders, just a fair one.

Open Dogs, parti-colored—1st, Oakley Magpie; 2nd, Imported Trey, this dog shows a lot of quality, slightly heavy headed and could be better behind, otherwise a very good one; 3rd, Luckey Deever, a nice headed dog, and a very typical cocker, not too good in shoulders.

Puppy Bitches—1st, Calmo Ino, a nice headed bitch, nicely coupled and well ribbed up, shade on small side; 2nd, Pollar; 3rd, Dott, the above two are both fair bitches and should improve with age.

Novice Bitches, Black—1st, Calmo Alto, a shade fine in face, otherwise a good one; 2nd, Lady Ardath; 3rd, Calmo Ino.

Limit Bitches, Black—1st, Robin-hurst Desire, nice head and a fair good bitch but very light in bone; 2nd, Calmo Alto; 3rd, Oakley Black Wings.

Open Bitches, Black—1st, Robin-hurst Desire; 2nd, Tipperary Queen.

Novice Bitches, A. O. C. than Black—1st, Sweet Colleen, this is a real nice bitch, good front and shoulders, and will make a grand brood bitch, she is put up right; 2nd, Beauty Spot, this is a nicely coupled little bitch, slightly loaded in snoulder but well up; 3rd, Dott.

Limit Bitches, any solid color than Black—1st, Calmo Ido, a good one described; 2nd, Eze, another good one also described; 3rd, Pearl B., a clean cut head and a very fair bitch, but the class was an exceptionally hot one.

Open Bitches, any solid color than Black—A repeat.

Open Bitches, Parti-colored—1st, Beauty Spot, this one alone in this class.

Canadian Bred, Open Dogs and Bitches—1st, Master Laddie; 2nd, Sweet Colleen; 3rd, Calmo Ido.

Laddie, winner Black Dogs. Robin-hurst Desire, winner Black Bitches.

Oakley Magpie, winner A. O. C. Dogs. Calmo Ido, winner A. O. C. Bitches.

Lindburg's Laund Lustre was second Limit Class, another heavy-coated one at nearly five years old, as fine in head as a youngster, she is round in eye and not the best of ears.

burg, lacked in strength of muzzle to first two, but a nicely marked pup of good color and nice formation.

Novice dogs were headed by Dr. H. Mason's Mason's Glory Boy, a very short-headed son of Ch. Dowd's Glory, beautiful color and markings, and a pretty even dog all over. 2nd, Star Hill Barea.

Limit dogs (under 17 lbs.), 1st, W. A. Currie's Dodge's Pride, a very trim well-marked mahogany brindle, a well-known and consistent winner. 2nd, A. Carter's Lloyd George, good head and front, well marked, very rich dark brindle, none too good behind and a poor shower.

He is a very short-headed, well-marked dark brindle, of the stocky type, a splendid poser, but none too good as a mover, is now well on his way to a championship. 2nd, Bellwood Connie. 3rd, Sir Henry.

Limit dogs (22 to 27 lbs.), 1st, C. L. McQuillan's Clifton Byng, a strong headed, well marked seal brindle, with a better pair of front legs would take some beating. 2nd, T. E. Milburn's Dr. Cameo Jr., a well marked dark brindle, very strong in muzzle, would have won had he shown better.

Open dogs (22 to 27 lbs.), 1st, Brown & Phillip's The Spirit, one of our well-known winners, a trim well-finished seal brindle, with a little better under-jaw would be a topper. 2nd, Dr. Cameo Jr.

Puppy bitches, 1st, H. E. C. Brennan's Speen Queen, a real smart dark brindle, a good shower, lacks a little in

stop, which may improve in time. 2nd, W. A. Currie's Belle Mahone, a rich dark mahogany brindle, a good shower, lacks a little in expression at present, principally owing to a poor ear carriage, will in time trim up into a real good one. 3rd, A. Smith's Lady Cuning, a real good bitch, even dark brindle, splendid head, good shower, a little long in tail and in poor condition.

Novice bitches, 1st, Belle Mahone. 2nd, Lady Cuning. 3rd, Omar Patsie.

Limit bitches, (under 17 lbs.), 1st, J. Thompson's Baby Ringleader, a real smart one, well marked, beautiful brindle, a good shower and a typical Boston all over. 2nd, Omar Patsie.

Open bitches (under 17 lbs.), 1st, Baby Ringleader. 2nd, Mr. W. C. Ingram's Oxonian's Imp, a real good dark brindle, lack of head markings spoils her chances.

Limit bitches (17 to 22 lbs.), 1st, Mrs. W. C. Ingram's Sweet Clover, a high-class one, beautiful head, rich dark brindle color, a little long in body and very timid. 2nd, C. L. McQuillan's Clifton Belle, a well marked dark brindle, loses to the winner in general finish. 3rd, Lady Cuning.

Open bitches (17 to 22 lbs.), 1st, R. E. Stonehouse's Golderest Firefly, a grand headed dark brindle, good feet and legs, also a good shower, a little long in body, eventually went to winners. 2nd, Ingram's Sweet Clover. 3rd, Lady Cuning.

J. S. Hickford, one of the best known breeders of English Setters on the coast, returned from France after serving over two years. Jack, as he is known on the coast, was gassed and also had trench fever and wounded. All the fanciers were more than delighted to know of Mr. Hickford's safe return. At the last meeting of the Terminal City Kennel Club Mr. Hickford was elected honorary district vice-president of the T. C. K. C. for Victoria.

Mrs. Thornton Sharp, one of Vancouver's foremost Wire Fox Terrier breeders, has moved over to Victoria for the present. Mr. Thornton Sharp has been in France ever since the war started. They will again make Vancouver their home when Mr. Sharp returns.

#### Post Mortem Examinations—

Carcases for examination MUST be sent prepaid to Dr. J. A. Campbell, 8 Edward St., Toronto. A fee of \$2.00 MUST accompany the carcass in all cases, or else it will be destroyed without examination.

Questions must be brief. In every case breed, sex, age and conditions observed should be given; proper name and address must be given (not for publication), also nom de plume over which he wishes questions answered.

#### H. N., Brantford—

Q. I have two Beagle pups that are coughing and constantly vomiting, and don't seem to eat. There is no discharge from the nose or eyes. Could you tell me what I can do for them?

A. Your pups have a form of distemper infection that has become localized in the throat. Get the following made up by your druggist:

Chlorate Potassium ..... 3 drachms  
Simple Syrup ..... 1 ounce  
Water to make ..... 4 ounces  
Give a teaspoonful four times a day.

You did not state age of pups, the above dose is for a six months old Beagle. Feed raw lean meat, bread and milk with egg beaten up in it. Keep them dry and do not allow too much exercise.

#### Novice, London, Ont.—

Q. Could you give me a few pointers on the care of stud dog. Is there anything special I should give him?

A. Dogs used much at stud require a liberal diet, half of which should consist of underdone meat, and stud dogs must have plenty of regular exercise, which, for a Terrier, for instance, should amount to one hour's walking twice a day. Dogs not kept in good health and condition often fail to get

stock, and when several bitches miss to a certain dog the news soon circulates amongst breeders who cease to send their bitches. Many highly-bred dogs are shy breeders and require an occasional stimulant or tonic, but these are not a substitute for good food and proper exercise, which are essential for a dog to be a sure breeder.

Q. Does blindness in one eye disqualify a dog for showing purposes.

A. No. Total blindness disqualifies.

#### J. C. A., Ottawa—

Q. Have a litter of Boston puppies three weeks old. Would there be any danger in treating them for worms when they are six weeks old?

A. You may safely treat them for worms when they are four weeks old, and it is a very good precaution; but be sure to use a reliable preparation. We can recommend any of those advertised in Kennel and Bench.

#### H. L., Toronto—

Q. I have a Boston Terrier puppy, seven and a half months old, that has a swelling the size of a walnut under its throat directly below the ear. It is lively and eats well. Is there anything I can do to remove it?

A. The enlargement is an affected gland, and in all probability contains pus. I would take it to a veterinary surgeon and get him to open it up and it will soon subside and there will be no trace of it left. Sometimes if it is not properly opened it fills up again.

#### J. D., Montreal—

Q. I have a Pekingese puppy, three months old, that has a rupture at the navel, about half an inch below the stomach wall. There is an opening which I can insert the end of my finger and I am afraid that the bowel protrudes. Is it likely to become bigger, and what treatment is necessary?

A. I would not be too alarmed over it. A rupture the size you mention is not serious. The opening will not grow any bigger but the pup will grow stronger and larger and there is very little danger of anything happening.

## OUR MAIL BAG

The following are two of the many letters of appreciation we receive from our boys overseas:

Macedonia.

Dear Editor:

Many thanks for yours of the 25th. Sorry I have not answered before, but have been rather busy lately. Now dogs, I suppose, will interest you, but am afraid that neither Salonica, Macedonia, Egypt, Palestine, or any other old place in this vicinity can be accused of possessing a breed of dog. There were a few good dogs in Salonica belonging to the Crown Prince of Serbia. He had, as far as reports can testify,

a kennel of about 20 Pointers, where they were originally imported from is difficult to say, probably from Blighty.

Here in the Holy Land we have only one type of dog. It is a mongrel with quite an amount of jackal, or as we would call it in Canada, Coyotte blood. Its appearance is like a small edition of the Husky, and that I think exactly expresses it.

As regards sport, there is unlimited opportunities in Macedonia. Partridge (two kinds, French and probably Hungarian), hare and woodcock, with great possibilities for good sport when in the right district. Out here there is little chance of anything except Plover. When I was at Ishmailie I noticed the green variety was one of the officially barred birds. I have heard a great deal of sand grouse, but so far have not come across them. As far as I can understand, it is a smaller bird than the English or Scotch grouse and probably about the same size as the Canadian willow grouse, food hen, or whatever one wishes to call it.

May I now apologize for the brevity of this letter, but thank you and your members for the resolution passed in January, 1917, making us gratuitous members for the duration of the war. Many thanks also for copies sent me of K. & B. I have been in the depths of despondency owing to their absence, but of course it may be that they have been sunk.
