### IMPORTANT!

On the reverse side of this page will be found a series of proposed amendments of our constitution. Read them over very carefully. They have been proposed by our President himself, who believes that their adoption is of vital interest to the future progress of the Canadian Kennel Club.

We cannot disguise the fact that the very pronounced dissatisfaction which exists amongst many of our members to-day is the result of the interpretation of our Constitution as it now reads, and it is to relieve this situation that the amendments have been proposed. The dissatisfaction referred to is Dominion-wide in its scope, and is shared by our old and new members alike. Especially is this true in the Provinces of British Columbia, Alberta, Saskatchewan, Manitoba (conditions are intolerable in this province), and the Maritimes.

Frankly, we regret having to propose the re-opening of the Stud Book again, yet, under prevailing conditions it has become imperative to do so for a short period, during which we trust to have the hearty co-operation of every fancier who may feel it incumbent upon him or her to assist in the work of having every eligible animal recorded during the time that the book remains open.—Editor.



# PROPOSED AMENDMENTS TO THE CONSTITUTION

The several proposed amendments to the Constitution having been duly received at the offices of the Canadian Kennel Club, Inc., and in the hands of the Secretary ninety days in advance of the Annual Meeting, as required by By-Law 20 of the Canadian Kennel Club Book of Constitution, will come before the Annual Meeting to be held at the Carls-Rite Hotel, corner of Front and Simcoe Streets, Toronto, on the evening of Saturday, February 19th, at 8 o'clock. A representative gathering is anticipated. Read the following carefully. Study the proposed amendments, and come to the Annual Meeting prepared to discuss the proposed changes comprehensively.



Dear Sir: I herewith advise you that at the next Annual Meeting of the Canadian Kennel Club, Inc., I will propose the following amendments to the Constitution and By-Laws:—

All of which is in the best interests of the Canadian Kennel Club, and its many members, wherever located.

That; Article 3—Members. Page 4 of the Book of Constitution, Section 3, which reads:

Application for membership shall be in writing on the form prescribed, and each applicant shall agree to be bound by the Constitution and Amendments and all rules of the Club, but the Club shall have the power to reject any application for membership.

Be amended to read:

Application for membership shall be in writing on the form prescribed, and each applicant shall agree to be bound by the Constitution and amendments and all rules of the Club, but the BOARD OF DIRECTORS SHALL have power to reject for CAUSE ANY APPLICATION FOR MEMBERSHIP PROVIDED THAT THE APPLICANT SO REJECTED, SHALL HAVE THE RIGHT TO APPEAL AGAINST SUCH REJECTION, TO THE NEXT GENERAL MEETING OF THE CLUB, WRITTEN NOTICE OF SUCH INTENTION TO APPEAL MUST BE GIVEN WITHIN 30 DAYS OF SUCH REJECTION.

That; Article 3—Members. Page 5 of the Book of Constitution, Section 5, which reads:

The liability of each member shall be limited to the amount of membership or other fees or dues which he may owe to the Club.

Be amended to read:

The liability of each member shall be limited to the amount of membership or other fees, FINES, or dues which he may owe to the Club.

That; Article 3—Members. Page 6 of the Book of Constitution, Section 10, which reads:

The Directors shall have power to suspend or expel any person whether a member of the Club or not, who fails to observe any rule, regulations or By-Laws of the Club, or whose conduct in their opinion is prejudicial to the interests of the Club, and the person so suspended or expelled shall have no claim against the Club or be allowed any of the privileges of the Club, including registration of pedigrees, or be allowed to enter into any competition held under the show rules of the Club. No person, however, shall be suspended or expelled until such person has first been notified of the alleged offence and has been given an opportunity to appear in person before the Board of Directors.

Be amended to read:

The Directors shall have power to suspend, expel OR DISQUALIFY A MEMBER OF THE CLUB who fails to observe any rule, regulations or By-Laws of the Club, or whose conduct in their opinion is prejudicial to the interests of the Club, and the MEMBER so suspended or expelled, OR DISQUALIFIED shall have no claim against the Club or be allowed any of the privileges of the Club, including registration of pedigree OR KENNEL NAME, or be allowed to enter into any competition held under the show rules of the Club. THE DIRECTORS SHALL ALSO HAVE POWER TO DISQUALIFY ANY PERSON NOT A MEMBER OF THE CLUB WHOSE CONDUCT IN THEIR OPINION IS PREJUDICIAL TO THE CLUB, AND THE PERSON SO DISQUALIFIED SHALL NOT BE ALLOWED TO REGISTER PEDIGREES OR KENNEL NAMES, OR TO ENTER INTO ANY COMPETITION HELD UNDER THE DOG SHOW RULES OF THE CLUB. No person, however, shall be suspended or expelled or DISQUALIFIED until such person has first been notified of the alleged offence and has been given an opportunity to appear in person before the Board of Directors.

Such person shall have the right to appeal to the Club from the action of the Directors at an annual or general meeting, provided notice of appeal has been given in writing to the Director, but reinstatement may only be made by the affirmative vote of two-thirds of the members thereof.

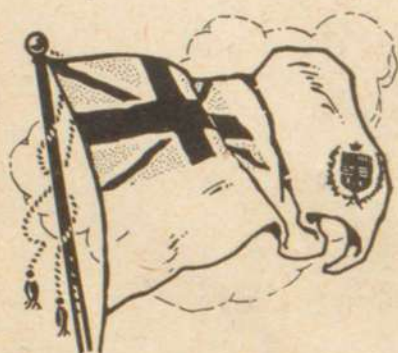

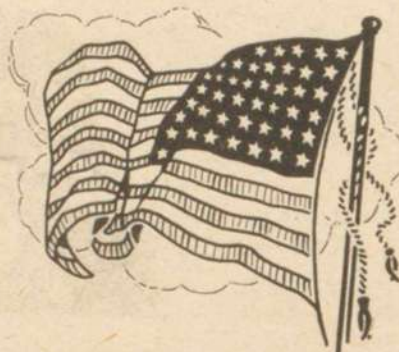

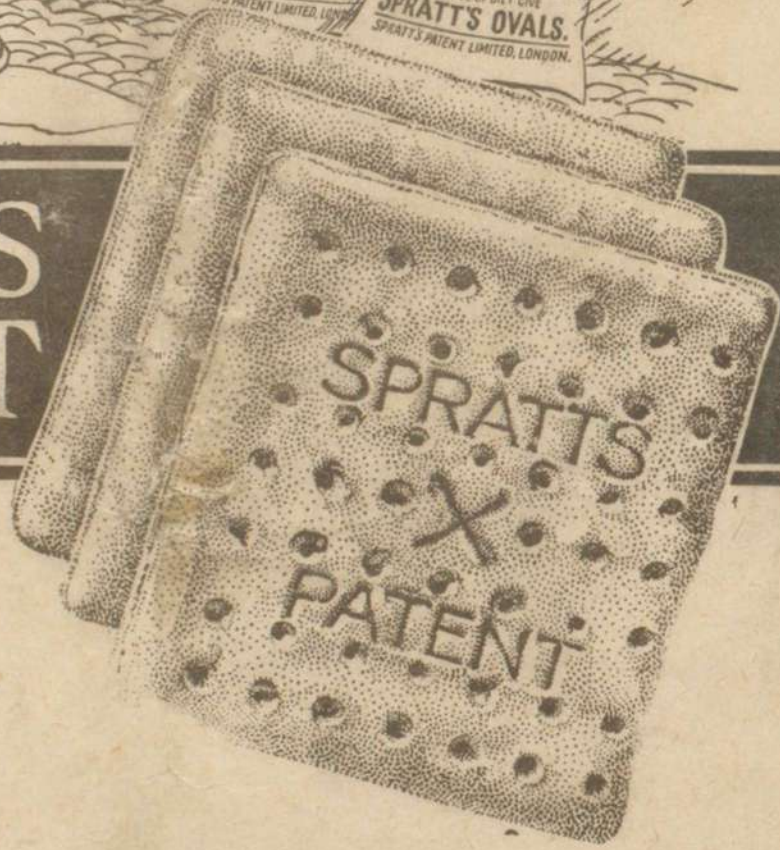
