# How to Give MEDICINES


Give medicines to your dog only on the advice of your veterinarian or when you are absolutely sure of both the disease to be cured and the power of the medicine. If there is the least suspicion or doubt, get the veterinarian's advice first.

## TABLETS, CAPSULES OR PILLS

Stand in front of dog, a little to his right side. Open mouth with left hand by pressing upper lips against teeth as indicated (upper left).

With thumb and forefinger drop pill on extreme back of tongue. With the forefinger gently press it as far down the throat as possible (second upper left).

Keep head up and mouth closed as shown (third upper left) until sure the dog has swallowed.



## POWDERS

Have powder ready on folded paper. Open dog's mouth as before and pour powder well back on tongue. Hold mouth closed as before.



## LIQUID MEDICINES

With thumb and finger of left hand seize loose skin of cheek and corner of mouth and draw away from teeth to form a natural channel. With right hand gently force up dog's head and pour in medicine from small bottle. Keep dog still till he has swallowed.

# DACHSHUNDE AT WORK

**I**NCREASING interest in the dachshunde as hunting dogs and the probability of a formal field trial for the breed in June have raised the question of training methods in Canada—how best to cultivate the hunting instinct and train a dachshunde in the finesse of field trials.

Training must cover the three branches of trials—leashwork (5 points), burrow work (30 points), and trailing (65 points) but as we must crawl before we can walk, so we must try to get our dogs into shape early in the spring.

Leashwork is compulsory at all trials. The dog may be really leashed or he may be free. He must stay close to his leader, turn when his leader turns, stop when his leader stops and must not tug or strain or run ahead. This sounds simple but takes quite a bit of patient training.

This article cannot give all details but is designed to meet the requirements of those who may not have a great deal of spare space. Burrows may be quite complicated and for those who wish to construct something more pretentious, reference may be made to Dr. Fritz Engelmann's book "Der Dachshund". The Standard burrow which is illustrated on this page is simpler and can be constructed by anyone with twenty or twenty-five square feet of space. It will be used also for formal trials.

This burrow is laid in a shallow ditch about ten inches deep. The top is flush with the ground and the bottom of the tunnel is earth. The sides and top are made of wooden planks of one inch thickness. In each section of the top there is a removable piece held in place by latches. Gates A, C, D, E, F, G are composed of flat pieces of metal or wood which slide through slots in the top of the burrow to close off certain sections completely. The gate B. is a grating which separates animal from dog in the searching enclosure H, allows them to see and smell each other but no contact can be made. The top of the searching enclosure is removable. Tunnels should be about ten inches wide.

The entrance of the tunnel should gradually descend into the searching enclosure which is well walled in and which should be large enough to permit game boxes to be put in or taken out. The entrance A and the exits X and Y should also be large enough that game boxes can be placed in them to release or capture the game without any danger of escape.

The thirty points for burrow work are made up as follows:

Entrance, 5 points; Barking at enclosure, 15 points; Accuracy and Speed, 5 points; Action at exit, 5 points, a possible total of 30 points.

Entrance: First there is a silence trial—game is merely chased through the burrow, one arm of the exits being closed and the game placed safely in its carrying box. Loud barking disqualifies a dog as one who barks when there is no game will give much trouble in an actual hunt. A few yelps of excitement and eagerness will not be considered "burrow noise" however but no great leniency should be extended. Some dogs will not accept the empty burrow at all and later prove their ability in the actual burrow trial. These lose five points.

The burrow is scented anew by chasing game from entrance into searching enclosure H. Solid gate C is closed to imprison the game and grating B. is put in place to protect the animal from the dog. The dog is then unleashed at the entrance. Pups are allowed two false entries, novices and higher, only one. Disqualification is the penalty.


The dog must locate the game within ten minutes or he is disqualified and has to be removed from trial. On locating game pups must bark loudly and continuously for a period of ten minutes; dogs in novice or higher, for a period of twenty minutes. (A good hunting dog needs a good strong voice as in natural burrows it is the voice which leads the master to dig down to the prey and dachshunde have been known to go down very deep.)

When the din of the barking trial is over, all the gates of ONE exit passage are opened on the exit side of the grating and the game is allowed to run through into its carrying box and removed. The last exit gate is closed and the grating in the searching enclosure is drawn up. If the dog takes the correct exit and truly follows the scent the next thing to notice is

his behaviour at the exit gate. He should scratch, bark and exhibit great eagerness. His trial is then finished. If he takes the wrong exit passage twice he loses five points.

All this sounds easy but it is more difficult than you may think. Be sure to keep your dogs under control and permit NO INTERFERENCE from any dog with the dog being tried. The dogs should not be allowed to see the game being put into the burrow and even dogs who are good friends should not be permitted near each other when trials are going on. Dachsies can be trained to hunt together, usually by taking out a mother with her own pups, but it is not wise to experiment at first. A free for all may result. You may think butter would not melt in the mouth of your innocent-faced darling but a dachsie can be very fierce and VERY VERY QUICK if he is roused to the pitch of excitement which the sight or smell of game may cause. This would apply even to my sainted Dandy, the dog who, as you all know, "has never done

## JUBILEE PRIZE WINNERS

THESE is an old saying that reads—"It's an evil wind that blows nobody any good"—but the favorable winds of our Golden Jubilee Year celebrations have blown much that was good and desirable into the pockets of our Canadian Kennel Club members during 1938. The break-down shows that the several provinces shared fairly proportionately in view of the number of dog shows held in the respective provinces. For instance, from nineteen shows Ontario earned four hundred and fifty-five dollars, plus twenty dollars for two Field Trial dogs that had completed their championships. With thirteen shows, British Columbia members collected three hundred and forty-five dollars, and with six shows Alberta helped herself to two hundred and forty dollars. Saskatchewan, with four shows, took down two hundred and thirty dollars, the Maritimes, with five fixtures, one hundred and seventy dollars; Manitoba, with three shows, won one hundred and forty dollars; Quebec, with one all-breed show and one limited show, won twenty-five dollars; the whole making a

grand total of one thousand, six hundred and twenty-five dollars; and to this must be added the Canadian Kennel Club's one hundred dollar prize for the Canadian-bred dog winning the most group classes during the Golden Jubilee Year. This expenditure of one thousand, seven hundred and twenty-five dollars; whilst extraordinary outlay as far as the club is concerned, has been extraordinary income as far as a great many of our members are concerned.

Commencing at the Western Coast, and travelling in an easterly direction, we find the diminutive, perky little

Pomeranian, the audacious looking Pekingese, dignified and haughty as can be; the largest of the terrier family, the airedale, and the aristocratic borzoi, all lining up for a further sharing of the rich prizes still to be distributed. Such prizes include three sterling silver trophies donated to us through the generosity of Spratt's Patent, Limited, London, England; The Ross-Miller Biscuit Company, Limited, Napanee, Ontario; Kent's Limited, Jewelers, Toronto, Ontario; Stone

The pomeranians we have referred to include Mrs. J. W. Bruce's (Toronto, Ont.) Champion Melbourne Supremacy, the winner of the Canadian Kennel Club's one hundred dollar cash prize for the Canadian-bred dog or bitch winning the most group classes during the Golden Jubilee year, and in virtue of this outstanding win, Ch. Melbourne Supremacy automatically wins a Spratt's Patent,

Limited, solid silver cup for having won the C.K.C. one hundred dollar cash prize. The Pomeranian, Champion Wembley Gold Shade, owned by Mrs. E. Bradley, Vancouver, B.C., will be awarded the Kent's Limited Trophy, for having been runner-up in the "most group classes" contest. Champion Wembley Gold Shade won six group classes during 1938. Then the two Pekes of Mrs. Denyer Morris, Toronto, Ont., "Ti Ti of Rivercourt" and "Ah Kwa of Rivercourt". These Canadian-bred Pekes were sent out after the Spratt's Patent, Limited, Golden Jubilee Certificates at the first shows of the year, and kept up the quest until the end of the year, and Mrs. Morris' perseverance has been rewarded with the winning of the two Spratt's solid silver trophies. In passing, we would mention that Mrs. Morris won twenty-five of the Spratt's Patent, Limited, Golden Jubilee Certificates, going far afield in order to establish a margin of safety which constituted a challenge to all other likely to be interested. trust the rewards have proven to be sufficient justification for the effort entailed by the conditions involved. We also trust that our Golden Jubilee year generosity has been appreciated.

Sid Perkins and George Kynoch equally share the honour of having been most favored, each having won ninety-five dollars. Other winners of twenty-five dollars or more included Evan Gravell's (Vancouver) English setter "Snowdon Clincher"; C. M. Butler's (Vancouver) springer spaniel, Champion "Prince of Huntswell"; W. R. Wilgress' (New Westminster) Champion "Shiplake Challenge"; Jack Forbes' (Vancouver) Irish setter, Champion "Strathbogie



A welcome to a new advertiser this month—O. C. Hughes, London, Ont. For many years Mr. Hughes has been breeding setters and only three years ago he went into cockers. His stud force, Hu-mar Toroclan, a well marked black and tan, is by Am. Ch. Torohill Smoky, top cocker and group winner at Westminster in 1937. Only shown once as a puppy he went reserve winners at London; and, although only a year old, he has sired two litters—black and tans when bred to a black bitch and solids when bred to a red and white bitch. Mr. Hughes has recently completed arrangements to send Toroclan's sister on a visit to Ch. Blackstone's Reflector, best of breed at the 1938 Westminster, who is a half brother of Torohill Smoky. Sounds like good science.

Still the "Type" controversy rages—English or American or both together or both separate. Many letters from Canada and the United States have expressed opinions. I would like to print them all, but space does not permit and I must be satisfied with the publication of this one from Don McKinnon, Parkhill, Ont.

Dear Mac,

"What with your column in Kennel and Bench this month and as events transpired at the National Kennel Club show, the English cocker seems to have come to town in a large way. (The proposal to award him special variety in the Gundog group is, to my way of thinking, a progressive one. The history of the spaniel has been one of division and, in view of the immense popularity of the cocker, this step seems to me to be inevitable. You know that I like the working dog (dual-purpose) so, in presenting my brief for the English cocker, I am keeping in mind his field, as well as show, attributes—a true representative of the Gundog group.

"There is, no doubt, a distinct difference in the American and English type of cocker spaniel. If we dig into the history of the breed, we find originally a spaniel, though later divided

into Springer and Field. From 1870 there was the matter of the Field shown as over and under 25 lbs. Gradually, the cocker as we know him evolved, and when the weight was lifted in England in 1901 the breed went from a strictly woodcock dog to a small all rounder, built for and used as a working dog.

"Starting with the early importations to the United States, we note a divergence in the interpretation of the standard and the cocker in America was kept to a weight limit of 24 lbs. The English dog, having more weight leeway, seems to have developed into a more workmanlike size, approximately 29 lbs. He was used in field trials and before attaining a championship was required to earn a field certificate of merit. He became longer on the leg, shorter in back and altogether different to the early good dogs such as Lily Obo, Little Prince, Ridgeway Raca, etc., while the American dog was kept much to the type of the earlier specimens. Mrs. Moffit, in her book on the cocker spaniel, while holding no brief for the English dog, admires his front, shoulders, etc., and above all his CONSISTENCY TO TYPE. She further claims that there is a distinct difference in head, height, and general outline. Coming from such a source this speaks for itself.

"In comparing the breed standards as published in Dog World (Am.) June, 1937, there is no radical difference shown in the different breeds of Spaniels, beyond the matter of weight. We have cockers from 18-24 lbs., Welsh Springers 35-40 lbs., Sussex 35-40 lbs., Field 35-50 lbs., English Springers 45-50 lbs., Clumbers 55-65 lbs. There is no weight given for English Cockers. We therefore find Spaniels from 18-65 lbs., though there is a gap from 24-33 lbs. Why not let the Englishman fill this gap? He is as distinctly different as the Sussex and Clumber, the Field and the Welsh Springer from the English springer.

"There is another angle of this cocker question that always creates a certain amount of discomfort among the majority of breeders, and that is regarding the working blood in their dogs. Mr. Freeman Lloyd, (an undoubted authority) Gundog Editor of Field and Stream, has for some years been advising cocker breeders to get more length of jaw and more leg under their dogs in order to better fit them for field work. Latterly he has been pointing out the number of English importations and asks his readers to take advantage of this blood to carry out the above mentioned requirements. Mr. Lloyd's connection with dogdom goes back to the early days of Laverack and his setters and is without any doubt one of the greatest boosters for the spaniel as a Gundog in America.

"To the city dwelling man, the English cocker has much to offer, particularly if he likes an occasional day of upland shooting, not to mention a bit of duck retrieving. Through the Championships in his pedigree his working blood can be proven, he is of a size capable of retrieving the average upland game, from woodcock to pheasant. He is not so big that he crowds the average apartment, house or car and when taken out on a string by the little woman he isn't so hard to look at.

"Taking him any way you like, I can't see why the English cocker shouldn't be given recognition as a Gundog. He is a progressively bred dog; authorities admit that there is room for a practical Gundog of his size; he breeds true and is admittedly distinctive in type; his working and show blood can be proven; he is a show dog (See results Parti-color Cockers, Nat'l. K.C. show, Royal Winter Fair, 1938.) He is the APARTMENT GUNDOG."

Saunders, whose knowledge of springers is as intimate and thorough as his experience with cockers, has consented to pinch hit in the interest of western springers until a permanent appointment is made.—D.E.J.*

This column, written without time for news gathering, can most appropriately be a general survey of the

springer fancy west of the Ontario border. First, in Winnipeg is E. Chevrier—considered the dean of springer fanciers in Western Canada, a staunch supporter of both field trials and bench competitions and owner of the famous Anandale prefix that will always be associated with good springers.

While in Winnipeg, keep your eyes on our old friend "Scotty" Kynoch. With a large, excellently appointed training camp, he has turned out some exceptionally fine field dogs and when he puts a dog down in the ring you can be sure the best is being shown. Thoroughness might well be the watchword at Silverdale kennels and thorough is their training and showmanship.

Hazeldel Kennels, also in Winnipeg, are fast coming to the fore with the sort of competition and the quality of dog that keeps the rest up on their toes. They specialize in yard training and fault correction.

Now we come to Medicine Hat where Messrs. Armstrong and Currie keep that district conscious of springer quality. They both operate large kennels with the accent on springers and they really make their dogs hunt. ## DOBERMAN PINSCHERS

It will not be long before our Spring shows are under way, and a little training in ring manners on the younger dogs at this time will mean much when the time comes to take him into the ring. Posing and moving are two principal things in handling. The dog must move freely, soundly and with spirit or style even in a small or crowded ring. Keep his attention off the other dogs particularly when you have him posed or set up. Train him to stand still facing you, front feet turning neither in or out, ears erect by any means you can, hind legs set far enough back so that the high point is the withers or top of back over front shoulders. It is poor sportsmanship to let your dog wander over and sniff your competitor's dog after he has nicely set up and possibly the judge is going over him. Do not try to pose your dog too long at one time. He will get restless. In the ring wait until the judge is ready to go over your dog then set him up, and if you know the faults of your dog try and cover them up. A good judge will spot faults of the dog while moving and will not let you fool him in the set up. Many of the all-rounders are cranks on some particular thing such as back line, head,

tail set, depth of brisket, or markings which really is a minor fault, so if you can outsmart them that is O.K.

Mr. Glenn S. Staines of the famous Pontchartrain Kennels at Royal Oak, Mich., will judge Dobes at Buffalo, N.Y., late in February. Mr. Staines is recognized as the Dean of American Doberman breeders and has been active for seventeen or eighteen years. Following his usual custom the handlers and owners will be called to the ring and instructions given as to the setting up, moving, etc. This is a wonderful help especially to the new exhibitors. There will be no hanging the dog with a tight lead to cover up weak pasterns or flat feet. Following each class, if the owner wishes, their dog will be faulted and the good points of the other dogs pointed out.

Mr. H. C. McLeod, Beardmore, Ont., reports a litter of six out of his Lady and sired by Ch. Prince Zmitri of Starkanhart.

In the Championship Section of the January Kennel and Bench, a great dog was not given due credit for his quality. Troll v. d. Engelsburg, a Canadian and American champion, world sieger, twice German sieger, and twice winner of the Wander Prize, can truly be listed among the greatest Dobes of all time. In Canada his wins include best in show, London; best in group, Ladies Kennel Club, Toronto; best in group, National Kennel Club; best in group, Canadian National Exhibition; best in show, Toronto Kennel Club fall show; best of breed, Hamilton; and best in show, London fall show. And her record in the

United States is equally impressive. Her owner, E. Bornstein, of Peoria, Ill., one of the finest enthusiasts in the fancy, has kept track of Troll's progeny record and it is safe to say that no dog of any breed has come close to equalling it. In 1938 Sieger Show he established a world record for his progeny.

## AIREDALES

*Breed Editor,  
Mrs. W. H. Humphries,

I wonder how long it is since some of us read the standard of our breed! The average breeder sees a lanky, flat-sided dog, with poor quarters but a magnificent head and front, coat and colour, weighs the good points against the bad ones, turns the dog right down in his mind, refuses to use him, and mutters in his beard when some judge blandly puts him right up over dogs that beat him in body and quarters and fail to him a little in head and front. The usual wail is: "Modern judges only look at the front end of a dog". But will these ringside critics read the standard and prepare for the shock of their lives! Out of 100 points, coat and colour receive 25, head (including ears, eyes and mouth) gets 20, front (including neck, shoulders and chest) gets 10, body gets 10 only, while hindquarters and set of tail split 5 between them! The remaining points are 15 for legs and feet, and 15 for character and expression. Thus, the "front end of the dog" gets actually 30 points for construction, together with most of the 15 for character and expression. Add a good coat and colour, and 40% of the dog is covered before body, quarters, legs and feet are even considered. We may not be breeding along these lines ourselves, in fact the picture may be all against our own personal likes and dislikes but we cannot get away from it. There is the standard, adopted by the Airedale Terrier Club of America from the similar standard of the Midland A.T.C. of England. Some of those judges must have been right after all!

Some time ago, Mr. A. P. Mutchmor, who owned Ch. Clipstone First Shot and his dam, wrote me several interesting letters about inbreeding, pointing out how in other live stock breeding back and back again to prepotent blood had proved the only way

to fix type. His own warning was that only healthy specimens of perfect temperament should enter into such a programme, and that in our breed in particular, soft coats must be avoided like the plague. In Airedales, of course, almost any mating at all involves some inbreeding, it being next to impossible to find an absolute outcross, in any country. Every show Airedale, of any reputation whatever, goes back in tail-male to a dog described by those who saw him as "a very ordinary sort," Cragsman King, who once stood at stud at a fee of one guinea. This dog not only sired four exceptional dogs for his owner, but his grandson Int. Ch. Warland Ditto, proved to be the first and perhaps the greatest, of the post-war sires. In turn, Ditto's grandson, Clonmel Monarque, produced the full brothers, Clee Brigand and Ch. Clee Courtier, on whose blood the present-day Airedale is founded. Just because these two were brothers, and happened to remain in England until they died, while possible breeding competitors, e.g. Ch. Hornell Mixer, Ch. Hornell Rocket, etc. were exported, it is the exception to find any English-bred dog without cross after cross of their blood. Some of the Warland champions, that look like outcrosses to Courtier, at first glance, were bred from Brigand bitches. The famous litter brothers, Chs. Walnut Challenger, Walnut Commander and Ileene Lustre, were out of a Courtier bitch. Ch. Covert Dazzle, who is proving even greater as a producer than she was as a show bitch, was by Clee Brigand out of a Courtier bitch. Ch. Belfort Supreme was by Courtier out of a Brigand bitch. And so on, through the lists of champions! It was certainly lucky for English breeders that the owners of these two great brothers refused again and again to export them, and doubly fortunate that Walnut King Nobbler, who is surpassing his sire's record and can now be credited with sixteen champions, is another fixture in the Old Country.

### LIVE STOCK PEDIGREE ACT

The function of the Registration Office of the Dominion Department of Agriculture includes the administration of the Live Stock Pedigree Act and regulations of Live Stock Breed Associations operating under it. The details of pure-bred live stock recording require constant attention as to its effect in protecting breeders and customers. Improvement in live stock breeding involves systematic use of pure-bred blood. It is a fundamental point that the records of pure-bred animals be accurate and authentic, so that breeders and purchasers have the assurance that the certificates accompanying pure-bred animals are reliable. Infractions of the Act and regulations appear to be decreasing. Penalties are provided for improper registration.—*Publicity and Extension Division Dom. Dep't. of Agriculture.*

## THE SHOW CIRCUITS

With progressing winter and advancing spring, the show circuits of Canada and the Northern States will get under way this month.

Westminster starts the ball rolling and by the time this is published three thousand dogs in Canada and the United States will be groomed and ready for the greatest indoor contest of the year.

### BUFFALO

Buffalo's 15th annual All-Breed dog show under the auspices of the Kennel Club of Buffalo, Inc., will be held on Saturday and Sunday, February 25th and 26th, at the Broadway Auditorium. Early indications are that this year's show will be one of the largest and most elaborate in the history of the local dog club. Entries are certain to come from the four corners of the United States and Canada.

strings, as well as the usual class money of \$10, \$5 and \$2 for six or more entries and \$5, \$2 for three or more entries.

The Show will be staged in the Main St. Armory, proclaimed one of the finest buildings for Dog Show purposes anywhere.

### DETROIT

Detroit Kennel Club announces an innovation this year that promises to appeal to all exhibitors of pure bred dogs. This big show at the motor metropolis will be held March 4 and 5 in the spacious Convention Hall and will open the midwestern circuit. The Detroit show will be benched on the same lines as usual with liberal cash offerings in all breeds and more costly specials than ever in the history of the club. Convention Hall is spacious enough to bench the largest of indoor shows and it is all on one floor—a few minutes to any hotel.

# LOOKING BACKWARD

By JAMES D. STRACHAN

There may be little or no justification for looking backwards probably, unless the backward glance is made strictly for the purposes of taking stock of what has been accomplished successfully, or the odds and ends which have been started, and which have yet to reach the stage of completion. The New Year offers a seasonal excuse for such retrospection, and so we have decided to take time out to look things over in a general way. Our Golden Jubilee Year having spent itself and having become history in its own right, The Canadian Kennel Club, Inc., should now be sufficiently matured as to cash in to splendid advantage on its own past experiences. The pitfalls of yesteryear must now be made the stepping stones toward the higher levels of success for the present and for the future. In the writer's considered opinion it is greatly to be deplored that we have been frequently called upon to take cognizance of much that has had the appearance of suspicion, or distrust, or both, during the past several years, a condition which promises little or no abatement at the time this article is being penned.

The thorn which has pierced our flesh to the greatest depth has unquestionably been the remorseless matter of "practical and effective system of identification" as outlined in Sub-section (n) of Chapter 5 of the Live Stock Pedigree Act of 1932, but the sting of this thorn has brought in its ugly wake other matters of equally major importance, such as the set-up of the Live Stock Records in its relationship to the Department of Agriculture under the Live Stock Pedigree Act, and also, the relationship of the other twenty-seven Canadian Record Associations affiliated with the Canadian National Live Stock Records and functioning under the several amendments of the original Act, and including the newer Act of 1932. The problem of satisfactory identification and of the other matters referred to, being considered as "Before the Courts", so to speak, we must not take the liberty of discussing them at any great length here, so we will be content to observe that the "Stormy Petrel"—Identification—has been very thoroughly discussed and investigated, and as a result this issue may find its proper niche in the life of our organization at an early date.

The costs of membership in the foregoing matters of major importance added an appreciable load on the Club's finances during the last several months of our financial year. Ordinarily this extra load would not have caused any great concern, but coming as it did on top of our Golden Jubilee expenditures, the strain on the Club's bank balances became a matter of grave concern with the writer. This condition may be better understood when we say that our principal account was overdrawn at the Bank for the first time in twenty years. This should have been altogether unnecessary, as all matters causing us worry seemed to be in a fair way for adjustment. Identification was being whipped into conformity with the Act. Proper affiliations were in the process of investigation

and had been brought as near to desirable perfection as dependable persons could make them, therefore, it would possibly be an unfortunate miscarriage of justice if we allowed the proceedings of the Special General Meeting of members held at Vancouver on August Twelfth to be considered as our first hint respecting the alleged irregular relationship of the affiliations between the Records Office and the Department of Agriculture, and of the Breed Associations, to either or both. This situation was opened wide and frankly discussed at the Annual Meeting of the Canadian National Live Stock Record Board on March Twenty-third, Nineteen Hundred and Thirty-four, which meeting recorded as representatives from The Canadian Kennel Club, Inc., the names of Capt. H. Dudley-Waters and Dr. H. E. Batt. During the proceedings of this meeting, let us quote from the verbatim report of the meeting referred to. By doing so we will furnish lots of food for thought at this time:

"The Chairman: I think, Gentlemen, you have all received copies of the Constitution, which is the main business to come before this meeting, and that you had an opportunity to peruse it. We have had some correspondence from various organizations, some of which are represented here and some that are not, but we have not had any outstanding objections raised in connection with it.

"The big question behind the framing of this Constitution was that of bringing it up to date in order to comply with the Live Stock Pedigree Act 1932 passed by the Dominion Parliament.

"There had been some questions going through the minds of members of the Record Committee as to how the new Act would affect the status of the Canadian National Live Stock Records, and as to whether it would effect the 1931 Act and subsequent amendments. The Record Committee submitted to the Department of Agriculture for an opinion from the Justice Department a memorandum as follows:

"The Canadian National Live Stock Records was organized in 1905 by written agreement with the Federal Department of Agriculture, the nucleus consisting of seven pure bred organizations incorporated under the Live Stock Pedigree Act, 1900, R. S. 1906, Chap. 131. These affiliations continued from time to time up to 1912 when 22 organizations were operating under the Act and comprised the Canadian National Live Stock Records as of that date. The Act of 1900 was repealed and substituted by Live Stock Pedigree Act 1912, R.S. 1927, Chap. 121. These 22 organizations continued, together with the addition of five others, who also affiliated and functioned under the Act, until the Act of 1912 was repealed and was substituted by the Live Stock Pedigree Act 1932, 22-23 George V., Chap. 49. The organizations affiliated since the original seven, by the fact of their incorporation under the Acts mentioned, subscribed to the same conditions as the original subscribers.

"It may be noted that all the original seven organizations which be-

came affiliated in 1905 and all others have or are filing applications for new articles of incorporation under the 1932 Act.

"The Live Stock Pedigree Act has been repealed and amended from time to time for the better functioning of the affiliated organizations.

"Does the passing of the 1932 Act, section 14, alter the status of affiliated associations in their relationship in the Canadian National Live Stock Records as was constituted under the Act of 1912?

"Under Article 14 of the 1932 Act, does not the filing of an amended application for incorporation with the Department of Agriculture and approved by the Minister of Agriculture, constitute an application or affiliation?

"It is suggested that an interpretation be secured from the Justice Department and that in the interpretation written that the clause or clauses of the Interpretation Act under which interpretation is made be cited in order that it may be placed on file."

## CANADIAN NATIONAL LIVE STOCK RECORDS.

On the 2nd of May, the Deputy Minister of Justice furnished the following memorandum of interpretation to the Deputy Minister of Agriculture:  
Ottawa, 2nd May, 1934.

Sir,—

Re: Interpretation of Live Stock Pedigree Act, 1932—status of affiliated associations.

I have the honour to acknowledge receipt of your letter of April 11th putting forward two questions submitted by the Director of Canadian National Live Stock Records. I can see nothing in the Live Stock Pedigree Act, 1932, calculated to alter the status of affiliated associations in their relationship in the Canadian National Live Stock Records as constituted under previous legislation. The statutory body provided for, by section 13 of the Act of 1932 would appear in view of the provisions of section 14 of that Act, not to come into being until articles of affiliation drawn in accordance with section 13 have been subscribed to by the individual association and have been endorsed as approved by the Minister of Agriculture. Your letter does not set out as a fact that such articles have been drawn, subscribed to and endorsed; if not I would suggest that there is no occasion at this time for considering your second question.

For such interest as it may provide I am passing to you herewith copy of departmental memorandum prepared in this matter.

The members will be prepared to agree that the advice sent out from the Department of Justice could be depended upon to furnish the advice that would be tantamount to protective security. We repeat it, "I can see nothing in the Live Stock Pedigree

Act, 1932, calculated to alter the status of affiliated associations in their relationship in the Canadian National Live Stock Records as constituted under previous legislation."

The above ruling when read in conjunction with Section 1, **Record Board**, of the Constitution of The Canadian National Live Stock Records, which reads as follows. "The Canadian National Live Stock Records shall include the organizations originally incorporated under the Live Stock Pedigree Act, which affiliated by agreement and those organizations which have or may become incorporated and affiliated by provision in each approved constitution," could only add all the necessary confidence which remained to be indicated. Nevertheless, the matters of 'incorporation' and 'affiliation' have since become most active, if not actually acute, so much so, that at the time of writing the necessary adjustments, now considered necessary, have not yet been made. But in view of recent activities in Ontario, Quebec, and British Columbia, we deem it expedient to chronicle the following as a matter of membership information. During the early Summer of 1936, the then Board of Directors took action in respect to a complaint which led to the denial of Club privileges to the party complained against without allowing the privilege of a hearing. This incident developed rapidly and took on an importance which threatened to reach the Courts, and it was at this time that the matter of dependable 'incorporation' was challenged right in the Board Room by the Club's Honorary Legal Adviser, Mr. Peter Wright, who forcibly focussed the attention of the Directors of their then legal position in its relationship to the Live Stock Pedigree Act of 1932. So whatever has followed or whatever may yet be accomplished in due course in regard to 'incorporation', affiliation or both, credit must be directed towards the Club's Honorary Legal Adviser, who, as far as The Canadian Kennel Club, Inc., is concerned, is directly responsible for the revealing of whatever weakness may be found in our 'affiliation' foundation, all due respect to all other parties interested in our Club's welfare since Mr. Wright's clever and timely discovery. Because of member investigations, which were all so unnecessary in the writer's opinion, our several bank accounts were weakened most uncomfortably.

Just in case some member might be interested in knowing why the costs of the members' meetings at Toronto, Vancouver and Montreal should give us concern at this time, we would just mention several of the major charges against our 1938 income:

These figures represent a generosity that brought us within sight of our securities and when the additional costs for Special General Meetings came to be added, well, we were almost down to our securities. It would be literally correct to say, that the profits of this year's busi-

ness have been used up almost entirely in the interests of the Organization, whereas, some margin of profit should be as desirable as it should be essential, and it must be the problem for the 1939 officers to re-adjust the entire matter of Club expenditure, so that a healthy balance may be assured from year to year in the future.

With the matters, referred to, brought into alignment, and properly adjusted, the future of the Club should be harmonious and satisfying to all concerned and the Golden Jubilee Year will mark the line of demarcation between the first half century of the Club's existence and the more prosperous and pleasurable years, which we dare prophecy will mark the years still ahead of The Canadian Kennel Club, Inc.

spaniel "Busher Jackson"; George Kynoch's (Winnipeg) old English sheepdog, Champion "Silverdale Snowman"; Dr. C. A. Lambert's (St. Boniface, Man.) English setter, Champion "Manitoba Ruby"; F. G. Bell's (Winnipeg) chow-chow, "Chief Long Lance". W. H. Humphries, Richmond Hill, Ont., sent a couple of his aire-dale terriers to Western shows, and picked up forty-five dollars by winning three terrier groups with "Lamorna Proconsul" (2) and "Lamorna Northern Light" (1).

As we have already mentioned, Sid Perkins was the big winner in Ontario, and he unquestionably has earned the Crown of the Golden Jubilee Year. Other winners of twenty-five dollars or more were Mrs. H. Giddings, (Oakville, Ont.) with her sealyham terrier "Marine Brazen Marina", and Mrs. R. E. Lipe, Toronto, with her Boston terrier, "Lipe's Bonny Kaye".

Quebec suffered from scarcity of shows, and as a result her portion of the Golden Jubilee Year disbursements seem to be rather small when compared with the other participating Provinces. One all-breed show and one limited show made up the Quebec Show Calendar for 1938, so that only twenty-five dollars was won at Quebec shows. Of this amount, ten dollars went to Dr. L. A. Gendreau, Sherbrooke, with his smooth-coated dachshund, "Tucson von Mayndale", and fifteen dollars to W. E. Cooper, London, Ontario, with his bulldog, "Piccadilly Playboy". However, a dog from the province of Quebec invaded the Maritimes in J. T. McCallum's cocker spaniel "Thetford Kingley Tugson", collected the cream of the Bedford Kennel Club show, and incidentally the forty dollars in cash prizes which went with winning Best in Show, Best in Sporting Group and Best Bred by Exhibitor.

The Maritime provinces with five shows won one hundred and sixty-five dollars, but unselfishly shared it with a Quebec breeder as referred to in the preceding paragraph. A. V. Martin, Halifax, N.S., was the only fancier in the Maritimes who won twenty-five dollars or better. Mr. Martin won fifteen dollars at Saint John and a like amount at Halifax.

We could continue and account for every nickel of the one thousand, seven hundred and twenty-five dollars, but we must not impose on the good

nature of Kennel and Bench readers too much. As additional information, however, we furnish the following:

In the race for the one hundred dollars cash prize offered by The Canadian Kennel Club to the dog or bitch winning the most group classes during 1938, said dog or bitch to be owned by a member of The Canadian Kennel Club and registered in the C.K.C. stud book, the records show the following:

1st, Champion Melbourne Supremacy (pomeranian) 10 groups; 2nd, Champion Wembley Gold Shade (pomeranian) 6 groups; 3rd, Champion Kado Strelka O'Dolina (borzoi) 5 points; 3rd, Champion Silverdale Snowman (Old English sheepdog) 5 points; 3rd, Champion Rockley Riot Act (airedale) 5 points.

The other contestants have three points each or less. Each point represents a group class won.

The competition for the Ross-Miller Biscuit Co. Ltd. trophy was equally as keen, and the contestants stacked up as follows:

1st, Champion Rockley Riot Act (airedale) 27 points; 2nd, Champion Kado Strelka O'Dolina (borzoi) 26 points; 3rd, Champion Wembley Gold Shade (pomeranian) 23 points; 4th, Champion Melbourne Supremacy (pomeranian) 22 points; 5th, Champion Strathbogie Red Mac (Irish setter) 21 points.

Alphabetically, the Provinces put up the following interesting contention. For Alberta, Champion Dail of Travers, springer spaniel owned by W. Armstrong of Medicine Hat—14 points. For British Columbia, Champion Wembley Gold Shade, pomeranian owned by Mrs. E. Bradley, Vancouver—23 points. For Manitoba, Champion Silverdale Snowman, Old English sheepdog, owned by Geo. Kynoch, Winnipeg—16 points. For the Maritimes, Champion Maximus of Sunstead, springer spaniel owned by Frank Shute, Fredericton, N.B.—9 points. For Ontario, Champion Rockley Riot Act, aire-dale terrier owned by Sid Perkins, Toronto—27 points. For Quebec, Champion Thetford Kingley Tugson, cocker spaniel owned by J. T. McCallum, Thetford Mines—13 points. For Saskatchewan, Champion Busher Jackson, springer spaniel owned by C. W. Pollard, Regina, 9 points.

And so, having brought the Golden Jubilee Year's celebration activities into focus, we leave the picture in the hands of our members for their inspection, and we trust for their pleasure as well.

To those who possibly felt that their Golden Jubilee cheques were being kept from them too long during the past year, we crave indulgence, and plead only our intense desire to make sure that every win was found valid, and that when it was recorded, it would be beyond dispute. wrong"; so be careful.

### TRAILING TRIAL—65 points.

The points for trailing are awarded as follows: Picking up scent 10 points; accuracy, 10 points; speed, 1 points; barking game 30 points; protecting game, 5 points. It will be seen from this that the largest group of points go for barking the game. The reason for the surprisingly deep, powerful voice of the dachshund is now made clear. The dog has a peculiar "death-bark" or "totverbellen" which sounds the fate of the game from afar and calls the master to the kill.

The trail is laid by dragging the carcass of a rabbit or other such animal together with a container perforated with small holes, in which container the blood of the animal has been collected. This drag should be freshly laid for every dog to be tried if possible and if there are many contestants it is advisable to have two or three trails to avoid delays. The scent should be laid by a stranger to the dog and a good way to do it is to attach the carcass and container of blood to a line and pole. Pieces of paper should be dropped so that judges and onlookers can follow the

course with the eye. Trails should be about a mile long but this distance is not arbitrary. Special trail shoes and wheels for laying scent are often used in Germany but the simple method above outlined will suffice. It is a good plan to lay trails below a small hill so that spectators may have the fun of watching the whole procedure.

The carcass is hung on a tree at the end of the trail just within reach of the dog.

Only judges or stewards are permitted to approach the laid trails. The leader of the dog brings his dog up to a distance no greater than 150 feet from the start of the trail and unleashes him. The leader remains there, leaving the dog to exhibit his prowess. If the game is not found within one-half hour, the dog is disqualified. This time is based on the one-mile course. The time is adjusted by the judges to suit other conditions but it will generally be found that the dog is off like a streak of lightning.

On finding the dead game, the dog sets up a loud barking and the leader then starts off to his dog who barks continuously till he arrives.

A dog who tries to feed on the game is disqualified. The game is supposed to be protected until the master comes and the dog is correct in attempting

to drive off stewards or judges should they approach before his master.

Some dogs will return to the leader on finding the game and bring him back to their booty. This is not considered as desirable as staying in position and barking till the leader comes.

Three judges do the scoring for dachshund trials and their findings are averaged. In order to secure a high standard of performance dogs must, in order to win prizes, make the following minimum scores.

Burrow Work		Trailing	
	Points		Points
1st .....	25	1st .....	50
2nd .....	15	2nd .....	35
3rd .....	10	3rd .....	20

If the dog is entered in both branches of trial his minimum must be for 1st, 75 points; 2nd, 60 points; 3rd, 40 points. Leashwork is compulsory, of course for either or both branches of the trial.

Prizes are awarded according to the numerical standing always providing that it is at least the above minimum. In case of a tie, judges may consider condition, conformation and type.
