

We take pleasure this month in depicting, for our Terrier Issue, a head-study of the beautiful Miniature Schnauzer, International Champion Benrook Beau-Brummell. This outstanding young dog has compiled a sensational show record in both Canada and the United States. In his short Canadian show career he has twice been placed Reserve Best in Show and while gaining his American title obtained wins at the Specialty Show of the Miniature Schnauzer Club of America as well as Group Placings at All-Breed Shows.


His breeding combines the finest modern producing blood-lines in Miniature Schnauzers, his sire being the famous Ch. Dorem Display and his dam being Ch. Karen of Marienhof II. Among his kennel mates at the Cosburn Kennels is Yankee-Pride Kandy (Ch. Sandman of Sharvogue ex Ch. Meldon's Medley) who will shortly be bred to "Beau".

He is owned by Mr. and Mrs. W. Gottschalk who are also well known for their splendid Boston Terriers. He was handled in Canada by Mr. Ted Ward of Clarkson and in the United States by his son, Mr. George Ward of Birmingham, Michigan.

IDENTIFICATION ...

As our members and other breeders have been informed, positive identification of a dog will be required before registration of that dog will be possible. The Club's Constitution presently provides for two methods of identification, i.e.: a statement of colours and markings, and tattooing. Information about these methods appears hereunder and breeders wishing further information may address inquiries to the Canadian Kennel Club, Toronto.

COLORS AND MARKINGS




For many years it has been sufficient for a breeder, when completing an application for registration of an individual dog, to merely state the colours briefly, such as "black, white and tan". This brief description is no longer acceptable for registration purposes. A statement of colour and markings will be acceptable for registration purposes providing such description will establish positive identification. The following descriptions will serve as a guide to those using this method:

White; spotted black ears and jaws, black patch on right shoulder and back, two black spots on right side and black spot on left ribs, black spot on base of tail; ticked.

Liver and white; white stripe on forehead; liver on right side of head extending over ear and eye, liver patch on left side of neck, over left shoulder, on top of rump and left flank; tail liver, tail tip and parts of body ticked.

In describing the location of markings the correct canine terminology should be used, and to assist breeders towards that end, the illustration at the left is published.


TATTOOING




Tattooing is a method of identification presently provided for in the Club's Constitution. A dog may be tattooed on its ear or ears, belly, flank or lips. The required markings consist of the identification letters allotted the breeder or owners by the recording office, a serial number, and a yearly identification letter which denotes the year in which the dog was born. The tattoo markings shown in the illustration at the left were made in 1938, but had the dog been tattooed under the existing tattoo regulations, the markings would have appeared as AE5S rather than AES5 as shown in the illustration. The letters AE indicate the breeder or owner of the dog, the numeral 5 indicates that it was the fifth dog tattooed by the breeder or owner in that year, and the letter S indicates that the dog was born in 1938. Information on tattooing appeared in a printed pamphlet distributed to members early in November. Additional copies of this pamphlet are available without charge to members or other breeders desirous of obtaining a copy. Write the Club's Toronto office. Instructions on tattooing may be obtained by writing manufacturers of tattooing equipment.

Other methods of identification have been suggested and so that the practicability of these methods can be considered by the members for possible inclusion with the presently permitted methods, information about these methods (noseprinting, charting and photography) follows. As will be noted elsewhere in this issue, a proposed amendment in respect to identification has been submitted for the consideration of the members attending the next Annual General Meeting to be held on February 8th, 1950.


NOSE PRINTING





In 1939 the Club's Constitution provided for nose printing as a method of identification. The enlarged illustration at the above left is that of a six-year-old Wire Fox Terrier's nose print. The enlarged illustration on the above right is that of a three-months-old Great Dane. In principle, nose printing is the same as fingerprinting. Fingerprinting is the most dependable method of identifying humans.

CHARTING



A suggested method of identification known as "charting" is well known to breeders of racing and coursing Greyhounds and is also used by at least one other live stock association in Canada. The illustration at the left indicates an outline of a dog on which markings have been drawn. The right side only of the dog has been shown, but the same procedure would be followed in indicating the markings on the left side of the dog. When used some years ago by breeders of dogs, the method required the breeder to provide two charts of each side. One chart of each side was adhered to the certificate of registration, the second copy being retained in the recording office.

The grid lines are used by the breeder to assist him in the correct placement of the markings that run from one side of the dog to the other side.

PHOTOGRAPHS

Photography is a method used by at least one cattle association in Canada but, like charting, it has its limitations in that it can only be used where photographs will establish positive identification, i.e. where a dog has definite markings which



will show up in photographs. Such photographs need not be of the expensive variety, but can be snapshots taken with an ordinary camera. The method as used elsewhere requires the applicant to provide four photographs of the animal about to be registered (two of each side). One photograph of each side is adhered to the reverse side of the certificate, the second copies being retained at the recording office.

The illustrations of the right and left sides of the Pointer shown under this heading would undoubtedly serve to identify the particular dog represented.



THE FORUM

This is the first of a series of articles dealing with canine government in other countries. As we are so closely interested in the American Kennel Club the following brief outline of their procedure is given.

A T one time, dogdom on the North American continent was controlled by one organization, the National American Kennel Club, and some of our show-giving clubs in Canada were members of that organization. The American Kennel Club was organized in 1884 with representation from Canada on the Board. It was not until 1887 that the Canadian breeders decided there were sufficient of their number to form a club of their own. Thus the Canadian Kennel Club had its beginning as a member organization, just as it is today.

As reported in the October, 1948, issue of Dogs in Canada, three of the men who voted the American Kennel Club into being on September 17th, 1884, were from Canada. They were representatives of the Montreal Kennel Club, the New Brunswick Kennel Club and the London Kennel Club.

These organizers were the first actual members of the American Kennel Club. Individual membership was not considered feasible and in place of this established Kennel Clubs and Breed Clubs were accepted as members, with the right to appoint a delegate as a representative to attend the meetings and assist with the business affairs of the Club.

The first Specialty Club of a breed becomes designated as the parent Club and from this parent Club various other Specialty Clubs of that breed receive guidance. There are also the All Breed Clubs which appoint a delegate to represent them at the meetings of the American Kennel Club. Once these delegates of the member clubs are appointed they act on behalf of not only their own individual clubs but all prospective clubs which wish to become members of the organization. From these elected delegates, a Board of Directors is formed to conduct the affairs of the American Kennel Club. There are twelve members on this Board and each year three members are elected for a four-year term. As only three are elected each year it can readily be seen that there is little change in the actual Board from year to year, and as the Directors are elected in advance one knows who will be on, say three years from now.

This Board of twelve persons elects the Executive Vice-President, the Executive Secretary, the Secretary and the Treasurer. The President is selected from one of the Board of Directors. While the Board of Directors meets each month, the club delegates meet quarterly to adopt needed legislation which is prepared for submission by the Board of Directors.

Notice of any change in legislation is published in the American Kennel Gazette three months before it is considered by the delegates, in order that a cross section of the opinions of the dog fanciers across the United States may be considered. This is in direct contrast to the Canadian method where changes can only be made once a year at the Annual meeting.

A Club or Association must have held at least three Dog Shows or Field Trials in consecutive years under the rules of the American Kennel Club before its application for membership can be considered by the Board of Directors and by the delegates at the quarterly meeting. Specialty Clubs must have been formed for the improvement of their breed and the parent club of that breed must consider the application and give their consent before the said club may apply for membership. These Specialty Clubs, working in conjunction with their parent club, may make application for changes in the breed standard. In order to be democratic, all proposed changes, applications, etc., are published in the American Kennel Gazette before being referred to the Board of Directors of the American Kennel Club for approval or disapproval and all letters sent to the Board of Directors of the American Kennel Club for and against candidates, etc., are considered privileged communications, the contents of which are not disclosed. In this way, it will be seen that the breeders and exhibitors of pure-bred dogs in the United States are an integral part of that organization. Any proposed amendments or changes can be discussed at the individual club meetings and the delegate then goes to the American Kennel Club meeting to express the views of those he represents.

An admission fee is charged to all new clubs applying for membership and Annual Dues are paid by the member clubs each year. The American Kennel Club is the governing body for registrations and bench shows. All purebred dogs born in the United States must be registered in the American Kennel Club before they can be accepted for registration in the Canadian Kennel Club. There are, however, other organizations in the United States which register pure-bred dogs, the most prominent of which is the American Field which registers sporting dogs and publishes a Stud Book which not only gives the pedigree of the dogs, but also their performance in the field. The National Coursing Association which registers greyhounds, also has an authentic Stud Book which is accepted by the American Kennel Club. For many years, the Greyhound Associations have used the charting system as a means of identification.

The procedure for applying for dates under which to hold a dog show or Field Trial is similar to that of the Canadian Kennel Club. Member clubs or associations are entitled to hold one show and one Field Trial a year without payment of a fee, but non-member clubs or associations pay a license fee for each show which is held.

Bench show rules are similar to those in our country and we endeavour to publish any changes of importance to Canadian exhibitors in the Forum of Dogs in Canada.

Sometime ago we mentioned that the American Kennel Club had proposed the abolition of the "limit class" and the substitution of a "bred by exhibitor class". A motion covering this change is contained in the Agenda for the Annual General Meeting of the Canadian Kennel Club in February, 1950.

At the December meeting of the American Kennel Club, the new ruling was brought before the delegates for discussion and approval. As a result of that discussion, the new ruling regarding this class reads as follows:

"'Bred by exhibitor class' shall be for all dogs excepting Champions, six months of age and over which shall be presently owned and exhibited by the same person or kennels who were the recognized breeders on the records of the American Kennel Club".

The change from the original proposed ruling is that the sentence requiring that the dog be shown by a breeder or a member of his family has now been deleted. All that is necessary for a dog to qualify for the "bred by exhibitor" class is that the dog is owned and exhibited by the breeder. It is immaterial who handles the dog in the ring.

Another ruling which should be of interest to the exhibitors at the dog shows is the number of dogs to be judged by one person during a show. The ruling now reads as follows:

"This schedule shall be based on the judging of not more than an average of 25 dogs per hour by each judge, during the advertised hours of the duration of the show, with a total assignment in the breed classes for any one judge of not over 150 dogs in one day".

The above information is passed on to our readers in order that they may be kept up to date on the changes which are made at the American Kennel Club shows.



Terrier, but there the similarity ends, as the Cairn is definitely a dog whose history is so steeped in antiquity that the historians become confused when they endeavour to link it too closely to the Skye Terrier, also a native of the Isle of Skye.

The earliest mention of the Cairn Terrier is that it was introduced into England at the time of the Battle of the Spanish

This breed had been used by the Scots to prey upon the otter and rodents. Developed by selection for the "bolting" of otters, foxes or badgers, it was not intended for actual combat with them, but merely for expelling these animals from their homes. As most of the wild animals referred to were considerably heavier in weight than the Cairn Terriers, it was necessary that the dogs should have sufficient pluck to hold their own in case it was necessary to enter into conflict. From these requirements necessary to enter into conflict. From these requirements necessary for a working Terrier, there developed the smart dog of today which has endeared itself to the public without becoming a lap dog. Its general appearance is that of an active, game, hardy, small working Terrier of the short-legged class; built with a medium length

and wider than any other terrier and well furnished with hair giving a general foxy expression.

THE WEST HIGHLAND WHITE TERRIER

As with all breeds of dogs, the fanciers in their efforts to set a standard, make rules and regulations which must be followed, so standard, make rules and regulations which must be followed, so when occasionally white puppies were born in litters of the old-fashioned Cairn Terriers, they were given away as pets. However, the white puppies, having all the characteristics of their coloured brothers and sisters, met with a friendly reception until the idea came about of collecting them and propagating a breed distinct unto itself. At first they were known as the Roseneath Poltalloch, but later as they became more popular, they were named West Highland White Terriers. Possessing all the characteristics of the Cuirn Terrier, they are becoming extremely popular, both as pets and as good, sporty hunters in the woods.

The general appearance of the West Highland White Terrier is that of a small, game, hardy-looking Terrier, possessed with no small amount of self-esteem.

Congratulations to Mr. William Semple of Regina, Saskatchewan, and Mrs. F. Yeigh McEachren of Caulfield, B.C., whose dogs have been awarded the W. H. Pym Medal and the James D. Strachan Memorial Medal respectively as the dogs of the year.

The W. H. Pym Medal is awarded to the Wire Fox Terrier, Champion Stra'ven's Simon as the dog winning the most Best in Show awards during 1949. Bred and owned by Mr. William Semple, this dog won four Best in Show All Breeds. This award was open to all dogs whether Canadian-bred or imported, and we are indeed pleased to note that Ch. Stra'ven's Simon is a Canadian-bred dog.

The James D. Strachan Memorial Medal is for the dog winning the most Best Canadian-bred in Show All Breeds during the year. This was won by the Kerry Blue Terrier, Int. Ch. Kenmare Masterpiece with seven Best Canadian-bred in Shows during the year. Bred by Mrs. S. Spiker of Hamilton, Ontario, and owned by Mrs. F. Yeigh McEachren, this Kerry Blue Terrier is now being readied for the Westminster Kennel Club Show at Madison Square Gardens, New York.

It is a long jump from Newtonbrook, Ontario, to South America, but in these days of air travel it is but a short journey. George Getty has sent six of his Collies to the Minister of Agriculture, Republic of Columbia, South America. Another female Collie is due to follow later after she has been bred.

Shipping instructions for these dogs are quite interesting, in view of the fact that what is required for identification purposes is photographs of each individual dog, these photographs to accompany the dogs and also be attached to the export certificates.

From Westminster Beach, Long Island, comes word that the Labrador Retriever, Field Trial Champion Marvadale Black Gum, owned by Paul Bakewell III, won the National Retriever Trials. It was necessary to run extra series after the ten regulation classes before the winner could be selected. The closest performances to the win were made by Field Trial Champion Spider of Kingswere and Field Trial Champion Ready Always of Marienhill. The latter won its Canadian Field Trial Championship at the York Retriever Trials last summer.

We are quite interested in the achievement of F.T. Ch. Marvadale Black Gum, as one of his sons, Deer Creek's North Wind II, now owned by Mr. H. V. P. Lewis of Toronto, Ontario, won the Derby Stake at the Illinois River Field Club at Dundee, Ill. Amongst those he defeated was the winner of the Country Life Trophy, also one of

the top Derby winners in the United States.

On November 30th, 1949, a new Act was substituted for the Live Stock Pedigree Act, 1932. As the Canadian Kennel Club is incorporated under the pure-bred Live Stock Records Association, the readers of Dogs in Canada will be interested to know of any changes which were made.

Primarily, the intention of the new Act was to simplify the procedure for incorporation and affiliation of Associations; to clarify the authority of affiliated Associations in their relationship with the Canadian National Live Stock Records, and we will endeavour to explain what changes were made between the old Act and the new Act without becoming too technical as regards the Canadian Kennel Club.

A new provision was made regarding the rights of the Associations in their disciplinary actions against members. under the new Act,

"Notwithstanding anything in the by-laws of an association incorporated under this or any other Act mentioned in paragraph (b) of section two, no person shall be deprived of the right to register or transfer purebred live stock unless he has violated or is reasonably suspected by an association to have violated

 (a) a by-law of an association relating to eligibility for registration, establishment of production credentials or payment of fees,

(b) section sixteen or section seventeen of this Act, or

(b) any provision of the Animal Contagious Diseases Act or the regulations thereunder relating to the identification, marking or testing of animals."

Section sixteen mentioned above was previously sub-section two of Section 4 in the old Act, and section seventeen is a revision of the same section in the old Act.

Under section ten the authority of the Minister of Agriculture is enlarged in that,

3. "The Minister may at any time conduct an inspection of private breeding records, of the adequacy of the system of identification practised by an association and of the manner in which the system of identification is being practised.

4. "The Minister may authorize an officer in the Department of Agriculture, who shall be known as the Chief Registration Officer, to approve certificates of registration under this section on behalf of the Minister."

Section fourteen makes provision for registrations by unincorporated Associations. Once the Associations have become incorporated, they may apply for transfer of their property and funds.

As stated before, the above is but a brief résumé of the important changes made. If the members have a copy of the Constitution which was sent to each one in 1947, they will find therein a copy of the Live Stock Pedigree Act to which they may refer when noting the above changes.

1460 (1443). IDENTIFICATION

REPORT: The President reported that:

(a) Pursuant to the decision of the Board, an effort had been made to obtain an interview with the Minister of Agriculture re the situation in respect to identification and the stoppage in the issuance of certificates of registration;

(b) He had been informed that the Minister was in western Canada and the Deputy Minister, being overseas, was likewise not available;

(c) He had therefore arranged for representatives of the Club to meet with Mr. N. Young, Director of Production Services, the division of the Department of Agriculture most concerned with the duties and responsibilities of the Chief Registration Officer and his staff:

(d) A Club delegation consisting of Vice-President Walter Brown, the Secretary-Treasurer and himself had met with Mr. Young, Mr. MacVannel, the Chief Registration Officer, and Mr. Steele, the Associate Chief Registration Officer in Ottawa on October 31st.

(e) The Club's representatives had stressed the inconvenience and embarrassment which many breeders were experiencing because of their inability to obtain certificates of registration, particularly for dogs which had been sold and delivered;

(f) Mr. Young had, on behalf of the Department, clearly indicated that a simple statement of color or color and markings was not suitable identification, within the meaning of the Live Stock Pedigree Act, unless that description made it possible to definitely identify the dog being registered from other dogs of the same breed, and some other method or methods of positive identification would have to be practiced (where a clearly stated description of color and markings would not establish positive identification) in order that the provisions of the Act, a federal law, would be complied with;

(g) The Club's representatives had pointed out that on two occasions registrations were stopped without warn

breeders so that they combined the saw fit:
Under the chairmanship of Mr. Young the situation was discussed under the following main headings:
(i) The principle of identification as referred to in the Act, and the meaning of "identification" as interpreted by the Department:
(ii) What should be done with all those applications being held in abeyance in the Live Stock Records

being held in abeyance in the Live Stock Records office;

(iii) What are to be the identification requirements of the future;

The Department's intention to require that its interpretation of "identification" be observed being clear, the Club's representatives had suggested that all applications on file should be dealt with as before, that reasonable advance notice of the new regulations should be given all breeders, and the new regulations apply to all dogs whose applications for registration are received at the Live Stock Records office after January 1st. 1950; The Department's representatives did not indicate any intention to compel the practice of any specific method or methods of identification, nor was there any discussion which would serve to indicate that the Department would not approve any methods of positive identification that would enable compliance with the law; The discussion ended on the understanding that Mr. Young would discuss the matter further with Mr. J. G. Taggart, the Deputy Minister of Agriculture (who was then on his way back to Ottawa from overseas), and if

Mr. Taggart approved the Department would make possible the issuance of certificates for all applications being held in the Live Stock Records office, the existing continue to the end of the year, and the new identification requirements would become effective on January Ist, 1950, for applications for registration reaching the Records office after that acts office but before leaving Ottawa he had suggested to Mr. Young by telephone, that the new regulations apply to dogs BORN after January 1st, 1950, and Mr. Young had agreed to refer this suggestion to the Deputy Minister.

(m) In mediately on his return to Toronto he addressed to the members indicating what had been done to remedy the situation in respect to identification;

(n) After his message to the members had been prepared and mimeographed a telephone call from Mr. Young had the suggestions advanced by the Club's representatives, with the result that he had addressed a further message (dated November 3rd) to the members, both messages (dated November 3rd) to work the subject of the same time; the subject of the same ti

should develop confidence and support for our administration."

The Secretary read a letter, dated November 10th, addressed to the President by Mr. J. G. Taggart, Deputy Minister of Agriculture, in which Mr. Taggart indicated that Mr. Young's letter of November 5th was in general agreement with his own ideas on the subject of identification, and stating that he thought that dog breeders would find it a decided advantage from both a breeding and selling standpoint when all pure-bred dogs are identified in accordance with regulations.

DISCUSSION: The President pointed out that there appeared to be a misunderstanding prevalent amongst the Club's members to the effect tattooing will be the only system of identification available to dog breeders after January 1st, and expressed a view that a message should be addressed to the members correcting that belief. The President read a short message which he suggested be sent to members as soon as possible.

RESOLUTION: It was regularly moved by Director Riedel, seconded by Director Boughs:

"THAT, a copy of the proposed message read by the President be sent to all members." Motion carried.

DISCUSSION: The President suggested that with the general meeting but a short time away, steps should be taken to make it possible for the members attending that meeting to increase the number of methods of identification available to breeders and owners. He expressed the view that the prompt submission of a proposed amendment calling for a revision of the section dealing with identification would enable the Board and the members to give consideration to other methods of positive identification so that at the general meeting the members could reach a definite decision on a variety of methods which they believed would enable compliance with identification requirements.

DISCUSSION: In discussing this communication it was pointed out that:

(a) The Canadian National Live Stock Records had nothing to do with the situation in respect to identification, it being solely a matter between the Club and the Department of Agriculture;

(b) The principle in respect to identification applies to all associations incorporated under the Live Stock Pedigree Act regardless of where or how their registration records are maintained.

1461. LETTER FROM MRS. LORNA LACKSON

She read a letter from the American Kennel Club, which stated that although the parents of her dogs were not A.K.C. registered, the registration of the individual dogs would be possible providing three complete generations of known pedigree were

available for each dog and providing each dog was credited with ten or more championship points in its show records. Mrs. Jackson stated that because of the expense involved it was not her wish to campaign those dogs at American shows, and enquired whether or not the Board or the Registration Committee could take any action which would make registration of her dogs in Canada possible.

ACTION: After discussion it was suggested that Mrs. Jackson turn over to the Secretary all documents, printed matter and photographs for review, and that in the meantime arrangements be made for the inspection of the three dogs.

A breeder or owner shall have the choice of the methods outlined in this Chapter but it must be distinctly understood that the Club and/or the federal Department of Agriculture has the right to decide whether or not positive identification in each instance has been sufficiently well established to justify the issuance of a certificate of registration.

METHODS OF IDENTIFICATION: (a) COLORS AND MARKINGS. A complete statement of the colors and

markings of a dog will be accepted as a means of identification providing the statement will establish positive identification and identify that dog from others of the same breed. All colors and the location of markings must be stated on the application for registration form.

(b) TATTOO MARKINGS. On application to the recording office a breeder or owner will be allotted identification letters for his exclusive use in tattoo marking dogs for registration purposes. Tattoo markings will be accepted as a means of identification only if regulations in respect to tattoo markings, as adopted by the Board of Directors, are fully observed. Each application for registration must show, in the space provided for that purpose, the tattoo identification letters allotted to the breeder or owner, the serial number and designating year letter. The location of the tattoo markings on a dog shall be of the breeder's or owner's selection.

(c) NOSE-PRINTS. On application to the recording office a breeder or owner may obtain nose-print paper and fingerprint ink, as approved by the Club, for the purpose of identifying dogs by the nose-print method. Two nose-prints, on regulation forms, must

accompany the application for registration of the dog. To be acceptable each nose-print should be clear and distinct.

(d) PHOTOGRAPHS. A breeder or owner may submit, along with the application for registration of a dog, two photographs of each side of the dog. This method will only apply to dogs having markings where the use of a photograph will establish positive iden-tification. The reverse side of each photograph must state the name of the dog as shown on the application for registration, the date of birth, name of the sire and dam, and the signature of the person making application for registration.

(b) When hounds have been laid on a line, or have harked into the pack, the duties of the handlers shall cease until further instructions are received from the Judges or Marshals.

3. The hounds entered in each stake shall have affixed to their sides a number with a durable paint to be clearly visble and to be at least 3½ inches in height, starting with the number one (1), in no case shall a letter or the number zero (6) be used. The secretary of the club to be the only person to record these numbers and have them correspond with the name of each hound entered. Judges and marshals not to be present when the painting and recording of hounds is taking place. Ten minutes to elapse after the last hound has been painted before casting bounds. Hounds to be painted in the field if possible. From this time on, every hound is to lose his identity and only to be spoken of by his number.

4. Two judges shall be used to judge classes up to 25 entries and one additional 10 entries or fraction thereof. This means three judges would be required for from 26 to 35 entries; four for from 36 to 46 entries, etc.). These additional judge is to be required for each additional 10 entries or fr

IT is strange how few see the good points in a dog. The majority always emphasize the faults. Dr. McCain and his wife stayed with us on their way to Eastern Ontario Collie show and he was one that could see the good points that he wanted to incorporate in his breeding. This is the way of a great

Eastern Ontario Collie Club want separate points for colour and to make it more difficult to make cheap champions. One way is to compel them to have at least two three-point wins. That is all right in Ontario and Quebec but then when we go to the far west or the far east, we have to consider their smaller entries. As far as separate points for colour-a good collie is a good collie, no matter what his colour.

"Stepping out of my character," as the actor on the stage says, and mentioning my own dogs. I am going to refer to the tail pedigree published in the last issue of Dogs in Canada of one of our collies. Many people have phoned me to explain. In the passing of Walter Pye of Windsor, we have lost a very enthusiastic breeder. He will best be remembered as having the winning pup in the Sweepstakes at Guelph last spring.

Don't let any person tell you we are not breeding as good collies in Canada as anywhere. This is somewhat of a record. George Getty sold two females and four dogs to the Minister of Agriculture of Colombo, South America for \$1,565. This is not "eye wash."

Hedley Hull wants to eliminate the limit class. I could never see any advantage in having so many classes. I would suggest two puppy classes, Novice, Canadian bred, Open sable or sable and white, open tri-colour, open blue merle and any other colour. It will save the clubs buying so many ribbons and as we said before save the judges a lot of time.
