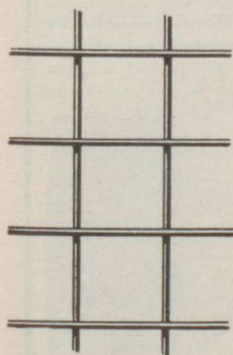

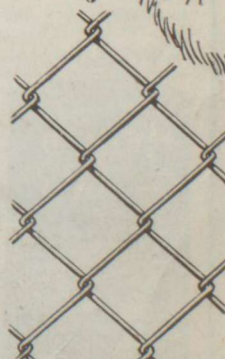

OUR COVER

The charming lady with the Great Danes on our Front Cover, this month, is Mrs. David Fingard, formerly Mildred Blanche Beattie of Detroit.

The dogs shown are: Champion Fingard's Odin, bred by Mr. Fingard, which was adjudged Best of Breed at Buffalo Great Dane Specialty Show in what was considered the largest entry of Danes in the history of Western New York State. He is the grandsire of many of Canada's Great Dane Champions including Ch. Kindon Chloe, a Best in Show All Breeds winner.

The dog next to Odin is Champion Fingard's Joe L, which is the sire and grandsire of many Great Dane Champions. Looking at Champion Joe L. is Champion Fingard's Duchess II, which won Best of Breed at the International Kennel Club of Chicago Show. Duchess has also won many Working Groups and Reserve Best in Show All Breeds. Recently, she whelped a litter of puppies sired by Champion Fingard's Count, the double Best in Show All Breeds Winner featured on last November's Cover of Dogs in Canada.

The two puppies shown on our Front Cover are now living in Johannesburg, Transvaal, South Africa, where they are giving a good account of themselves at the dog shows.

Mr. Fingard, who is believed to have bred more Great Dane Champions which in turn have produced Champions than any other breeder of Great Danes in Canada, has several promising puppies which will be ready for the show ring this year.

The Westminster Kennel Club Show 1950

THE 74th Annual Dog Show of the Westminster Kennel Club, held at the Madison Square Garden, New York City, was enjoyed to the utmost by a party of thirty Ontarians who flew to New York via T.C.A. on Sunday morning, February 12th. The weather was ideal and the trip, which took less than two hours, was thoroughly enjoyed by all aboard the "North Star".

The Specialty Shows were the first points of interest. After seeing the Boxer and All Terrier Show, we left for the Henry Hudson Hotel, where the Boston Terrier Club of New York was holding its annual Show. The Canadians found that no make-up of any kind was allowed on the dogs according to A.K.C. ruling so were able to relax and enjoy the show.

On Tuesday morning we were the guests of the Gaines Dog Research Center at a breakfast in the Hotel Taft, when the results were announced of the nation-wide poll to determine dogdom's most outstanding Man and Woman of the Half Century. Mr. George F. Foley, of Philadelphia, and Mrs. Geraldine R. Dodge, of Madison, N.J., were awarded the honours.

Mr. Foley, America's veteran dog show superintendent, was voted the honor because of his earnest and consistent efforts in elevating dog shows to their present high standard of efficiency, importance and organization, and for his contributions to the betterment of all dog interests and in promoting the purebred dog. He has been managing shows since 1902, and as spectator and exhibitor he has been at every Westminster Kennel Club show—of which he has been manager since 1928—for more than 50 years.

Mrs. Dodge, famed as "the first lady of American dogdom," has long been the great friend of dogs and dog folk in many fields of activity. She has helped incomparably in popularizing many breeds and in promoting dog welfare in general, and by her sponsorship of the Morris & Essex Show has made possible the world's most important outdoor dog event.

In this poll Mrs. Dodge was also voted Dogdom's Woman of the Year 1949—this is the second year in succession she has won the honor—while the Dogdom's Man of the Year honour fell on the shoulders of Capt. Will Judy, of Chicago, editor of "Dog World" magazine and founder of National Dog Week, for his sincere, continuous and helpful work on behalf of purebred dogs and "the dog game" as a whole.

John P. Wagner, of Milwaukee, who last year won the Dog Breeder of the Year award, won the same honor this year, as did Phil Marsh, of Fort Wayne, Ind., who repeated on the Dog Handler of the Year title. The former is the owner, and the latter the handler, of Ch. Mazelaine's Zazarac Brandy, who went best in show at the 1949 Westminster. Under the rules of the poll, any person who wins a poll title three times is automatically ineligible for future awards in his category.

Dog Judge of the Year: Mrs. Beatrice H. Godsol, of Canoga Park, Calif., for her knowledge of the breeds, her careful judging and gracious and charming manner in the show ring.

Dog Writer of the Year: Henry P. Davis, of Bridgeport, Conn., because of his successful completion of the mammoth work "The Modern Dog Encyclopaedia," and for his keen interest in and fine magazine writing on bench show and field dogs.

On Tuesday, we visited the American Kennel Club, where we met Mr. John Neff, the Executive Secretary, and Miss Phyllis B. Everett, Secretary. We then went to the Garden to chat with Mr. W. P. of Calgary, were comparing the New York weather with that of Western Canada and by all accounts New York was winning, as it was pouring with rain.

Dr. J. A. Campbell, who is most interested in our identification problems, was looking at the identacode method of identification as used by Blanche Saunders of Obedience Trial fame, on her French Poodles. Mr. H. L. Walley was seen renewing acquaintance with the beautiful Scottish Terrier which he had sold to Mrs. John Winant. Incidentally, the sire of Mr. Walley's dog was the winner of Best in Show at the Garden. Sam Foster, of the Canadian National Exhibition, was looking for judging talent for the next big dog show. Mrs. Eileen McEachren flew in from Vancouver.

THE ENGLISH SPRINGER SPANIEL

Description and Standard of Points

FOREFACE—Nostrils well developed, soft, liver color or black, according to color of coat. Muzzle deep, with plenty of upper lip and flew. Jaws good length, straight, fairly square, neither under nor overshot. Nicely chiseled below eyes.

Skull—Should rise from foreface without a pronounced stop. Skull of medium length and fairly broad. From the stop the median line, or groove, continues backward to the front of the sagittal crest (forehead) forming two slightly rounded halves above the eyes. Eyebrows and temples well developed, not thick in cheeks. Top of skull flat from forehead to occiput and slightly rounded on sides and back; occiput not domed; the top of occiput bone should be rounded, not pointed or angular in contour.

The resulting appearance is the head of medium length, fairly broad and slightly rounded, with a well defined stop effect—well chiseled under the eyes and free of cheekiness—with a strong, lean, fairly square jaw and well muzzled with plenty of lip, but not too thick or pendulous as in the hound, even set teeth, and well developed nostrils—an impressive head without being heavy. A ponderous head is objectionable.

Faults—Oval skull; cheekiness; too much stop which gives Clumber expression. Too heavy appearing head.

Eyes—Neither too full nor too small; medium size; not prominent or sunken but well set in, not showing haw, of an alert and kindly expression. In color dark hazel, brown or nearly black, harmonizing with the coat.

Note: Seldom darker than dark hazel in the liver and white.

Faults—Light yellow eyes, or eyes showing much haw, should be penalized.

Ears—Lobular, long and wide, set on not higher than in line with level of eye, flaps hanging close to cheeks, well covered both inside and outside with fine feather, which should not be curly. The leather should not be longer than to reach to the tip of the nose.

Faults—Ears off line of level of eyes, or set too far back on head.

Neck—Moderately long, strong and muscular coming out of shoulders rather full and tapering to the head, slightly arched and free from throatiness. "A springer grasps with the teeth, but weight is borne by the neck."

Faults—Too short, or ewe-like; set into head too heavily, causing throatiness.

Brisket—Not too wide so as to interfere with the free action of the forelegs, but well developed and nicely rounded.

Shoulders—The blades wide, strong and sloping, well set back forming a strong and powerful upper arm, muscular without being mutton shouldered.

Faults—Straight shoulders or mutton shoulders, which cause the dog to be paddle gaited.

Body—The chest deep and well developed, with plenty of heart and lung room, but not too round or wide. Walls of chest deep with well sprung ribs. Back from withers to root of tail equal height at shoulder. Back should be strong, straight—never sway-backed. Strong loins, with hips nicely rounded, slight arch over loin and hip joints, thighs broad, well developed and muscular. The hind quarters giving the appearance of great driving power. Rump slightly sloping to base of tail, belly nicely curved from chest to flank, but not in any way "tucked up".

Faults—Sway back. Ribs too round, too flat or too shallow. Too long body or loosely coupled body. Too high rump.

Legs—Forelegs, elbows well let down, setting close to the body, with free action from the shoulder. Forearm straight, with the same degree of size to toes, with slightly flattened bone and muscle. Wrist, sometimes called the "knee", straight and almost flat. Pastern short and strong. Feet strong and compact, with good strong, round pads, well feathered between toes. Wavy feathering of moderate heaviness down to pastern.

Note: When viewed from the front, Springer should be straight from shoulder to foot, elbow close to body and knee bending neither in nor out.

Faults—Crooked legs. Too light bones. Splay or hare feet.

Hindlegs—From hip to hock, long and sinewy; hock to heel, short and strong. Stifles and hock moderately bent and not inclining either in or out, firm on feet, feet round and not too small, with strong, thick close pads. Well feathered between toes. Moderately feathered down to hock. Profuse feathering objectionable.

Stern—Set on low, well fringed with wavy feather. Preferably never carried above the level of the back. Of lively motion when dog is excited.

Coat—On head, front of forelegs and below hock on front of hindlegs, short and fine; on other parts of body, flat or wavy (never curly) of medium length but

of sufficient density to be waterproof, weatherproof and thornproof, glossy and refined in texture. A nice fringe of wavy hair on throat, brisket, chest and belly.

(Close trimming or treatment of coat to give artificial appearance should be severely penalized.)

Height—Dogs, 18½ inches at shoulder. Should not vary more than ½ inch either way therefrom. Bitches—18 inches at shoulder. Should not vary more than ½ inch either way therefrom.

Weight—Dogs about 45 lbs.—should not exceed 50 lbs. Bitches about 42 lbs.—should not exceed 47 lbs.

Note: It is desirable that proper balance and proportion shall always be considered more important than mere weight. The dog or bitch possessing true Springer type which is balanced in both vertical and horizontal dimensions and possesses bone and substance in keeping with its size, should, even though under or over the weight and dimension limits set down, always be considered preferable to one which is ill-proportioned and attains the weight limit through excess or lack of height, length, width or substance.

Color—Liver and white, black and white, liver and tan, black and tan, tan and white; black, white and tan; liver, black, roan, etc.—anything except red and white, and lemon and white, which should be penalized.

Gait—The Springer gait is strictly his own. His forelegs should swing straight forward from the shoulder, throwing the foot well forward in an easy and free manner, not a paddle or with a choppy or Terrier stride. In the rear his hocks must drive well under his body following on a line with the forelegs.

Note: At slow movement many Springers have a pacing stride which is also acceptable for Springer gait.

General Appearance and Type—The Springer Spaniel is a hunting dog of all work. His qualities, stated in this standard, will give him speed, agility and endurance to cope with the most difficult field trial and hunting conditions. He is a medium size variety of Spaniel, active, symmetrical, upstanding, strong, built for endurance, but not in any way coarse or ponderous. A well-balanced sporting dog of distinct Spaniel character, combining beauty and utility. Excessive lowness or length should be penalized as interfering with the dog's activity.

Know Your Breed...

By Alva McColl

THE ENGLISH SPRINGER SPANIEL



OF ALL the breeds in dogdom, there is none which has so many sub-varieties as that of the Spaniel family. The Springer, or Springing Spaniel as the name denotes, is probably the animal most used for sporting purposes by the one-dog man, for it can do every kind of work—hunt, retrieve and go to water—making itself exceedingly useful.

Early historians tell how this breed was used for springing game for the net, the hawk, the greyhound or the gun. Both France and Spain claim that this popular breed originated there, and this could be borne out by the fact that paintings by the Old Masters of the 17th century seen in the picture galleries on the Continent depict beautiful Springer Spaniels so typical of the present dog that they could hold their own in the show ring today.

The popularity of the breed also lies in the fact that the show dog has not lost its working capabilities. In the evolutionary process the breeders have kept the beautiful, true form of the Springer Spaniel with the build and anatomy necessary for agility to do a hard day's work. Field Trials for Springer Spaniels are held in almost every country in the world where Field Trials are known.

In addition to the qualities of a good hunting and show dog, the Springer Spaniel

has a sweet disposition which makes it an ideal home companion, and a possessive spirit which is the first requisite of a good watch dog.

Its gait is strictly its own. The forelegs swing straight from the shoulder, throwing the foot well forward in an easy and free manner, not a paddle or with a choppy or Terrier stride. In the rear, the hocks must drive well under the body following on a line with the forelegs. The Springer is a medium size variety of the Spaniel breed, active, symmetrical, upstanding, strong, built for endurance, but not in any way coarse or ponderous. It is a well balanced dog, combining beauty with utility.

The colours which are recognized in the Standard of the Breed are liver and white, black and white, liver and tan, black and tan, tan and white, black, white and tan, liver, roan, etc.,—anything except red and white and lemon which should be penalized.

Height—Dogs 18½ inches at shoulder. Females, 18 inches at shoulder. Both dogs and females should not vary more than one-half inch either way.

Weight—Dogs about 45 pounds—should not exceed 50 pounds. Females, about 42 pounds—should not exceed 47 pounds.

PROPOSED BY-LAWS

Article I. NAME

The name of the Club shall be The Canadian Kennel Club.

Article II. HEAD OFFICE

The head office of the Club shall be in Toronto, Ontario.

Article III. RECORDING OFFICE

The recording office of the Club shall be at such place as may be determined from time to time by the Board of Directors.

Article IV. CORPORATE SEAL

The seal, an impression of which is stamped in the margin hereof, shall be the corporate seal of the Club.

Article V. OBJECTS

The objects of the Club are:

- (a) To keep a record of the pedigrees of all breeds of dogs;
- (b) To collect, preserve and publish data, information and documents relating to dogs;
- (c) To encourage the breeding of pure-bred dogs in Canada and to protect the interests of owners and breeders, to make grants to dog shows and field trial competitions, and in such other ways as it may seem fit, encourage, guide and advance the welfare of dogs and their owners.

Article VI. PRIVILEGES

1. The privileges of the Club as they apply to all persons and organizations shall mean:

(a) The use of the services of the recording office as they concern the records of this Club;

(b) The use of the services rendered by the publications of this Club.

2. The privileges of the Club as they apply to all members shall mean:

(a) All those privileges set forth in section 1 of this article;

(b) All those privileges accorded members of the Club as set forth in these by-laws and any privileges extended to members by order of the Board of Directors.

3. Any person, partnership, company or organization availing themselves of the privileges of this Club as set forth in this article shall by such act be deemed to have agreed to the authority of the Club and its Board of Directors, as conferred on the Club by these by-laws.

4. Except as otherwise provided in Section 6, sub-section 5 of the Live Stock Pedigree Act (1949), no person, partnership, company or organization suspended or expelled by this Club, the Kennel Club (England), The American Kennel Club or any association incorporated under The Live Stock Pedigree Act shall be entitled to any of the rights and privileges set forth above unless reinstated by the suspending or expelling organization.

5. Any partnership or company that is a member of this Club may exercise any of the foregoing privileges to which it is entitled only through its authorized representative named in such partnership's or company's application or through his successor duly appointed by such partnership or company, written notification of which appointment has been delivered to the Secretary. Partnership or company membership shall not entitle members of such to membership privileges, and individual membership of each and all of the members of a partnership or of a company shall not entitle a partnership or a company to membership privileges.

6. The privileges accorded members by these by-laws may be accorded only those of the original incorporators of the Club who remain members in good standing but such privileges shall not exceed those accorded members presently in good standing.

Article VII. MEMBERS

CLASSES. There shall be three classes of members as follows:

(a) **LIFE MEMBERS:**—Life members shall be those persons who may from time to time be elected to such membership by the unanimous vote of the members

The new Live Stock Pedigree Act provides for the affiliation of associations forming the Canadian National Live Stock Records. Articles of Affiliation, as prescribed by the Minister of Agriculture, will be presented for the consideration of the members attending the meeting.

The Board of Directors will present, for the consideration of the members attending the meeting, suggested arrangements intended to provide for continuation of the services which have been rendered by the Club but which services, in the opinion of the Department of Agriculture, do not come within the jurisdiction of The Live Stock Pedigree Act 1949.

In addition, the proposed amendments published in the January (1950) issue of DOGS IN CANADA will be on the agenda of the meeting.

of an election of officers or other Directors by the Board of Directors the Chairman shall be entitled to vote and in the case of a tie he shall have the second or casting vote.

6. Following each meeting of the Board of Directors the Secretary shall cause to be published in the next issue of "Dogs in Canada" a resumé of the business transacted at such meeting with specific mention of the motions before the meeting, the movers and seconders thereof and except in the case of votes by secret ballot as required in these By-laws the names of those voting pro or con. Such resumé shall before publication be approved by each Director present at such meeting. The scope of the resumé shall be such as to enable the members to follow intelligently the entire business of the Club provided, however, that if the Club's solicitor shall give his opinion that the publication of any information need not be published. If for any reason, the resumé cannot be published in the issue provided for above, it will be published in the following issue of "Dogs in Canada".

Article XI. DUTIES, OFFICERS AND DIRECTORS

1. **PRESIDENT.** The President shall be the chief executive officer of the Club and shall have the general powers and duties of supervision and management usually vested in the office of President of similar organizations. He shall be ex officio a member of all committees and Chairman of all meetings of the Board of Directors and of the members.

2. **VICE-PRESIDENT:** If the President is absent or unable to act, his duties and powers may be exercised by the Vice-President.

3. **SECOND VICE-PRESIDENT.** If the President and Vice-President are absent or unable to act, the Second Vice-President may exercise the duties and powers of the President.

4. No officer or Director may pledge the credit of the Club except as authorized by a two-third majority vote of the ordinary members of the Club at a general meeting.

5. The individual officers and Directors of this Club shall have such further duties and powers as may be delegated to them by the Board of Directors providing the said duties and powers are not contrary to the provisions of these By-laws.

Article XII. ELECTIONS

1. The President, Vice-President, Second Vice-President and all other Directors shall be elected annually all in the manner hereinafter provided. The President, Vice-President and Second Vice-President shall be elected on the vote of the members at large and other Directors shall be elected by each electoral zone. For the purpose of an election only those ordinary members in good standing as of June 30th in the election year shall be eligible to move or second a nomination, be nominated, vote, stand for election and/or be elected as an officer or other Director.

2. (a) **NUMBER OF DIRECTORS.** For the purpose of election of Directors and of effecting proportional representation as well as may be, the membership shall be divided into electoral zones of which the initial zones shall consist of members residing in each of the following provinces or aggregation of provinces:

1. Alberta.
2. British Columbia.
3. Manitoba.
4. Nova Scotia, New Brunswick, Prince Edward Island and Newfoundland (Maritime Provinces).
5. Ontario.
6. Quebec.
7. Saskatchewan.

(b) **QUINQUENNIAL ADJUSTMENT.** The number of Directors to be elected for the electoral zones set forth in (a) above shall be determined and adjusted every five years. There shall be an adjustment in the year 1950 to govern the year 1951 and the following shall be the manner of the determination of the number of Directors to be elected for 1951 and the years that follow until a further adjustment is made as provided for by this article. To the total number of members of the Club for the year preceding the year in which the adjustment is made shall be added the total number of registrations of individual dogs for year preceding the year in which the adjustment is to be made and the sum thereof divided by the total number of provinces (nine for this purpose). The number so resulting shall be the unit of representation by provinces. The number forming said unit shall be divided into the sum total of the membership of the given zone for the year preceding the year in which the adjustment is to be made, and the registrations of individual dogs for such zone for the year preceding the year in which the adjustment is to be made, and the quotient shall be the number of Directors for such zone. If such quotient includes a fraction, such fraction shall be ignored if one-half or less and treated as an added integer if more than one half, but every province or aggregation of provinces as set forth in (a) above shall be entitled to elect at least one Director.

(c) Whenever as a result of a quinquennial adjustment, a province included in an aggregate group shall in respect of membership and registration, have attained to the unit of representation computed aforesaid, such province shall thereupon withdraw from its former group and shall constitute a separate electoral zone, and be entitled, as such, to separate representation, and subject to the change thereby resulting the grouping shall be as heretofore:

out that the Deputy Minister had suggested that they be consulted regarding the revision of the Club's Constitution, and they had been invited to attend the meeting so that some understanding could be reached and guidance obtained in respect to the revision of the Club's Constitution, particularly with regard to the Club's powers and objects.

Mr. MacVannel indicated that representatives of the Department were pleased to accept the invitation, that they believed that the right course had been followed and that they would endeavor to be as helpful as possible. Mr. MacVannel explained that the Act was primarily intended to provide for the incorporation of Live Stock Associations as registration bodies and that it was the feeling of the Department that the activities of such associations should be largely confined to matters concerning registration or closely related to registration.

Mr. MacVannel went on to state that:

- (a) As Chief Registration Officer of the Department he was in some measure responsible for the Club's Constitution making reference to the Club having objects and powers relating to dog shows and trials;
- (b) When the question was raised as to the Club's authority in respect to shows and trials the matter had been referred to the Department of Justice which had indicated that an error had been made in allowing the Club to exercise powers beyond those permitted by the Act;
- (c) In view of the opinion given by the Department of Justice, instructions had been given that steps be taken as soon as possible to amend the Constitution;
- (d) The Department had since, on a number of occasions, indicated that revision of the Club's Constitution should be undertaken at the earliest possible date;
- (e) The new Act did not differ to any great extent from the previous Act, but officials of the Department felt that revision of the Club's Constitution should be taken as soon as possible and not left over until 1951.

The President pointed out that the annual general meeting had been called for February 8th, and asked since no specific notice had been given members that a general revision of the Constitution was necessary or contemplated, what procedure should now be followed in order to eliminate the necessity and expense of two general meetings in 1950.

Mr. MacVannel expressed the opinion that the Department would feel that the Club was acting properly in all respects if the Board gave the members thirty days' clear notice that the Directors were presenting new by-laws at the annual general meeting in order to comply with the new Act.

The President stated that the preparation of new by-laws would be greatly facilitated if Mr. MacVannel would suggest where revisions were most necessary. Mr. MacVannel stated that the Department would prefer that the Club draft by-laws which it considered to be best from its point of view after which they could be considered by the Department in the regular way. Acting on the President's suggestion that he indicate possible amendments, Mr. MacVannel suggested:

- (a) Deletion of the word "incorporated" from the Club's name for that word was not a part of the Club's name in its original application for incorporation;
- (b) Deletion of reference to shows, trials, racing and coursing in the Club's objects and powers;
- (c) That the Club's solicitor redraft the objects so as to conform to the Club's charter;
- (d) Tightening up of the section referring to audits and reports;
- (e) That the section referring to agreements be condensed;
- (f) That the referendum ballots be deleted;
- (g) That trial boards be deleted;
- (h) That wherever possible all sections be condensed as much as possible.

The President asked Mr. MacVannel what action should be taken so that some central organization could carry on the functions heretofore exercised by the Club in respect to shows and trials. Mr. MacVannel suggested that consideration be given to the setting up of an organization, distinct from the Canadian Kennel Club, which would serve the same purpose, where shows and trials are concerned, as the Canadian Kennel Club had in the past.

3. On or before October 1st in each year there shall be mailed postage prepaid to the members entitled to vote:

(a) A complete list of all such members in good standing as of June 30th in such year.

(b) The nomination paper in such form as may be approved by the Board of Directors.

If through mistake, inadvertence, accident or other cause the list of members and nomination papers are not mailed on or before October 1st they shall be mailed as soon as possible thereafter. Military, civil or courtesy titles or decorations and/or abbreviations thereof are not to be shown on the membership list.

4. Any member entitled to vote and in good standing as of June 30th in the election year may move or second a nomination for:

(a) President and/or

(b) Vice-President and/or

(c) Second Vice-President and/or

(d) One Director for the electoral zone in which such member resides save that any such member resident in Ontario may move or second nominations for five (5) Directors.

5. Completed nomination papers shall be mailed (registered) postage prepaid to the Secretary so as to be received by him on or before 5 p.m. on the 1st day of November and no nominations received thereafter may be considered in the election provided that if the 1st of November falls on a Sunday the time limit shall be extended to 5 p.m. on November 2nd. All nomination papers must be signed by two members whose names appear in the list of members referred to above.

6. The Secretary of this Club shall upon receipt of a nomination paper in the proper form acknowledge same to the mover of the nomination and advise by postage prepaid or telegraph those nominated of their nomination specifically naming the office(s) for which they have been nominated.

7. A member, nominated for election to an office, and desirous of standing for election to that office, must advise the Secretary in writing or by telegraph of his acceptance of the nomination and such acceptance must reach the office of the Club not later than 5.00 p.m. on November 15th; a member whose acceptance of a nomination does not reach the office of the club by 5.00 p.m. on November 15th shall be deemed to have refused the nomination. An ordinary member may only stand for election and be elected to one office.

8. Ballots shall be in such form as may be approved by the Board of Directors. Military, civil or courtesy titles or decorations and/or abbreviations thereof shall not be shown in connection with names appearing on the ballots.

9. Between the 16th day of November and the 29th day of November, the Secretary shall deliver to the election commission:

(a) A certified list of the members entitled to vote and in good standing as of June 30th in the current year;

(b) A ballot bearing the corporate seal of the Club for each of such members;

(c) Envelopes stamped and addressed to the address of each such member last known to the Secretary;

(d) Return envelopes stamped and addressed to the election commission and marked "Ballot", one for each such member;

(e) A certified list of all those who have been elected by acclamation as well as a list of all offices for which no nominations have been received.

Upon receipt of the foregoing the election commission shall mark each ballot for the purposes of identification and in the counting of votes no other ballots may be taken into account.

10. On or before November 29th the election commission shall mail to every member entitled to vote in the envelope provided:

(a) A ballot;

(b) A return envelope stamped and addressed to the election commission and marked "Ballot".

If through mistake, inadvertence, accident or other cause the voting papers are not mailed on or before November 29th, they shall be sent out as soon as possible thereafter.

11. Default in supplying a ballot and/or a return envelope to any member or the non-receipt of either of such papers by any member within the prescribed time shall not invalidate any election held in the manner herein provided.

12. Only those ballots shall be counted that are in the hands of the election commission by 12 o'clock noon on the 22nd day of December following the mailing of the ballots provided that if the 22nd of December is a Sunday the time for the receipt of the ballots by the election commission shall be extended to the 23rd of December and provided further that the date for receiving ballots shall be extended one day for each day's delay starting from November 29th in the mailing of the ballots by the election commission.

13. The election commission shall forthwith after the last day for receiving ballots open the envelopes and proceed to count the votes.

14. The election commission shall on or before the 28th day of December or as soon thereafter as possible furnish the Secretary with a report of the election certified by the affidavit of a member of the election commission setting forth:

(a) The number of votes cast for each candidate for office;

(b) The names of all persons elected by acclamation as previously advised by the Secretary;

He expressed the view that application for the incorporation of such a body should be made to the Secretary of State for Canada.

RESOLUTION: The President expressed to Mr. MacVannel and Mr. Steele the Board's appreciation for their helpful suggestions and it was regularly moved by Director Farmer, seconded by Director Boughs:

"THAT, a vote of thanks be extended to Mr. MacVannel and to Mr. Steele for the information and assistance that they have given us this afternoon."

Motion carried.

—Mr. MacVannel and Mr. Steele then left the meeting.

DISCUSSION: The President suggested that the Club's solicitor should be immediately contacted with a view to preparation of new by-laws and the preparation of an application, to the Secretary of State, for incorporation of a body which would have authority to deal with competitive events for pure-bred dogs. The matter was left over for further discussion.

1487. REPORT OF THE ELECTION COMMISSION AND RELATED MATTERS

REPORT: The Secretary tabled the report of the Election Commission on the election of Officers, Directors, Field Trial Representatives and Provincial Committees for 1950.

ACTION: The Secretary was directed to refer the report to the next annual general meeting.

SUBJECT: The Secretary tabled correspondence in respect to alleged irregularities in the election of Officers, Directors, etc., for 1950.

RESOLUTION: Following consideration the following resolution was regularly moved by Director Farmer, seconded by Director Mrs. Brown:

"THAT, in view of the report of the election commission the Board is not in a position to deal with any alleged irregularity unless such allegations are supported by affidavits or sworn testimony."

Motion carried.

1489. LETTER FROM MR. PETER HOPKINSON

SUBJECT: The Secretary read a letter from Mr. Peter Hopkinson, MacDonald's Corners, Ontario, in which Mr. Hopkinson referred to general "dissatisfaction over the uncertainty of new identification procedures", and the fear on the part of some members that tattooing would be the only method of identification allowed. Mr. Hopkinson referred also to shows of two days' duration and suggested that permits for two day shows be not extended.

DISCUSSION: The Board agreed that since identification would be a matter considered by the members attending the annual general meeting no necessity existed for making any statement on the subject. It was further agreed that in view of the Club's position regarding shows and trials, Mr. Hopkinson's letter should be tabled.

RESOLUTION: It was regularly moved by Director Farmer, seconded by Director McRae:

"THAT, Mr. Hopkinson's letter be tabled and he be informed that it would be his privilege to air his views, at the annual general meeting, on the subjects referred to in his communication."

Motion carried.

1491 (1466). ADOPTION OF MINUTES

SUBJECT: The Secretary presented for adoption the minutes of the meeting of the Board of Directors held on December 14th, 1949.

RESOLUTION: It was regularly moved by Vice-President Riedel, seconded by Director Boughs:

"THAT, the minutes of the meeting of the Board of Directors held on December 14th, 1949, be adopted."

Motion carried.

1492 (1467). FINANCIAL REPORT

REPORT: The Secretary reported that:

(c) All those offices for which no nominations had been received as previously advised by the Secretary.

Upon receipt of the election commission's report the Secretary shall forthwith send a copy of the said report to each candidate for office. The election commission shall seal the counted ballots in packages and deposit the same with the Secretary who shall preserve the same until the 1st day of April next following, after which date they shall be destroyed.

15. In the event of a tie in the voting for the office of President, the Vice-President shown to have been elected by the report shall cast the deciding ballot. The member shown to have been elected as President shall cast the deciding ballot in event of ties for the offices of Vice-President, Second Vice-President or other Director.

16. In the event that no nomination has been received for any office the person holding that office shall continue in such office until his successor shall have been duly elected as hereinbefore provided or until he shall have resigned or shall have been otherwise disqualified provided that if less than five (5) qualified members have been nominated for the office of Directors for the Province of Ontario the members so nominated shall be declared elected by acclamation and the Board of Directors shall fill the vacancy(s) from members entitled to vote and resident in Ontario.

17. The officers and other Directors elected in each annual election shall take office on January 1st of the year for which they were elected. The report and proceedings of the election commission shall be subject to review at the annual general meeting next following the publication of the report.

Article XIII. COMMITTEES, REPRESENTATIVES AND APPOINTMENTS

1. REGISTRATION COMMITTEE. (a) This committee shall consist of the President, or one of the Vice-Presidents, who shall be Chairman, and two or more Directors as may be determined from time to time by the Board of Directors. The Secretary shall be the Secretary of this committee.

(b) The committee shall have the power to:

(i) Authorize registration of change of ownership and registration of dogs where signatures or other information is unobtainable;

(ii) Authorize registration of a dog imported from any British or foreign country not listed in Article XXVIII, Section 2;

(iii) Authorize the registration of a dog as provided for in Article XXVIII, Section 6.

(iv) Do such other acts and things as provided for by the By-laws.

(c) The findings of this committee shall be presented in writing and be incorporated in the minutes of the next succeeding meeting of the Board of Directors.

2. SPECIAL COMMITTEES. The Board of Directors or the members in general meeting assembled, may appoint from their number or from the other members of the Club, special committees, but must in all cases name the member who shall be the presiding officer. The duties of each such committee shall be such as may be delegated to it by the Board of Directors or the members in general meeting assembled. The action of any special committee is subject to the approval of the Board of Directors.

3. REPRESENTATIVES. Representatives to other organizations shall be appointed by the Club at its annual general meeting. Any such representatives not so appointed may be appointed by the Board of Directors. The Board of Directors may direct the representatives in the carrying out of their functions as representatives of the Club.

4. APPOINTMENTS. (a) The Board of Directors may appoint Honorary Presidents and Honorary Vice-Presidents. They shall hold office during the pleasure of the Board. Their position shall be purely honorary;

(b) The Board of Directors may appoint a Solicitor and an Honorary Veterinary-Surgeon. They shall hold office during the pleasure of the Board.

(c) A Director may, with the permission of the Board, appoint members in an advisory capacity.

5. REGISTRAR. The recording office shall assign to the Club a person to act as Registrar. The duties of the Registrar shall be those assigned to him by the Director of the recording office.

6. EXAMINING COMMITTEES. The Board of Directors may from time to time as occasion requires, appoint an examining committee, composed of one or more members, to examine and report on a dog for which application for registration has been received. The procedure to be followed and the report to be made by each examining committee shall be as prescribed by the Board of Directors.

7. AUDITOR. The members at the annual general meeting shall appoint a firm of chartered accountants to be the auditors of the Club. They shall examine the books of account of the Club, vouchers for all payments and certify the usual statements of assets and liabilities and receipts and expenditures for the year for presentation to the next annual general meeting, and shall perform such other duties as may be assigned by the Board of Directors.

8. ELECTION COMMISSION. The auditors of the Club shall be the election commission. Their duties shall be such as are assigned by Article XII.

Article XIV. STAFF

1. The staff of the Club shall consist of the Secretary, Treasurer or Secretary-Treasurer and such other persons as may be authorized by the Board of Directors to serve on the staff.

(1) The audited financial statements for the past year had not yet been received but that present indications were that the Club had operated without financial loss during 1949.

(2) Financial statements for 1949 had been received from the Canadian National Live Stock Records and the report indicated that:

(a) Receipts for the Club memberships, registrations, etc., during 1949, totalled \$66,103.18 as compared with \$63,562.30 in 1948;

(b) Memberships in 1949 totalled 3,616 as compared with 3,445 in 1948;

(c) Registrations had increased from 17,831 in 1948 to 18,602 in 1949;

(d) Transfers had increased from 18,209 in 1948 to 18,882 in 1949;

(e) Exports had increased from 1,287 in 1948 to 1,443 in 1949;

(f) Litter registrations had decreased from 6,569 in 1948 to 6,167 in 1949;

(g) Membership fees had increased from \$14,544.00 in 1948 to \$15,427.00 in 1949;

(h) Operational items handled by the Live Stock Records had increased from 58,010 in 1948 to 58,765 in 1949;

(i) That costs for the Records Office handling the Club's business had increased from \$21,626.66 in 1948 to \$25,679.01 in 1949.

DISCUSSION: The Secretary pointed out that when the Board last reviewed financial statements indicating the Club's financial progress during 1949 it had estimated that funds which had been sent to the Live Stock Records on account would be sufficient to meet operational costs of the Records Office during 1949, and although the number of transactions handled by the Live Stock Records Office had increased slightly over 1948, the Records Office costs had increased by over \$4,000.00, there being no intimation to the Board during the year that such a decided increase was expected. Director Farmer suggested that the Club's monthly cheque to the Records Office should be sent promptly and that efforts be made to obtain a quarterly statement from the Records Office so that the Board would have some idea as to whether or not costs were the same as the previous year so that it would be in a better position to calculate the Club's financial position during the year. The President suggested that some consideration should be given to the setting up of the Club's own Recording Office for while the Records Office costs for the handling of the Club's business during 1948 represented 32.8% of the revenue deposited during 1948, this percentage had increased to 39% during 1949.

The Secretary pointed out that there was a balance due the Records Office on the Club's 1949 operations of \$2,924.53 to which should be added other accounts payable bringing the total to approximately \$5,000.00 and that at the end of the year bank deposits available to cover these accounts amounted to \$2,004.88. The Secretary sought an instruction as to funds necessary to pay these accounts. Director Farmer suggested that if the yield on bonds held by the Club was materially less than 3% then it would be preferable to dispose of bonds rather than raise the required funds by bank loan.

RESOLUTION: It was regularly moved by Director Farmer, seconded by Director Spratt:

"THAT, the Secretary determine the yield on bonds now held by the Club, and if the yield is less than 3% bonds be sold to raise the \$5,000.00 required to liquidate accounts payable at the end of 1949."

1493 (1469). COMPLAINTS

DISCUSSION: The President recommended that a Complaints Committee be set up to review all complaints requiring the attention of the Board of Directors and that the report of the Complaints Committee be presented at each meeting of the Board for consideration. The President expressed the view that this procedure would expedite consideration of complaints by the Board at its meetings.

RESOLUTION: It was regularly moved by Vice-President Riedel, seconded by Director Farmer:

"THAT, the Complaints Committee be composed of Directors Boughs, Mrs. Brown and Spratt, who shall review all complaints and present a resume and their recommendations to the Board of Directors for consideration."

Motion carried.

1494. AFFILIATION

REPORT: The Secretary read a letter received from Mr. A. P. MacVannel, dated

2. The Secretary shall be ex officio clerk of the Board of Directors. He shall attend all meetings of the Board and of the members and record all facts and minutes of all proceedings in the books kept for that purpose. He shall give all notices required to be given to members and to Directors. He shall be custodian of the seal of the Club and of all books, papers, records, correspondence, contracts and other documents belonging to the Club, save as otherwise provided in these by-laws, and he shall perform such other duties as are set forth in these by-laws or as may be from time to time determined by the Board of Directors. The Secretary shall keep at the head office of the Club and at such time as the recording office is under the control of the Board of Directors, the Registrar shall keep at such recording office a book wherein shall be typed or printed a copy of these by-laws, with all amendments thereof, which books shall at all reasonable times be open to the inspection of the members of the Club who may make copies thereof.

3. The Treasurer shall keep full and accurate accounts of all receipts and disbursements of the Club in proper books of account, and shall deposit all moneys or other valuable effects in the name and to the credit of the Club in such bank or banks as may from time to time be designated by the Board; shall disburse the funds of the Club under the direction of the Board of Directors, taking proper vouchers therefor; and shall render to the Board of Directors at the regular meetings thereof or whenever required of him, an account of his transactions as Treasurer and of the financial position of the Club. He shall also perform such other duties as may from time to time be determined by the Board of Directors.

4. Any person occupying the position of Secretary-Treasurer shall perform the duties of the Secretary and the Treasurer set out above.

5. The duties of the other members of the staff shall be such as are delegated by the Board of Directors or by some member of the staff authorized to delegate such duties.

6. The Board of Directors may delegate such of its powers and duties to one or more members of the staff as it sees fit and necessary.

7. The Board of Directors may require that any or all members of the staff be bonded for an amount fixed by the Board of Directors.

Article XV. DISCIPLINE

1. The Board of Directors shall have the power to suspend, to expel or reprimand any member, or deprive any non-member of the privileges of the Club, if in the opinion of the Board of Directors he has violated:

- A by-law of the Club relating to eligibility for registration, establishment of production credentials or payment of fees;
- section sixteen or section seventeen of the Live Stock Pedigree Act, 1949; or
- any provisions of the Animal Contagious Diseases Act or the regulations thereunder relating to the identification, marking or testing of pure-bred dogs.

2. The Board of Directors shall have the power to terminate the membership of a member who, in the opinion of the Board of Directors, has committed an act which is considered to be prejudicial to the objects or interests of the Club, or to the interests of its members or their dogs.

3. On report to the Board of Directors in writing of a charge or complaint against any person which may result in suspension, or expulsion or termination of membership, or deprivation of privileges, the charge or complaint shall be laid before a meeting of the Board of Directors who shall, if they decide to entertain the charge or complaint, designate the time and place at which the hearing of the charge or complaint will be conducted.

4. A member, person, partnership or company against whom a charge or complaint has been laid shall have fifteen days notice in writing by registered mail of the charge or complaint that has been preferred and the time and place where a hearing shall be conducted. All persons affected by the charge or complaint shall have the right to be heard in person and may produce such evidence and witnesses as they may desire.

5. Any person so suspended, expelled, or deprived the privileges of the Club shall have the right to apply to the Board of Directors for reinstatement. Should the Board not grant the application for reinstatement such person shall have the right to apply for reinstatement by the next succeeding annual general meeting, but reinstatement by an annual general meeting shall be only by a majority vote of the members thereat.

6. (a) "Expulsion," when imposed, automatically terminates membership in the Club and deprives the person so expelled from privileges accorded members and non-members of the Club;

(b) "Suspension," when imposed, automatically deprives a member of the privileges of membership for the period ordered when the suspension is imposed and all other privileges which may be accorded non-members of the Club for a like period;

(c) "Deprivation of privileges," when imposed, automatically deprives a non-member of all privileges accorded non-members of the Club.

(d) "Termination of membership in the Club," when imposed, automatically deprives a person of the privileges of membership but permits of his receiving the privileges accorded non-members of the Club.

7. Upon receipt by the Board of Directors of a certificate of conviction issued by the clerk of any Court, certifying as to the conviction of any person, partner-

December 30th, in which Mr. MacVannel reported that the new Live Stock Pedigree Act had received Royal assent on December 10th and that the new Act provided that each association may sign Articles of Affiliation within a year. Mr. MacVannel's letter went on to state that it would be advisable to state in the notice calling the annual general meeting that the Articles of Affiliation would be presented for the consideration of the Club by the Department of Agriculture.

Article XVI. RECIPROCAL AND OTHER AGREEMENTS

1. It shall be the duty of the Board of Directors to enter with any club or organization conducting registration records for or clubs, associations and companies when, in the opinion of the Directors, such agreements will further dog breeding in Canada.

2. All agreements entered into, as provided in this Article, must conform with the Live Stock Pedigree Act, 1949.

3. A copy of all such agreements shall be deposited with the Minister of Agriculture.

Article XVII. ORDER AND CONDUCT OF BUSINESS

1. The order of business at all general and Board of Directors meetings shall be as follows:

- (a) Identification of members;
- (b) Reading minutes of previous meeting;
- (c) Report of officers, Directors and committees;
- (d) Correspondence;
- (e) Unfinished Business;
- (f) If annual meeting, report of election of Directors and appointment of representatives;
- (g) New Business;
- (h) Adjournment.

The above order, with the exception of (a), identification of members, may be changed at the pleasure of the meeting assembled.

2. Rules of Order, as found in "How to Conduct Public Meetings" by H. G. MacGill, shall govern meetings of the Club and Board of Directors insofar as they are applicable and not inconsistent with the provisions of the By-laws.

Article XVIII. AUDIT AND ANNUAL REPORT

1. The Board of Directors at each annual general meeting shall submit the following:

- (a) A complete report of the affairs of the Club;
- (b) A detailed statement duly audited of the receipts and disbursements of the preceding year and of the assets and liabilities of the Club.

2. A copy of this report, a list of the officers elected and those appointed, also general information on the affairs of the Club, shall be submitted to the Minister of Agriculture for Canada within twenty days of the meeting.

3. The fiscal year shall correspond to the calendar year.

4. At the end of each quarter there shall be prepared and submitted to the Board of Directors a financial statement indicating the financial position of the Club.

Article XIX. EXPENSES, INCOME AND PROPERTY

The income and property of the Club from whatever source shall be applied by the Board of Directors solely towards the promotion of the objects of the Club and no part thereof shall be paid directly or indirectly by way of bonus or otherwise as profit or dividend to any member of the Club, past, present or future, or to any person claiming to be a member, provided, however, that nothing herein contained shall prevent the payment of remuneration to any Secretary, Treasurer, Officer, Clerk, Servant or other person or persons or organization actually rendered the Club whether such are members of the Club or not, and the expenses of the Directors or other officers incurred in doing the business of the Club save as otherwise provided in these by-laws.

Article XX. PUBLICATIONS

The Club may publish an official organ and such other publications as may be deemed necessary.

Article XXI. STUD BOOKS

1. The Board of Directors may from time to time cause to be published extracts from the Club's registration records which shall be in such form and contain such information as may be decided by the Board of Directors. Extracts published for any given year shall be known as "The Club Stud Book" for that year.

2. If necessary the charge for the current volume (or part thereof) and back volumes, shall be fixed by the Board of Directors.

Article XXII. PRIVATE BREEDING AND IDENTIFICATION

1. There shall be kept by each breeder a private record which shall contain full particulars of his breeding operations and identification of his dogs, and possession by reason of ownership, lease or agreement. These records shall be kept in the form as set forth in "Canadian Kennel Club Private Breeding Record Book".

2. When and if, as a result of any charge or complaint laid against a breeder, the Board of Directors has occasion to doubt the authenticity of the records, it may require the breeder to produce the original records.

SUBJECT: The Secretary read a letter from the Secretary of the Ottawa Kennel Club indicating that in addition to Mr. W. C. Baldwin, Mr. Harry Fraser and Mr. Mac MacLean, they proposed utilizing the services of novice judges to judge the breeds at its sanction show on February 11th, the aforementioned judges to take over for Best of Breed, Groups and Best in Show.

ACTION: Following discussion the Secretary was directed to inform the Ottawa Kennel Club that while the Board looked with favour upon their attempt to advance the judging situation in Canada, it was the Board's suggestion that the actual judging be done by recognized judges to whom the novice judges could be considered apprentice.

REPORT: The Secretary reported on correspondence with the Fredericton Kennel Club and Director W. P. Moore, regarding the Fredericton Kennel Club's wish to select Mrs. William Constable, of Boston, Mass., as judge of all breeds at a championship show which it proposes holding in September.

DISCUSSION: The Board agreed that unless Mrs. Constable is licensed as an all breed judge by the American Kennel Club, it could not approve of the selection in view of the requirements of Chapter 7, Section 4, of the Dog Show Rules.

SUBJECT: Director Farmer suggested that when judges are approved each

5. The Board of Directors may, from time to time as it deems advisable for registration purposes, divide any recognized breed into two or more distinct breeds, and shall have the authority to prescribe regulations governing any such division which it may order or has, in the past, been ordered by the members or a previous Board. Such regulations shall not, however, be effective until approved by the Department of Agriculture. No claim may be made against the Club or its Board of Directors by reason of any loss or damage resulting from such divisions and/or re-classification of registered dogs in the breed so divided.

Article XXVII. IDENTIFICATION

1. In order to be eligible for registration a dog must be identified by any one of the methods outlined in section 2 of this article, so that the certificate of registration issued for the dog will make it possible to distinguish it from any other dog of the same breed. A breeder or owner shall have the choice of the methods outlined in this article but it is the privilege of the Chief Registration Officer to decide whether or not positive identification, in each instance, has been sufficiently well established.

2. METHODS OF IDENTIFICATION

(a) **COLORS AND MARKINGS.** A complete statement of the colors and conspicuous markings of a dog will be accepted as a means of identification providing such color and markings identify that dog from any other of the same breed.

(b) **TATTOO MARKINGS.** On application to the recording office a breeder or owner will be allotted identification letters for his exclusive use in tattoo marking dogs for registration purposes. Tattoo markings will be accepted as a means of identification only if regulations in respect to tattoo markings, as adopted by the members, are fully observed.

3. IDENTIFICATION RECORDS:

Each breeders' private breeding records* shall also contain full particulars of the identification of each dog in his possession by reason of ownership, lease or agreement.

(*see Article XXII).

Article XXVIII. RULES OF ELIGIBILITY

1. The following dogs are eligible for registration providing that, in each instance application for registration is acceptable to the Club's Registrar and to the Chief Registration Officer and is in accordance with the terms of these By-laws, and is accompanied by the required fees, documents and evidence as may be required elsewhere in these By-laws:

(a) A dog born in Canada of a litter registered with the Canadian Kennel Club.

(b) A dog registered in any of the following Stud Books or records:

- (1) The Kennel Club, England;
- (2) The American Kennel Club;
- (3) The Association of Masters of Harriers and Beagles;
- (4) The Association of Masters of Foxhounds;
- (5) The National Coursing Club, England;
- (6) The Irish Kennel Club;
- (7) The Irish Coursing Club;
- (8) Newfoundland Live Stock Register.

(c) A dog born in Canada and registered in the National Coursing Association Stud Book, The Field Dog Stud Book, or The International Fox Hunters Stud Book, provided the certificate of registration as issued by an organization above stated with certified three generation pedigree accompanies the application for registration. A copy of the three generation pedigree may be made by the recording office but the original certificate and pedigree certificate shall be returned to the applicant. If official three generation pedigree is not obtainable, evidence of authentic ancestry for three generations must be filed with the Club.

(d) A dog registered in any British or foreign record or stud book not listed in Section 1(b) of this article may be inspected by an examining committee, and if registration is authorized by the Registration Committee, it will be eligible for registration the same as if the dog had been registered in any of the records listed in section 1(b) of this article.

(e) A dog of a recognized breed for which no foreign record has been established in the country of their origin, may be inspected by an examining committee, and if approved by the Registration Committee it shall be recorded in the Canadian Kennel Club Stud Book.

(f) A dog the application for registration of which is accompanied by a three generation statement of breeding with particulars as to breeder, owner, date and place of birth, and colour or colours, all of which must be set forth in the form of an affidavit, but no dog whose application for registration is made in accordance with this section may be registered until examined by an examining committee and registration has been authorized by the Registration Committee.

2. Where inspection of a dog is a requisite before eligibility for registration can be established, the Board of Directors may appoint an examining committee, as occasion may require, to inspect the dog or dogs involved. Following inspection the examining committee shall submit an inspection report and its recommendations to the Registration Committee.

3. The foregoing Rules of Eligibility shall in every respect be subject to the provisions of Article XXVI, Section 5, of these By-laws.

judge should be provided with a copy of the Dog Show Rules and informed that he is expected to follow the Rules in all respects and to judge according to the standards laid down by the Canadian Kennel Club which are identical to those adopted by the American Kennel Club.

ACTION: The suggestion was let over for further consideration.

SUBJECT: The Secretary referred to Section 6, Part 5 of the new Live Stock Pedigree Act which provides that no person may be deprived of the right to register and transfer pure-bred dogs unless he had committed offences referred to in that Section, and sought instruction regarding future distribution of lists of persons denied the privileges of the Club.

ACTION: The matter was held for further consideration at the next meeting of the Board.

SUBJECT: The Secretary referred to the new identification requirements and the effect it may have, for a time, on the registration of dogs referred to in Chapter 16, Section 2, of the Dog Show Rules. The Secretary pointed out that a proposed amendment to this Section was included in the amendments published in the January issue of DOGS IN CANADA and the Board may wish to make a recommendation to the members attending the annual general meeting when the proposed amendment in question came before the meeting.

ACTION: The matter was left over for consideration at the annual general meeting.

SUBJECT: The Secretary read a letter from the Fredericton Kennel Club suggesting that a representative of the Humane Society should attend each dog show, the arrangement to be made by the show giving club.

RESOLUTION: It was regularly moved by Director Farmer, seconded by Director Spratt:

"THAT, the letter be tabled."

Motion carried.

SUBJECT: Vice-President Riedel referred to the arrangement put into effect by the American Kennel Club whereby a dog meeting certain registration requirements could be registered providing it earned a specified number of championship points at shows held under its Rules, and suggested that the Board give consideration to adoption of a similar arrangement in Canada.

ACTION: It was agreed that this suggestion be considered when the proposed by-laws are placed before the members attending the annual general meeting.

SUBJECT: The Secretary read a letter from the Secretary of the Canadian Association of Exhibitions, reporting that at the convention of their association last November a resolution had been adopted regarding the standardization of colours for ribbons used at all live stock shows in Canada. The colour for first prize was indicated as red, second prize blue, which reversed the colours set out in Chapter 5, of the Dog Show Rules.

ACTION: The letter was ordered tabled for the Board agreed that it had no authority to amend the Dog Show Rules.

SUBJECT: The Secretary asked for an instruction on informing show-giving clubs regarding the order of breed judging at coming shows. He enquired whether the order should carry on from where it left off in 1949 or whether, in each Province, the first show should start with Group 1.

ACTION: It was agreed that in each instance each Province should start with Group 1.

SUBJECT: The Secretary tabled a detailed report from Director W. P. Moore reporting on the proceedings of the annual meeting of the "Association of Maritime Kennel Clubs", held at Amherst, N.S., on November 6th. The meeting largely dealt with arrangements for proposed show circuits during 1950 and other matters relative to the holding of championship shows.

ACTION: The report was held over for consideration at the annual meeting.

SUBJECT: The Secretary read letters received from Mr. C. A. Lessard in answer to letters addressed to Mrs. Yolanda Lessard regarding the absence of The Great Danes FINGARD'S KING OF MONT CLAIRE and FINGARD'S PRINCE OF MONTCLAIR from the second day of the Canine Breeders' and Exhibitors' Association championship show held on September 8th and 9th, 1949.

A discussion followed.

Article XXIX. REGISTRATION OF LITTERS

1. **APPLICATION FOR REGISTRATION.** The owner at the time of the birth may make application, on a form supplied by the Club for that purpose, for registration of a litter born in the Dominion of Canada. All blank spaces on the form must be filled in, in ink or typewritten except signatures which must be signed in ink.

2. **DAM OF THE LITTER.** The dam must be registered with the Canadian Kennel Club in the name of the person signing the application for registration as owner or lessee at the time of the birth of the litter.

3. **SIRE OF THE LITTER.** (a) If owned or leased by a resident of the Dominion of Canada, the sire must be registered with the Canadian Kennel Club in the name of the person certifying the service;

(b) If owned by a resident of the United States, the sire must be registered with the American Kennel Club in the name of the person certifying the service. In such cases the certification of the Secretary of the American Kennel Club will be required to the effect that the dog is recorded with the American Kennel Club as being the property of the person signing as owner of the sire at the time of the service;

(c) If owned by a resident of a country other than Canada or the United States, a certificate of service issued by the recognized British or foreign Stud Book shall be required as well as a certified copy of the known pedigree of the sire to the minimum of three generations.

(d) If the owner or lessee of the sire of a litter shall refuse, fail or neglect to sign where required, an application for registration of a litter when requested to do so by the owner of the dam at time of birth of the litter, the Board of Directorate shall have the power to authorize registration of the litter, through the Registration Committee, if it is satisfied that the owner of the sire has no justifiable reason for withholding his signature.

4. **SIGNATURES.** (a) If owned or leased by a resident of Canada or the United States the signature in ink of the owner or lessee of the sire will be required certifying to the date(s) of service;

(b) The signature in ink of the owner or lessee of the dam at the time of the service will be required certifying as to the service of the dam to the sire named on the application on the date(s) set forth on the application.

(c) The signature in ink of the owner or lessee of the dam at the time of birth of the litter will be required certifying the date of birth of the litter and the number of males and females alive at the time of the application for registration of the litter.

5. **BREEDER.** The breeder of a litter is the owner or lessee of the dam at the time of service. The first owner is the owner or lessee of the dam at the time the litter was born.

6. **AGE.** No litter out of a dam under six months or over twelve years of age at the time of mating, or by a sire under six months or over twelve years of age at the time of mating will be registered unless the application for registration is accompanied by an affidavit or evidence which shall prove the facts, set out in the application for registration of a litter, to the satisfaction of the recording office.

7. **ARTIFICIAL INSEMINATION.** Artificial insemination as a means of producing conception shall not be recognized and the submission of an application for registration of litter to the recording office shall be taken to mean that the litter is a result of conception brought about by a natural mating.

8. **MATINGS.** Notwithstanding any other provisions of these By-laws, no litter is eligible for registration if the dam of the litter was mated to two or more stud dogs during the period of three months immediately preceding the birth of the litter.

Article XXX. REGISTRATION OF INDIVIDUAL DOGS

1. **APPLICATION FOR REGISTRATION.** The application for registration of a dog must be on the form supplied by the Club for that purpose. All blank spaces on the form must be filled in, in ink or by typewriter except signature which must be signed in ink.

2. **PLACE OF BIRTH.** (a) The owner at the time of birth may make application for registration of a dog born in Canada provided the litter of which the dog is part (or whole) has first been registered with the Canadian Kennel Club with the exception of dogs eligible for registration under Sections, 2, 3, 5 and 6 of Article XXVIII.

(b) A person resident in Canada may make application for registration of a dog registered with the American Kennel Club providing the American Kennel Club certificate of registration showing the applicant's ownership accompanies the application for registration.

Note: An arrangement exists with the American Kennel Club whereby all dogs born in Canada must be registered with the Canadian Kennel Club before being eligible for registration with the American Kennel Club and vice versa.

(c) A person resident in the United States may make application for registration of a dog registered with the American Kennel Club provided the American Kennel Club certificate of registration showing the applicant's ownership accompanies the application for registration.

(d) A person resident in Canada may make application for registration of a dog imported to Canada from a country other than the United States, providing the application for registration is accompanied by an export certificate (or official certificate of registration with satisfactory evidence that the dog has been im-

ACTION: The Secretary was directed to inform Mrs. Lessard that a dog may only be removed from a championship show after written permission is obtained, as provided in Chapter 19, Section 1, of the Dog Show Rules. The Secretary was further directed to cancel the wins earned by FINGARD'S KING OF MONTCLAIR and FINGARD'S PRINCE OF MONTCLAIR at this show and to make the necessary adjustments in the Club's records.

1499 (1452). APPLICATIONS FOR HANDLERS' LICENSES

REPORT: The Secretary reported that the following had submitted applications for Handlers' Licenses:

The Secretary reported that a completed application had been received from Mr. Charles Morgan, Sr., whose 1949 Handler's License fee had been received last August.

RESOLUTION: It was regularly moved by Director Boughs, seconded by Director Mrs. Brown:

"THAT, the applications reported by the Secretary be approved on the condition that such applications meet the requirements of the Dog Show Rules and that the applicants residing in the United States are licensed as professional handlers by the American Kennel Club." Motion carried.

1500 (1470). APPOINTMENT OF REGISTRATION COMMITTEE

REPORT: The Secretary reported that while it was customary for the Board at its annual meeting to appoint a Registration Committee, there were a number of files presently awaiting the attention of the Committee when it is appointed.

DISCUSSION: It was agreed since the need of appointing the Committee was immediate and the members of the Committee usually were local members of the Board, the Committee should be appointed at this meeting.

RESOLUTION: It was regularly moved by Vice-President Riedel, seconded by Director Farmer:

"THAT, the President and Directors Boughs and Spratt be appointed the Registration Committee for 1950." Motion carried.

1501 (1482). FOXHOUND FIELD TRIALS

REPORT: Director Farmer reported on his discussion with the President of the All-Canadian Foxhunters' Association regarding foxhound trials and expressed the view that because of the nature of the foxhound trial it would be unwise to permit of a foxhound earning a Field Trial Championship as a result of a win made at a single trial. The President pointed out that until Foxhound Field Trial enthusiasts had indicated their wishes with respect to Foxhound Field Trial Rules there was no reason to make any decision at this point.

ACTION: No further action was taken at this time.

Director Farmer left the meeting at this time in order catch the night train to Ottawa.

1502 (1486). ANNUAL MEETINGS REVISION OF CONSTITUTION

DISCUSSION: In discussing whether to postpone the annual general meeting until the new by-laws are available for the consideration of the members, the Board agreed that it would be preferable to postpone the annual meeting for the following reasons:

1. A general meeting with all members of the Board present would cost the Club in excess of \$2,500.00 and there was little point in putting the Club to the expense of two general meetings in the space of two or three months;

2. Members should be given an opportunity of dealing with the adoption of the new by-laws;

ACTION: Following further discussion the following steps were agreed upon:

1. The members of the Board outside Ontario would be promptly notified of the postponement of the annual general meeting and the reasons for the postponement;

2. The following post card notice would be sent to all members as soon as possible:

"The Board of Directors regrets that it is necessary to postpone the Annual

ported to Canada) issued by the Secretary of a recognized Stud Book or foreign record specifying the breeder, colour and markings, date of birth, intermediate owners (if any), Canadian importer with date of purchase and the known pedigree of the dog to the minimum of three generations;

(e) The owner of a dog may make application for registration of a dog, the registration of which is not otherwise provided for in sub-sections (a), (b), (c), (d) or (e) of this section but such application must be consistent with sub-section (b), (c), (d), (e), or (g) of Section 1 of Article XXVIII.

3. SIGNATURES. (a) If born in Canada the signature in ink of the owner at the time of birth must appear on the application for registration form in the space provided for that purpose;

(b) If imported to Canada, the signature in ink of the importer must appear on the application for registration form in the space provided for that purpose;

(c) If owned by a resident of the United States the signature in ink of the owner as recorded with the American Kennel Club must appear on the application for registration form in the space provided for that purpose.

4. NAME. (a) No two dogs of the same breed shall have the same name, however, no change may be made in the name of an imported dog. The recording office may add numeral affix to a dog's name for the purpose of distinguishing between dogs which otherwise have the same name;

(b) The right is reserved to change any name when necessary, preserving, however, as far as possible some characteristics of the name given on the application;

(c) The name of a dog will not be accepted if containing more than thirty letter spaces or characters including numeral affix;

(d) Only the owner at time of birth may request a change of name of a dog after it has been registered but no change shall be permissible after a dog has been registered sixty days;

(e) The name of an imported dog may not be changed, and no claim may be made against this Club should the name of an imported dog infringe the rights of any person, partnership or company whose kennel name has been registered by this club;

(f) Notwithstanding any other provisions of these by-laws or agreements entered into by this club, the names of members of the Royal Family and national leaders shall not be permitted in connection with the naming of dogs for registration purposes.

5. AGE. Application for registration of a dog born in Canada five years of age or over, that was not identified when less than one year old, shall not be considered unless an affidavit by the first owner accompanies the application. Such affidavit shall set forth the reasons why the dog was not registered at an earlier date and must be satisfactory to the recording office. If the dog is not then in possession of the first owner, identity must be established by the first owner and the owner shall also furnish the affidavit which must be satisfactory to the Registration Committee.

6. If an unidentified dog, whether registered or not, is lost to its registered or reputed owner, through any cause whatsoever, it shall be declared non-existent, unless subsequent representations are made to the Board of Directors which indicate reasonable grounds that the identity of the dog can be established, in which case, the matter shall be referred to the Board of Directors for their consideration.

7. Notwithstanding any other provisions of these by-laws or agreements entered into by this club, no individual dog is eligible for registration if its dam was mated to two or more stud dogs in the three month's period immediately preceding the birth of the dog.

8. Notwithstanding any other provisions of these By-laws or agreements entered into by this club, no individual dog is eligible for registration if the litter of which it is part or whole was the result of artificial insemination.

Article XXXI. REGISTRATION OF TRANSFERS OF OWNERSHIP

1. Where a dog is sold or otherwise disposed of the person disposing of the dog must immediately take the necessary action to provide the new owner with a Canadian Kennel Club certificate of registration showing the change of ownership. Failure to provide a certificate as herein required shall subject a member so in default to expulsion or suspension, and if a non-member to deprivation of the privilege of the Club. Where disciplinary action has been taken the Board of Directors shall have the power to authorize the issuance of a certificate of registration to the new owner.

2. An application for registration of change of ownership must be made in ink or typewritten on a form supplied by the Club for that purpose. The certificate may be returned by the recording office to either the applicant or the new owner.

3. If a resident of Canada should purchase a dog exported to the United States, the dog must be registered with the American Kennel Club in the name of the new Canadian owner. The Canadian certificate of registration together with the American Kennel Club certificate must be forwarded to the recording office. No signed application for transfer is required.

4. Every transfer of ownership must be recorded on the records of this Club, and if it is proven to the satisfaction of the Board of Directors that a transfer of ownership has been, by accident or otherwise, left unrecorded they may take disciplinary action as provided for in Article XV.

Article XXXII. CERTIFIED PEDIGREES

1. A certified pedigree is a certified genealogical table showing the ancestral line of descent of a dog as indicated by the Club's registration records and such

General Meeting, scheduled for February 8th, 1950. This postponement is considered advisable for the reason that it is now necessary for the Club to prepare and present, for the consideration of the members, by-laws and regulations that will conform to the new Live Stock Pedigree Act which received Royal assent on December 10th, 1949.

"The by-laws and regulations, when prepared, together with the amendments published in the January (1950) issue of DOGS IN CANADA, will come before the Annual General Meeting, the date of which will be announced as soon as possible."

3. The Club's Solicitor be consulted immediately regarding the drafting of new by-laws to conform to the new Live Stock Pedigree Act;

4. The Club's Solicitor be consulted immediately regarding steps to be taken to set up an organization which would continue the functions of the Canadian Kennel Club as far as it concerned competitive events for pure-bred dogs;

5. This meeting would be adjourned to reconvene at the call of the President as soon as new by-laws had been prepared and the advice of the Club's Solicitor had been obtained on the proposed new organization.

1503 (1468). IDENTIFICATION

ACTION: This matter was left over for further discussion at the next meeting of the Board.

1504 (1471). LETTER FROM THE PROFESSIONAL HANDLERS' ASSOCIATION

SUBJECT: The Secretary read a letter received from the Professional Handlers' Association regarding cancellation of entries at championship shows.

ACTION: The matter was ordered held over for further consideration at the next meeting of the Board.

1505 (1473). LETTER FROM J. BROOKS (1478). LETTER FROM MRS. M. GIBSON

SUBJECT: The Secretary read letters from Mr. J. Brooks, Calgary, Alberta, and Mrs. Mercedes Gibson, Cowichan Station, B.C., regarding judging at championship shows.

ACTION: Both letters were ordered held over for consideration at the next meeting of the Board.

1506 (1375). C.K.C. MEDALS

REPORT: The Secretary reported that: (a) Mr. William Semple, Regina, Sask., was the winner of the Wm. H. Pym Medal offered by the Club to the member whose dog won the most Best in Show awards at championship shows held under the Club's Rules during 1949.

(b) Mrs. F. Yeigh McEachren, Caulfield, B.C., was the winner of the James D. Strachan Memorial Medal offered by the Club to the member whose dog won the most Best Canadian Bred in Show awards at championship shows held under the Club's Rules during 1949.

The Secretary exhibited a sample medal.

ACTION: The Secretary was directed to arrange for medals as per the sample exhibited, these medals to be distributed to the winners as soon as possible along with the congratulations of the Board.

1507. LIGHTING SYSTEM

REPORT: The Secretary reported that the lighting system in the Club's office had required much attention and maintenance during 1949, and that the Board had considered the possibility of replacing the fluorescent fixtures with the incandescent variety.

ACTION: The matter was left in the hands of the Secretary for further attention and report.

1508. ADJOURNMENT

At 11.15 p.m., on motion by Vice-President Riedel, duly seconded and carried, this meeting of the Board of Directors adjourned to reconvene at the call of the President.

FEBRUARY 9th, 1950

1509. The meeting of the Board of Directors which commenced on January 18th, 1950, reconvened, at the call of the President, in the Club's offices, 667 Yonge Street, Toronto, at 2.00 p.m., on February 9th, 1950. The President, W. J. Risewick, presided. Officers and Directors present were D. Riedel, Paddy Boughs, Mrs. Ellen Brown, J. J. Farmer, and C. S. Spratt. Director T. B. McRae was absent, being out of town.

1510. REVISION OF CONSTITUTION

British or foreign stud books as may be in the Club's files. It is certified as being correct only to the extent that it reflects the ancestral line of descent as shown in the records and stud books available to the Club, and no claim may be entered against the Club or its recording office in the event the information shown thereon is incorrect.

2. A "three-generation pedigree" is one which shows the name of the sire and dam, all grandparents, and all great grandparents of a particular dog.

3. The Club may decline to provide a certified pedigree for any reason which it deems sufficient.

Article XXXIII. DUPLICATE CERTIFICATES

1. A duplicate certificate may be issued if the registered owner or his authorized agent files a statutory declaration on a form supplied by the Club for the purpose of showing in a satisfactory manner that the original is lost, destroyed or unobtainable.

2. Once a duplicate certificate has been issued the original is void and if found must be returned to the recording office to be filed.

Article XXXIV. REGISTRATION OF LEASES

In case a male or female is leased or loaned for any purpose the form of lease supplied by the Club for that purpose must be filled in, signed by the lessee and lessor and forwarded with the certificate of registration and the required fees to the recording office so that the lease may be recorded. The lease of a dog shall not be recorded on the certificate of registration. The terms, conditions or arrangements agreed on by the lessee and lessor shall be fully disclosed on the application for registration of lease or a copy of the agreement signed by the lessee and lessor shall be attached to the application for registration of the lease.

Article XXXV. FEES

1. All fees for transactions requiring the services of the recording office shall be made payable to the Canadian Kennel Club, Inc., and should be sent direct to the recording office. They may be in the form of a postal note, post office money order, express money order, bank money order or certified bank cheque payable at par at the office of the records.

2. On receipt of fees the recording office shall forthwith deposit the same to the credit of the Club in a chartered bank selected by the Board of Directors.

Registration of dogs recorded in any recognized British or foreign record is chargeable at the same rate as for Canadian-born dogs. If a dog is sold before being registered, each change of ownership is charged for at regular rate of transfer, but only if such transfers take place in Canada. Also, with an imported dog, the increasing schedule of fees shall take effect from the date upon which it becomes possible to make registration in Canada, without respect to the actual age of the dog, and the fees so charged will be according to the Canadian Kennel Club status of the new owner.

4. The Board of Directors shall have the power, by an affirmative majority vote of the entire Board, to make changes in the above stated schedule of fees. Such changes must, however, be endorsed by the Minister of Agriculture and shall only be effective when endorsed by the Minister. Thirty days' notice of any and all changes made by the Board of Directors shall be given all members of the Club in good standing either in the official organ of the Club or by mail, postage prepaid, before such changes become effective. The members attending any general meeting of the Club shall have the power to, without prior notice of intention to do so, instruct the Board of Directors to make no changes in the schedule of fees during the balance of the calendar year in which it is in office.

REPORT: The President reported that preparation of the new by-laws had been completed on February 7th and he had therefore re-convened the meeting of the Board which commenced on January 18th so that the Board could review the proposed by-laws.

DISCUSSION: The Board reviewed the proposed by-laws section by section, and made a number of alterations.

The President suggested that before the proposed by-laws are set in type and distributed to the members along with the notice calling the annual general meeting, it would be advisable to ascertain, if possible, whether or not the by-laws as drafted would be acceptable to the Department of Agriculture. Director Farmer indicated that he would be prepared to take the proposed by-laws to officials of the Department and obtain their reaction so that if major alterations, additions or deletions were indicated, the Board could take such action as it deemed advisable under the circumstances.

ACTION: It was agreed that Director Farmer would take the proposed by-laws and would obtain the reaction of officials of the Department as soon as possible.

SUBJECT: The Secretary read a memorandum received from the Club's solicitor regarding proposed arrangements intended to provide for continuation of such of the Club's activities as are not authorized under the Live Stock Pedigree Act, 1949.

ACTION: It was agreed that Director Farmer would consult with officials of the Department of Agriculture on provisions of this memorandum and obtain their reaction for the Board of Directors. It was unanimously agreed that as soon as the reaction of the Department had been obtained to the proposed by-laws, the President would, on behalf of the Board of Directors, set the dates of the annual meetings so that notice could go forward to the Board and the members at the earliest possible date.

1511. ADJOURNMENT

On motion by Director Spratt, duly seconded and carried, this meeting adjourned at 10.20 p.m. to reconvene in the Club's offices, 667 Yonge Street, Toronto, on February 22nd, 1950, at 10.00 a.m.
